**Приложение к идентичным письмам Постоянного представителя Ливана при Организации Объединенных Наций от 14 января 2020 года на имя Генерального секретаря и Председателя Совета Безопасности**

The letter in question contains mendacious and unconfirmed allegations and fabrications intended to defame Lebanon in the international arena.

Following investigations conducted by the Ministry of National Defence – Army Command into the Lebanese violations alleged by the Israeli enemy for the month of August 2019, the following facts have emerged:

**Inaccurate:** The Army was briefed by the United Nations Interim Force in Lebanon (UNIFIL) during the incident, and it was ascertained that the incident:

1. Was not a violation of Security Council resolution [1701 \(2006\)](#)
2. Did not occur.

**Unconfirmed:**

1. The Army was not informed of the incident by UNIFIL
2. The Army was informed by UNIFIL after the incident had ended, and a Lebanese Army patrol was deployed but was not able to confirm it.

**Observations:** The Israeli allegations are discussed at the tripartite meetings that are held at Ra's al-Naqrurah. They are not comparable to the violations that Israel commits of the sovereignty of Lebanon. Those violations include ongoing air and sea violations, pursuing and attempting to abduct herders whenever they come near the line of withdrawal, pointing weapons and tank cannons towards Lebanese civilians, Lebanese Army patrols and UNIFIL troops, and the ongoing occupation of the northern part of Ghajar town, the Shab'a Farms, the Kafr Shuba heights, Jabal al-Shaykh and Lebanese territory along the Blue Line.

Accordingly, please inform the Permanent Mission of Lebanon to the United Nations and instruct it to make these facts known, in order to expose the Israeli enemy's attempt to defame Lebanon by making Lebanon appear to be the one violating international law and failing to comply with Security Council resolution [1701 \(2006\)](#). Israel is doing this only to provide cover for its own land, sea and air violations of Lebanese sovereignty.
