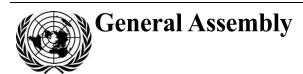

# Report of the Fifth Committee

## I. Introduction

- 1. The previous recommendations made by the Fifth Committee to the General Assembly under agenda item 139 are set out in the reports of the Committee contained in documents A/75/683 and A/75/683/Add.1.
- 2. During the first part of the resumed seventy-fifth session, the Fifth Committee met formally and remotely owing to the coronavirus disease (COVID-19) pandemic, during which it resumed its consideration of the item. The Committee formally resumed its consideration of the item in person at its 15th meeting, on 29 June 2021. Statements and observations made in the course of the Committee's formal consideration of the item are reflected in the relevant summary record.<sup>1</sup>

# II. Consideration of draft decision A/C.5/75/L.50

- 3. At its 15th meeting, on 29 June, the Committee had before it a draft decision entitled "Questions deferred for future consideration" (A/C.5/75/L.50), submitted by the Chair of the Committee.
