

Financing of the African Union-United Nations Hybrid Operation in Darfur

Report of the Fifth Committee

I. Introduction

- 1. At its 2nd plenary meeting, on 17 September 2021, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-sixth session the item entitled "Financing of the African Union-United Nations Hybrid Operation in Darfur" and to allocate it to the Fifth Committee.
- 2. During the main part of the seventy-sixth session, the Fifth Committee met formally and remotely owing to the coronavirus disease (COVID-19) pandemic, during which it considered the item. The Committee formally considered the item in person at its 9th meeting, on 23 December 2021. Statements and observations made in the course of the Committee's formal consideration of the item are reflected in the relevant summary records.¹
- 3. For its consideration of the item, the Committee had before it the following documents:
- (a) Report of the Secretary-General on the donation of assets of the African Union-United Nations Hybrid Operation in Darfur to the Government of the Sudan (A/76/504);
- (b) Related report of the Advisory Committee on Administrative and Budgetary Questions (A/76/585).

II. Consideration of draft resolution A/C.5/76/L.11

4. At its 9th meeting, on 23 December, the Committee had before it a draft resolution entitled "Financing of the African Union-United Nations Hybrid Operation

in Darfur" (A/C.5/76/L.11), submitted by the Chair of the Committee on the basis of informal consultations coordinated by the representative of Japan.

5. At the same meeting, the Committee adopted draft resolution A/C.5/76/L.11 without a vote (see para. 6).

III. Recommendation of the Fifth Committee

6. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolution:

Financing of the African Union-United Nations Hybrid Operation in Darfur

The General Assembly,

Having considered the report of the Secretary-General on the financing of the African Union-United Nations Hybrid Operation in Darfur¹ and the related report of the Advisory Committee on Administrative and Budgetary Questions,²

Recalling Security Council resolution 1769 (2007) of 31 July 2007, by which the Council established the African Union-United Nations Hybrid Operation in Darfur for an initial period of 12 months from 31 July 2007, and the subsequent resolutions by which the Council extended the mandate of the Operation, the latest of which was resolution 2559 (2020) of 22 December 2020, by which the Council decided to terminate the mandate of the Operation as of 31 December 2020,

Recalling also its resolution 62/232 A of 22 December 2007 on the financing of the Operation and its subsequent resolutions thereon, the latest of which was resolution 75/251 C of 30 June 2021,

1. Endorses the conclusions and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions, and requests the Secretary-General to ensure their full implementation;

Donation of assets of the African Union-United Nations Hybrid Operation in Darfur

- 2. *Takes note* of the report of the Secretary-General on the financing of the Operation;
- 3. Approves the donation of assets of the Operation, with an acquisition cost of 145,456,300 United States dollars and a net book value of 55,291,700 dollars, to the Government of the Sudan:
- 4. Decides to keep under review, during its seventy-sixth session, the item entitled "Financing of the African Union-United Nations Hybrid Operation in Darfur".
