Financing of the International Residual Mechanism for Criminal Tribunals

Report of the Fifth Committee

I. Introduction

1. At its 2nd plenary meeting, on 17 September 2021, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-sixth session the item entitled "Financing of the International Residual Mechanism for Criminal Tribunals" and to allocate it to the Fifth Committee.

2. During the main part of the seventy-sixth session, the Fifth Committee met formally and remotely owing to the coronavirus disease (COVID-19) pandemic, during which it considered the item. The Committee formally considered the item in person at its 9th meeting, on 23 December 2021. Statements and observations made in the course of the Committee's formal consideration of the item are reflected in the relevant summary records.¹

3. For its consideration of the item, the Committee had before it the following documents:

(a) Report of the Secretary-General on the proposed budget for the International Residual Mechanism for Criminal Tribunals for 2022 (A/76/411);

(b) Performance report of the Secretary-General on the budget of the International Residual Mechanism for Criminal Tribunals for 2020 (A/76/370);

(c) Financial report and audited financial statements for the year ended 31 December 2020 and report of the Board of Auditors on the International Residual Mechanism for Criminal Tribunals (A/76/5/Add.15);

(e) Report of the Secretary-General on the revised estimates for the International Residual Mechanism for Criminal Tribunals: effect of changes in rates of exchange and inflation (A/76/594);

II. Consideration of draft resolution A/C.5/76/L.16

4. At its 9th meeting, on 23 December, the Committee had before it a draft resolution entitled "Financing of the International Residual Mechanism for Criminal Tribunals" (A/C.5/76/L.16), submitted by the Chair of the Committee on the basis of informal consultations coordinated by the representative of Switzerland.

5. At the same meeting, the Committee adopted draft resolution A/C.5/76/L.16 without a vote (see para. 7).

6. The representatives of Cameroon (on behalf of the African Group), Rwanda and the United Republic of Tanzania made statements after the adoption of the draft resolution.

III. Recommendation of the Fifth Committee

7. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolution:

Financing of the International Residual Mechanism for Criminal Tribunals

The General Assembly,

Having considered the reports of the Secretary-General on the budget performance for 2020, the proposed budget for 2022 and the revised estimates arising from the effect of changes in rates of exchange and inflation for the International Residual Mechanism for Criminal Tribunals, ¹ the financial report and audited financial statements for the year ended 31 December 2020 and the report of the Board of Auditors on the International Residual Mechanism for Criminal Tribunals for Criminal Tribunals² and the recommendations contained therein, as well as the related reports of the Advisory Committee on Administrative and Budgetary Questions,³

Recalling its resolution 66/240 A of 24 December 2011 on the financing of the International Residual Mechanism for Criminal Tribunals and its subsequent resolutions thereon, the latest of which was resolution 75/249 of 31 December 2020,

1. *Takes note* of the reports of the Secretary-General;

2. *Endorses* the related conclusions and recommendations contained in the reports of the Advisory Committee on Administrative and Budgetary Questions;

3. *Decides* to appropriate to the special account for the International Residual Mechanism for Criminal Tribunals a total amount of 89,690,200 United States dollars gross (81,377,300 dollars net) for 2022, as detailed in the annex to the present resolution;

4. *Also decides* that the total assessment for 2022 under the special account amounting to 77,443,400 dollars shall consist of:

(a) 89,690,200 dollars, being the estimated appropriation approved for the period;

(b) Less 8,736,500 dollars, being the credit of the cancellation of prior period obligations/commitments corresponding to the biennium 2018–2019, and other revenue;

(c) Less 3,510,300 dollars, being the surplus resulting from the final expenditure for the budget for 2020;

5. *Further decides* to apportion the amount of 38,721,700 dollars gross (35,134,300 dollars net) among Member States in accordance with the scale of assessments applicable to the regular budget of the United Nations for 2022;

6. *Decides* to apportion the amount of 38,721,700 dollars gross (35,134,300 dollars net) among Member States in accordance with the scale of assessments applicable to peacekeeping operations of the United Nations for 2022;

7. Also decides that, in accordance with the provisions of its resolution 973 (X) of 15 December 1955, there shall be set off against the apportionment among Member States, as provided for in paragraphs 5 and 6 above, their respective share in the Tax Equalization Fund of the estimated staff assessment income in the amount of 7,174,800 dollars approved for the Mechanism for 2022.
