Revitalization of the work of the General Assembly

Report of the First Committee

Rapporteur: Mr. Nazim **Khaldi** (Algeria)

1. At its 3rd plenary meeting, on 16 September 2022, the General Assembly, on the recommendation of the General Committee, decided to allocate item 124 to all the Main Committees for the purpose of discussing their working methods, as well as considering and taking action on their respective tentative programmes of work.
2. The First Committee considered the item at its 10th and 32nd meetings, on 13 October and 4 November 2022, respectively.¹
3. At the 32nd meeting, the Chair made a statement and introduced the provisional programme of work and timetable of the First Committee for 2023.
4. Also at the same meeting, the Committee adopted its provisional programme of work and timetable for 2023, as set out in the annex to the present report.

5. The First Committee recommends to the General Assembly the adoption of the following draft decision:

Delegations are encouraged to limit their statements for the general debate to a maximum of eight minutes. Statements on behalf of a group of countries should not exceed 12 minutes. The list will give priority to high-level representatives and should be shared with the Committee on a regular basis so as to increase transparency. Wide civil society participation is encouraged.

^b During thematic discussions, delegations are encouraged to limit their statements to a maximum of five minutes; statements on behalf of a group of countries should not exceed seven minutes.
