

Report of the Third Committee*

Rapporteur: Ms. Shalini Gungaram (Mauritius)

- 1. At its 3rd plenary meeting, on 16 September 2022, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-seventh session the item entitled:
 - "Promotion and protection of human rights:
 - "(a) Implementation of human rights instruments;
 - "(b) Human rights questions, including alternative approaches for improving the effective enjoyment of human rights and fundamental freedoms;
 - "(c) Human rights situations and reports of special rapporteurs and representatives;
 - "(d) Comprehensive implementation of and follow-up to the Vienna Declaration and Programme of Action"

and to allocate it to the Third Committee.

- 2. The Third Committee considered the item jointly with its sub-items and heard introductory statements and held interactive dialogues and a general discussion at its 17th to 38th meetings, on 13 and 14, from 17 to 21 and from 25 to 28 October 2022. An account of the Committee's discussion under the item is contained in the relevant summary records. An account of the Committee's consideration of the sub-items is contained in the addenda to the present report.
