## Programme budget for 2022

### Report of the Fifth Committee

*Rapporteur:* Mr. Marinko Avramović (Bosnia and Herzegovina)

#### I. Introduction

1. The previous recommendation made by the Fifth Committee to the General Assembly under agenda item 137 is set out in the report of the Committee contained in document [A/77/535](#).

2. Under that agenda item, the Fifth Committee considered the question of revised estimates relating to the programme budget for 2022 under section 3, Political affairs, and section 36, Staff assessment: special political missions – United Nations Assistance Mission in Afghanistan at its 2nd and 9th meetings, on 3 and 25 October 2022, respectively. Statements and observations made in the course of the Committee's consideration of the question are reflected in the relevant summary records.<sup>1</sup>

3. For its consideration of the question, the Committee had before it the following documents:

(a) Report of the Secretary-General on revised estimates relating to the programme budget for 2022 under section 3, Political affairs, and section 36, Staff assessment: special political missions – United Nations Assistance Mission in Afghanistan ([A/76/6 \(Sect. 3\)/Add.9](#));

(b) Related report of the Advisory Committee on Administrative and Budgetary Questions ([A/76/7/Add.41](#)).

#### II. Consideration of draft resolution [A/C.5/77/L.4](#)

4. At its 9th meeting, on 25 October, the Committee had before it a draft resolution entitled “Revised estimates relating to the programme budget for 2022 under section 3, Political affairs, and section 36, Staff assessment: special political missions – United

Nations Assistance Mission in Afghanistan” ([A/C.5/77/L.4](#)), submitted by the Chair of the Committee on the basis of informal consultations coordinated by the representative of Kenya.

5. At the same meeting, the Committee adopted draft resolution [A/C.5/77/L.4](#) without a vote (see para. 6).

### III. Recommendation of the Fifth Committee

6. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolution:

**Revised estimates relating to the programme budget for 2022 under section 3, Political affairs, and section 36, Staff assessment: special political missions – United Nations Assistance Mission in Afghanistan**

*The General Assembly,*

*Recalling* its resolution 76/245, section X of its resolution 76/246 and its resolutions 76/247 A to C, of 24 December 2021, and section II of its resolution 76/246 B of 13 April 2022,

*Having considered* the report of the Secretary-General<sup>1</sup> and the related report of the Advisory Committee on Administrative and Budgetary Questions,<sup>2</sup>

1. *Takes note* of the report of the Secretary-General;
2. *Endorses* the conclusions and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions;
3. *Appropriates*, under the procedures provided for in paragraph 11 of annex I to resolution 41/213 of 19 December 1986, an additional amount of 131,345,400 United States dollars under section 3, Political affairs, of the programme budget for 2022 for the United Nations Assistance Mission in Afghanistan;
4. *Also appropriates* the related staff assessment portion in the amount of 10,905,200 dollars under section 36, Staff assessment, to be offset by a corresponding amount under income section 1, Income from staff assessment, of the programme budget for 2022.
