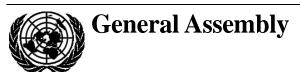

- 4. Draft resolution A/AC.109/2013/L.10 was adopted.
- 5. **Mr. Demekhin** (Russian Federation) said that his Government consistently advocated the right of the peoples of the Non-Self-Governing Territories to self-determination and independence. However, consideration of that particularly political issue in the framework of the Economic and Social Council distracted the Council from its primary function of coordinating the work of the United Nations in the economic and social sphere. Thus, the item should be removed from the Council's agenda.

- 8. **Mr. Aisi** (Papua New Guinea) suggested that the Committee should defer its consideration of the question of New Caledonia to its 9th meeting in order to allow for further consultation with all the parties involved.
- 9. It was so decided.
