5. **The Chair** suggested that the Committee should authorize the Rapporteur to prepare the report of the Special Committee to the seventy-first session of the General Assembly. In accordance with established practice, the Committee should authorize the Rapporteur to submit the report directly to the Assembly.

Closure of the session

8. **The Chair**, reviewing the work accomplished by the Committee during the 2016 session, said that valuable information had emerged in the course of the recent Pacific Regional Seminar, not least because of the participation also of United Nations specialized agencies, whose expertise could do much to further decolonization. The success of the annual International

Week of Solidarity with the Peoples of Non-Self-Governing Territories, which had included exhibitions, cultural events and academic discussions, had demonstrated the international interest in decolonization, despite the fact that the subject was unfortunately not at the moment a priority of the United Nations as a whole. There had been frank, informative discussions in the Committee on often contentious issues and all those who could make a constructive contribution had been heard. Yet the need to promote consensus and a calm, more effective approach had become apparent in view of the disruptive and undiplomatic behaviour of an observer delegation during the consideration of the question of Western Sahara. On the other hand, the Committee had made a wise decision to begin adopting separate resolutions on the small Territories in the Caribbean, the Pacific and the Atlantic, allowing it to deal properly with specific aspects of the individual Territories. Ways would have to be found to help those which had specifically requested assistance during the session. All administering Powers, as well, had been urged to become constructively involved in the Committee's work in order to fulfil their responsibility to hasten the self-determination of all the remaining dependent Territories. After the customary expression of thanks to the Committee members and Secretariat staff, he declared the session closed.

The meeting rose at 4.05 p.m.
