Communications Received during the Period 21 October - 3 November 1947

- A. COMMUNICATIONS REQUESTING HEARINGS BEFORE THE AD HOC COMMITTEE. No communications received.
- B. COMMUNICATIONS SUBMITTING MEMORANDA.
 - Letter dated 1 October from Shalom Zamir, Tel-Aviv, enclosing a copy of his memorandum which was previously submitted to the Special Committee on Palestine on 18 June 1947. He asks that this memorandum be brought to the attention of the Ad Hoc Committee.

C. COMMUNICATIONS REQUESTING ACTION OR INTERVENTION BY THE UNITED NATIONS.

- Letter dated 22 October from Mr. Benjamin M. Laikin, President of the Zionist Council of Detroit, calling the attention of the United Nations to the deplorable conditions of Jewish refugees and urging the establishment of a Jewish national home in Palestine as a speedy solution to this problem.
- Letter dated 24 October from Mr. Joseph S. Lerner, National Jewish Welfare Board, Chicago, enclosing a resolution urging the United Nations to accept the majority recommendations of the Special Committee and to implement them forthwith.
- D. OTHER COMMUNICATIONS.
 - Seven letters dated 6 8 October from the Secretaries of various branch offices of the Moslem Brotherhood, Alexandria, protesting, on behalf of their society and of other Arabs, against the partition of Palestine and affirming their intention to resist such a measure.
 - 2. Cable dated 20 October from the Chairman of the Central Committee of the Council of Jewish Displaced Persons, Munich, expressing the hope that United Nations deliberations on the Palestinian problems will result in free immigration of Jewish refugees

- Cable dated 21 October from the President of the Committee for 3. the Arabs, Rio de Janeiro, announcing that the Syrians in Brazil are opposed to the partition of Palestine as being incompatible with the United Nations Charter.
- Cable dated 24 October from the Secretary of the Tribal 4. Conference General, Baghdad, submitting the following resolutions adopted on 22 October by representatives of all the Iraqi tribes, stating: that the Conference (1) regards any danger threatening Palestine as a danger to all Arab countries, (2) finds any attempt to partition Palestine just cause for resistance by the Arabs, (3) regards any solution to the Palestinian problem unsatisfactory to the Arabs as a definite threat to peace and security in the Middle East, (4) suggests that every country supporting partition should be boycotted as a direct enemy of the Arabs and (5) calls for full-scale mobilization of Arab forces in preparation for a Holy War. Twenty-seven miscellaneous cables and letters from individuals, commenting on the Special Committee's report, offering solutions

to the Palestine problem and setting forth viewpoints thereon.
