Introductory note

1. At the request of the Committee on the Exercise of the Inalienable Rights of the Palestinian People, the Secretariat prepared, in 1976, a document containing resolutions and decisions of the United Nations relating to the question of Palestine from 1947 to 1975.
2. In 1980, the Secretariat prepared an addendum for the period 1976-1979, and in 1982 a second addendum for the period 1980-1981.
3. The present document, covering 1982, is intended to bring this chronological compilation up to date. The decisions of the Security Council included are those relating to substantive matters.

37/43. Importance of the universal realization of the right of peoples to self-determination and of the speedy granting of independence to colonial countries and peoples for the effective guarantee and observance of human rights

The General Assembly,

Recalling its resolutions 2649 (XXV) of 30 November 1970, 2955 (XXVII) of 12 December 1972, 3070 (XXVIII) of 30 November 1973, 3246 (XXIX) of 29 November 1974, 3382 (XXX) of 10 November 1975, 33/24 of 29 November 1978, 34/44 of 23 November 1979, 35/35 of 14 November 1980 and 36/9 of 28 October 1981, as well as Security Council resolutions 418 (1977) of 4 November 1977 and 437 (1978) of 10 October 1978,

Recalling also its resolutions 2465 (XXIII) of 20 December 1968, 2548 (XXIV) of 11 December 1969, 2708 (XXV) of 14 December 1970, 3103 (XXVIII) of 12 December 1973 and 3314 (XXIX) of 14 December 1974 concerning the use and recruitment of mercenaries against national liberation movements and sovereign States, as well as Security Council resolutions 496 (1981) of 15 December 1981 and 507 (1982) of 28 May 1982,

Recalling further its relevant resolutions on the question of Palestine, in particular resolutions 3236 (XXIX) and 3237 (XXIX) of 22 November 1974, 36/120 of 10 December 1981 and ES-7/6 of 19 August 1982,

Recalling also its resolutions on the question of Namibia, in particular resolution ES-8/2 of 14 September 1981,

Recalling the resolutions on Namibia adopted by the Council of Ministers of the Organization of African Unity at its thirty-seventh ordinary session, held at Nairobi from 15 to 26 June 1981, particularly resolutions CM/Res.855 (XXXVII) and CM/Res.865 (XXXVII), 1/

Deeply concerned at the continued terrorist acts of aggression committed by the Pretoria régime against independent African States, in particular Angola, Botswana, Mozambique, Seychelles and Zambia,

Deeply angered by the occupation of part of the territory of Angola by the troops of the racist régime of South Africa,

Recalling the Political Declaration adopted by the First Conference of Heads of State and Government of the Organization of African Unity and the League of Arab States, held at Cairo from 7 to 9 March 1977, 2/

Considering that the denial of the inalienable rights of the Palestinian people to self-determination, sovereignty, independence and return to Palestine and the repeated acts of aggression by Israel against the peoples of the region constitute a serious threat to international peace and security,

Deeply shocked and alarmed at the deplorable consequences of the Israeli invasion of Beirut on 3 August 1982, and recalling all the resolutions of the Security Council, in particular resolutions 520 (1982) of 17 September 1982 and 521 (1982) of 19 September 1982,

Reaffirming its faith in the importance of the implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples, contained in General Assembly resolution 1514 (XV) of 14 December 1960,

Reaffirming the importance of the universal realization of the right of peoples to self-determination, national sovereignty and territorial integrity and of the speedy granting of independence to colonial countries and peoples as imperatives for the full enjoyment of all human rights,

Reaffirming that "bantustanization" is incompatible with genuine independence, national unity and sovereignty and has the effect of perpetuating the power of the white minority and the racist system of apartheid in South Africa,

Reaffirming the obligation of all Member States to comply with the principles of the Charter of the United Nations and the resolutions of the United Nations regarding the exercise of the right to self-determination by peoples under colonial and foreign domination,

Reaffirming also that the system of apartheid imposed on the South African people constitutes an inadmissible violation of the rights of that people and a constant threat to international security,

Reaffirming the national unity and territorial integrity of the Comoros,

Gravely concerned at the continuation of the illegal occupation of Namibia by South Africa and the continued violations of the human rights of the peoples still under colonial and foreign domination and alien subjugation,

1. Calls upon all States to implement fully and faithfully the resolutions of the United Nations regarding the exercise of the right to self-determination and independence by peoples under colonial and foreign domination;
2. Reaffirms the legitimacy of the struggle of peoples for independence, territorial integrity, national unity and liberation from colonial and foreign domination and foreign occupation by all available means, including armed struggle;
3. Reaffirms the inalienable right of the Namibian people, the Palestinian people and all peoples under foreign and colonial domination to self-determination, national independence, territorial integrity, national unity and sovereignty without outside interference;
4. Notes again with satisfaction resolution AHG/Res.103 (XVIII) adopted by the Assembly of Heads of State and Government of the Organization of African Unity at its eighteenth ordinary session, held at Nairobi from 24 to 27 June 1981, 3/ and the decisions of its Implementation Committee to organize and conduct a general, free and regular referendum on self-determination in Western Sahara, and welcomes the willingness of the United Nations to collaborate in the implementation of the process envisaged by the Organization of African Unity;

5. Takes note of the contacts between the Government of the Comoros and the Government of France in the search for a just solution to the integration of the Comorian island of Mayotte into the Comoros in accordance with the resolutions of the Organization of African Unity and the United Nations on this question;

6. Condemns the policy of "bantustanization" and reiterates its support for the oppressed people of South Africa in their just and legitimate struggle against the racist minority régime of Pretoria;

7. Further condemns South Africa for its increased oppression of the Namibian people, for the massive militarization of Namibia and for its armed attacks on the front-line States with the aim of destabilizing their Governments;

8. Strongly condemns the establishment and use of armed terrorist groups by South Africa with a view to pitting them against the national liberation movements and destabilizing the legitimate Governments of southern Africa, thus impeding effective implementation of General Assembly resolution 1514 (XV);

9. Strongly reaffirms its solidarity with the independent African countries and liberation movements that are victims of the murderous acts of aggression of the Pretoria régime and of its attempts at destabilization;

10. Strongly condemns once again the invasion and occupation of part of the territory of Angola by troops of the racist Pretoria régime and demands the immediate withdrawal of those troops from Angolan territory;

11. Reaffirms that the practice of using mercenaries against sovereign States and national liberation movements constitutes a criminal act and that the mercenaries themselves are criminals, and calls upon the Governments of all countries to enact legislation declaring the recruitment, financing and training of mercenaries in their territories and the transit of mercenaries through their territories to be punishable offences, and prohibiting their nationals from serving as mercenaries, and to report on such legislation to the Secretary-General;

12. Strongly condemns the continued violations of the human rights of the peoples still under colonial and foreign domination and alien subjugation, the continuation of the illegal occupation of Namibia, and South Africa's attempts to dismember its Territory, the perpetuation of the racist minority régime in southern Africa and the denial to the Palestinian people of their inalienable national rights;

13. Also strongly condemns the policies of those Western and other countries whose political, economic, military, nuclear, strategic, cultural and sports relations with the racist minority régime in South Africa encourage that régime to persist in its suppression of the aspirations of peoples to self-determination and independence;

14. Again demands the immediate application of the mandatory arms embargo against South Africa, imposed under Security Council resolution 418 (1977), by all countries, particularly by those countries that maintain military and nuclear co-operation with the racist Pretoria régime and continue to supply related matériel to that régime;

15. Notes again with satisfaction the Paris Declaration on Sanctions against South Africa, the Special Declaration on Namibia and the reports of the technical and political commissions adopted by the International Conference on Sanctions against South Africa, held in Paris from 20 to 27 May 1981, convened jointly by the United Nations and the Organization of African Unity; 4/

16. Demands the immediate implementation of General Assembly resolution ES-8/2 on Namibia;

17. Calls for a substantial increase in all forms of assistance given by all States, United Nations organs, specialized agencies and non-governmental organizations to the victims of racism, racial discrimination and apartheid through their national liberation movements recognized by the Organization of African Unity;

18. Strongly condemns those Governments that do not recognize the right to self-determination and independence of all peoples still under colonial and foreign domination and alien subjugation, notably the peoples of Africa and the Palestinian people;

19. Strongly condemns the increasingly widespread massacres of innocent and defenceless people, including women and children, by the racist minority Pretoria régime in its desperate attempt to thwart the legitimate demands of the people;

20. Strongly condemns the massacre of Palestinians and other civilians at Beirut on 17 September 1982;

21. Strongly condemns the expansionist activities of Israel in the Middle East and the continual bombing of Palestinian civilians, which constitute a serious obstacle to the realization of the self-determination and independence of the Palestinian people;

22. Strongly condemns the Israeli aggression against Lebanon in June 1982, which endangers stability, peace and security in the region, and reiterates its support for the efforts undertaken to implement the resolutions of the Security Council, in particular those demanding the immediate and unconditional withdrawal of Israeli forces from Lebanese territory to internationally recognized boundaries and respect for the sovereignty and territorial integrity of Lebanon;

23. Urges all States, competent organizations of the United Nations system, specialized agencies and other international organizations to extend their support to the Palestinian people through its sole and legitimate representative, the Palestine Liberation Organization, in its struggle to regain its right to self-determination and independence in accordance with the Charter of the United Nations;

24. Demands the immediate and unconditional release of all persons detained or imprisoned as a result of their struggle for self-determination and independence, full respect for their fundamental individual rights and the observance of article 5 of the Universal Declaration of Human Rights, 5/ under which no one shall be subjected to torture or to cruel, inhuman or degrading treatment;

25. Recommends that the Security Council should make urgent appeals for clemency to the South African authorities in order that the lives of the three African National Congress freedom fighters sentenced to death on 6 August 1982 may be saved in accordance with General Assembly resolution 37/1 of 1 October 1982;

26. Demands the immediate release of children detained in Namibian and South African prisons;

27. Reiterates its appreciation for the material and other forms of assistance that peoples under colonial rule continue to receive from Governments, United Nations agencies and intergovernmental organizations, and calls for a substantial increase in this assistance;

28. Urges all States, specialized agencies and competent organizations of the United Nations system to do their utmost to ensure the full implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples and to intensify their efforts to support peoples under colonial, foreign and racist domination in their just struggle for self-determination and independence;

29. Requests the Secretary-General to give maximum publicity to the Declaration on the Granting of Independence to Colonial Countries and Peoples and to give the widest possible publicity to the struggle being waged by oppressed peoples for the realization of their self-determination and national independence;

30. Decides to consider this item again at its thirty-eighth session on the basis of the reports that Governments, United Nations agencies and intergovernmental and non-governmental organizations have been requested to submit concerning the strengthening of assistance to colonial territories and peoples.

37/75. Establishment of a nuclear-weapon-free zone in the region of the Middle East

The General Assembly,

Recalling its resolutions 3263 (XXIX) of 9 December 1974, 3474 (XXX) of 11 December 1975, 31/71 of 10 December 1976, 32/82 of 12 December 1977, 33/64 of 14 December 1978, 34/77 of 11 December 1979, 35/147 of 12 December 1980 and 36/87 of 9 December 1981 on the establishment of a nuclear-weapon-free zone in the region of the Middle East,

Recalling also the recommendations for the establishment of such a zone in the Middle East consistent with paragraphs 60 to 63, in particular paragraph 63 (d), of the Final Document of the Tenth Special Session of the General Assembly, 1/

Emphasizing the basic provisions of the above resolutions, which call upon all parties directly concerned to consider taking the practical and urgent steps required for the implementation of the proposal to establish a nuclear-weapon-free zone in the region of the Middle East and, pending and during the establishment of such a zone, to declare solemnly that they will refrain, on a reciprocal basis, from producing, acquiring or in any other way possessing nuclear weapons and nuclear explosive devices and from permitting the stationing of nuclear weapons on their territory by any third party, to agree to place all their nuclear facilities under International Atomic Energy Agency safeguards and to declare their support for the establishment of the zone and deposit such declarations with the Security Council for consideration, as appropriate,

Reaffirming the inalienable right of all States to acquire and develop nuclear energy for peaceful purposes,

Emphasizing further the need for appropriate measures on the question of the prohibition of military attacks on nuclear facilities,

Bearing in mind the consensus reached by the General Assembly at its thirty-fifth session that the establishment of a nuclear-weapon-free zone in the region of the Middle East would greatly enhance international peace and security,

Desirous to build on that consensus so that substantial progress can be made towards establishing a nuclear-weapon-free zone in the region of the Middle East,

1. Urges all parties directly concerned to consider seriously taking the practical and urgent steps required for the implementation of the proposal to establish a nuclear-weapon-free zone in the region of the Middle East in accordance with the relevant resolutions of the General Assembly and, as a means of promoting this objective, invites the countries concerned to adhere to the Treaty on the Non-Proliferation of Nuclear Weapons; 2/

2. Calls upon all countries of the region that have not done so, pending the establishment of the zone, to agree to place all their nuclear activities under International Atomic Energy Agency safeguards;

3. Invites those countries, pending the establishment of a nuclear-weapon-free zone in the region of the Middle East, to declare their support for establishing such a zone, consistent with the relevant paragraph of the Final Document of the Tenth Special Session of the General Assembly, and to deposit those declarations with the Security Council;

4. Invites further those countries, pending the establishment of the zone, not to develop, produce, test or otherwise acquire nuclear weapons or permit the stationing on their territories, or territories under their control, of nuclear weapons or nuclear explosive devices;

5. Invites the nuclear-weapon States and all other States to render their assistance in the establishment of the zone and at the same time to refrain from any action that runs counter to both the letter and spirit of the present resolution;

6. Requests the Secretary-General to submit a report to the General Assembly at its thirty-eighth session on the implementation of the present resolution;

7. Decides to include in the provisional agenda of its thirty-eighth session the item entitled "Establishment of a nuclear-weapon-free zone in the region of the Middle East".

The General Assembly,

Recalling its resolutions 3376 (XXX) of 10 November 1975, 31/20 of 24 November 1976, 32/40 of 2 December 1977, 33/28 of 7 December 1978, 34/65 of 29 November and 12 December 1979, ES-7/2 of 29 July 1980, 35/169 of 15 December 1980, 36/120 of 10 December 1981, ES-7/4 of 28 April 1982, ES-7/5 of 26 June 1982 and ES-7/9 of 24 September 1982,

Having considered the report of the Committee on the Exercise of the Inalienable Rights of the Palestinian People, 1/

1. Expresses its appreciation to the Committee on the Exercise of the Inalienable Rights of the Palestinian People for its efforts in performing the tasks assigned to it by the General Assembly;

2. Endorses the recommendations of the Committee contained in paragraphs 114 to 119 of its report and draws the attention of the Security Council to the fact that action on the Committee's recommendations, as endorsed by the General Assembly in its resolution 31/20, is long overdue;

3. Requests the Committee to keep the situation relating to the question of Palestine under review and to report and make suggestions to the General Assembly or the Security Council, as appropriate;

4. Authorizes the Committee to continue to exert all efforts to promote the implementation of its recommendations, to send delegations or representatives to international conferences where such representation would be considered by it to be appropriate, and to report thereon to the General Assembly at its thirty-eighth session and thereafter;

5. Requests the United Nations Conciliation Commission for Palestine, established under General Assembly resolution 194 (III) of 11 December 1948, as well as other United Nations bodies associated with the question of Palestine, to co-operate fully with the Committee and to make available to it, at its request, the relevant information and documentation which they have at their disposal;

6. Decides to circulate the report of the Committee to all the competent bodies of the United Nations and urges them to take the necessary action, as appropriate, in accordance with the Committee's programme of implementation;

7. Requests the Secretary-General to continue to provide the Committee with all the necessary facilities for the performance of its tasks.

Having considered the report of the Committee on the Exercise of the Inalienable Rights of the Palestinian People, 1/

Noting, in particular, the information contained in paragraphs 103 to 111 of that report,

Recalling its resolutions 32/40 B of 2 December 1977, 33/28 C of 7 December 1978, 34/65 D of 12 December 1979, 35/169 D of 15 December 1980 and 36/120 B of 10 December 1981,

1. Notes with appreciation the action taken by the Secretary-General in compliance with General Assembly resolution 36/120 B;

2. Requests the Secretary-General to ensure that the Division for Palestinian Rights of the Secretariat continues to discharge the tasks detailed in paragraph 1 of General Assembly resolution 32/40 B, paragraph 2 (b) of Assembly resolution 34/65 D and paragraph 3 of resolution 36/120 B, in consultation with the Committee on the Exercise of the Inalienable Rights of the Palestinian People and under its guidance;

3. Also requests the Secretary-General to provide the Division for Palestinian Rights with the necessary resources to carry out its tasks, as urged in paragraph 109 of the Committee's report;

4. Further requests the Secretary-General to ensure the continued co-operation of the Department of Public Information and other units of the Secretariat in enabling the Division for Palestinian Rights to perform its tasks and in covering adequately the various aspects of the question of Palestine;

5. Invites all Governments and organizations to lend their co-operation to the Committee and the Division for Palestinian Rights in the performance of their tasks;

6. Notes with appreciation the action taken by Member States to observe annually on 29 November the International Day of Solidarity with the Palestinian People and the issuance by them of special postage stamps for the occasion.

The General Assembly,

Recalling its resolutions 3236 (XXIX) and 3237 (XXIX) of 22 November 1974 and all other United Nations resolutions, including resolution ES-7/2 of 29 July 1980, pertinent to the question of Palestine,

Recalling also its resolutions 36/120 C of 10 December 1981, in which it decided to convene an International Conference on the Question of Palestine for a comprehensive effort to seek effective ways and means to enable the Palestinian people to attain and to exercise their rights, and ES-7/7 of 19 August 1982, in which it decided to convene the Conference at the headquarters of the United Nations Educational, Scientific and Cultural Organization, in Paris, from 16 to 27 August 1983,

Convinced that a comprehensive, just and lasting peace in the Middle East can be established, in accordance with the Charter of the United Nations and the relevant resolutions of the Organization, through a just solution to the problem of Palestine on the basis of the attainment of the legitimate rights of the Palestinian people,

Convinced that the Conference will provide a unique opportunity to heighten awareness of the underlying causes of the question of Palestine and to contribute actively and constructively to a solution of the question on the basis of relevant United Nations resolutions,

Stressing the need to assure the participation of all Member States in the Conference and their support for its preparations,

Taking note with appreciation of the report of the Preparatory Committee for the International Conference on the Question of Palestine, 2/

1. Reiterates the responsibility of the United Nations to strive for a lasting peace in the Middle East through a just solution of the problem of Palestine;

2. Endorses the recommendations of the Preparatory Committee for the International Conference on the Question of Palestine contained in paragraph 32 of its report 2/ concerning the preparatory activities for the Conference, the objectives of the Conference, the documentation, the draft provisional agenda, the draft provisional rules of procedure, participation in the Conference and the organization of work;

3. Calls upon all organizations of the United Nations system to continue to extend their fullest support to the Conference and to its preparation;

4. Urges all Member States to promote heightened awareness of the importance of the Conference and to intensify preparations at the national, subregional and regional levels in order to ensure its success;

5. Calls upon all Member States to contribute to the achievement of Palestinian rights and to support modalities for their implementation, and to participate in the Conference and the regional preparatory meetings preceding it;

6. Decides to consider the results of the Conference at its thirty-eighth session.

1. Takes note of the declaration of the Palestine Liberation Organization of 19 April 1981 of its intention to pursue its role in the solution of the question of Palestine on the basis of the attainment in Palestine of the inalienable rights of the Palestinian people in accordance with the relevant resolutions of the United Nations;
2. Reaffirms the principle of the inadmissibility of the acquisition of territory by force;

Reaffirms once again that a comprehensive, just and lasting peace in the Middle East cannot be established without the unconditional withdrawal of Israel from the Palestinian and the other Arab territories occupied since 1967, including Jerusalem, and without the exercise and attainment by the Palestinian people of its inalienable rights in Palestine in accordance with the principles of the Charter and the relevant resolutions of the United Nations;
4. Requests the Security Council to discharge its responsibilities under the Charter and recognize the inalienable rights of the Palestinian Arab people, including the right to self-determination and the right to establish its independent Arab State in Palestine;
5. Reiterates its request that the Security Council take the necessary measures, in execution of the relevant United Nations resolutions, to implement the plan which, inter alia, recommends that an independent Arab State shall come into existence in Palestine;
6. Requests the Secretary-General to report on the progress made in implementing the present resolution as soon as possible.

Recalling, in particular, the principles relevant to the question of Palestine that have been accepted by the international community, including the right of all States in the region to existence within internationally recognized boundaries, and justice and security for all the peoples, which requires recognition and attainment of the legitimate rights of the Palestinian people,

Recognizing the necessity of participation by all parties concerned in any efforts aimed at the attainment of a just and lasting solution,

1. Reaffirms the inalienable legitimate rights of the Palestinian people, including the right to self-determination and the right to establish, once it so wishes, its independent State in Palestine;

2. Declares all Israeli policies and practices of, or aimed at, annexation of the occupied Palestinian and other Arab territories, including Jerusalem, to be in violation of international law and of the relevant United Nations resolutions;

3. Demands, in conformity with the fundamental principles of the inadmissibility of the acquisition of territory by force, that Israel should withdraw completely and unconditionally from all the Palestinian and other Arab territories occupied since June 1967, including Jerusalem, with all property and services intact;

4. Urges the Security Council to facilitate the process of Israeli withdrawal;

5. Recommends that, following the withdrawal of Israel from the occupied Palestinian territories, those territories should be subjected to a short transitional period under the supervision of the United Nations, during which period the Palestinian people would exercise its right to self-determination;

6. Urgently calls for the achievement of a comprehensive, just and lasting peace, based on the resolutions of the United Nations and under its auspices, in which all parties concerned, including the Palestine Liberation Organization, the representative of the Palestinian people, participate on an equal footing;

7. Recommends that the Security Council should take early action to promote a just and comprehensive solution to the question of Palestine;

8. Requests the Secretary-General to report to the General Assembly at its thirty-eighth session on the progress made in implementing the present resolution.

1. Reaffirms that the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, is applicable to Palestinian and other Arab territories occupied by Israel since 1967, including Jerusalem;
2. Condemns once again the failure of Israel as the occupying Power to acknowledge the applicability of that Convention to the territories it has occupied since 1967, including Jerusalem;
3. Strongly demands that Israel acknowledge and comply with the provisions of that Convention in Palestinian and other Arab territories it has occupied since 1967, including Jerusalem;
4. Urgently calls upon all States parties to that Convention to exert all efforts in order to ensure respect for and compliance with its provisions in Palestinian and other Arab territories occupied by Israel since 1967, including Jerusalem.

4. Demands once more that the Government of Israel, the occupying Power, desist forthwith from taking any action which would result in changing the legal status, geographical nature or demographic composition of the Palestinian and other Arab territories occupied since 1967, including Jerusalem;

1. Commends the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Population of the Occupied Territories for its efforts in performing the tasks assigned to it by the General Assembly and for its thoroughness and impartiality;
2. Deplores the continued refusal by Israel to allow the Special Committee access to the occupied territories;
3. Demands that Israel allow the Special Committee access to the occupied territories;
4. Reaffirms the fact that occupation itself constitutes a grave violation of the human rights of the civilian population of the occupied Arab territories;
5. Condemns the continued and persistent violation by Israel of the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, and other applicable international instruments, and condemns in particular those violations which that Convention designates as "grave breaches" thereof;
6. Declares once more that Israel's grave breaches of that Convention are war crimes and an affront to humanity;
7. Strongly condemns the following Israeli policies and practices:
 - (a) Annexation of parts of the occupied territories, including Jerusalem;
 - (b) Imposition of Israeli laws, jurisdiction and administration on the Syrian Golan Heights, which has resulted in the effective annexation of the Syrian Golan Heights;

(c) Establishment of new Israeli settlements and expansion of the existing settlements on private and public Arab lands, and transfer of an alien population thereto;

(d) Evacuation, deportation, expulsion, displacement and transfer of Arab inhabitants of the occupied territories and denial of their right to return;

(e) Confiscation and expropriation of private and public Arab property in the occupied territories and all other transactions for the acquisition of land involving the Israeli authorities, institutions or nationals on the one hand and the inhabitants or institutions of the occupied territories on the other;

(f) Excavations and transformations of the landscape and the historical, cultural and religious sites, especially at Jerusalem;

(g) Destruction and demolition of Arab houses;

(h) Collective punishment, mass arrests, administrative detention and ill-treatment of the Arab population;

(i) Ill-treatment and torture of persons under detention;

(j) Pillaging of archaeological and cultural property;

(k) Interference with religious freedoms and practices as well as family rights and customs;

(l) Interference with the system of education and with the social and economic development of the population in the occupied Palestinian and other Arab territories;

(m) Interference with the freedom of movement of individuals within the occupied Palestinian and other Arab territories;

(n) Illegal exploitation of the natural wealth, resources and population of the occupied territories;

8. Reaffirms that all measures taken by Israel to change the physical character, demographic composition, institutional structure or status of the occupied territories, or any part thereof, including Jerusalem, are null and void, and that Israel's policy of settling parts of its population and new immigrants in the occupied territories constitutes a flagrant violation of the Geneva Convention and of the relevant resolutions of the United Nations;

9. Demands that Israel desist forthwith from the policies and practices referred to in paragraphs 7 and 8 above;

10. Urges the international organizations and the specialized agencies, in particular the International Labour Organisation, to examine the conditions of Arab workers in the occupied Palestinian and other Arab territories, including Jerusalem;

11. Reiterates its call upon all States, in particular those States parties to the Geneva Convention, in accordance with article 1 of that Convention, and upon international organizations and the specialized agencies not to recognize any changes carried out by Israel in the occupied territories and to avoid actions, including those in the field of aid, which might be used by Israel in its pursuit of the policies of annexation and colonization or any of the other policies and practices referred to in the present resolution;

12. Requests the Special Committee, pending the early termination of Israeli occupation, to continue to investigate Israeli policies and practices in the Arab territories occupied by Israel since 1967, to consult, as appropriate, with the International Committee of the Red Cross in order to ensure the safeguarding of the welfare and human rights of the population of the occupied territories and to report to the Secretary-General as soon as possible and whenever the need arises thereafter;

13. Requests the Special Committee to continue to investigate the treatment of civilians in detention in the Arab territories occupied by Israel since 1967;

14. Condemns Israel's refusal to permit persons from the occupied territories to appear as witnesses before the Special Committee;

15. Requests the Secretary-General:

(a) To provide all necessary facilities to the Special Committee, including those required for its visits to the occupied territories, with a view to investigating the Israeli policies and practices referred to in the present resolution;

(b) To continue to make available additional staff as may be necessary to assist the Special Committee in the performance of its tasks;

Cognizant of the fact that the Palestine refugees have, for the last three decades, lost their lands and means of livelihood,

Having examined with appreciation the report of the Secretary-General 6/ on offers of grants and scholarships for higher education for Palestine refugees and on the scope of the implementation of resolution 36/146 H,

Having also examined the report of the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, covering the period from 1 July 1981 to 30 June 1982, 3/ dealing with this subject,

Noting that fewer than one per thousand of the Palestine refugee students have the chance to continue higher education, including vocational training,

Noting also that over the past several years the number of scholarships offered by the United Nations Relief and Works Agency for Palestine Refugees in the Near East has dwindled to half of what it was because of the Agency's recurring budgetary difficulties,

1. Urges all States to respond to the appeal contained in General Assembly resolution 32/90 F of 13 December 1977 in a manner commensurate with the needs of Palestine refugees for higher education and vocational training;

2. Strongly appeals to all States, specialized agencies and non-governmental organizations to augment the special allocations for grants and scholarships to Palestine refugees in addition to their contributions to the regular budget of the United Nations Relief and Works Agency for Palestine Refugees in the Near East;

3. Expresses its appreciation to all Governments, specialized agencies and non-governmental organizations that responded favourably to General Assembly resolution 36/146 H;

4. Invites the relevant United Nations agencies to continue to expand the inclusion, within their respective spheres of competence, of assistance for higher education for Palestine refugee students;

5. Appeals to all States, specialized agencies and the United Nations University to contribute generously to the Palestinian universities in the territories occupied by Israel since 1967;

6. Also appeals to all States, specialized agencies and other international bodies to contribute towards the establishment of vocational training centres for Palestine refugees;

7. Requests the United Nations Relief and Works Agency for Palestine Refugees in the Near East to act as recipient and trustee for such special allocations and scholarships and to award them to qualified Palestine refugee candidates;

8. Requests the Secretary-General to report to the General Assembly at its thirty-eighth session on the implementation of the present resolution.

Having considered the report of the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, covering the period from 1 July 1981 to 30 June 1982, 3/ and his special report covering the period from 6 June to 31 August 1982, 4/

Referring to the humanitarian principles of the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, 13/ and to the obligations arising from the regulations annexed to the Hague Convention of 1907,

Deeply distressed at the sufferings of the Palestinians resulting from the Israeli invasion of Lebanon,

1. Urges the Secretary-General, in consultation with the United Nations Relief and Works Agency for Palestine Refugees in the Near East, and pending the withdrawal of Israeli forces from the Palestinian and other Arab territories occupied by Israel since 1967, including Jerusalem, to undertake effective measures to guarantee the safety and security and the legal and human rights of the Palestinian refugees in the occupied territories;
2. Calls upon Israel, the occupying Power, to release forthwith all detained Palestine refugees, including the employees of the United Nations Relief and Works Agency for Palestine Refugees in the Near East;
3. Also calls upon Israel to desist forthwith from preventing those Palestinians registered by the United Nations Relief and Works Agency for Palestine Refugees in the Near East as refugees in Lebanon from returning to their camps in Lebanon;
4. Further calls upon Israel to allow the resumption of health, medical, educational and social services rendered by the United Nations Relief and Works Agency for Palestine Refugees in the Near East to the Palestinians in the refugee camps in southern Lebanon;

Recalling its resolution 36/146 F of 16 December 1981 and all previous resolutions on the question, including resolution 194 (III) of 11 December 1948,

Taking note of the report of the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, covering the period from 1 July 1981 to 30 June 1982, 3/

1. Notes with regret that repatriation or compensation of the refugees as provided for in paragraph 11 of General Assembly resolution 194 (III) has not been effected, that no substantial progress has been made in the programme endorsed by the Assembly in paragraph 2 of its resolution 513 (VI) of 26 January 1952 for the reintegration of refugees either by repatriation or resettlement and that, therefore, the situation of the refugees continues to be a matter of serious concern;
2. Expresses its thanks to the Commissioner-General and to all the staff of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, recognizing that the Agency is doing all it can within the limits of available resources, and also expresses its thanks to the specialized agencies and private organizations for their valuable work in assisting the refugees;
3. Reiterates its request that the headquarters of the United Nations Relief and Works Agency for Palestine Refugees in the Near East should be relocated to its former site within its area of operations as soon as practicable;
4. Notes with regret that the United Nations Conciliation Commission for Palestine has been unable to find a means of achieving progress in the implementation of paragraph 11 of General Assembly resolution 194 (III) and requests the Commission to exert continued efforts towards the implementation of that paragraph and to report to the Assembly as appropriate, but not later than 1 October 1983;
5. Directs attention to the continuing seriousness of the financial position of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, as outlined in the report of the Commissioner-General;
6. Notes with concern that, despite the commendable and successful efforts of the Commissioner-General to collect additional contributions, this increased level of income to the United Nations Relief and Works Agency for Palestine Refugees in the Near East is still insufficient to cover essential budget requirements in the present year and that, at currently foreseen levels of giving, deficits will recur each year;

Taking note of the reports of the Secretary-General, 1/

Recalling Security Council resolution 497 (1981) of 17 December 1981,

Reaffirming its resolutions 36/226 B of 17 December 1981 and ES-9/1 of 5 February 1982,

Recalling its resolution 3314 (XXIX) of 14 December 1974, in which it defined an act of aggression, inter alia, as "the invasion or attack by the armed forces of a State of the territory of another State, or any military occupation, however temporary, resulting from such invasion or attack, or any annexation by the use of force of the territory of another State or part thereof" and provided that "no consideration of whatever nature, whether political, economic, military or otherwise, may serve as a justification for aggression",

Reaffirming the fundamental principle of the inadmissibility of the acquisition of territory by force,

Reaffirming once more the applicability of the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, 2/ to the occupied Palestinian and other Arab territories, including Jerusalem,

Noting that Israel's record and actions establish conclusively that it is not a peace-loving Member State and that it has not carried out its obligations under the Charter of the United Nations,

Noting further that Israel has refused, in violation of Article 25 of the Charter, to accept and carry out the numerous relevant decisions of the Security Council, the latest of which was resolution 497 (1981), thus failing to carry out its obligations under the Charter,

1. Strongly condemns Israel for its failure to comply with Security Council resolution 497 (1981) and General Assembly resolutions 36/226 B and ES-9/1;

2. Declares once more that Israel's decision of 14 December 1981 to impose its laws, jurisdiction and administration on the occupied Syrian Golan Heights constitutes an act of aggression under the provisions of Article 39 of the Charter of the United Nations and General Assembly resolution 3314 (XXIX);

3. Declares once more that Israel's decision to impose its laws, jurisdiction and administration on the occupied Syrian Golan Heights is null and void and has no legal validity and/or effect whatsoever;

4. Declares all Israeli policies and practices of, or aimed at, annexation of the occupied Palestinian and other Arab territories, including Jerusalem, to be in violation of international law and of the relevant United Nations resolutions;

5. Determines once more that all actions taken by Israel to give effect to its decision relating to the occupied Syrian Golan Heights are illegal and invalid and shall not be recognized;

6. Reaffirms its determination that all the provisions of the Hague Convention of 1907 3/ and the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, continue to apply to the Syrian territory occupied by Israel since 1967, and calls upon the parties thereto to respect and ensure respect of their obligations under these instruments in all circumstances;

7. Determines once more that the continued occupation of the Syrian Golan Heights since 1967 and their effective annexation by Israel on 14 December 1981, following Israel's decision to impose its laws, jurisdiction and administration on that territory, constitute a continuing threat to international peace and security;

8. Strongly deplores the negative vote by a permanent member of the Security Council which prevented the Council from adopting against Israel, under Chapter VII of the Charter, the "appropriate measures" referred to in resolution 497 (1981) unanimously adopted by the Council;

9. Further deplores any political, economic, financial, military and technological support to Israel that encourages Israel to commit acts of aggression and to consolidate and perpetuate its occupation and annexation of occupied Arab territories;

10. Firmly emphasizes once more its demands that Israel, the occupying Power, rescind forthwith its decision of 14 December 1981 to impose its laws, jurisdiction and administration on the Syrian Golan Heights, which has resulted in the effective annexation of that territory;

11. Reaffirms once more the overriding necessity of the total and unconditional withdrawal by Israel from all the Palestinian and other Arab territories occupied since 1967, including Jerusalem, which is an essential prerequisite for the establishment of a comprehensive and just peace in the Middle East;

12. Determines once more that Israel's record and actions confirm that it is not a peace-loving Member State, that it has persistently violated the principles contained in the Charter and that it has carried out neither its obligations under the Charter nor its commitment under General Assembly resolution 273 (III) of 11 May 1949;

13. Calls once more upon all Member States to apply the following measures:

- (a) To refrain from supplying Israel with any weapons and related equipment and to suspend any military assistance that Israel receives from them;
- (b) To refrain from acquiring any weapons or military equipment from Israel;
- (c) To suspend economic, financial and technological assistance to and co-operation with Israel;
- (d) To sever diplomatic, trade and cultural relations with Israel;

14. Reiterates its call to all Member States to cease forthwith, individually and collectively, all dealings with Israel in order totally to isolate it in all fields;

15. Urges non-member States to act in accordance with the provisions of the present resolution;

16. Calls upon the specialized agencies and other international organizations to conform their relations with Israel to the terms of the present resolution.

Recalling the relevant provisions of the Universal Declaration of Human Rights, 4/

Recalling also the Constitution of the United Nations Educational, Scientific and Cultural Organization 5/ and all other relevant international instruments concerning the right to cultural identity in all its forms,

1. Condemns those acts of plundering the Palestinian cultural heritage;
2. Calls upon the Government of Israel to make full restitution through the United Nations Educational, Scientific and Cultural Organization, of all the cultural property belonging to Palestinian institutions, including the archives and documents removed from the Palestine Research Centre and arbitrarily seized by the Israeli forces.

Welcoming the world-wide support extended to the just cause of the Palestinian people and the other Arab countries in their struggle against Israeli aggression and occupation in order to achieve a comprehensive, just and lasting peace in the Middle East and the full exercise by the Palestinian people of its inalienable national rights, as affirmed by previous resolutions of the General Assembly relating to the question of Palestine and the situation in the Middle East,

Gravely concerned that the Arab and Palestinian territories occupied since 1967, including Jerusalem, still remain under Israeli occupation, that the relevant resolutions of the United Nations have not been implemented and that the Palestinian people is still denied the restoration of its land and the exercise of its inalienable national rights in conformity with international law, as reaffirmed by resolutions of the United Nations,

Reaffirming the applicability of the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, 2/ to all the occupied Palestinian and other Arab territories, including Jerusalem,

Reiterating all relevant United Nations resolutions which emphasize that the acquisition of territory by force is inadmissible under the Charter of the United Nations and the principles of international law and that Israel must withdraw unconditionally from all the Palestinian and other Arab territories occupied by Israel since 1967, including Jerusalem,

Reaffirming further the imperative necessity of establishing a comprehensive, just and lasting peace in the region, based on full respect for the Charter and the principles of international law,

Gravely concerned also at recent Israeli actions involving the escalation and expansion of the conflict in the region, which further violate the principles of international law and endanger international peace and security,

Welcoming the Arab peace plan adopted unanimously at the Twelfth Arab Summit Conference, held at Fez, Morocco, on 25 November 1981 and 9 September 1982, 9/

Bearing in mind the address made, on 26 October 1982, by His Majesty King Hassan II of Morocco, in his capacity as President of the Twelfth Arab Summit Conference, 10/

1. Condemns Israel's continued occupation of the Palestinian and other Arab territories, including Jerusalem, in violation of the Charter of the United Nations, the principles of international law and the relevant resolutions of the United Nations, and demands the immediate, unconditional and total withdrawal of Israel from all these occupied territories;

2. Reaffirms its conviction that the question of Palestine is the core of the conflict in the Middle East and that no comprehensive, just and lasting peace in the region will be achieved without the full exercise by the Palestinian people of its inalienable national rights and the immediate, unconditional and total withdrawal of Israel from all the Palestinian and other occupied Arab territories;

3. Reaffirms further that a just and comprehensive settlement of the situation in the Middle East cannot be achieved without the participation on an equal footing of all the parties to the conflict, including the Palestine Liberation Organization, the representative of the Palestinian people;

4. Declares once more that peace in the Middle East is indivisible and must be based on a comprehensive, just and lasting solution of the Middle East problem, under the auspices of the United Nations, which ensures the complete and unconditional withdrawal of Israel from the Palestinian and other Arab territories occupied since 1967, including Jerusalem, and which enables the Palestinian people, under the leadership of the Palestine Liberation Organization, to exercise its inalienable rights, including the right to return and the right to self-determination, national independence and the establishment of its independent sovereign State in Palestine, in accordance with the resolutions of the United Nations relevant to the question of Palestine, in particular General Assembly resolutions ES-7/2 of 29 July 1980, 36/120 A to F of 10 December 1981, 37/86 A to D of 10 December 1982 and 37/86 E of 20 December 1982;

5. Rejects all agreements and arrangements in so far as they violate the recognized rights of the Palestinian people and contradict the principles of just and comprehensive solutions to the Middle East problem to ensure the establishment of a just peace in the area;

6. Deplores Israel's failure to comply with Security Council resolutions 476 (1980) of 30 June 1980 and 478 (1980) of 20 August 1980 and General Assembly resolutions 35/207 of 16 December 1980 and 36/226 A and B of 17 December 1981, determines that Israel's decision to annex Jerusalem and to declare it as its "capital", as well as the measures to alter its physical character, demographic composition, institutional structure and status, are null and void and demands that they be rescinded immediately, and calls upon all Member States, the specialized agencies and all other international organizations to abide by the present resolution and all other relevant resolutions, including Assembly resolutions 37/86 A to E;

7. Condemns Israel's aggression and practices against the Palestinian people in the occupied Palestinian territories and outside these territories, particularly Palestinians in Lebanon, including the expropriation and annexation of territory, the establishment of settlements, assassination attempts and other terrorist, aggressive and repressive measures, which are in violation of the Charter and the principles of international law and the relevant international conventions.

8. Strongly condemns the imposition by Israel of its laws, jurisdiction and administration on the occupied Syrian Golan Heights, its annexationist policies and practices, the establishment of settlements, the confiscation of lands, the diversion of water resources and the imposition of Israeli citizenship on Syrian

nationals, and declares that all these measures are null and void and constitute a violation of the rules and principles of international law relevant to belligerent occupation, in particular the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949;

9. Considers that the agreements on strategic co-operation between the United States of America and Israel signed on 30 November 1981 would encourage Israel to pursue its aggressive and expansionist policies and practices in the Palestinian and other Arab territories occupied since 1967, including Jerusalem, would have adverse effects on efforts for the establishment of a comprehensive, just and lasting peace in the Middle East and would threaten the security of the region;

10. Calls upon all States to put an end to the flow to Israel of any military, economic and financial aid, as well as of human resources, aimed at encouraging it to pursue its aggressive policies against the Arab countries and the Palestinian people;

11. Requests the Secretary-General to report to the Security Council periodically on the development of the situation and to submit to the General Assembly at its thirty-eighth session a comprehensive report covering the developments in the Middle East in all their aspects.

The General Assembly,

Recalling its resolution ES-7/5 of 26 June 1982,

Recalling also Security Council resolution 512 (1982) of 19 June 1982,

Expressing its deep alarm at the Israeli invasion of Lebanon, which claimed the lives of a very large number of civilian Palestinians,

Horried by the Sabra and Shatila massacre,

Noting with deep concern the dire need of the Palestinian victims of the Israeli invasion for urgent humanitarian assistance,

Noting the need to provide economic and social assistance to the Palestinian people,

1. Condemns Israel for its invasion of Lebanon, which inflicted severe damage on civilian Palestinians, including heavy losses of human lives, intolerable sufferings and massive material destruction;
2. Endorses Economic and Social Council resolution 1982/48;
3. Calls upon Governments and relevant United Nations bodies to provide humanitarian assistance to the Palestinian victims of the Israeli invasion of Lebanon;
4. Requests the relevant programmes, organizations, agencies and organs of the United Nations system to intensify their efforts, in co-operation with the Palestine Liberation Organization, to provide economic and social assistance to the Palestinian people;
5. Also requests that United Nations assistance to the Palestinians in the Arab host countries should be rendered in co-operation with the Palestine Liberation Organization and with the consent of the Arab host Government concerned;
6. Requests the Secretary-General to report to the General Assembly at its thirty-eighth session, through the Economic and Social Council, on the progress made in the implementation of the present resolution.

37/135. Permanent sovereignty over national resources in the occupied Palestinian and other Arab territories

The General Assembly,

Recalling its resolutions 3175 (XXVIII) of 17 December 1973, 3336 (XXIX) of 17 December 1974, 3516 (XXX) of 15 December 1975, 31/186 of 21 December 1976, 32/161 of 19 December 1977, 34/136 of 14 December 1979, 35/110 of 5 December 1980 and 36/173 of 17 December 1981 on permanent sovereignty over national resources in the occupied Palestinian and other Arab territories,

Recalling also its previous resolutions on permanent sovereignty over natural resources, particularly their provisions supporting resolutely the efforts of the developing countries and the peoples of territories under colonial and racial domination and foreign occupation in their struggle to regain effective control over their natural and all other resources, wealth and economic activities,

Bearing in mind the relevant principles of international law and the provisions of the international conventions and regulations, in particular Convention IV of the Hague of 1907, 1/ and the fourth Geneva Convention of 12 August 1949, 2/ concerning the obligations and responsibilities of the occupying Power,

Bearing in mind also the pertinent provisions of its resolutions 3201 (S-VI) and 3202 (S-VI) of 1 May 1974, containing the Declaration and the Programme of Action on the Establishment of a New International Economic Order, and 3281 (XXIX) of 12 December 1974, containing the Charter of Economic Rights and Duties of States,

Regretting that the report of the Secretary-General on permanent sovereignty over national resources in the occupied Palestinian and other Arab territories, requested in General Assembly resolution 36/173, was not submitted,

1. Condemns Israel for its exploitation of the national resources of the occupied Palestinian and other Arab territories;
2. Emphasizes the right of the Palestinian and other Arab peoples whose territories are under Israeli occupation to full and effective permanent sovereignty and control over their natural and all other resources, wealth and economic activities;
3. Reaffirms that all measures undertaken by Israel to exploit the human, natural and all other resources, wealth and economic activities in the occupied Palestinian and other Arab territories are illegal and calls upon Israel to desist immediately from such measures;
4. Further reaffirms the right of the Palestinian and other Arab peoples subjected to Israeli aggression and occupation to the restitution of, and full compensation for the exploitation, depletion and loss of and damages to, their natural, human and all other resources, wealth and economic activities, and calls upon Israel to meet their just claims;

5. Calls upon all States to support the Palestinian and other Arab peoples in the exercise of their above-mentioned rights;

6. Calls upon all States, international organizations, specialized agencies, business corporations and all other institutions not to recognize, or co-operate with or assist in any manner in, any measures undertaken by Israel to exploit the national resources of the occupied Palestinian and other Arab territories or to effect any changes in the demographic composition, the character and form of use of their natural resources or the institutional structure of those territories;

7. Requests the Secretary-General to prepare and submit to the General Assembly at its thirty-eighth session, through the Economic and Social Council, the two reports requested in Assembly resolution 36/173.

1. Takes note of the report of the Secretary-General on the living conditions of the Palestinian people in the occupied Palestinian territories; 4/
2. Takes note of the statement made by the observer of the Palestine Liberation Organization; 5/
3. Expresses its alarm at the deterioration in the living conditions of the Palestinian people in the Palestinian territories occupied since 1967 as a result of the Israeli occupation;
4. Affirms that the Israeli occupation is contradictory to the basic requirements for the social and economic development of the Palestinian people in the occupied West Bank and the Gaza Strip;
5. Affirms also that the exercise by the Palestinian people of their right to self-determination is a prerequisite for their social and economic development in the Palestinian territories occupied since 1967;
6. Calls upon the Israeli occupation authorities to give United Nations bodies and experts access to the Palestinian territories occupied since 1967;

8. Requests the Secretary-General to prepare and submit to the General Assembly at its thirty-eighth session, through the Economic and Social Council, a comprehensive report on the living conditions of the Palestinian people in the occupied Palestinian territories.

The General Assembly,

Having considered the question of Palestine at its resumed seventh emergency special session,

Noting with regret and concern that the Security Council, at its 2348th meeting, on 2 April 1982, and at its 2357th meeting, on 20 April 1982, failed to take a decision as a result of the negative votes of the United States of America,

Having heard the statement by the Head of the Political Department of the Palestine Liberation Organization, the representative of the Palestinian people, 1/

Convinced that the worsening situation in the Middle East and the failure to find a solution to this question pose a grave threat to international peace and security,

Deploring the repressive measures taken by the Israeli authorities in the illegally occupied Palestinian Arab territories, including Jerusalem,

Recalling the relevant United Nations resolutions pertaining to the status and unique character of the Holy City of Jerusalem, in particular Security Council resolutions 465 (1980) of 1 March 1980, 476 (1980) of 30 June 1980 and 478 (1980) of 20 August 1980,

Affirming once more that the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, 2/ is applicable to all territories occupied by Israel since 1967, including Jerusalem,

Noting with regret that, owing to the negative vote of one of its permanent members, the Security Council has, so far, failed to take a decision on the recommendations of the Committee on the Exercise of the Inalienable Rights of the Palestinian People endorsed by the General Assembly in its resolution 31/20 of 24 November 1976, 32/40 A of 2 December 1977, 33/28 A of 7 December 1978, 34/65 A of 29 November 1979, 35/169 A of 15 December 1980 and 36/120 D of 10 December 1981,

1. Reaffirms its resolutions ES-7/2 of 29 July 1980 and 3236 (XXIX) and 3237 (XXIX) of 22 November 1974 and all other relevant United Nations resolutions pertinent to the question of Palestine;

2. Reaffirms the fundamental principle of the inadmissibility of the acquisition of territory by force;

3. Reaffirms that all the provisions of the Hague Conventions of 1907 ^{3/} and the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, apply to all territories occupied by Israel since 1967, including Jerusalem, and calls upon all parties to these instruments to respect and ensure respect of their obligations in all circumstances;

4. Demands that Israel should comply with the provisions of Security Council resolution 465 (1980);

5. Further demands that Israel should comply with all United Nations resolutions relevant to the status and unique character of the Holy City of Jerusalem, in particular with Security Council resolutions 476 (1980) and 478 (1980);

6. Expresses its rejection of all policies and plans aiming at the resettlement of the Palestinians outside their homeland;

7. Condemns Israel, the occupying Power, for its:

(a) Failure to fulfil its obligations under the provisions of the Geneva Convention relative to Protection of Civilian Persons in Time of War;

(b) Disbanding of the elected municipal council of El-Bireh;

(c) Dismissal of the elected mayors of Ramallah and Nablus;

(d) Violation of the sanctity of the Holy Places, particularly of Al-Haram Al-Shareef, in Jerusalem;

(e) Shooting and killing and wounding of worshippers in the precincts of Al-Haram Al-Shareef by members of the Israeli army on 11 April 1982;

(f) Repressive measures, including shooting at the unarmed civilian population in the occupied Palestinian territory and in the occupied Syrian Golan Heights, resulting in death and injury;

(g) Attacks against and interference with the functions of various civic and religious institutions in the occupied Palestine territory, including Jerusalem, in particular educational institutions;

8. Condemns all policies which frustrate the exercise of the inalienable rights of the Palestinian people, in particular providing Israel with military, economic and political assistance and the misuse of the veto by a permanent member of the Security Council, thus enabling Israel to continue its aggression, occupation and unwillingness to carry out its obligations under the Charter and the relevant resolutions of the United Nations;

9. Urges all Governments which have not yet done so:

(a) To recognize the inalienable rights of the Palestinian people;

(b) To renounce the policy of providing Israel with military, economic and political assistance, thus discouraging Israel from continuing its aggression, occupation and disregard of its obligations under the Charter and the relevant resolutions of the United Nations;

(c) To act accordingly in all the organs of the United Nations;

10. Condemns the policies which encourage the flow of human resources to Israel, enabling it to implement and to proceed with its colonization and settlement policies in the occupied Arab territories;

11. Declares once again that Israel's record and actions confirm that it is not a peace-loving Member State and that it has carried out neither its obligations under the Charter nor its commitment under General Assembly resolution 273 (III) of 11 May 1949;

12. Calls again upon Israel, the occupying Power, to observe and apply scrupulously the provisions of the Geneva Convention relative to the Protection of Civilian Persons in Time of War and the principles of international law governing military occupation in all the occupied Palestinian and other Arab territories, including Jerusalem;

13. Demands that Israel, the occupying Power, should permit entry into the occupied territories of the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Population of the Occupied Territories and of the Commission established by Security Council resolution 446 (1979), in order to facilitate the fulfilment of the mandates entrusted to them by the General Assembly and by the Council, respectively;

14. Urges the Security Council to recognize the inalienable rights of the Palestinian people as defined in General Assembly resolution ES-7/2 and to endorse the recommendations of the Committee on the Exercise of the Inalienable Rights of the Palestinian People, as endorsed by the Assembly in its resolution 31/20 and in subsequent resolutions;

15. Calls upon the Secretary-General, in concurrence with the Security Council and in consultation as appropriate with the Committee on the Exercise of the Inalienable Rights of the Palestinian People, to initiate contacts with all parties to the Arab-Israeli conflict in the Middle East, including the Palestine Liberation Organization, the representative of the Palestinian people, with a view to finding concrete ways and means to achieve a comprehensive, just and lasting solution, conducive to peace, in conformity with the principles of the Charter and relevant resolutions and based on the implementation of the recommendations of the Committee as endorsed by the General Assembly at its thirty-first session;

16. Requests the Secretary-General to follow up the implementation of the present resolution and to report thereon at appropriate intervals to Member States as well as to the Security Council and to submit a comprehensive report to the General Assembly at its thirty-seventh session under the item entitled "Question of Palestine";

17. Decides to adjourn the seventh emergency special session temporarily and to authorize the President of the latest regular session of the General Assembly to resume its meetings upon request from Member States.

ES-7/5. Question of Palestine

The General Assembly,

Having considered the question of Palestine at its resumed seventh emergency special session,

Having heard the statement of the Palestine Liberation Organization, the representative of the Palestinian people,

Alarmed by the worsening situation in the Middle East resulting from Israel's acts of aggression against the sovereignty of Lebanon and the Palestinian people in Lebanon,

Recalling Security Council resolutions 508 (1982) of 5 June 1982, 509 (1982) of 6 June 1982 and 512 (1982) of 19 June 1982,

Taking note of the reports of the Secretary-General relevant to this situation, particularly his report of 7 June 1982,

Taking note of the two positive replies to the Secretary-General by the Government of Lebanon and the Palestine Liberation Organization,

Noting with regret that the Security Council has, so far, failed to take effective and practical measures, in accordance with the Charter of the United Nations, to ensure implementation of its resolutions 508 (1982) and 509 (1982),

Referring to the humanitarian principles of the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, and to the obligations arising from the regulations annexed to the Hague Conventions of 1907,

Deeply concerned at the sufferings of the Palestinian and Lebanese civilian populations,

Reaffirming once again its conviction that the question of Palestine is the core of the Arab-Israeli conflict and that no comprehensive, just and lasting peace in the region will be achieved without the full exercise by the Palestinian people of its inalienable national rights,

Reaffirming further that a just and comprehensive settlement of the situation in the Middle East cannot be achieved without the participation on an equal footing of all the parties to the conflict, including the Palestine Liberation Organization as the representative of the Palestinian people,

1. Reaffirms the fundamental principle of the inadmissibility of the acquisition of territory by force;

2. Demands that all Member States and other parties observe strict respect for Lebanon's sovereignty, territorial integrity, unity and political independence within its internationally recognized boundaries;

3. Decides to support fully the provisions of Security Council resolutions 508 (1982) and 509 (1982) in which the Council, inter alia, demanded that:

(a) Israel withdraw all its military forces forthwith and unconditionally to the internationally recognized boundaries of Lebanon;

(b) All parties to the conflict cease immediately and simultaneously all military activities within Lebanon and across the Lebanese-Israeli border;

4. Condemns Israel for its non-compliance with resolutions 508 (1982) and 509 (1982);

5. Demands that Israel comply with all the above provisions no later than 0600 hours, (Beirut time) on Sunday, 27 June 1982;

6. Calls upon the Security Council to authorize the Secretary-General to undertake necessary endeavours and practical steps to implement the provisions of resolutions 508 (1982), 509 (1982) and 512 (1982);

7. Urges the Security Council, in the event of continued failure by Israel to comply with the demands contained in resolutions 508 (1982) and 509 (1982), to meet in order to consider practical ways and means in accordance with the Charter of the United Nations;

ES-7/6. Question of Palestine

The General Assembly,

Having considered the question of Palestine at its resumed seventh emergency special session,

Having heard the statement of the Palestine Liberation Organization, the representative of the Palestinian people, 1/

Guided by the purposes and principles of the United Nations, in particular the respect for the principle of equal rights and self-determination of peoples,

Aware of the functions of the Security Council during its meetings relevant to the situation in the Middle East, in particular since 4 June 1982,

Expressing its deep regret that the Security Council has, so far, failed to take effective and practical measures in accordance with the Charter of the United Nations to ensure implementation of its resolutions 508 (1982) of 5 June 1982 and 509 (1982) of 6 June 1982,

Alarmed that the situation in the Middle East has further worsened as a result of Israel's acts of aggression against the sovereignty of Lebanon and the Palestinian people in Lebanon,

Guided further by the purposes and principles of the United Nations, in particular to take effective collective measures for the prevention and removal of threats to the peace and for the suppression of acts of aggression,

Mindful of the humanitarian principles and provisions of the Geneva Conventions of 1949 2/ and Additional Protocol I thereto 3/ and the obligations arising from the regulations annexed to the Hague Conventions of 1907, 4/

Reaffirming its conviction that the question of Palestine is the core of the Arab-Israeli conflict and that no comprehensive, just and lasting peace in the region will be achieved without the full exercise by the Palestinian people of its inalienable rights in Palestine,

Reaffirming once again that a just and comprehensive settlement of the situation in the Middle East cannot be achieved without the participation on an equal footing of all the parties to the conflict, including the Palestine Liberation Organization as the representative of the Palestinian people,

Expressing its indignation at the continuation and intensification of military activities by Israel within Lebanon, particularly in and around Beirut,

Recalling all its resolutions relevant to the question of Palestine,

Recalling Security Council resolutions 508 (1982) of 5 June 1982, 509 (1982) of 6 June 1982, 511 (1982) of 18 June 1982, 512 (1982) of 19 June 1982, 513 (1982) of 4 July 1982, 515 (1982) of 29 July 1982, 516 (1982) of 1 August 1982, 517 (1982) of 4 August 1982 and 518 (1982) of 12 August 1982,

1. Reiterates its affirmation of the fundamental principle of the inadmissibility of the acquisition of territory by force;
2. Calls for the free exercise in Palestine of the inalienable rights of the Palestinian people to self-determination without external interference and to national independence;
3. Reaffirms its rejection of all policies and plans aiming at the resettlement of the Palestinians outside their homeland;
4. Demands that Israel respect and carry out the provisions of the previous resolutions of the General Assembly relating to the occupied Palestinian and other Arab territories, including Jerusalem, as well as the provisions of Security Council resolution 465 (1980) of 1 March 1980, in which the Council, inter alia:

(a) Determined that all measures taken by Israel to change the physical character, demographic composition, institutional structure or status of the Palestinian and other Arab territories occupied since 1967, including Jerusalem, or any part thereof had no legal validity and that Israel's policy and practices of settling parts of its population and new immigrants in those territories constituted a flagrant violation of the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, 5/ and also constituted a serious obstruction to achieving a comprehensive, just and lasting peace in the Middle East;

(b) Strongly deplored the continuation and persistence of Israel in pursuing those policies and practices and called upon the Government and people of Israel to rescind those measures, to dismantle the existing settlements and in particular to cease, on an urgent basis, the establishment, construction and planning of settlements in the Arab territories occupied since 1967, including Jerusalem;

5. Demands also that Israel carry out the provisions of Security Council resolutions 509 (1982), 511 (1982), 512 (1982), 513 (1982), 515 (1982), 516 (1982), 517 (1982) and 518 (1982);

6. Urges the Secretary-General, with the concurrence of the Security Council and the Government of Lebanon and pending the withdrawal of Israel from Lebanon, to undertake effective measures to guarantee the safety and security of the Palestinian and Lebanese civilian population in South Lebanon;

7. Condemns Israel for its non-compliance with resolutions of the Security Council, in defiance of Article 25 of the Charter of the United Nations;

8. Urges once again the Security Council, in the event of continued failure by Israel to comply with the demands contained in its resolutions 465 (1980), 508 (1982), 509 (1982), 515 (1982) and 518 (1982), to meet in order to consider practical ways and means in accordance with the relevant provisions of the Charter;

9. Requests once again the Secretary-General to delegate a high-level commission to investigate and make an up-to-date assessment of the extent of loss of human life and material damage and to report, as soon as possible, on the result of this investigation to the General Assembly and the Security Council;

10. Requests the Secretary-General and organizations of the United Nations system, in co-operation with the International Committee of the Red Cross and other non-governmental organizations, to investigate the strict application by Israel of the provisions of the Geneva Conventions of 1949 and other instruments in the case of those detained;

11. Calls once again upon the Secretary-General to initiate contacts with all the parties to the Arab-Israeli conflict in the Middle East, including the

Palestine Liberation Organization, the representative of the Palestinian people, with a view to convening an international conference, under the auspices of the United Nations, to find concrete ways and means of achieving a comprehensive, just and lasting solution, conducive to peace in conformity with the principles of the Charter and relevant resolutions;

12. Decides to adjourn the seventh emergency special session temporarily and to authorize the President of the latest regular session of the General Assembly to resume its meetings upon request from Member States.

ES-7/7. International Conference on the Question of Palestine

The General Assembly,

Recalling its resolution 36/120 C of 10 December 1981, by which it decided to convene an International Conference on the Question of Palestine, not later than 1984, for a comprehensive effort to seek effective ways and means to enable the Palestinian people to attain and exercise its rights,

Deeply alarmed at the explosive situation in the Middle East resulting from the Israeli aggression against the sovereign State of Lebanon and the Palestinian people, which poses a threat to international peace and security,

Deeply aware of the responsibility of the United Nations under its Charter for the maintenance of international peace,

Gravely concerned that no just solution to the problem of Palestine has been achieved and that this problem therefore continues to aggravate the Middle East conflict, of which it is the core, and to endanger international peace and security,

Taking note of the final communiqué of the Extraordinary Ministerial Meeting of the Co-ordinating Bureau of the Non-Aligned Countries on the Question of Palestine, held at Nicosia from 15 to 17 July 1982, 1/

Recognizing the need to intensify all efforts by the international community to enable the Palestinian people to attain and exercise its inalienable rights as defined and reaffirmed in United Nations resolutions,

Stressing the importance of the work of the Preparatory Committee for the International Conference on the Question of Palestine and the need for securing the broadest possible involvement of Member States in the preparatory processes leading up to the Conference, and in the Conference itself,

1. Decides to convene the International Conference on the Question of Palestine at the headquarters of the United Nations Educational, Scientific and Cultural Organization, in Paris, from 16 to 27 August 1983;
2. Requests the Secretary-General to ensure that adequate resources from the regular budget of the United Nations are provided urgently in order to enable the successful holding of the Conference and to carry out the necessary preparations for and follow-up activities to the Conference;
3. Calls upon all States to co-operate with the Preparatory Committee for the International Conference on the Question of Palestine in the implementation of the present resolution and invites them to establish national focal points for effective co-ordination of preparations at the national level.

Appalled at the massacre of Palestinian civilians in Beirut,

Recalling Security Council resolutions 508 (1982) of 5 June 1982, 509 (1982) of 6 June 1982, 513 (1982) of 4 July 1982, 520 (1982) of 17 September 1982 and 521 (1982) of 19 September 1982,

Taking note of the reports of the Secretary-General relevant to the situation, particularly his report of 18 September 1982, 2/

Noting with regret that the Security Council has so far not taken effective and practical measures, in accordance with the Charter of the United Nations, to ensure implementation of its resolutions 508 (1982) and 509 (1982),

Referring to the humanitarian principles of the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, 3/ and to the obligations arising from the regulations annexed to the Hague Conventions of 1907, 4/

Deeply concerned at the sufferings of the Palestinian and Lebanese civilian populations,

Noting the homelessness of the Palestinian people,

Reaffirming the imperative need to permit the Palestinian people to exercise their legitimate rights,

1. Condemns the criminal massacre of Palestinian and other civilians in Beirut on 17 September 1982;
2. Urges the Security Council to investigate, through the means available to it, the circumstances and extent of the massacre of Palestinian and other civilians in Beirut on 17 September 1982, and to make public the report on its findings as soon as possible;
3. Decides to support fully the provisions of Security Council resolutions 508 (1982) and 509 (1982), in which the Council, inter alia, demanded that:
 - (a) Israel withdraw all its military forces forthwith and unconditionally to the internationally recognized boundaries of Lebanon;
 - (b) All parties to the conflict cease immediately and simultaneously all military activities within Lebanon and across the Lebanese-Israeli border;
4. Demands that all Member States and other parties observe strict respect for the sovereignty, territorial integrity, unity and political independence of Lebanon within its internationally recognized boundaries;
5. Reaffirms the fundamental principle of the inadmissibility of the acquisition of territory by force;
6. Resolves that, in conformity with its resolution 194 (III) and subsequent relevant resolutions, the Palestinian refugees should be enabled to return to their homes and property from which they have been uprooted and displaced, and demands that Israel comply unconditionally and immediately with the present resolution;

7. Urges the Security Council, in the event of continued failure by Israel to comply with the demands contained in resolutions 508 (1982) and 509 (1982) and the present resolution, to meet in order to consider practical ways and means in accordance with the Charter of the United Nations;

8. Calls upon all States and international agencies and organizations to continue to provide the most extensive humanitarian aid possible to the victims of the Israeli invasion of Lebanon;

9. Requests the Secretary-General to prepare a photographic exhibit of the massacre of 17 September 1982 and to display it in the United Nations visitors' hall;

10. Decides to adjourn the seventh emergency special session temporarily and to authorize the President of the latest regular session of the General Assembly to resume its meetings upon request from Member States.

RESOLUTIONS ADOPTED BY THE SECURITY COUNCIL

RESOLUTION 501 (1982)

Adopted by the Security Council at its 2332nd meeting,
held on 25 February 1982

The Security Council,

Recalling its resolutions 425 (1978), 426 (1978), 427 (1978), 434 (1978), 444 (1979), 450 (1979), 459 (1979), 467 (1980), 474 (1980), 483 (1980), 488 (1981), 490 (1981) and 498 (1981),

Acting in accordance with its resolution 498 (1981), and in particular paragraph 10 of that resolution in which it decided to review the situation as a whole,

Having studied the special report of the Secretary-General on the United Nations Interim Force in Lebanon (S/14869),

Noting the letter of the Permanent Representative of Lebanon to the President of the Security Council (S/14875),

Having reviewed the situation as a whole in the light of the Secretary-General's report and of the letter of the Lebanese Permanent Representative,

Taking note from the Secretary-General's report that it is the strong recommendation of UNIFIL's Force Commander, and also the wish of the Lebanese Government, that the ceiling for UNIFIL troops should be increased; and that the Secretary-General fully supports the recommendation for an increase by 1,000 of the troop strength of UNIFIL,

1. Reaffirms its resolution 425 (1978) which reads:

The Security Council,

Taking note of the letters of the Permanent Representative of Lebanon (S/12600 and S/12606) and the Permanent Representative of Israel (S/12607),

Having heard the statements of the Permanent Representatives of Lebanon and Israel,

Gravely concerned at the deterioration of the situation in the Middle East, and its consequences to the maintenance of international peace,

Convinced that the present situation impedes the achievement of a just peace in the Middle East,

1. Calls for strict respect for the territorial integrity, sovereignty and political independence of Lebanon within its internationally recognized boundaries;

2. Calls upon Israel immediately to cease its military action against Lebanese territorial integrity and withdraw forthwith its forces from all Lebanese territory;

3. Decides, in the light of the request of the Government of Lebanon, to establish immediately under its authority a United Nations interim force for southern Lebanon for the purpose of confirming the withdrawal of Israeli forces, restoring international peace and security and assisting the Government of Lebanon in ensuring the return of its effective authority in the area, the force to be composed of personnel drawn from States Members of the United Nations;

4. Requests the Secretary-General to report to the Council within twenty-four hours on the implementation of this resolution.

2. Decides to approve the immediate increase in the strength of the United Nations Interim Force in Lebanon recommended by the Secretary-General (in para. 6 of document S/14869) from approximately 6,000 to approximately 7,000 troops to reinforce present operations as well as to make further deployment possible on the lines of resolution 425 (1978);

3. Re-emphasizes the terms of reference and general guidelines of UNIFIL, as stated in the report of the Secretary-General of 19 March 1978 (S/12611) confirmed by resolution 426 (1978), and particularly

(a) That "the Force must be able to function as an integrated and efficient military unit";

(b) That "the Force must enjoy the freedom of movement and communication and other facilities that are necessary to the performance of its tasks";

(c) That the Force "shall not use force except in self-defence";

(d) That "self-defence would include resistance to attempts by forceful means to prevent it from discharging its duties under the mandate of the Security Council";

4. Calls upon the Secretary-General to renew his efforts to reactivate the General Armistice Agreement between Lebanon and Israel of 23 March 1949, and in particular to convene an early meeting of the Mixed Armistice Commission;

5. Requests the Secretary-General to continue his discussions with the Government of Lebanon and the parties concerned with a view to submitting a report by 10 June 1982 on the necessary requirements for achieving further progress in a phased programme of activities with the Government of Lebanon;

6. Decides to remain seized of the question and invites the Secretary-General to report to the Security Council on the situation as a whole within two months.

RESOLUTION 506 (1982)

Adopted by the Security Council at its 2369th meeting
on 26 May 1982

The Security Council,

Having considered the report of the Secretary-General on the United Nations Disengagement Observer Force (S/15079),

Decides:

- (a) To call upon the parties concerned to implement immediately Security Council resolution 338 (1973) of 22 October 1973;
- (b) To renew the mandate of the United Nations Disengagement Observer Force for another period of six months, that is, until 30 November 1982;
- (c) To request the Secretary-General to submit, at the end of this period, a report on the developments in the situation and the measures taken to implement Security Council resolution 338 (1973).

RESOLUTION 508 (1982)

Adopted by the Security Council at its 2374th meeting,
on 5 June 1982

The Security Council,

Recalling Security Council resolutions 425 (1978), 426 (1978) and the ensuing resolutions, and more particularly, Security Council resolution 501 (1982),

Taking note of the letters of the Permanent Representative of Lebanon dated 4 June 1982 (S/15161 and S/15162),

Deeply concerned at the deterioration of the present situation in Lebanon and in the Lebanese-Israeli border area, and its consequences for peace and security in the region,

Gravely concerned at the violation of the territorial integrity, independence, and sovereignty of Lebanon,

Reaffirming and supporting the statement made by the President and the members of the Security Council on 4 June 1982 (S/15163), as well as the urgent appeal issued by the Secretary-General on 4 June 1982,

Taking note of the report of the Secretary-General,

1. Calls upon all the parties to the conflict to cease immediately and simultaneously all military activities within Lebanon and across the Lebanese-Israeli border and no later than 0600 hours local time on Sunday, 6 June 1982;

2. Requests all Member States which are in a position to do so to bring their influence to bear upon those concerned so that the cessation of hostilities declared by Security Council resolution 490 (1981) can be respected;

3. Requests the Secretary-General to undertake all possible efforts to ensure the implementation of and compliance with this resolution and to report to the Security Council as early as possible and not later than forty-eight hours after the adoption of this resolution.

RESOLUTION 509 (1982)

Adopted by the Security Council at its 2375th meeting,
on 6 June 1982

The Security Council,

Recalling its resolutions 425 (1978) of 19 March 1978 and 508 (1982) of 5 June 1982,

Gravely concerned at the situation as described by the Secretary-General in his report to the Council,

Reaffirming the need for strict respect for the territorial integrity, sovereignty and political independence of Lebanon within its internationally recognized boundaries,

1. Demands that Israel withdraw all its military forces forthwith and unconditionally to the internationally recognized boundaries of Lebanon;

2. Demands that all parties observe strictly the terms of paragraph 1 of resolution 508 (1982) which called on them to cease immediately and simultaneously all military activities within Lebanon and across the Lebanese-Israeli border;

3. Calls on all parties to communicate to the Secretary-General their acceptance of the present resolution within 24 hours;

4. Decides to remain seized of the question.

RESOLUTION 511 (1982)

Adopted by the Security Council at its 2379th meeting,
held on 18 June 1982

The Security Council,

Recalling its resolution 425 (1978), 426 (1978), 427 (1978), 434 (1978), 444 (1979), 450 (1979), 459 (1979), 467 (1980), 483 (1980), 488 (1981), 490 (1981), 498 (1981), and 501 (1982),

Reaffirming its resolutions 508 (1982) and 509 (1982),

Having studied the report of the Secretary-General on the United Nations Interim Force in Lebanon (S/15194 and Add.1 and 2) and taking note of the conclusions and recommendations expressed therein,

Bearing in mind the need to avoid any developments which could further aggravate the situation and the need, pending an examination of the situation by the Council in all its aspects, to preserve in place the capacity of the United Nations to assist in the restoration of the peace,

1. Decides as an interim measure, to extend the present mandate of the Force for a period of two months, that is, until 19 August 1982;
2. Authorizes the Force during that period, to carry out, in addition, the interim tasks referred to in paragraph 17 of the Secretary-General's report (S/15194/Add.2);
3. Calls on all concerned to extend full co-operation to the Force in the discharge of its tasks;
4. Requests the Secretary-General to keep the Security Council regularly informed of the implementation of resolutions 508 (1982) and 509 (1982) and the present resolution.

RESOLUTION 512 (1982)

Adopted by the Security Council at its 2380th meeting
on 19 June 1982

The Security Council,

Deeply concerned at the sufferings of the Lebanese and Palestinian civilian populations,

Referring to the humanitarian principles of the Geneva Conventions of 1949 and to the obligations arising from the regulations annexed to the Hague Convention of 1907,

Reaffirming its resolutions 508 (1982) and 509 (1982),

1. Calls upon all the parties to the conflict to respect the rights of the civilian populations, to refrain from all acts of violence against those populations and to take all appropriate measures to alleviate the suffering caused by the conflict, in particular, by facilitating the dispatch and distribution of aid provided by United Nations agencies and by non-governmental organizations, in particular, the International Committee of the Red Cross (ICRC);
2. Appeals to Member States to continue to provide the most extensive humanitarian aid possible;
3. Stresses the particular humanitarian responsibilities of the United Nations and its agencies, including the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA), towards civilian populations and calls upon all the parties to the conflict not to hamper the exercise of those responsibilities and to assist in humanitarian efforts;
4. Takes note of the measures taken by the Secretary-General to co-ordinate the activities of the international agencies in this field and requests him to make every effort to ensure the implementation of and compliance with this resolution and to report on these efforts to the Council as soon as possible.

RESOLUTION 513 (1982)

Adopted by the Security Council at its 2382nd meeting,
on 4 July 1982

The Security Council,

Alarmed by the continued sufferings of the Lebanese and Palestinian civilian populations in South Lebanon and in West Beirut,

Referring to the humanitarian principles of the Geneva Conventions of 1949 and to the obligations arising from the Regulations annexed to the Hague Convention of 1907,

Reaffirming its resolutions 508 (1982), 509 (1982) and 512 (1982),

1. Calls for respect for the rights of the civilian populations without any discrimination and repudiates all acts of violence against those populations;
2. Calls further for the restoration of the normal supply of vital facilities such as water, electricity, food and medical provisions, particularly in Beirut;
3. Commends the efforts of the Secretary-General and the action of international agencies to alleviate the sufferings of the civilian population and requests them to continue their efforts to ensure their success.

RESOLUTION 515 (1982)

Adopted by the Security Council at its 2385th meeting,
on 29 July 1982

The Security Council,

Deeply concerned at the situation of the civilian population of Beirut,

Referring to the humanitarian principles of the Geneva Conventions of 1949 and to the obligations arising from the regulations annexed to the Hague Convention of 1907,

Recalling its resolutions 512 (1982) and 513 (1982),

1. Demands that the Government of Israel lift immediately the blockade of the city of Beirut in order to permit the dispatch of supplies to meet the urgent needs of the civilian population and allow the distribution of aid provided by United Nations agencies and by non-governmental organizations, particularly the International Committee of the Red Cross (ICRC);
2. Requests the Secretary-General to transmit the text of this resolution to the Government of Israel and keep the Security Council informed of its implementation.

RESOLUTION 516 (1982)

Adopted by the Security Council at its 2386th meeting
on 1 August 1982

The Security Council,

Reaffirming its resolutions 508 (1982), 509 (1982), 511 (1982), 512 (1982) and 513 (1982),

Recalling its resolution 515 (1982) of 29 July 1982,

Alarmed by the continuation and intensification of military activities in and around Beirut,

Taking note of the latest massive violations of the cease-fire in and around Beirut,

1. Confirms its previous resolutions and demands an immediate cease-fire, and a cessation of all military activities within Lebanon and across the Lebanese-Israeli border;
2. Authorizes the Secretary-General to deploy immediately on the request of the Government of Lebanon, United Nations observers to monitor the situation in and around Beirut;
3. Requests the Secretary-General to report back to the Council on compliance with this resolution as soon as possible and not later than four hours from now.

RESOLUTION 517 (1982)

Adopted by the Security Council at its 2389th meeting
on 4 August 1982

The Security Council,

Deeply shocked and alarmed by the deplorable consequences of the Israeli invasion of Beirut on 3 August 1982,

1. Reconfirms its resolutions 508 (1982), 509 (1982), 512 (1982), 513 (1982), 515 (1982) and 516 (1982);
2. Confirms once again its demand for an immediate cease-fire and withdrawal of Israeli forces from Lebanon;
3. Censures Israel for its failure to comply with the above resolutions;
4. Calls for the prompt return of Israeli troops which have moved forward subsequent to 1325 hours EDT on 1 August 1982;

5. Takes note of the decision of the Palestine Liberation Organization to move the Palestinian armed forces from Beirut;

6. Expresses its appreciation for the efforts and steps taken by the Secretary-General to implement the provisions of Security Council resolution 516 (1982), and authorizes him, as an immediate step, to increase the number of United Nations observers in and around Beirut;

7. Requests the Secretary-General to report to the Security Council on the implementation of the present resolution as soon as possible and not later than 1000 hours EDT on 5 August 1982;

8. Decides to meet at that time if necessary in order to consider the report of the Secretary-General and, in case of failure to comply by any of the parties to the conflict, to consider adopting effective ways and means in accordance with the provisions of the Charter of the United Nations.

RESOLUTION 518 (1982)

Adopted by the Security Council at its 2392nd meeting
on 12 August 1982

The Security Council,

Recalling its resolutions 508 (1982), 509 (1982), 511 (1982), 512 (1982), 513 (1982), 515 (1982), 516 (1982), and 517 (1982),

Expressing its most serious concern about continued military activities in Lebanon and, particularly, in and around Beirut,

1. Demands that Israel and all parties to the conflict observe strictly the terms of Security Council resolutions relevant to the immediate cessation of all military activities within Lebanon and, particularly, in and around Beirut;

2. Demands the immediate lifting of all restrictions on the city of Beirut in order to permit the free entry of supplies to meet the urgent needs of the civilian population in Beirut;

3. Requests the United Nations observers in and in the vicinity of Beirut to report on the situation;

4. Demands that Israel co-operate fully in the effort to secure the effective deployment of the United Nations observers, as requested by the Government of Lebanon, and in such a manner as to ensure their safety;

5. Requests the Secretary-General to report soonest to the Security Council on the implementation of the present resolution;

6. Decides to meet if necessary in order to consider the situation upon receipt of the report of the Secretary-General.

RESOLUTION 519 (1982)

Adopted by the Security Council at its 2393rd meeting
on 17 August 1982

The Security Council,

Recalling its resolutions 425 (1978), 426 (1978), 427 (1978), 434 (1978), 444 (1979), 450 (1979), 459 (1979), 467 (1980), 483 (1980), 488 (1981), 490 (1981), 498 (1981), 501 (1982) and 511 (1982),

Reaffirming its resolutions 508 (1982) and 509 (1982), as well as subsequent resolutions on the situation in Lebanon,

Having studied with grave concern the report of the Secretary-General on the United Nations Interim Force in Lebanon (S/15357) and noting its conclusions and recommendations and the wishes of the Lebanese Government as set out therein,

Bearing in mind the need, pending an examination by the Council of the situation in all its aspects, to preserve in place the capacity of the United Nations to assist in the restoration of the peace and of the authority of the Lebanese Government throughout Lebanon,

1. Decides to prolong the present mandate of UNIFIL for a further interim period of two months, that is, until 19 October 1982;
2. Authorizes the Force during that period to continue to carry out, in addition, the interim tasks in the humanitarian and administrative fields assigned to it in operative paragraph 2 of resolution 511 (1982);
3. Calls on all concerned, taking into account paragraphs 5, 8 and 9 of the Secretary-General's report (S/15357), to extend full co-operation to the Force in the discharge of its tasks;
4. Supports the efforts of the Secretary-General, with a view to optimum use of UNTSO observers as envisaged by relevant resolutions of the Security Council;
5. Decides to consider the situation fully and in all its aspects before 19 October 1982.

RESOLUTION 520 (1982)

Adopted by the Security Council at its 2395th meeting,
on 17 September 1982

The Security Council,

Having considered the report of the Secretary-General of 15 September 1982 (S/15382/Add.1),

Condemning the murder of Bashir Gemayel, Lebanon's constitutionally selected President-elect, and every effort to disrupt by violence the restoration of a strong, stable government in Lebanon,

Having listened to the statement by the Permanent Representative of Lebanon,

Taking note of Lebanon's determination to ensure the withdrawal of all non-Lebanese forces from Lebanon,

1. Reaffirms its resolutions 508 (1982), 509 (1982) and 516 (1982) in all their components;
2. Condemns the recent Israeli incursions into Beirut in violation of the cease-fire agreements and of Security Council resolutions;
3. Demands an immediate return to the positions occupied by Israel before 15 September 1982, as a first step towards the full implementation of Security Council resolutions;
4. Calls again for the strict respect for Lebanon's sovereignty, territorial integrity, unity and political independence under the sole and exclusive authority of the Lebanese Government through the Lebanese Army throughout Lebanon;
5. Reaffirms its resolutions 512 (1982) and 513 (1982) which call for respect for the rights of the civilian populations without any discrimination and repudiates all acts of violence against those populations;
6. Supports the efforts of the Secretary-General to implement Security Council resolution 516 (1982) concerning the deployment of United Nations observers to monitor the situation in and around Beirut and requests all the parties concerned to co-operate fully in the application of that resolution;
7. Decides to remain seized of the question and asks the Secretary-General to keep the Council informed on developments as soon as possible and not later than twenty-four hours.

RESOLUTION 521 (1982)

Adopted by the Security Council at its 2396th meeting
on 19 September 1982

The Security Council,

Appalled at the massacre of Palestinian civilians in Beirut,

Having heard the report of the Secretary-General (S/15400),

Noting that the Government of Lebanon has agreed to the dispatch of United Nations Observers to the sites of greatest human suffering and losses in and around that city,

1. Condemns the criminal massacre of Palestinian civilians in Beirut;
2. Reaffirms once again its resolutions 512 (1982) and 513 (1982) which call for respect for the rights of the civilian population without any discrimination and repudiates all acts of violence against that population;
3. Authorizes the Secretary-General as an immediate step to increase the number of United Nations observers in and around Beirut from 10 to 50 and insists that there shall be no interference with the deployment of the observers and that they shall have full freedom of movement;
4. Requests the Secretary-General, in consultation with the Government of Lebanon, to ensure the rapid deployment of those observers in order that they may contribute in every way possible within their mandate, to the effort to ensure full protection for the civilian population;
5. Requests the Secretary-General as a matter of urgency to initiate appropriate consultations and in particular consultations with the Government of Lebanon on additional steps which the Council might take, including the possible deployment of United Nations forces, to assist that Government in ensuring full protection for the civilian population in and around Beirut and requests him to report to the Council within forty-eight hours;
6. Insists that all concerned must permit United Nations observers and forces established by the Security Council in Lebanon to be deployed and to discharge their mandates and in this connexion solemnly calls attention to the obligation on all Member States under Article 25 of the Charter to accept and carry out the decisions of the Council in accordance with the Charter;
7. Requests the Secretary-General to keep the Council informed on an urgent and continuing basis.

RESOLUTION 523 (1982)

Adopted by the Security Council at its 2400th meeting
on 18 October 1982

The Security Council,

Having heard the statement of the President of the Lebanese Republic,

Recalling its resolutions 425 (1978), 426 (1978) and 519 (1982),

Reaffirming its resolutions 508 (1982) and 509 (1982), as well as all subsequent resolutions on the situation in Lebanon,

Having studied the report of the Secretary-General (S/15455 and Corr.1), and taking note of its conclusions and recommendations,

Responding to the request of the Government of Lebanon,

1. Decides to extend the present mandate of UNIFIL for a further interim period of three months, that is, until 19 January 1983;
2. Insists that there shall be no interference under any pretext with the operations of UNIFIL and that the Force shall have full freedom of movement in the discharge of its mandate;
3. Authorizes the Force during that period to carry out, with the consent of the Government of Lebanon, interim tasks in the humanitarian and administrative fields, as indicated in resolutions 511 (1982) and 519 (1982), and to assist the Government of Lebanon in assuring the security of all the inhabitants of the area without any discrimination;
4. Requests the Secretary-General, within the three-month period, to consult with the Government of Lebanon and to report to the Council on ways and means of ensuring the full implementation of the UNIFIL mandate as defined in resolutions 425 (1978) and 426 (1978), and the relevant decisions of the Security Council;
5. Requests the Secretary-General to report to the Security Council on the progress of his consultations.

RESOLUTION 524 (1982)

Adopted by the Security Council at its 2403rd meeting,
on 29 November 1982

The Security Council,

Having considered the report of the Secretary-General on the United Nations Disengagement Observer Force (S/15493),

Decides:

(a) To call upon the parties concerned to implement immediately Security Council resolution 338 (1973) of 22 October 1973;

(b) To renew the mandate of the United Nations Disengagement Observer Force for another period of six months, that is, until 31 May 1983;

(c) To request the Secretary-General to submit, at the end of this period, a report on the developments in the situation and the measures taken to implement Security Council resolution 338 (1973).
