

I. Introduction

- 1. The Secretary-General has the honour to place before the General Committee, for its consideration, the following observations and proposals in connection with the report to be made to the General Assembly by the General Committee regarding the organization of the seventy-third regular session and future sessions of the Assembly, the adoption of the agenda and the allocation of items.
- 2. Over the years, the General Assembly has adopted a number of provisions aimed at rationalizing the procedures and organization of the Assembly. Some of those provisions are reproduced in the annexes to the rules of procedure of the General Assembly (A/520/Rev.18 and A/520/Rev.18/Amend.1). The Secretary-General wishes to draw the attention of the General Committee to resolutions of the General Assembly relating to the revitalization of its work.¹

II. Organization of the session

A. General Committee

- 3. The Secretary-General wishes to draw the attention of the General Committee to rule 40 of the rules of procedure and to document A/56/1005 (annex, paras. 9–10) pertaining to the functions of the Committee.
- 4. The Secretary-General also wishes to draw the attention of the General Committee to paragraph 5 of the annex to resolution 58/316 pertaining to the functions of the General Committee. The Committee may wish to recall in particular subparagraphs (e) to (h), according to which the General Committee shall continue to consider the further biennialization, triennialization, clustering and elimination of items of the customary agenda of the General Assembly; schedule informal briefings on topical issues; recommend to the Assembly a programme of, and format for, interactive debates on the items of its agenda; and consider ways and means to further improve its working methods to increase its efficiency and effectiveness in all aspects.
- 5. In subsequent resolutions on the revitalization of its work, the General Assembly stressed the importance of enhancing the role of the General Committee. By its resolution 72/313, the General Assembly, recalling its resolutions 1898 (XVIII), 2837 (XXVI), 45/45, 51/241, 58/126 and 58/316, called upon the President of the General Assembly to make full use of the General Committee throughout the session with a view to reviewing the programme of work of the Assembly and its Main Committees, in line with rule 42 of the rules of procedure of the General Assembly.
- 6. The Secretary-General wishes to recall that, at the outset of each session, each Vice-President of the General Assembly shall designate a liaison person for the duration of the session. This designation may be made by means of a letter to the President (resolution 55/285, annex, para. 20).

B. Rationalization of work

- 7. The Secretary-General wishes to draw the attention of the General Committee to relevant resolutions relating to the rationalization of work, including the administrative and financial functioning of the Organization.²
- 8. The Secretary-General also wishes to draw the attention of the General Committee to paragraph 14 of the annex to resolution 55/285, which reads:

As regards implementation of paragraph 7 of the annex to resolution 51/241, the President of the General Assembly, after consideration by the Assembly of the report of the Secretary-General on the work of the Organization, shall inform the Assembly of his assessment of the debate on the report in order for the Assembly to determine the need for further action.

- 9. The General Committee may wish to bring to the attention of the General Assembly paragraphs 14 and 16 of resolution 72/313, in which the Assembly called upon the President of the General Assembly to closely consult with the General Committee and the Member States on the holding of interactive inclusive thematic debates on current issues of critical importance to the international community, including with regard to the frequency and preliminary programme of such debates; and requested the President of the General Assembly to limit high-level meetings to current issues of critical importance to the international community, with the interest of the wider membership in mind and with a focus on the most vulnerable, while encouraging the allocation of events of a strictly sectoral or thematic nature to the six Main Committees.
- 10. The General Committee may also wish to draw the attention of the General Assembly to paragraph 27 of resolution 72/313, in which the Assembly emphasized that the General Assembly and its Main Committees, at the seventy-third session, in consultation with Member States, should continue their consideration of and make proposals for the further biennialization, triennialization, clustering and elimination of items on the agenda of the Assembly, including through the introduction of a sunset clause, with the clear consent of the sponsoring State or States, taking into account the relevant recommendations of the Ad Hoc Working Group on the Revitalization of the work of the General Assembly.
- 11. The General Committee may further wish to draw the attention of the General Assembly to paragraph 29 of resolution 72/313, in which the Assembly recalled the need to enhance synergies and coherence and reduce overlap where it is found to exist in the agendas of the General Assembly, especially of its Second and Third Committees, the Economic and Social Council and its subsidiary bodies, and the work of the high-level political forum on sustainable development convened under the auspices of the Council and the Assembly, as well as all other related forums, in accordance with relevant rules of procedure and in the light of the adoption of the 2030 Agenda for Sustainable Development, and called for the continuation of such efforts during the seventy-third session of the Assembly.
- 12. The General Committee may wish to draw the attention of the General Assembly to paragraph 30 of resolution 72/313, in which the Assembly requested the General Committee, while exercising its functions under rule 40 of the rules of procedure of the General Assembly, to pay special attention to the reduction of such overlap.
- 13. The General Committee may also wish to draw the attention of the General Assembly to paragraph 31 of resolution 72/313, in which the Assembly requested the

President of the General Assembly at its seventy-third session to identify proposals, through consultations with all Member States and with the President of the Economic and Social Council, as well as through the convening of the General Committee, aimed at addressing gaps and duplication in the agenda of the Assembly as they relate to the 2030 Agenda for Sustainable Development, taking into account the report on the strategic alignment of future sessions of the General Assembly and other relevant inputs, for the consideration of Member States during the seventy-third session of the Assembly.

- 14. The General Committee may wish to bring to the attention of the General Assembly paragraph 20 of resolution 72/313, in which the Assembly reaffirmed existing relevant mandates related to the improvement of the working methods of the Main Committees, including section C of the annex to resolution 58/316, paragraphs 7 to 13 of resolution 59/313, cluster III of the annex to resolution 60/286 and resolution 69/321, in particular paragraphs 16 and 17 thereof.
- 15. The General Committee may also wish to bring to the attention of the General Assembly that the Main Committees shall meet in substantive session only after the end of the general debate and that the First Committee and the Special Political and Decolonization Committee (Fourth Committee) shall not meet simultaneously and may consider meeting in a sequential manner during the regular session of the General Assembly. This arrangement shall not apply if it affects their respective identities, programmes of work and effective consideration of their agendas (resolution 51/241, annex, paras. 31 and 36).
- 16. The General Committee may wish to bring to the attention of the General Assembly paragraph 22 of resolution 72/313, in which the Assembly requested each Main Committee to further discuss its working methods at the beginning of every session and invited the Chairs of the Main Committees to brief the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly during the seventy-second session on any best practices and lessons learned.
- 17. The General Committee may also wish to bring to the attention of the General Assembly paragraph 23 of resolution 72/313, in which the Assembly requested the Chairs of the Main Committees to organize handover meetings of the outgoing and incoming bureaux to exchange views on outcomes and the upcoming agenda, and invited the Chairs of the Main Committees to present a report to their successors on best practices and lessons learned.
- 18. The General Committee may further wish to bring to the attention of the General Assembly paragraph 25 of resolution 72/313, in which the Assembly called upon the six Chairs of the Main Committees to meet periodically during the General Assembly session to share best practices and increase the coherence and complementarity of the work of the Main Committees.
- 19. The General Committee may wish to bring to the attention of the General Assembly paragraph 60 of resolution 72/313, in which the Assembly called upon all relevant intergovernmental bodies to review the need for and content of the *Journal* summaries of their meetings and other announcements, and to take the steps necessary with a view to ensuring a more streamlined format for the *Journal of the United Nations*.
- 20. The General Committee may also wish to bring to the attention of the General Assembly the pattern for the rotation of the Chairs of the Main Committees for the seventy-fourth to the eighty-third sessions of the Assembly contained in the annex to resolution 72/313.
- 21. The General Committee may further wish to bring to the attention of the General Assembly paragraphs 32 and 50 of resolution 72/313, in which the Assembly encouraged Member States, in proposing and voting for candidates to subsidiary

organs of the General Assembly, to seek to promote gender balance in all such bodies, and to seek gender balance in the distribution of the Chairs and bureau members of the Main Committees as well as the Vice-Presidents of the General Assembly, where applicable.

C. Opening and closing dates of the session

- 22. In accordance with rule 1 of the rules of procedure, the seventy-third regular session of the General Assembly shall begin on Tuesday, 18 September 2018.³
- 23. The General Committee may wish to recommend to the General Assembly that the seventy-third session of the Assembly recess on Monday, 17 December 2018, and close on Monday, 16 September 2019 (rule 2 of the rules of procedure and para. 4 of annex IV to the rules of procedure).
- 24. The General Committee may also wish to recommend to the General Assembly that, during the main part of the session, the First Committee complete its work by Friday, 9 November, the Special Political and Decolonization Committee (Fourth Committee) by Friday, 16 November, the Second Committee by Thursday, 29 November, the Third Committee by Wednesday, 21 November, the Fifth Committee by Tuesday, 18 December, and the Sixth Committee by Tuesday, 13 November 2018.⁴

D. Seating arrangements

- 25. In accordance with established practice, the Secretary-General has drawn lots for the purpose of choosing the Member State to occupy the first desk on the General Assembly floor from which the alphabetical seating order will begin. The name drawn was Mali. The other countries will follow in the English alphabetical order, and the same order will be observed in the Main Committees. In accordance with established practice, the President of the General Assembly, the Secretary-General and the Secretary will occupy the seats at the podium during formal plenary meetings.
- 26. The General Committee may wish to bring to the attention of the General Assembly paragraph 42 of resolution 71/323, in which the Assembly decided that, with due consideration given to accessibility issues, in all plenary meetings of the General Assembly, including plenary meetings of high-level events, the seating arrangement of Member States shall follow English alphabetical order, beginning with the name of the country selected by lot each year and avoiding distinctions between Member States as to the rank of the head of delegation.

E. Schedule of meetings

27. The Secretary-General wishes to recall that, in view of financial constraints, meetings at Headquarters will not be serviced beyond 6 p.m. or on weekends. Consequently, meetings should start promptly at 10 a.m. and be adjourned by 6 p.m. on weekdays. The Secretary-General also wishes to recall resolution 59/313, in which the Assembly strongly urged all officers presiding over meetings of the Assembly to start such meetings on time. The Secretary-General wishes to bring to the attention of the General Committee that, without exception, interpreters are assigned to service meetings up to a maximum of three hours; and that, beyond that, a 5-to-10-minute

- courtesy is granted at the discretion of the interpretation team leader if it makes a significant difference to the proceedings.
- 28. The Secretary-General wishes to recall paragraph 37 of resolution 72/313, in which the General Assembly recommended that speakers should be mindful of the speed of statement delivery, bearing in mind the need for accuracy of interpretation.
- 29. The Secretary-General wishes to draw the attention of the General Committee to paragraph 1 (b) of the annex to resolution 58/316, which reads:

With effect from the fifty-ninth session of the General Assembly, the meetings of the plenary Assembly shall normally be held on Mondays and Thursdays.

- 30. The Secretary-General also wishes to draw the attention of the General Committee to paragraph 4 of resolution 72/19, in which the Assembly noted with satisfaction that the Secretariat had taken into account the arrangements referred to in General Assembly resolutions 53/208 A, 54/248, 55/222, 56/242, 57/283 B, 58/250, 59/265, 60/236 A, 61/236, 62/225, 63/248, 64/230, 65/245, 66/233, 67/237 and 68/251 concerning Orthodox Good Friday and the official holidays of Eid al-Fitr and Eid al-Adha, and requested all intergovernmental bodies to observe those decisions when planning their meetings.
- 31. The Secretary-General further wishes to draw the attention of the General Committee to paragraphs 5 to 9 of resolution 69/250, in which the Assembly acknowledged the significance of the following holidays and observances and invited United Nations bodies at Headquarters and other duty stations where observed to avoid holding meetings on those days, and in this regard encouraged this arrangement be taken into account when drafting future calendars of conferences and meetings: Yom Kippur (19 September 2018, observed), Day of Vesak (to be determined), Diwali (7 November 2018, observed), Gurpurab (23 November 2018) and Orthodox Christmas (to be determined).
- 32. The General Committee may wish to recommend to the General Assembly that, in accordance with past practice, it waive the requirement that at least one third of the members of the Assembly, in the case of plenary meetings, and one quarter of the members of a Main Committee, in the case of Main Committee meetings, be present in order to declare a meeting open and to permit the debate to proceed. This recommendation would be made on the understanding that such a waiver would not imply any permanent change in the provisions of rules 67 and 108 of the rules of procedure and that the requirement of the presence of a majority of the members for any decision to be taken would be maintained.
- 33. The General Committee may wish to bring to the attention of the General Assembly paragraph 46 of resolution 72/313, in which the Assembly encouraged the scheduling of future high-level meetings during the first half of the year, from within existing resources, taking into account the calendar of conferences and without prejudice to the current practice of convening one high-level meeting in September at the beginning of each session of the Assembly.
- 34. The General Committee may wish to draw the attention of the General Assembly to paragraph 44 of resolution 72/313, in which the Assembly reiterated its invitation to the President of the General Assembly and the Chairs of the Main Committees, in consultation with the General Committee and Member States, as well as to the Secretary-General, to enhance the coordination of the scheduling of the meetings of the Assembly, including high-level meetings and high-level thematic debates, with a view to optimizing their interactivity, effectiveness and distribution throughout the session, and to consider ways to decrease the number of high-level events held during the general debate.

- 35. The General Committee may also wish to draw the attention of the General Assembly to paragraph 40 of resolution 72/313, in which the Assembly decided to continue to consider ways to rationalize the number of side events held during the high-level segment of the general debate, bearing in mind the need to enhance its decorum and significance, and encouraged the scheduling of side events at United Nations Headquarters outside of the hours when the general debate is being held.
- 36. The General Committee may further wish to draw the attention of the General Assembly to the fact that, in accordance with past practice, the Assembly holds a single debate on the items on its agenda, and that a specific mandate from the Assembly is needed for any additional debates.

F. General debate

- 37. The General Committee may wish to bring to the attention of the General Assembly that, pursuant to resolution 57/301, the general debate for the seventy-third session shall begin at 9 a.m. on Tuesday, 25 September 2018. The Secretary-General recommends that the general debate continue on Saturday, 29 September, in order to maximize the number of speakers during that week. The general debate will continue on Monday, 1 October. The General Committee may also wish to bring to the attention of the Assembly that the list of speakers for each day shall be completed and no speakers will be transferred to the next day, notwithstanding the implications for hours of work. Furthermore, there shall be no time limits for statements in the general debate but the Assembly will indicate a voluntary guideline of up to 15 minutes for each statement.
- 38. The General Committee may also wish to bring to the attention of the General Assembly that, pursuant to paragraph 7 of the annex to resolution 58/126, the theme "Making the United Nations relevant to all people: global leadership and shared responsibilities for peaceful, equitable and sustainable societies" has been proposed for the general debate at the seventy-third session.
- 39. The General Committee may wish to bring to the attention of the General Assembly that, pursuant to paragraphs 4 and 10 of resolution 51/241 and as at previous sessions, the Secretary-General wishes to make a brief presentation of his annual report⁵ as the first item in the morning prior to the opening of the general debate on Tuesday, 25 September 2018.
- 40. The General Committee may wish to draw the attention of the General Assembly to paragraph 15 of resolution 72/313, in which the Assembly recommended that, unless decided otherwise, no other agenda items should be opened during the dates allocated for the general debate.

G. Conduct of meetings, length of statements, explanations of vote, right of reply, points of order and concluding statements

- 41. The General Committee may wish to draw the attention of the General Assembly to the relevant rules of procedure regarding the conduct of meetings, namely, rules 35, 68, 72, 73, 99 (b), 106, 109, 114 and 115.
- 42. The General Committee may also wish to draw the attention of the General Assembly to paragraph 32 of resolution 71/323 and paragraph 34 of resolution 72/313, in which the Assembly recalled rule 72 of the rules of procedure of the General Assembly and called for strict adherence by each speaker to the time limits

- in the Assembly, where applicable, and in particular during the general debate, the high-level meetings of the Assembly and the high-level thematic debates convened by the President of the General Assembly, bearing in mind that all speakers shall get the same opportunity to deliver their statements within the allocated time limit, as set out in the rules of procedure of the Assembly.
- 43. The General Committee may further wish to bring to the attention of the General Assembly that, in accordance with past practice, the format of debates in plenary should include statements, as applicable, by the President of the General Assembly, the Secretary-General, Member States and observers, unless otherwise mandated by the Assembly; that each delegation makes no more than one statement in a debate, delivered by no more than one accredited representative physically present in the General Assembly Hall (and not with a video recording or screen-projected presentation), unless otherwise mandated by the Assembly; that the introduction of a draft resolution or decision is to be made by no more than one delegation; that the consideration of draft proposals would take place following the conclusion of the debate; and that, after action on a draft resolution or decision, and besides statements in explanation of vote after the vote, "statements after adoption" are permitted only at the President's discretion.
- 44. The General Committee may wish to draw the attention of the General Assembly to paragraph 35 of resolution 72/313, in which the Assembly reiterated its invitation to the Chairs of meetings of the General Assembly, especially when there is very limited time available for debate, to consider recommending the "all protocol observed" principle, whereby participants are encouraged to refrain from listing standard protocol expressions during their statements.
- 45. The General Committee may also wish to draw the attention of the General Assembly to paragraph 38 of resolution 72/313, in which the Assembly urged all presiding officers and Member States to strictly adhere to the scheduled starting time of meetings of the Assembly and its subsidiary bodies.
- 46. The General Committee may further wish to draw the attention of the General Assembly to paragraph 39 of resolution 72/313, in which the Assembly called upon all officers chairing or facilitating intergovernmental processes to seek to conduct informal negotiations during regular working hours, in order to allow for the active and constructive participation of all Permanent Missions in the work of the United Nations.
- 47. The General Committee may wish to bring to the attention of the General Assembly that explanations of vote should be limited to 10 minutes; that, when the same draft resolution is considered in a Main Committee and in plenary meeting, a delegation should, as far as possible, explain its vote only once, that is, either in the Committee or in the plenary meeting, unless that delegation's vote in the plenary meeting is different from its vote in the Committee; and that delegations should exercise their right of reply at the end of the day whenever two meetings have been scheduled for that day and whenever such meetings are devoted to the consideration of the same item (decision 34/401, paras. 6–8 (A/520/Rev.18, annex V)).
- 48. The General Committee may also wish to recommend to the General Assembly that points of order be limited to five minutes.
- 49. The General Committee may further wish to recommend to the General Assembly that, in order to save time at the end of the session, the practice of making concluding statements in the Assembly and its Main Committees should be dispensed with except for statements by the presiding officers (decision 34/401, para. 17 (A/520/Rev.18, annex V)).
- 50. The General Committee may wish to draw the attention of the General Assembly to resolution 59/313, in which the Assembly invited Member States that are aligned

with statements already made by the Chair of a group of Member States, where possible, to focus additional interventions that they make in their national capacity on points that have not already been adequately addressed in the statements of the group in question, bearing in mind the sovereign right of each Member State to express its national position.

- 51. The General Committee may also wish to draw the attention of the General Assembly to the fact that the voting results are final once the voting process has concluded in the Assembly. Delegations may submit voting intention forms provided by the Secretariat in order to clarify their voting intentions, which will be further reflected in the official records of the meetings.
- 52. The General Committee may further wish to draw the attention of the General Assembly to the fact that, once the Assembly adopts a draft resolution or decision, Member States can no longer join in sponsoring it. Likewise, when a Main Committee has adopted a proposal and recommends its adoption by the Assembly, Member States can no longer join in sponsoring that proposal.
- 53. The General Committee may wish to bring to the attention of the General Assembly paragraphs 47 and 48 of resolution 71/323, in which the Assembly decided that the names of candidates for election by the General Assembly or by the Main Committees shall be communicated to the Secretariat, where possible, at least 48 hours prior to an election unless otherwise required by specific rules governing the elections concerned, and that those names shall be printed on the ballot papers, while additional space shall be provided on the ballot paper for inscribing other names, where applicable; and that on the day of election in the General Assembly or in the Main Committees the campaign materials distributed in the General Assembly Hall or in the Committee meeting room shall be limited to a single page of information regarding the candidates, with a view to preserving the decorum of the Assembly.
- 54. The General Committee may also wish to bring to the attention of the General Assembly paragraph 53 of resolution 72/313, in which the Assembly requested the continuation of the practice implemented during the secret vote counting procedure, whereby no use of mobile phones or/and other electronic communication devices is permitted in the room where counting is being conducted, thus ensuring the confidentiality of elections and integrity of secret ballots.

H. Records of meetings

- 55. The Secretary-General wishes to recall that, as at past sessions, during the seventy-third session, verbatim records will continue to be provided for the plenary meetings of the General Assembly and the meetings of the First Committee, and summary records will be provided for the other Main Committees and the General Committee of the Assembly pursuant to resolution 49/221 B (annex, paras. 1–2). In paragraph 76 of resolution 66/246, the Assembly stressed the importance of an open, transparent and all-inclusive United Nations, and decided to approve the live webcasting, and subsequent web storage, of all the formal meetings of its six Main Committees. The Department of Public Information provides webcast coverage of formal (numbered) plenary meetings and plenary segments of meetings convened by the President of the General Assembly that are held in public. Other meetings of the Assembly are not automatically covered by webcast. However, if requested, the Department could provide additional webcast coverage of a meeting on a cost-recovery basis. The 2018 cost-recovery rates are \$232 for up to three hours of coverage during working hours.
- 56. Furthermore, the General Committee may wish to bring to the attention of the General Assembly that the practice of reproducing statements in extenso as separate

documents has been discontinued for all its subsidiary organs that are entitled to summary records and that any exceptions to this rule may be made by the body concerned only if the statements are to serve as bases for discussion and if, after hearing a statement of the relevant financial implications, the body decides that one or more statements in extenso may be included in the summary record, or reproduced as separate documents or as annexes to authorized documents (resolution 38/32 E, paras. 8–9).

- 57. The General Committee may wish to recommend to the General Assembly that the practice of not reproducing in extenso statements made in a Main Committee be maintained for the seventy-third session.
- 58. The General Committee may also wish to bring to the attention of the General Assembly that members who wish to make observations in the nature of rights of reply to addresses by Heads of State should submit their observations in writing for circulation as an Assembly document. At the 2377th meeting of the thirtieth session of the Assembly, in 1975, the President indicated that he did not consider it appropriate for oral rights of reply to be exercised in relation to addresses made by Heads of State. He further indicated that he would see no objection to observations in the nature of rights of reply to such addresses when made in writing. This has become a practice of the Assembly.

I. Resolutions

- 59. The General Committee may wish to bring to the attention of the General Assembly that:
 - Whenever possible, resolutions requesting the discussion of a question at a subsequent session should not call for the inclusion of a separate new item and such discussion should be held under the item under which the resolution was adopted (decision 34/401, para. 32 (A/520/Rev.18, annex V))
 - Efforts should be made to reduce the number of resolutions adopted by the General Assembly. Resolutions should request reports of the Secretary-General only in cases where that would be indispensable for facilitating the implementation of those resolutions or the continued examination of the question⁶
 - In order to ensure that resolutions have greater political impact, they should be short, in particular as regards the preambular part, and should focus more on action-oriented operative paragraphs (resolution 57/270 B, para. 69)
 - Whenever possible, for the adoption by the General Assembly of agreed texts of resolutions and decisions, informal consultations should be carried out with the widest possible participation of Member States (resolution 45/45, annex, para. 1 (A/520/Rev.18, annex VII, para. 1))
 - The terms "takes note of" and "notes" are neutral terms that constitute neither approval nor disapproval (decision 55/488, annex)
- 60. The General Committee may also wish to bring to the attention of the General Assembly paragraph 23 of the annex to resolution 60/286, in which the Assembly encouraged Member States to submit draft resolutions in a more concise, focused and action-oriented form, and paragraph 21 of resolution 66/294, in which the Assembly encouraged Member States, United Nations bodies and the Secretariat to continue to consult on the consolidation of documentation in order to avoid duplication of work,

to exercise the fullest possible discipline in striving for concise resolutions, reports and other documentation, inter alia, by referring to previous documents rather than repeating actual content, and to focus on key themes, and called upon them to observe existing submission deadlines so as to allow for the timely processing of documents to be examined by intergovernmental bodies.

- 61. The Secretary-General encourages Member States to transmit all draft resolutions and decisions in accordance with the guidelines for submission outlined by the Secretariat.⁷
- 62. The General Committee may wish to bring to the attention of the General Assembly that the numbering of resolutions and decisions are sequential, and that resolutions or decisions containing identical titles will be assigned identical symbols followed by a letter designation (e.g. "A" and "B").

J. Documentation

- 63. The General Committee may wish to bring to the attention of the General Assembly that the Assembly, including its Main Committees, should merely take note of those reports of the Secretary-General or subsidiary organs that do not require a decision by the Assembly and should neither debate nor adopt resolutions on them, unless specifically requested to do so by the Secretary-General or the organ concerned (decision 34/401, para. 28 (A/520/Rev.18, annex V)).
- 64. The General Committee may wish to draw the attention of the General Assembly to section III of resolution 57/283 B regarding the timely issuance of documents in the six official languages of the Assembly. The General Committee may also wish to draw the attention of the Assembly to resolution 59/313, in which the Assembly requested the Secretary-General to ensure that documentation and reports are issued well in advance, in keeping with the 6-week rule for the issuance of official documentation simultaneously in all official languages, and resolution 47/202, in which the Assembly urged the substantive departments of the Secretariat to comply with the rule which required them to submit pre-session documents to the Office of Conference Services at least 10 weeks before the beginning of sessions, in order to permit processing in time in all official languages.
- 65. The General Committee may also wish to draw the attention of the General Assembly to resolutions 48/264 and 55/285, in which the Assembly emphasized that restraint should be exercised in making requests for new reports and requested more integrated reports, and to resolution 57/270 B, in which it recognized the need to avoid requesting duplicative reports from the Secretary-General.
- 66. The General Committee may further wish to draw the attention of the General Assembly to resolution 67/297, in which the Assembly encouraged Member States, United Nations bodies and the Secretariat to continue to consult on the consolidation of documentation in order to avoid duplication of work, to exercise the fullest possible discipline in striving for concise resolutions, reports and other documentation, inter alia, by referring to previous documents rather than repeating actual content, and to focus on key themes, and called upon them to observe existing submission deadlines in order to allow for the timely processing of documents to be examined by intergovernmental bodies.
- 67. The General Committee may wish to draw the attention of the General Assembly to paragraphs 36, 45 and 54 of resolution 72/313, in which the Assembly encouraged Member States to make, to the extent possible, full use of the e-services provided by

the Secretariat, in order to save costs and reduce the environmental impact and improve the distribution of documents, and, in that regard, requested the Secretariat to further improve, harmonize and, where appropriate, unify such services, under eDelegate, including the continuation of the practice of making available all official correspondence of the United Nations addressed to the Member States; requested the Secretariat to ensure the availability through the eDelegate portal of provisional lists of speakers at United Nations meetings and conferences not later than by the end of the business day preceding the relevant meeting or conference; and requested the President of the General Assembly, in order to enhance transparency, to continue attaching the list of speakers at high-level thematic debates organized by the President to the summary of those events.

- 68. The General Committee may wish to bring the following to the attention of the General Assembly:
 - Resolutions should contain requests for observations from States or reports by the Secretary-General insofar as they are likely to facilitate the implementation of the resolutions or the continued examination of the question (resolution 45/45, annex, para. 10 (A/520/Rev.18, annex VII, para. 10))
 - Documents originating in the Secretariat should be no longer than 16 pages (8,500 words) (resolution 52/214 B, para. 4) and all intergovernmental bodies are invited to consider, where appropriate, the possibility of further reducing the length of their reports from 32 pages to 20 pages (10,700 words) without adversely affecting either the quality of presentation or the content of the reports (resolution 53/208 B, para. 15)
 - Member States and entities of the United Nations system should make a serious effort to submit their replies and inputs to requests for information or views pursuant to resolutions of the General Assembly within the prescribed deadlines (resolution 55/285, annex, para. 17)
 - Member States, when seeking additional information, are encouraged to request that they be provided with the information either orally or, if in writing, in the form of information sheets, annexes, tables and the like (resolution 59/313, para. 17)
- 69. The General Committee may wish to bring to the attention of the General Assembly that, pursuant to section IV, paragraph 21, of resolution 67/237, the Department for General Assembly and Conference Management will continue to offer paper-smart services as an additional support to delegations during the seventy-third session.

K. Questions relating to the programme budget

70. The General Committee may wish to draw the attention of the General Assembly to rule 153 of the rules of procedure, which reads:

No resolution involving expenditure shall be recommended by a committee for approval by the General Assembly unless it is accompanied by an estimate of expenditures prepared by the Secretary-General. No resolution in respect of which expenditures are anticipated by the Secretary-General shall be voted by the General Assembly until the Administrative and Budgetary Committee (Fifth Committee) has had an opportunity of stating the effect of the proposal upon the budget estimates of the United Nations.

71. Pursuant to rule 153 of the rules of procedure, the Secretariat considers the financial implications of all draft resolutions and decisions of the General Assembly

and its subsidiary organs. This process begins once the draft is submitted for issuance as a document of the Assembly. Until then, the Secretariat is not in a position to provide any official view as to whether a draft resolution or decision will have financial implications.

- 72. The General Committee may also wish to bring to the attention of the General Assembly that, in accordance with rule 153 of the rules of procedure, the consideration by the Administrative and Budgetary Committee (Fifth Committee) of any proposal involving expenditure before such a proposal is voted on by the Assembly is mandatory and the rule as formulated does not provide for any exceptions.
- 73. The General Committee may further wish to draw the attention of the General Assembly to the need for initiators of proposals with budgetary implications to clarify a timetable at an early stage with the Chair of the Administrative and Budgetary Committee (Fifth Committee) and the Chair of the Advisory Committee on Administrative and Budgetary Questions, in order to ensure full compliance with rule 153.
- 74. Also with regard to rule 153 of the rules of procedure, and paragraph 13 (d) of decision 34/401, which requires a minimum period of 48 hours before action is taken on a proposal so as to allow the Secretary-General to prepare the programme budget implications of proposals before the Assembly, the General Committee may wish to bring to the attention of the Assembly the fact that, in most cases, more than 48 hours are required for the Secretary-General to review the programme budget implications of proposals before the Assembly.
- 75. The General Committee may also wish to bring to the attention of the General Assembly paragraph 31 of resolution 71/323, in which the Assembly recalled rules 153 and 154 of the rules of procedure of the General Assembly and encouraged the Chairs of the Main Committees and the Secretary-General to ensure observance of those rules, within their respective mandates.
- 76. The General Committee may wish to draw the attention of the General Assembly to paragraphs 12 and 13 of decision 34/401 (A/520/Rev.18, annex V), which read:
 - 12. It is imperative that Main Committees should allow sufficient time for the preparation of the estimate of expenditures by the Secretariat and for its consideration by the Advisory Committee on Administrative and Budgetary Questions and the Fifth Committee and that they should take this requirement into account when they adopt their programme of work.

13. Furthermore:

- (a) A mandatory deadline, not later than 1 December, should be established for the submission to the Fifth Committee of all draft resolutions with financial implications;
- (b) The Fifth Committee should, as a general practice, consider accepting without debate the recommendations of the Advisory Committee on Administrative and Budgetary Questions on the financial implications of draft resolutions up to a prescribed limit, namely \$25,000 on any one item;
- (c) Firm deadlines should be set for the early submission of the reports of subsidiary organs which require consideration by the Fifth Committee;
- (d) A minimum period of 48 hours should be allowed between the submission and the voting of a proposal involving expenditure in order to allow the Secretary-General to prepare and present the related statement of administrative and financial implications.

77. The General Committee may also wish to draw the attention of the General Assembly to regulation 5.9 of the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation (ST/SGB/2018/3; first adopted in resolution 37/234, annex; the rules in the current revised edition are issued pursuant to resolution 72/9), as well as to Assembly resolution 54/236 and its decision 54/474. Regulation 5.9 reads:

Regulation 5.9. No council, commission or other competent body shall take a decision involving either a change in the programme budget approved by the General Assembly or the possible requirement of expenditure unless it has received and taken account of a report from the Secretary-General on the programme budget implications of the proposal.

78. Furthermore, the General Committee may wish to draw the attention of the General Assembly to paragraph 6 of its resolution 35/10 A, in which the Assembly:

Decides that all proposals affecting the schedule of conferences and meetings made at sessions of the General Assembly shall be reviewed by the Committee on Conferences when administrative implications are being considered under the requirements of rule 153 of the rules of procedure of the Assembly.

- 79. The General Committee may also wish to draw the attention of the General Assembly to section VI of its resolution 45/248 B on procedures for administrative and budgetary matters, in which the Assembly:
 - 1. Reaffirms that the Fifth Committee is the appropriate Main Committee of the General Assembly entrusted with responsibilities for administrative and budgetary matters;
 - 2. Reaffirms also the role of the Advisory Committee on Administrative and Budgetary Questions;
 - 3. Expresses its concern at the tendency of its substantive Committees and other intergovernmental bodies to involve themselves in administrative and budgetary matters;
 - 4. *Invites* the Secretary-General to provide all intergovernmental bodies with the required information regarding procedures for administrative and budgetary matters.
- 80. The General Committee may further wish to draw the attention of the General Assembly to the oral statement of programme budget implications read by the Secretariat prior to the consideration of a proposal containing budgetary implications that would have an impact on future budget periods and that would be included in the proposed programme budget or that would be funded from extrabudgetary resources.
- 81. The General Committee may wish to draw the attention of the General Assembly to the views expressed by the Advisory Committee on Administrative and Budgetary Questions on the use of the phrase "within existing resources" and to the report in which the Committee emphasized the responsibility of the Secretariat to inform the Assembly thoroughly and accurately about whether there are enough resources to implement a new activity. 9
- 82. The General Committee may wish to bring to the attention of the General Assembly that, pursuant to paragraph 5 of resolution 40/243, United Nations bodies may hold sessions away from their established headquarters when a Government

issuing an invitation for a session to be held within its territory has agreed to defray, after consultation with the Secretary-General as to their nature and possible extent, the actual additional costs directly or indirectly involved. The methods of budgeting these costs should be improved so as to ensure that all additional costs are accounted for. ¹⁰

- 83. The General Committee may also wish to bring to the attention of the General Assembly that all activities related to international conventions or treaties that, under their respective legal arrangements, ought to be financed outside the regular budget of the United Nations, may be undertaken by the Secretariat only when sufficient funding is received, in advance, from States parties and States not parties participating in the meetings.
- 84. The General Committee may wish to draw the attention of the General Assembly to the provision contained in paragraph 11 of resolution 69/250, in which the Assembly invited Member States to include in new legislative mandates adequate information on the modalities for the organization of conferences or meetings.
- 85. The General Committee may also wish to draw the attention of the General Assembly to the estimated conference servicing-related costs of convening an additional two meetings of up to three hours each in length during working hours, which are \$11,900, and during weekends, which are \$37,195 on a Saturday and \$37,627 on a Sunday, 11 and that those costs do not include additional services relating to substantive support by a Secretariat office, webcast services or costs relating to the holding of meetings outside working hours, among others.
- 86. The General Committee may further wish to draw the attention of the General Assembly to the estimated costs relating to the issuance of an additional report or note by the Secretariat not exceeding 8,500 words in length when originating in the Secretariat or 10,700 words when not originating in the Secretariat, which are \$27,800 for 8,500 words and \$34,800 for 10,700 words, 11 and that those costs relate to the editing, translation and issuance of the document and do not include additional services relating to substantive support in the drafting of its content.

L. Observances and commemorative meetings

- 87. Considering past practice, the General Committee may wish to recommend to the General Assembly that it adopt a format for commemorative meetings that includes statements by the President of the General Assembly, the Secretary-General, the Chairs of the five regional groups and the representative of the host country.
- 88. The General Committee may wish to draw the attention of the General Assembly to the practice of the Assembly to hold a formal plenary meeting to pay tribute to the memory of a deceased national leader who was the sitting Head of State at the time of death. In the case of the passing of a former Head of State, there is no such formal plenary meeting.

- 90. In addition, the General Assembly, by its decision 72/567, decided to include in the draft agenda of the seventy-third session the sub-item entitled "Strengthening the role of mediation in the peaceful settlement of disputes, conflict prevention and resolution" of the item entitled "Prevention of armed conflict". By its decision 72/568, the Assembly decided to include in the draft agenda of the seventy-third session the item entitled "Zone of peace and cooperation of the South Atlantic". By its decision 72/571, the Assembly decided to include in the draft agenda of the seventy-third session the item entitled "Request for an advisory opinion of the International Court of Justice on the legal consequences of the separation of the Chagos Archipelago from Mauritius in 1965". The items thus proposed for inclusion are listed in the draft agenda, which appears in paragraph 95 below.
- 91. In paragraph 2 (a) of the annex to resolution 58/316, the General Assembly decided, inter alia, that the agenda of the Assembly should be organized under headings corresponding to the priorities of the Organization, as contained in each medium-term plan or in the strategic framework, as appropriate, with an additional heading for "Organizational, administrative and other matters", for the purpose of giving a sense of structure to the work of the Assembly. Since the fifty-ninth session, the agenda of the General Assembly has been structured accordingly.
- 92. The Secretary-General wishes to recall the relevant resolutions pertaining to the review and coordination of the agenda, namely, annex I to resolution 48/264, the annex to resolution 51/241, the annex to resolution 55/285, paragraph 60 of resolution 57/270 B, and paragraphs 2 and 4 of the annex to resolution 58/316.
- 93. Bearing in mind the extremely heavy workload of the General Assembly and the need to make the most effective use of scarce resources, the General Committee may wish to consider deferring to a later session items for which decisions or action are not required at the current session (resolution 51/241, annex, paras. 23–26).
- 94. The Secretary-General wishes to draw the attention of the General Committee to decision 49/426, whereby the General Assembly decided that the granting of observer status in the Assembly should in future be confined to States and to those intergovernmental organizations whose activities cover matters of interest to the Assembly (see also para. 98).
