

Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects

Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects

Note by the Secretariat concerning the responsibilities entrusted to the Secretary-General under draft resolution A/C.1/55/L.50

- 1. Under the terms of operative paragraphs 4, 5, 7 and 8 of draft resolution A/C.1/55/L.50, the General Assembly would:
- (a) Recall the decision of the States parties to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects to convene the next review conference not later than 2001, preceded by a preparatory committee, and recommend that the review conference be held in December 2001 in Geneva;
- (b) Welcome the convening of the first Preparatory Committee for the Review Conference on 14 December 2000 in Geneva, and decide to convene the second Preparatory Committee from 2 to 6 April 2001 and the third Preparatory Committee from 24 to 28 September 2001;
- (c) Request the Secretary-General to render the necessary assistance and to provide such services, including summary records, as may be required for the second Review Conference of the States Parties to the Convention and its Preparatory Committee;
- (d) Also request the Secretary-General, in his capacity as depositary of the Convention and the Protocols thereto, to continue to inform the General Assembly periodically of the ratifications and acceptances of and accession to the Convention and its Protocols.

- 2. The requests contained in operative paragraphs 7 and 8 of the draft resolution are related to programme 26, Disarmament, of the medium-term plan for the period 1998-2001, as revised, and section 4, Disarmament, of the programme budget for the biennium 2000-2001.
- 3. No provision has been made under section 4, Disarmament, or section 2, General Assembly affairs and conference services, of the programme budget for the biennium 2000-2001 to cover the costs related to the activities required by operative paragraph 7 of the draft resolution. The costs related to activities associated with such meetings shall be met in accordance with the arrangements made by the States parties and no additional cost shall be borne by the regular budget of the United Nations.
- 4. Activities related to international conventions or treaties that, under their respective legal instruments, are to be financed outside the regular budget of the United Nations may be undertaken by the Secretariat only when sufficient funding is received, in advance, from the States parties. Furthermore, in accordance with established procedures, the United Nations would levy a charge at a rate of 13 per cent of expenditure for such activities, to defray the administrative and other support costs incurred in their implementation. Such expenses would also be borne by the States parties.
- 5. Should the General Assembly adopt draft resolution A/C.1/55/L.50, assistance from the Secretariat would be required for the convening of the second Review Conference and its Preparatory Committee. The related requirements are estimated as follows:
