The draft resolution provided a substantive framework for the consideration by the General Assembly of a timely response to the diverse challenges related to external debt sustainability and development in order to preclude the re-emergence of widespread debt crisis in developing countries.

The draft resolution aimed to create a platform for engagement in order to lay a solid foundation for future Economic and Social Council forums on that issue. The Group reasserted the need to strengthen the means of implementation and revitalize global partnerships for sustainable development as encapsulated in Goal 17 of the 2030 Agenda.

14. **Ms. Pamaranon** (Thailand), introducing draft resolution A/C.2/71/L.35 on behalf of the Group of 77 and China, said that the draft resolution had been based on the relevant report of the Economic and Social Commission for Western Asia (A/71/86-E/2016/13) which reflected the severely negative impacts on the socioeconomic condition of the Palestinian and Syrian people. It included updates of the current realities on the ground in the Occupied Palestinian territory, including East Jerusalem and the occupied Syrian Golan. The draft resolution reaffirmed the urgency of addressing the dire humanitarian crisis and advancing reconstruction in the Gaza Strip.
