### Implementation of the outcomes of the United Nations Conferences on Human Settlements and on Housing and Sustainable Urban Development and strengthening of the United Nations Human Settlements Programme (UN-Habitat)

*The General Assembly,*

*Recalling* its relevant resolutions on the implementation of the outcomes of the United Nations Conferences on Human Settlements (Habitat II) and on Housing and Sustainable Urban Development (Habitat III) and strengthening of the United Nations Human Settlements Programme (UN-Habitat), including its resolutions [32/162](#) of 19 December 1977, [56/206](#) of 21 December 2001, [65/165](#) of 20 December 2010, [66/207](#) of 22 December 2011, [67/216](#) of 21 December 2012, [68/239](#) of 27 December 2013, [69/226](#) of 19 December 2014, [70/210](#) of 22 December 2015, [71/235](#) of 21 December 2016 and [72/226](#) of 20 December 2017,

*Recalling also* its resolution [71/256](#) of 23 December 2016, entitled “New Urban Agenda”, in which it endorsed the New Urban Agenda, adopted by the United Nations Conference on Housing and Sustainable Urban Development (Habitat III), held in Quito from 17 to 20 October 2016, as contained in the annex to the above-mentioned resolution,

*Reaffirming* its resolution [70/1](#) of 25 September 2015, entitled “Transforming our world: the 2030 Agenda for Sustainable Development”, in which it adopted a comprehensive, far-reaching and people-centred set of universal and transformative Sustainable Development Goals and targets, its commitment to working tirelessly for the full implementation of the Agenda by 2030, its recognition that eradicating poverty in all its forms and dimensions, including extreme poverty, is the greatest global challenge and an indispensable requirement for sustainable development, its commitment to achieving sustainable development in its three dimensions — economic, social and environmental — in a balanced and integrated manner and to

building upon the achievements of the Millennium Development Goals and seeking to address their unfinished business,

*Reaffirming also* its resolution 69/313 of 27 July 2015 on the Addis Ababa Action Agenda of the Third International Conference on Financing for Development, which is an integral part of the 2030 Agenda for Sustainable Development, supports and complements it, helps to contextualize its means of implementation targets with concrete policies and actions and reaffirms the strong political commitment to address the challenge of financing and creating an enabling environment at all levels for sustainable development in the spirit of global partnership and solidarity,

*Reaffirming further* the Paris Agreement,<sup>1</sup> and encouraging all its parties to fully implement the Agreement, and parties to the United Nations Framework Convention on Climate Change<sup>2</sup> that have not yet done so to deposit their instruments of ratification, acceptance, approval or accession, where appropriate, as soon as possible,

*Reiterating* the 2030 Agenda for Sustainable Development pledge that no one will be left behind, reaffirming the recognition that the dignity of the human person is fundamental, and the wish to see the Goals and targets met for all nations and peoples and for all segments of society, and recommitting to endeavour to reach the furthest behind first,

*Recommitting* to ensuring that no country or person is left behind and to focusing our effort where the challenges are greatest, including by ensuring the inclusion and participation of those who are furthest behind,

*Noting* that the Sendai Framework for Disaster Risk Reduction 2015–2030<sup>3</sup> can contribute to the implementation of the New Urban Agenda,

*Reaffirming* the role and expertise of UN-Habitat, given its role within the United Nations system as a focal point on sustainable urbanization and human settlements, including in the implementation, follow-up to and review of the New Urban Agenda, in collaboration with other United Nations system entities,

*Reiterating* that the implementation of the New Urban Agenda contributes to the implementation and localization of the 2030 Agenda for Sustainable Development in an integrated and coordinated manner at the global, regional, national, subnational and local levels, with the participation of all relevant stakeholders,

*Reiterating also* its recognition that, over the years, the responsibilities of UN-Habitat have changed considerably in their scope and complexity,

*Recalling* UN-Habitat Governing Council resolution 26/8 of 12 May 2017, entitled “Promoting the effective implementation, follow-up to and review of the New Urban Agenda”,<sup>4</sup>

*Recalling also* the report of the Secretary-General’s High-level Independent Panel to Assess and Enhance the Effectiveness of UN-Habitat,<sup>5</sup>

*Recalling further* the high-level meeting of the General Assembly, at its seventy-first session, on the effective implementation of the New Urban Agenda and the

positioning of UN-Habitat in that regard and the summary of that meeting prepared by the President of the General Assembly,

*Reaffirming* the commitments on means of implementation included in the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda of the Third International Conference on Financing for Development,

*Acknowledging* the key role of national, subnational and local governments in the implementation of the New Urban Agenda, throughout the process, including policymaking, planning, design, implementation, operation and maintenance, monitoring and evaluation, as well as the financing and timely delivery of services,

*Reemphasizing* that the effective implementation of the New Urban Agenda requires enabling policy frameworks at the global, regional, national, subnational and local levels and effective means of implementation, including finance, capacity-building, mutually beneficial partnerships and the development, dissemination and diffusion and transfer of environmentally sound technologies to developing countries on favourable terms, including on concessional and preferential terms, as mutually agreed,

*Reaffirming* the importance of accountability, transparency and improved results-based management and further harmonized results-based reporting for increasing the quantity and quality of funding for operational activities, while recognizing the need to ensure an adequate quantity and quality of funding for the operational and normative activities of UN-Habitat, including its core resources, and the need to make funding more predictable, efficient and effective,

*Recognizing* the need to strengthen States' ownership, leadership and oversight of UN-Habitat, and considering the findings and recommendations of the open-ended Working Group established by the Chair of the Committee of Permanent Representatives of UN-Habitat pursuant to General Assembly resolution [72/226](#), including the concerns raised by States regarding the recommended reporting procedures of the Executive Board during the years when the proposed UN-Habitat Assembly does not meet,

*Affirming* that the focus of the work of UN-Habitat, in line with the New Urban Agenda and the 2030 Agenda, should remain within the framework of sustainable development, with the eradication of poverty in all its forms and dimensions as its overarching objective,

*Taking note* of the report of the Secretary-General on the implementation of the outcomes of the United Nations Conferences on Human Settlements and on Housing and Sustainable Urban Development and strengthening of the United Nations Human Settlements Programme (UN-Habitat),<sup>6</sup>

*Recognizing* the World Urban Forum as the foremost global arena for interaction among policymakers, local government leaders, non-governmental stakeholders and expert practitioners in the field of human settlements, and expressing its appreciation to the Government of Malaysia and to the city of Kuala Lumpur for hosting the ninth session of the Forum from 7 to 13 February 2018, which was the first session to have a thematic focus on the implementation of the New Urban Agenda adopted at Habitat III,

## **Governance of UN-Habitat**

### 1. *Decides:*

(a) To strengthen the intergovernmental nature and structure of the United Nations Human Settlements Programme (UN-Habitat) as set out, without prejudice to

the concerns regarding the reporting procedures, in the findings and recommendations of the open-ended Working Group established by the Chair of the Committee of Permanent Representatives of UN-Habitat pursuant to General Assembly resolution [72/226](#);

(b) To establish a multi-tiered intergovernmental structure for UN-Habitat that shall provide overall normative and policy guidance to UN-Habitat and oversee the operational aspects of its work; the UN-Habitat governance structure shall be composed of the following: (i) the UN-Habitat Assembly, with universal membership; (ii) the Committee of Permanent Representatives, with universal membership; and (iii) the Executive Board, consisting of 36 members;

(c) That the UN-Habitat Assembly shall replace the UN-Habitat Governing Council as a subsidiary organ of the General Assembly;

(d) That the UN-Habitat Assembly shall meet in Nairobi, during a five-day period, every four years, to provide policy guidance on human settlements and sustainable urbanization and strategic oversight of UN-Habitat, and in this regard, in addition to the existing functions of the UN-Habitat Governing Council, the UN-Habitat Assembly shall, inter alia:

(i) Identify key issues and areas of focus for the normative, policy and operational work of UN-Habitat in the framework of sustainable development;

(ii) Review major trends related to human settlements and urbanization;

(iii) Examine global norms and standards in human settlements and sustainable urbanization;

(iv) Adopt resolutions, declarations, recommendations, formal decisions, reports and other documents pertaining to strategic vision and political guidance in accordance with its mandate;

(v) Recommend strategies for coherent implementation of the urban and human settlements dimensions of the 2030 Agenda, the New Urban Agenda and other global agendas of the United Nations system;

(vi) Examine and approve the strategic plan of UN-Habitat, to be submitted by the Executive Board;

(vii) Review the Secretary-General's quadrennial report on the implementation of the New Urban Agenda;

(viii) Deliberate on and approve its rules of procedure and those of its subsidiary bodies;

(ix) Create other mechanisms, as deemed necessary, to facilitate its work;

(e) That the UN-Habitat Assembly shall report every four years on its work, to the General Assembly, through the Economic and Social Council at its substantive session;

(f) That the UN-Habitat Assembly, at its first session, shall establish an Executive Board comprising 36 members, to be elected by the UN-Habitat Assembly according to equitable geographical representation, following the formula established for the current UN-Habitat Governing Council<sup>7</sup> and the mandate as set out in the findings and recommendations of the open-ended Working Group, with the objectives

of increasing States' oversight of the operations of UN-Habitat and of strengthening the Organization's transparency, accountability, efficiency and effectiveness, as well as providing greater efficiency in decision-making, building trust and attracting sufficient, sustainable and predictable funding;

(g) That the Executive Board shall report to the UN-Habitat Assembly and that, when the latter is not in session, the Executive Board shall report to the Committee of Permanent Representatives, as appropriate, and submit periodic reports to the General Assembly through the Committee of Permanent Representatives and the Economic and Social Council at its substantive sessions on questions that fall within the Board's mandate;

2. *Emphasizes* that States that are not members of the Executive Board may participate in the deliberations as observers to Board meetings, through their permanent missions in Nairobi or otherwise;

3. *Also emphasizes* that representatives of specialized agencies as well as funds and programmes of the United Nations system may participate in the deliberations as observers to Board meetings;

4. *Decides* to strengthen the role of the Committee of Permanent Representatives in order to preserve the intergovernmental nature of UN-Habitat, and in that regard also decides that the Committee of Permanent Representatives shall convene in Nairobi, unless otherwise agreed, at least twice a year, when the Assembly is not in session to consider, as appropriate, the report of the Executive Board;

5. *Also decides* that the Committee of Permanent Representatives shall report to the UN-Habitat Assembly and shall convene in Nairobi, in an open-ended manner, prior to the Assembly for preparation of the session of the Assembly and for a high-level midterm review meeting;

6. *Further decides* that the UN-Habitat Assembly, with the objective of ensuring consistency in its overall policy guidance, shall establish clear and effective linkages between the Committee of Permanent Representatives and the Executive Board;

#### **Ensuring adequate funding and improving information to monitor funding trends**

7. *Decides* that the additional financial resources required, including to service the new intergovernmental governance processes of UN-Habitat, shall be funded from the regular budget and approved by the General Assembly;

8. *Requests* the Secretary-General to submit to the General Assembly for its approval during the main part of its seventy-third session a report containing a revised proposal on regular budget resources approved for the biennium 2018–2019 for the intergovernmental governance of UN-Habitat, in accordance with all relevant United Nations rules and regulations;

9. *Requests* the Executive Director of UN-Habitat to submit to the UN-Habitat Assembly, at its first session, a draft strategic plan, for the Assembly's approval;

10. *Requests* the UN-Habitat Assembly to ensure that the Executive Director of UN-Habitat submits to the UN-Habitat Executive Board, at its first session, a draft work programme and budget for 2020, including an organization chart, for the Board's approval;

11. *Invites* Member States, international and bilateral donors and financial institutions to contribute to UN-Habitat through increased voluntary non-earmarked

financial contributions to the United Nations Habitat and Human Settlements Foundation, including the urban basic services trust fund and other technical cooperation trust funds, invites Governments in a position to do so and other stakeholders to provide predictable multi-year funding and increased non-earmarked contributions to support the implementation of its mandate, and requests the Executive Director of UN-Habitat to ensure that reporting on funding is transparent and easily accessible to Member States, including through the creation of an online registry that contains relevant financial information;

12. *Urges* all Member States making financial contributions earmarked for the operational activities of UN-Habitat to ensure that such resources are fully aligned with the strategic plan of UN-Habitat and are in accordance with the priorities of Member States benefiting from those contributions;

### **Accelerating the implementation of the New Urban Agenda to achieve the Sustainable Development Goals**

13. *Reaffirms* that, by readdressing the way cities and human settlements are planned, designed, financed, developed, governed and managed, the New Urban Agenda will help to end poverty and hunger in all its forms and dimensions, reduce inequalities, promote sustained, inclusive and sustainable economic growth, achieve gender equality and the empowerment of all women and girls in order to fully harness their vital contribution to sustainable development, improve human health and well-being, foster resilience and protect the environment;

14. *Acknowledges* the central role that cities and human settlements can play in sustainable development, and urges UN-Habitat to further support increased participation of governments at all levels and regional organizations in the implementation of the New Urban Agenda and the Sustainable Development Goals relevant to cities and other human settlements, in particular by providing technical assistance aimed at developing the capacity of all levels of governments, especially in developing countries to plan and implement sustainable urbanization and human settlements programmes and projects;

15. *Recognizes* the importance of the implementation of the New Urban Agenda at the national, subnational, local, regional and global levels, taking into account different national realities, capacities and levels of development and respecting national legislation and practices, as well as policies and priorities;

16. *Urges* UN-Habitat to continue developing innovative methods, approaches and guidelines for data collection, analysis, and monitoring and implementation with the objective of supporting Member States, especially developing countries, when needed, in dealing with emerging urban challenges and opportunities;

17. *Also urges* UN-Habitat to enhance the dissemination of evidence-based urbanization and human settlements development knowledge and to raise public awareness of critical, as well as emerging, urbanization and human settlements challenges and opportunities;

18. *Further urges* UN-Habitat to ensure that its normative and operational activities are balanced, that its normative work guides and is integrated into its operational work and that the experiences gathered in the operational field feed into its normative work;

19. *Encourages* UN-Habitat to continue working closely with other entities of the United Nations system, including the regional commissions, as key partners in reaching out to Member States in the regions for the effective implementation of the New Urban Agenda and the urban and human settlements dimensions of the 2030 Agenda;

20. *Calls upon* the relevant organizations of the United Nations system, within their respective mandates and resources, to ensure that no one is left behind and no country is left behind in the implementation of the present resolution;

21. *Encourages* UN-Habitat to continue its collaboration with international and regional development banks and the private sector to ensure coherence of policy support and the alignment of large-scale urban investments with the principles of the New Urban Agenda and to facilitate increased investment in sustainable urbanization;

#### **Review and implementation**

22. *Requests* the Secretary-General to establish a special voluntary trust fund for the purpose of assisting developing countries in attending UN-Habitat Assembly and Executive Board sessions, and invites States, international financial institutions, donor agencies, intergovernmental organizations, non-governmental organizations and natural and juridical persons to make financial contributions to the voluntary trust fund;

23. *Also requests* the Secretary-General to submit a progress report to the General Assembly at its seventy-fourth session on the implementation of the present resolution entitled “Follow-up to the implementation of the New Urban Agenda and strengthening of the United Nations Human Settlements Programme (UN-Habitat)”.
