Report of the Secretary-General

<u>Introduction</u>

1. The General Assembly, by its resolution 46/37 F of 9 December 1991, entitled "United Nations Regional Centre for Peace and Disarmament in Africa, United Nations Regional Centre for Peace and Disarmament in Asia and the Pacific and United Nations Regional Centre for Peace, Disarmament and Development in Latin America and the Caribbean", decided that, to ensure the continued financial viability of the regional centres, the administrative costs of the centres should be financed from the regular budget.

2. In connection with the adoption of that resolution, the Fifth Committee had before it the recommendation of the Advisory Committee on Administrative and Budgetary Questions (ACABQ) that the Secretary-General submit a detailed report to the Fifth Committee, providing, <u>inter alia</u>, a full disclosure of the financial position of each Centre, with supporting documentation, the proposed programme of work and a functional breakdown of all staff, whether administrative or operational.

3. At its 46th meeting, on 7 December 1991, the Fifth Committee decided to inform the General Assembly that the adoption of the resolution might require up to \$600,000 and that the actual additional appropriation would be reviewed as soon as possible during the forty-sixth session of the General Assembly. The Committee also informed the Assembly in its report 1/ that, bearing in mind the comments and observations of ACABQ and all the views expressed in the Fifth Committee, it would review the matter further in the light of the report to be submitted by the Secretary-General. The present report should have been submitted earlier pursuant to the recommendation of ACABQ during the forty-sixth session of the General Assembly.

Programme of work, estimates of 1993 requirements, functional breakdown of staff and financial position of each centre

4. In the face of improved international relations during the past few years, regional and subregional issues have acquired additional urgency and importance in the field of disarmament and security. The pursuit of regional solutions to regional problems is thus being actively encouraged by the international community. The regional centres, through their various activities, have contributed to that process. Due to the added prominence given to regional and subregional issues on the international agenda, it is expected that the role played by the regional centres will increase accordingly and thus the scope of their activities will expand further.

Since their inception in 1986, 1987 and 1988, in Lomé, Lima and Kathmandu 5. respectively, the regional centres have been devoting efforts, in accordance with their mandates, to promoting cooperation among the States in their respective regions with a view to facilitating the development of effective measures of confidence-building, arms limitation and disarmament. In this connection, the regional centres have carried out programmes of activities that focus on the organization of regional conferences, meetings and seminars to facilitate the exchange of ideas and information between the governmental and non-governmental sectors and between Government and academic experts, as a means of finding common ground and delineating areas of possible future negotiation and agreement. Their activities also include publishing and disseminating information on issues of peace, security and disarmament in the respective regions, conducting research and studies and providing information services to groups and individuals in both the governmental and the non-governmental sectors in the regions concerned.

6. The activities of the regional centres are made possible primarily through voluntary contributions from Member States. Full accounts of these activities are contained in the reports of the Secretary-General on the regional centres. 2/

7. A detailed account of the programmes of activities for 1992 and those proposed for 1993, as well as estimates of 1993 requirements, functional breakdown of staff and the financial positions of the regional centres follows. It is to be noted that not all of the activities projected for 1992

have been implemented, owing to the lack of sufficient resources from voluntary contributions. Part of the difficulty in raising funds through voluntary contributions is that, in many cases, potential donors have wished to see an infrastructure already in place at the respective centres before committing themselves to contributing to any project.

A. <u>United Nations Regional Centre for Peace and</u> <u>Disarmament in Africa</u>

<u>Activities</u>

- 1. Information materials and services
- (a) Published material
- (i) <u>The African Peace Bulletin</u> (four issues in 1992 (two completed) and four issues in 1993);
- (ii) <u>Study Series on African Security</u> (two issues per year, 1992 and 1993).
- (b) Information services
- (i) Improvement of the Centre's public library, which currently serves an average of 50 readers a month (ongoing);
- (ii) Establishment of a computerized database on security and peace issues in Africa (first half of 1993).
 - 2. Coordination, harmonization and liaison

 (a) International conference entitled "Communication and crises: the role of the media in the peaceful resolution of conflicts in Africa"
 (May 1992 completed);

 (b) Training programmes on conflict resolution, crisis prevention and management, and confidence-building among African States (one per year, 1992 and 1993);

(c) Seminar on confidence- and security-building measures in southern Africa (Windhoek, Namibia, February 1993);

(d) Seminar on security and the problem of refugees in East Africa and the Horn of Africa (Nairobi, June/July 1993);

(e) Research project:

Stage 1 Research phase (one in 1992 and two in 1993): research on the role of border problems in African peace and security (1992 completed);

> <u>Stage 2</u> Follow-up workshops (one in 1992 and two in 1993): international experts workshop on the role of border problems in African peace and security (March 1992 completed);

(f) Literary contest on peace and disarmament for high school and university students in Africa (June-October 1993);

(g) Various peace- and security-related activities in observance of Disarmament Week (1992 (completed) and 1993);

(h) Support and participation in relevant activities organized within the framework of the World Disarmament Campaign by Governments and non-governmental organizations in the region (ongoing).

Staffing and financial position

<u>Staffing</u>

To ensure its smooth and effective functioning and the efficient implementation of the above programme of activities, the Centre would require, in addition to the Director, the services of 10 locally recruited staff consisting of: (a) one research assistant; (b) one administrative assistant; (c) one bilingual secretary; (d) one receptionist/typist; (e) two drivers; and (f) four watchmen/cleaners (two each for the Centre and the Director's residence). In this connection, a provision of \$101,000 (based on the 1992 rate) would be required in 1993 under general temporary assistance to cover salary and common staff costs of 10 locally recruited staff.

General operating expenses

On the basis of the previous years, it is estimated that a provision of \$16,000 would be required for 1993 to cover the following costs:

(a) Overtime (\$1,000);

(b) Maintenance of the premises, including electricity and water (\$4,000);

(c) Maintenance of equipment, furniture and vehicles, including petrol
(\$3,000);

- (d) Communication (\$3,000);
- (e) Miscellaneous services (\$3,000);
- (f) Acquisition of supplies, equipment and furniture (\$2,000).

Status of the Trust Fund

Since the Centre's inception in 1986, its total income and total expenditure for the last three bienniums have amounted to \$1,652,900 and

\$1,549,400 respectively. The Trust Fund balance available at 31 December 1991 was \$103,500. A total of \$1,466,300 has been pledged to the Trust Fund and a total of \$1,469,100 has been received (the increase in the amount received is due to the fluctuation in exchange rates). Statements of income, expenditure and a detailed account of the status of pledges and actual contributions to the Trust Fund of the Centre for the bienniums 1990-1991, 1988-1989 and 1986-1987 appear in annexes I to IV respectively (it is to be noted, however, that pledges in the amount of \$100,000 in connection with the seminar on confidence- and security-building measures in southern Africa, to be held under the auspices of the Centre at Windhoek, Namibia, in February 1993, have not yet been recorded and are therefore not reflected in annex IV).

B. United Nations Regional Centre for Peace and Disarmament in Asia and the Pacific

The Regional Centre for Peace and Disarmament in Asia and the Pacific, which was initiated in 1989, is still by and large in its initial stage. Since 1989, the Centre has been temporarily housed in the United Nations Development Programme (UNDP) building in Kathmandu and, until 1 September 1992, the functions of its Director were entrusted, on an interim basis, to the resident representative of UNDP. Under the circumstances, the Centre has been operating on a limited scale. Since 1989, three regional meetings on various disarmament issues have been organized by the Centre and the Office for Disarmament Affairs in 1990, 1991 and 1992.

In section V of resolution 46/185 C, of 20 December 1991, the General Assembly decided to establish a P-5 post for the Director of the Regional Centre, effective 1 January 1992, on a temporary basis, subject to a review for the need to establish the post on a permanent basis for the next biennium. With the appointment of the Director a.i. by the Secretary-General on 1 September 1992, the Centre is expected to develop a more extensive programme of activities for 1993 and to operate on a consolidated and strengthened basis.

<u>Activities</u>

- 1. Information materials and services
- (a) Published material

Disarmament Bulletin (four issues per year, 1992 and 1993);

- (b) Information services
- (i) Establishment of a reference library to respond to inquiries and provide resource materials to groups and individuals in the region upon request (1993);

- (ii) Providing inquirers, including constituencies of the World Disarmament Campaign in the region, with United Nations disarmament-related information through, <u>inter alia</u>, the establishment of a link with the disarmament database of the Office for Disarmament Affairs (1993);
- (iii) Developing mailing lists of constituencies of the World Disarmament Campaign in the region (1993);
 - (iv) Annual observance of Disarmament Week by organizing exhibits and film-screening on issues related to peace and disarmament (1993).
 - 2. Coordination, harmonization and liaison

 (a) Regional conference on security and disarmament issues in the region (one in 1992 in Kathmandu (completed) and two in 1993, in Kathmandu and Kyoto, Japan);

 (b) Seminars/workshops organized in cooperation with various institutions in the region (one seminar in Nagasaki, Japan, 1993);

(c) Subregional studies and research projects related to disarmament and security, jointly conducted with interested institutes and Governments in the region (one or two per year, 1993).

Staffing and financial position

Staffing

With the appointment of the Director of the Centre in 1992, as indicated above, it is envisaged that the Centre's yearly programme of activities will gradually expand. In order to implement the activities successfully and to make the Centre fully operational, it is estimated that seven locally recruited staff would be required as of 1 January 1993: (a) one national officer; (b) one research assistant; (c) one secretary; (d) one librarian; (e) one driver; (f) one security guard; and (g) one cleaner. In this connection, general temporary requirements of \$19,000 (based on the 1992 rate) would be required in 1993 to cover salary and common staff costs of seven locally recruited staff.

General operating expenses

It is estimated that a provision of \$69,000 would be required for 1993, out of which \$25,000 is recurrent and \$44,000 non-recurrent, as follows:

- (a) Rental and maintenance of premises (\$15,000);
- (b) Maintenance of equipment, furniture and a vehicle (\$3,000);
- (c) Communication (\$4,000);

(d) Miscellaneous services (\$3,000);

(e) Non-recurrent provision of \$44,000 for the purchase of: (a) a vehicle (\$22,000); (b) a photocopier (\$5,000); (c) a fax machine (\$3,500);
(d) three typewriters (\$3,000); supplies (\$2,500); and (e) furniture (\$8,000).

Status of the Trust Fund

Since 1988, the total income and total expenditure of the Trust Fund for the Centre have amounted to \$340,900 and \$1,400 respectively. The Trust Fund balance available at 31 December 1991 amounted to \$339,500. An amount of \$825,706 has been pledged to the Trust Fund, including \$500,000 earmarked for the construction of the Centre's building. Statements of income, expenditure and a detailed account of the status of pledges and contributions to the Trust Fund of the Centre for the bienniums 1990-1991 and 1988-1989 appear respectively in annexes IX to XI (it is to be noted that approximately \$370,000 is expected to be made available for the holding, under the auspices of the Centre, of a regional conference on disarmament issues at Kyoto in April 1993).

C. United Nations Regional Centre for Peace, Disarmament and Development in Latin America and the Caribbean

<u>Activities</u>

- 1. Information materials and services
- (a) Published material
- (i) The <u>Boletín</u> (four issues in 1992 (completed) and four issues in 1993);
- (ii) Two publications on Latin American security problems (one in 1992 (completed) and one in 1993);
- (b) Information services
- Dissemination of publications produced by the Centre to addressees on its distribution list, including Governments and constituencies of the World Disarmament Campaign in the region (ongoing);
- (ii) Maintenance of the reference library to provide resource materials to constituencies of the World Disarmament Campaign and individuals in the region upon request (ongoing).
- 2. Coordination, harmonization and liaison

 (a) Two symposia organized in cooperation with various institutions in the region, to be hosted by the respective institutions (one per year, 1992 and 1993);

(b) Eight seminars organized and held at Lima (four in 1992 and four in 1993);

(c) Seminar on arms proliferation and confidence- and security-building measures in Latin America (18-20 January 1993, Asunción, Paraguay).

Staffing and financial position

Staffing

It is estimated that in order to discharge its mandates and to achieve greater effectiveness in the region, the Centre would need to maintain, in addition to the Director, five locally recruited staff, consisting of (a) one information/research assistant; (b) one secretary; (c) one driver; (d) one security guard; and (e) one cleaner. In this regard, a provision of \$58,500 (based on the 1992 rate) for 1993 would be required under general temporary assistance to cover salary and common staff costs of five locally recruited staff. It should be noted that staffing costs related to the driver, the security guard and the cleaner are proportionately shared between the Centre (30 per cent) and the United Nations information centre in Lima (70 per cent).

General operating expenses

It is estimated that a total provision of \$36,500 would be required in 1993 for general operating expenses, out of which \$24,000 is recurrent and \$12,500 non-recurrent, as follows:

(a) Overtime (\$1,000);

(b) Rental and maintenance of premises, including water and electricity (\$13,500);

(c) Maintenance of equipment, furniture and a vehicle, including petrol (\$2,000);

- (d) Communication (\$3,000);
- (e) Miscellaneous services (\$2,500);

(f) Acquisition of supplies, equipment and furniture (\$2,000 recurrent) and purchase of a vehicle (\$12,500 non-recurrent).

It should be noted that the costs for rental and maintenance of premises, including water and electricity, and maintenance of a vehicle, including petrol, are shared between the Centre and the United Nations information centre at Lima on the basis of 30 per cent for the Centre and 70 per cent for the United Nations information centre. With regard to the purchase of the vehicle, the amount indicated above represents a 50 per cent share for the Centre.

Status of the Trust Fund

Since the Centre's inception in 1987, the total income and total expenditure of its Trust Fund have amounted to \$169,800 and \$135,500 respectively. The Trust Fund balance available at 31 December 1991 was \$34,300. Pledges made to the Centre in 1987 have amounted to \$184,000, of which \$154,800 has been deposited into its account. Statements of income, expenditure and a detailed account of the status of pledges and actual contributions to the Trust Fund of the Centre for the bienniums 1990-1991, 1988-1989 and 1986-1987 appear in annexes VIII to XI respectively (it is to be noted, however, that a pledge of \$80,000 in connection with the seminar on arms proliferation and confidence- and security-building measures in Latin America to be held, under the auspices of the Centre, at Asunción, Paraguay, in January 1993, has not yet been recorded and is therefore not reflected in annex VIII).

D. Summary of estimated 1993 resource requirement

8. It is to be noted that an appropriation of \$506,900 relating to salaries and common staff costs of three P-5 posts for the Directors of the regional centres in Africa, Latin America and in Asia and the Pacific was authorized by the General Assembly under the programme budget for the current biennium. In order to cover the administrative costs of the centres outlined in sections A, B and C above, net additional requirements would arise as follows:

9. It is not anticipated that the cost of \$300,000 could be absorbed from within the provisions to be transferred to section 37 of the programme budget for the biennium 1992-1993. Accordingly, it is estimated that additional appropriations of \$300,000 would be required for 1993 under section 37 in connection with the implementation of General Assembly resolution 46/37 F.

10. It will be recalled that under the procedure established by the General Assembly in its resolution 41/213 of 19 December 1986, a contingency fund is established each biennium to accommodate additional expenditures derived from legislative mandates not provided for in the proposed programme budget. Under the same procedure, if additional expenditures are proposed that exceed resources available from the contingency fund, these activities can be implemented only through redeployment of resources available from the low-priority areas or modifications of existing activities. Otherwise, such additional activities will have to be deferred until a later biennium. A consolidated statement of all programme budget implications and revised estimates will be submitted to the General Assembly towards the end of the current session.

11. No activity has been identified for termination, deferral, curtailment or modification under section 37 of the programme budget for the biennium 1992-1993. Accordingly, should it not prove possible to meet the costs required from the contingency fund, the implementation of the resolution would have to be postponed, as provided for in the guidelines for the use of the contingency fund adopted by the General Assembly in the annex to resolution 42/211 of 21 December 1987.
