

#### Programme budget for the biennium 2002-2003

#### **Draft report of the Fifth Committee**

Rapporteur: Mr. Haile Selassie Getachew (Ethiopia)

#### I. Introduction

- 1. At its 19th plenary meeting, on 20 September 2002, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-seventh session the item entitled "Programme budget for the biennium 2002-2003" and to allocate it to the Fifth Committee.
- 2. The Fifth Committee considered the item at its 7th, 12th, 13th, 15th-18th, 20th, 24th-32nd, 35th, 37th and \_\_\_\_\_ meetings, on 14, 21, 22, 24, 25, 28 and 29 October, 4, 11, 12, 18, 21 and 27 November and 3, 6, 9, 10, 11, 12, 13 and \_\_ December 2002. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary records (A/C.5/57/SR.7, 12, 13, 15-18, 20, 24-32, 35, 37 and \_\_\_\_).
- 3. In accordance with the criteria for the use of the contingency fund annexed to General Assembly resolution 42/211 of 21 December 1987, the Committee, at its 37th meeting, on 13 December 2002, considered a consolidated statement of programme budget implications and revised estimates that were subject to the criteria for the use of the contingency fund (A/C.5/57/33). The consolidated amount fell within the available balance of the contingency fund. The Committee therefore proceeded to approve the required amounts under the relevant sections of the programme budget.
- 4. Section II of the present report provides a summary of the recommendations made by the Fifth Committee during the fifty-seventh session of the General Assembly on the revised estimates submitted by the Secretary-General and on the programme budget implications of resolutions adopted by the Assembly, either on the recommendation of its Main Committees or in respect of items considered in plenary meeting.

- 5. Section III provides a summary of the special subjects considered by the Fifth Committee that led to the adoption of specific decisions to be recommended to the General Assembly.
- The recommendations of the Fifth Committee are contained in section IV.

#### II. Programme budget for the biennium 2002-2003

- 7. In its resolutions 56/254 A and B of 24 December 2001, the General Assembly approved budget appropriations for the biennium 2002-2003 in the amount of \$2,625,178,700 and income estimates in the amount of \$404,295,400. By its resolutions 56/274 B and 56/286 of 27 June 2002, further appropriations were approved resulting in revised appropriations of \$2,699,267,800 and revised income estimates in the amount of \$410,036,100.
- 8. Recommendations of the Fifth Committee during the current session of the General Assembly on revised estimates submitted by the Secretary-General, as well as on the programme budget implications of resolutions adopted by the Assembly under items considered by other Main Committees or in respect of items considered in plenary meeting, have resulted in a net increase in the approved level of appropriations in the amount of \$191,550,900 and a net increase in the approved income estimates in the amount of \$4,393,500.
- 9. The revised estimates of expenditure and income approved by the Fifth Committee and the financial implications of resolutions recommended by other Main Committees and subsequently by the General Assembly are indicated, by expenditure and income section, in the following table:

- 10. At its 37th meeting, on 13 December, the Committee considered the revised estimates of expenditure and income to be recommended for approval by the General Assembly for the biennium 2002-2003, as well as the financing of the appropriations for the year 2003. The Committee took the following action:
- (a) The Committee approved the revised budget appropriations for the biennium 2002-2003 (see para. 76, draft resolution II A);
- (b) The Committee approved the revised income estimates for the biennium 2002-2003 (see para. 76, draft resolution II B);
- (c) The Committee approved the draft resolution on the financing of the appropriations for the year 2003 (see para. 76, draft resolution II C).

#### III. Consideration of special subjects

## Construction of additional office facilities at the Economic Commission for Africa in Addis Ababa

- 11. The Committee considered this question at its 7th and 15th meetings, on 14 and 24 October. It had before it the report of the Secretary-General (A/57/322). The report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman.
- 12. At the 15th meeting, on 24 October, the Chairman of the Committee introduced a draft decision entitled "Construction of additional office facilities at the Economic Commission for Africa in Addis Ababa" (A/C.5/57/L.8). At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision I).

#### Videoconferencing at the United Nations

- 13. The Committee considered this question at its 7th and 15th meetings, on 14 and 24 October. It had before it the report of the Secretary-General (A/57/339 and Corr.1). The report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman.
- 14. At the 15th meeting, on 24 October, the Chairman of the Committee introduced a draft decision entitled "Videoconferencing at the United Nations" (A/C.5/57/L.10). At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision II).

#### Decentralized budgetary and financial arrangements for central services

- 15. The Committee considered this question at its 12th, 13th and 15th meetings, on 21, 22 and 24 October. It had before it the report of the Secretary-General (A/57/348) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.3, sect. E).
- 16. At the 15th meeting, on 24 October, the Chairman of the Committee introduced a draft decision entitled "Decentralized budgetary and financial arrangements for central services" (A/C.5/57/L.11). At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision III).

#### Delivery of advisory services

- 17. The Committee considered this question at its 12th, 13th and 15th meetings, on 21, 22 and 24 October. At its 12th meeting, on 21 October, it had before it the report of the Secretary-General (A/57/363) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.3, sect. D).
- 18. At the 15th meeting, on 24 October, the Chairman of the Committee introduced a draft decision entitled "Delivery of advisory services" (A/C.5/57/L.12). At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision IV).

#### Trends in extrabudgetary resources at the Economic Commission for Latin America and the Caribbean and the impact on its capacity to carry out the programme of work

- 19. The Committee considered this question at its 13th and 15th meetings, on 22 and 24 October. It had before it the report of the Secretary-General (A/57/364) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.3, sect. C).
- 20. At the 15th meeting, on 24 October, the Chairman of the Committee introduced a draft decision entitled "Trends in extrabudgetary resources at the Economic Commission for Latin America and the Caribbean and the impact on its capacity to carry out the programme of work" (A/C.5/57/L.13). At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision V).

#### Cooperation between headquarters departments and regional commissions

- 21. The Committee considered this question at its 12th, 13th and 28th meetings, on 21 and 22 October and on 27 November. It had before it the reports of the Secretary-General (A/57/361) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.3, sect. F).
- 22. At the 28th meeting, on 27 November, the Chairman of the Committee introduced a draft decision entitled "Cooperation between headquarters departments and regional commissions" (A/C.5/57/L.15). At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision VI).

#### **United Nations Fund for International Partnerships**

- 23. The Committee considered this question at its 20th and 28th meetings, on 4 and 27 November. It had before it the report of the Secretary-General (A/57/133) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.6).
- 24. At the 28th meeting, on 27 November, the Chairman of the Committee introduced a draft decision entitled "United Nations Fund for International Partnerships" (A/C.5/57/L.16). At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision VII).

## Inter-organizational security measures: framework for accountability for the United Nations field security management system

- 25. The Committee considered this question at its 20th and 28th meetings, on 4 and 27 November. It had before it the report of the Secretary-General (A/57/365) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.11).
- 26. At the 28th meeting, on 27 November, the Chairman of the Committee introduced a draft decision entitled "Inter-organizational security measures: framework for accountability for the United Nations field security management system" (A/C.5/57/L.17). At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision VIII).

## Conversion into established posts of some temporary assistance posts financed under section 2 of the programme budget

- 27. The Committee considered this question at its 24th, 25th and 28th meetings on 11, 12 and 27 November. It had before it the report of the Secretary-General (A/57/473), and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.14, sect. I).
- 28. At the 28th meeting, on 27 November, the Chairman of the Committee introduced a draft decision entitled "Conversion into established posts of some temporary assistance posts financed under section 2 of the programme budget" (A/C.5/57/L.19, draft decision I). At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision IX).

## Cases in which incumbents of the posts are being paid at a level other than the one provided for the post

- 29. The Committee considered this question at its 24th, 25th and 28th meetings on 11, 12 and 27 November. It had before it the report of the Secretary-General (A/57/466) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.14, sect. II).
- 30. At the 28th meeting, on 27 November, the Chairman of the Committee introduced a draft decision entitled "Cases in which incumbent of the posts are being paid at a level other than the one provided for the post" (A/C.5/57/L.19, draft decision II). At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision X).

#### Presentation of estimates of staff assessment

- 31. The Committee considered this question at its 24th, 25th and 28th meetings, on 11, 12 and 27 November. It had before it the report of the Secretary-General (A/57/464) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.14, sect. III).
- 32. At the 28th meeting, on 27 November, the Chairman of the Committee introduced a draft decision entitled "Presentation of estimates of staff assessment" (A/C.5/57/L.19, draft decision III). At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision XI).

#### **Development Account**

- 33. The Committee considered this question at its 20th and 28th meetings, on 4 and 27 November. It had before it the report of the Secretary-General (A/57/360) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.5).
- 34. At the 28th meeting, on 27 November, the Chairman of the Committee introduced a draft decision entitled "Development Account" (A/C.5/57/L.20), informal consultations on which had been coordinated by the representative of Ethiopia, Rapporteur of the Committee. At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision XII).

# Experience in applying the revised administrative arrangements approved by the General Assembly for the International Trade Centre UNCTAD/WTO in its decision 53/411B

- 35. The Committee considered this question at its 20th and 28th meetings, on 4 and 27 November. It had before it the report of the Secretary-General (A/C.5/57/14) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.10).
- 36. At the 28th meeting, on 27 November, the Chairman of the Committee introduced a draft decision entitled "Experience in applying the revised administrative arrangements approved by the General Assembly for the International Trade Centre UNCTAD/WTO budget in its decision 53/411 B" (A/C.5/57/L.21), informal consultations on which had been coordinated by the representative of Ethiopia, Rapporteur of the Committee. At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision XIII).

### Plan to increase the regular budget component of the United Nations Office at Nairobi

- 37. The Committee considered this question at its 12th, 13th and 28th meetings, on 21, 22 and 27 October. It had before it the report of the Secretary-General (A/57/362) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.3, sect. A).
- 38. At the 28th meeting, on 27 November, the Chairman of the Committee introduced a draft resolution entitled "Plan to increase the regular budget component of the United Nations Office at Nairobi" (A/C.5/57/L.23), informal consultations for which had been coordinated by the representative of Portugal. At the same meeting,

the Committee adopted the draft resolution without a vote (see para. 80, draft resolution I).

#### **Proposed revisions to the Financial Regulations of the United Nations**

- 39. The Committee considered this question at its 26th, 28th and 37th meetings, on 18 and 27 November and 13 December. It had before it the report of the Secretary-General (A/57/396). The report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman.
- 40. At the 28th meeting, on 27 November, the Chairman of the Committee introduced a draft decision entitled "Proposed revisions to the Financial Regulations of the United Nations" (A/C.5/57/L.24), which read:

"The General Assembly:

- "(a) Takes note of the report of the Secretary-General on the proposed revisions to the Financial Regulations of the United Nations and the observations of the Advisory Committee on Administrative and Budgetary Questions thereon;
- "(b) Adopts the revised Financial Regulations, as set forth in the abovementioned report of the Secretary-General;
- "(c) Decides that the revised Regulations shall become effective on 1 January 2003."
- 41. At the 37th meeting, on 13 December, the Chairman introduced a revised draft decision entitled "Proposed revisions to the Financial Regulations of the United Nations" (A/C.5/57/L.24/Rev.1). At the same meeting, the Committee adopted the revised draft decision (see para. 80, draft decision XIV).

#### Comprehensive review of the post structure of the United Nations Secretariat

- 42. The Committee considered this question at its 24th, 25th and 28th meetings, on 11, 12 and 27 November. It had before it the report of the Secretary-General (A/57/483) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.14, sect. V).
- 43. At the 28th meeting, on 27 November, the Chairman of the Committee introduced a draft decision entitled "Comprehensive review of the post structure of the United Nations Secretariat" (A/C.5/57/L.25). At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision XV).

#### **Results-based budgeting**

- 44. The Committee considered this question at its 24th, 25th and 28th meetings, on 11, 12 and 27 November. It had before it the report of the Secretary-General (A/57/478), the note by the Secretary-General transmitting the report of the Office of Internal Oversight Services (A/57/474) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.14, sect. VI).
- 45. At the 28th meeting, on 27 November, the Chairman of the Committee introduced a draft decision entitled "Results-based budgeting" (A/C.5/57/L.26), informal consultations on which had been coordinated by the representative of

Belgium, Vice-Chairman of the Committee. At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision XVI).

#### Additional expenditures deriving from inflation and currency fluctuations

- 46. The Committee considered this question at its 24th, 25th and 28th meetings, on 11, 12 and 27 November. It had before it the report of the Secretary-General (A/57/471) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.14, sect. IV).
- 47. At the 28th meeting, on 27 November, the Chairman of the Committee introduced a draft decision entitled "Additional expenditures deriving from inflation and currency fluctuations" (A/C.5/57/L.28), informal consultations on which had been coordinated by the representative of Belgium, Vice-Chairman of the Committee. At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision XVII).

## Request for a subvention to the United Nations Institute for Disarmament Research

- 48. The Committee considered this question at its 26th, 27th and 37th meetings, on 18, 21 November and 13 December. It had before it a note by the Secretary-General transmitting the recommendation of the Board of Trustees of the Institute for a subvention (A/C.5/57/4) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.7).
- 49. At the 37th meeting, on 13 December, the Chairman of the Committee introduced a draft decision entitled "Request for a subvention to the United Nations Institute for Disarmament Research" (A/C.5/57/L.27). At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision XVIII).

#### Capital master plan

- 50. The Committee considered this question at its 16th to 18th, 29th and 37th meetings, on 25, 28 and 29 October and 3 and 13 December. It had before it the report of the Secretary-General (A/57/285) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.4).
- 51. At the 29th meeting, on 3 December, the representative of Belgium, Vice-Chairman of the Committee, introduced a draft resolution entitled "Capital master plan" (A/C.5/57/L.29). At the 37th meeting, on 13 December, the Committee adopted the draft resolution without a vote (see para. 79, draft resolution I, sect. II).

#### Construction of additional office facilities at the Economic Commission for Latin America and the Caribbean

- 52. The Committee considered this question at its 28th and 37th meetings, on 27 November and 13 December. It had before it the report of the Secretary-General (A/57/467) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.8).
- 53. At the 37th meeting, on 13 December, the Chairman of the Committee introduced a draft decision entitled "Construction of additional office facilities at the

Economic Commission for Latin America and the Caribbean" (A/C.5/57/L.32). At the same meeting, the Committee adopted the draft resolution without a vote (see para. 80, draft decision XIX).

# Strengthening the Department of Public Information, within the existing capacity, in order to support and enhance the United Nations web site in all official languages of the Organization

- 54. The Committee considered this question at its 12th, 13th and 37th meetings, on 21 and 22 October and 13 December. It had before it the report of the Secretary-General (A/57/355) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.2).
- 55. At the 37th meeting, on 13 December, the Chairman of the Committee introduced a draft decision entitled "Strengthening the Department of Public Information, within the existing capacity, in order to support and enhance the United Nations web site in all official languages of the Organization" (A/C.5/57/L.37), informal consultations on which had been coordinated by the representative of Portugal. At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision XX).

#### Estimates in respect of matters of which the Security Council is seized

- 56. The Committee considered this question at its 29th, 30th and \_\_\_\_ meetings, on 3, 6 and \_\_ December. It had before it the report of the Secretary-General (A/C.5/57/23) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.17).
- 57. At the \_\_\_\_ meeting, on \_\_ December, the Chairman of the Committee introduced a draft resolution entitled "Revised estimates in respect of matters of which the Security Council is seized" (A/C.5/57/L.43), informal consultations on which had been coordinated by the representative of Egypt. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 79, draft resolution I, sect. III).

### Future operation of the International Research and Training Institute for the Advancement of Women

- 58. The Committee considered this question at its 29th, 31st, and 37th meetings, on 3, 9 and 13 December. It had before it a statement submitted by the Secretary-General (A/C.5/57/24) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.18).
- 59. At the 37th meeting, on 13 December, the Chairman of the Committee introduced a draft decision entitled "Future operation of the International Research and Training Institute for the Advancement of Women" (A/C.5/57/L.46, draft decision I), informal consultations on which had been coordinated by the representative of Belgium, Vice-Chairman of the Committee.
- 60. At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision XXI).

#### **Permanent Forum on Indigenous Issues**

- 61. The Committee considered this question at its 29th, 31st, 32nd and 37th meetings, on 3, 9, 10 and 13 December. It had before it a statement submitted by the Secretary-General (A/C.5/57/26) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.19).
- 62. At the 37th meeting, on 13 December, the Chairman of the Committee introduced a draft decision entitled "Permanent Forum on Indigenous Issues" (A/C.5/57/L.46, draft decision II), informal consultations on which had been coordinated by the representative of Belgium, Vice-Chairman of the Committee. At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision XXII).

#### **Khmer Rouge trials**

- 63. The Committee considered this question at its 31st, 32nd and 37th meetings, on 9, 10 and 13 December. It had before it the statement submitted by the Secretary-General (A/C.5/57/29) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.22).
- 64. At the 37th meeting, on 13 December, the Chairman of the Committee introduced a draft decision entitled "Khmer Rouge trials" (A/C.5/57/L.46, draft decision III), informal consultations on which had been coordinated by the representative of Belgium, Vice-Chairman of the Committee. At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision XXIII).

## Ensuring effective Secretariat support for the sustained follow-up to the outcome of the International Conference on Financing for Development

- 65. The Committee considered this question at its 35th and 37th meetings, on 12 and 13 December. It had before it the statement submitted by the Secretary-General (A/C.5/57/32) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.24).
- 66. At the 37th meeting, on 13 December, the Chairman of the Committee introduced a draft decision entitled "Ensuring effective Secretariat support for the sustained follow-up to the outcome of the International Conference on Financing for Development" (A/C.5/57/L.46, draft decision IV), informal consultations on which had been coordinated by the representative of Belgium, Vice-Chairman of the Committee. At the same meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision XXIV).

## Revised estimates resulting from resolutions and decision adopted by the Economic and Social Council at its substantive session of 2002

- 67. The Committee considered this question at its 20th and 37th meetings, on 4 November and 13 December. It had before it the report of the Secretary-General (A/C.5/57/13 and Corr.1) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.12).
- 68. At the 37th meeting, on 13 December, the Chairman of the Committee introduced a draft decision entitled "Revised estimates resulting from resolutions

and decision adopted by the Economic and Social Council at its substantive session of 2002" (A/C.5/57/L.46, draft decision V), informal consultations on which had been coordinated by the representative of Namibia. At the meeting, the Committee adopted the draft decision without a vote (see para. 80, draft decision XXV).

#### Strengthening the Terrorism Prevention Branch of the Secretariat

- 69. The Committee considered this question at its 20th and 37th meetings, on 4 November and 13 December. It had before it the reports of the Secretary-General (A/57/152 and Corr.1, A/57/152 and Add.1 and Corr.1 and 2 and A/57/152/Add.2) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.13).
- 70. At the 37th meeting, on 13 December, the Chairman of the Committee introduced a draft resolution entitled "Strengthening the Terrorism Prevention Branch of the Secretariat" (A/C.5/57/L.47), informal consultations on which had been coordinated by the representative of New Zealand. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 79, draft resolution I, sect. IV).

#### First performance report on the programme budget for the biennium 2002-2003

- 71. The Committee considered this question at its 29th, 30th and \_\_\_\_ meetings, on 3, 6 and \_\_ December. It had before it the report of the Secretary-General (A/57/616) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.16).
- 72. At the \_\_\_\_ meeting, on \_\_ December, the Chairman of the Committee introduced a draft resolution entitled "First performance report on the programme budget for the biennium 2002-2003" (A/C.5/57/L.48), informal consultations on which had been coordinated by the representative of Portugal. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 80, draft resolution I, sect. VI).

#### Contingency fund

- 73. The Committee considered this question at its \_\_\_\_ meeting, on \_\_ December. It had before it the report of the Secretary-General (A/C.5/57/33). The report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman.
- 74. At the same meeting the Committee decided, without a vote, to recommend to the General Assembly that it appropriate the required amounts, as contained in the report of the Secretary-General, and that it note that a balance of \$31,200 would remain in the contingency fund (see para. 79, draft resolution I, sect. VII).

#### **United Nations Institute for Training and Research**

75. The Committee considered this question at its 26th, 28th, 30th and \_\_\_\_ meetings, on 18 and 27 November and 6 and \_\_ December. It had before it the report of the Secretary-General (A/57/479) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/57/7/Add.15).

76. At the 30th meeting, on 6 December, the representative of Venezuela, on behalf of the Group of 77 and China, introduced a draft resolution entitled "United Nations Institute for Training and Research" (A/C.5/57/L.38), which read:

"The General Assembly,

"Having considered the report of the Secretary-General on the United Nations Institute for Training and Research and the related report of the Advisory Committee on Administrative and Budgetary Questions,

- "1. Notes that the United Nations Institute for Training and Research did not benefit from rental rates and maintenance costs similar to those enjoyed by other organizations affiliated with the United Nations such as the United Nations Institute for Disarmament Research and the United Nations Research Institute for Social Development;
- "2. Decides that the general administrative, personnel and financial services of the United Nations shall be utilized by the United Nations Institute for Training and Research on conditions determined in consultation between the Secretary-General and the Executive Director of the Institute;
- "3. Decides also that the United Nations will provide the space occupied by the Institute free of rent and maintenance charges and will also provide in future budgets, starting with the biennium 2004-2005, an amount of \$305,400 biennially for that purpose;
- "4. Decides further that the Institute's current outstanding debt of \$310,974 relating to unpaid rental and maintenance costs shall be paid by the United Nations in the context of the programme budget for 2004-2005;
- "5. Decides to amend paragraph 13 of article VIII of the statute of the Institute as proposed in the statement by the Secretary-General on these matters."
- 77. At the \_\_\_\_ meeting, on \_\_ December, the Vice-Chairman of the Committee, following informal consultations, introduced a draft resolution entitled "United Nations Institute for Training and Research" (A/C.5/57/L.50). At the same meeting, the Committee adopted draft resolution A/C.5/57/L.50 without a vote (see para. 79, draft resolution I, sect. V).
- 78. In view of the adoption of draft resolution A/C.5/57/L.50, draft resolution A/C.5/57/L.38 was withdrawn by the sponsor.

#### IV. Recommendations of the Fifth Committee

79. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolutions:

#### Draft resolution I Questions relating to the programme budget for the biennium 2002-2003

The General Assembly,

### I. Plan to increase the regular budget component of the United Nations Office at Nairobi

Recalling paragraph 163 of its resolution 56/253 of 24 December 2001, by which it requested the Secretary-General to bring the financial arrangements of the United Nations Office at Nairobi into line with those of similar United Nations administrative offices,

- 1. Takes note of the report of the Secretary-General on the plan to increase the regular budget component of the United Nations Office at Nairobi, and endorses the recommendations of the Advisory Committee on Administrative and Budgetary Questions thereon;
- 2. Welcomes the intention of the Secretary-General to continue to strengthen the United Nations Office at Nairobi and urges him to increase the regular budget component of the Office in future bienniums so as to ensure that the Office is able fully to execute programmes and activities within its mandate;
- 3. Requests the Secretary-General to take into account the provisions of the present resolution in the context of the proposed programme budget for the biennium 2004-2005.

#### II. Capital master plan

*Recalling* its resolutions 54/249 of 23 December 1999, 55/238 of 23 December 2000, 56/234 and 56/236 of 24 December 2001 and 56/286 of 27 June 2002,

Having considered the report of the Secretary-General on the capital master plan,3

Having also considered the related report of the Advisory Committee on Administrative and Budgetary Questions,<sup>4</sup>

- 1. Takes note with concern of the hazards, risks and deficiencies of the current condition of the United Nations Headquarters complex, and concurs with the Secretary-General that a decision on viable solutions must be made to ameliorate those conditions;
  - 2. Takes note of the report of the Secretary-General on the capital master plan;<sup>3</sup>
- 3. Also takes note of the related report of the Advisory Committee on Administrative and Budgetary Questions<sup>4</sup> and endorses the observations and recommendations contained therein, subject to the provisions of the present resolution;

4. Welcomes with appreciation the offer of support from the City and State of New York and acknowledges their efforts to make possible the implementation of the capital master plan;

#### Scope of the capital master plan

- 5. Decides to implement the capital master plan on the basis of the baseline scope under the first approach to phasing and swing space, with a projected construction budget of 1,049 million United States dollars,<sup>5</sup> a variance of plus or minus ten per cent, that is, a range currently estimated at 944.1 to 1,153.9 million dollars, a proposed construction start date of October 2004 and a construction duration of five years;
- 6. *Notes* that the projected budget should be increased by up to 144 million dollars, should the Assembly decide to implement any of the scope options referred to in paragraph 11 below;
- 7. Authorizes the Secretary-General to proceed with the remaining phases of design development and construction documentation, bearing in mind the provisions set out below;

#### Baseline scope

- 8. Approves the implementation of the baseline scope as amended by the exclusion of the proposed new large conference room and multi-function hall in the parking garage;
- 9. Requests the Secretary-General to submit to the General Assembly at its fifty-eighth session plans for the three additional conference rooms foreseen in the baseline scope, including the information used to determine the need for such additional space and the size of each room;
- 10. Also requests the Secretary-General to include in those plans viable solutions for allowing natural light into the rooms, with a view to ensuring occupationally healthy conditions;

#### Scope options

11. Approves the inclusion in the design documents of the proposed scope options for security, redundancy and contingency and sustainability within the design work for the capital master plan, without prejudice to the final decision to be made by the General Assembly at its fifty-eighth session with regard to the scope options to be included, and also approves the contingency plans for retaining the proposed new large conference room and multi-function hall in the parking garage of the United Nations Headquarters complex;

Swing space

- 12. Endorses the proposal of the Secretary-General, in line with the first approach to phasing and swing space, to complete the negotiations with the City of New York for the construction and lease purchase of a new United Nations consolidated building on a section of the Robert Moses Playground, including the cost of providing alternative park amenities for the community to compensate for the loss of part of the playground;
- 13. Requests the Secretary-General to include a permanent large conference room and a permanent multi-function hall in a design of the new United Nations consolidated building;
- 14. Also requests the Secretary-General to ensure that, in addressing the design of the United Nations consolidated building, the necessary security and environmental parameters are respected;
- 15. Approves, in principle, the approach of the Secretary-General that the acquisition of the United Nations consolidated building will be made through a lease-purchase agreement with the United Nations, upon the expiry of which the building and the land on which it stands would be owned by the United Nations;

#### Parking

- 16. Takes note with concern of the existing difficulties with regard to the availability of parking at the United Nations;
- 17. Requests the Secretary-General to study all viable options to ensure sufficient parking spaces so as to meet existing and future needs of diplomatic missions and Secretariat staff within the projected overall budget of the capital master plan, and to report thereon to the General Assembly at its fifty-eighth session in the context of its consideration of the capital master plan;

#### Management and oversight

- 18. Requests the Secretary-General to put in place strict control standards for all phases of the plan prior to and during its implementation, defining the precise refurbishment work to be done and the technical results to be achieved so as to ensure that there are no cost overruns associated with the overall project, that the project is completed successfully within the envisaged time frame and budget and within the agreed technical specifications, that there are financial penalties for contractors in the case of non-respect of deadlines and that there is a guarantee that will ensure the long-term quality of the work undertaken;
- 19. Concurs with the intention of the Secretary-General to establish an independent and impartial advisory board, as outlined in paragraph 66 of his report,<sup>3</sup> and requests him, in establishing the board, to reflect wide geographical representation;
- 20. Takes note of the information included in paragraph 75 of the report of the Secretary-General,<sup>3</sup> and of the fact that the Board of Auditors, in order to avoid a conflict of interest, did not assume responsibility for the validation of initial project costs;

- 21. *Stresses* in this regard the importance, as a matter of transparency, that the Secretary-General report to the General Assembly on such situations;
- 22. Also stresses the importance of oversight with respect to the development and implementation of the capital master plan, and requests the Board of Auditors and all other relevant oversight bodies to initiate immediate oversight activities and to report annually thereon to the General Assembly;
- 23. Takes note of annexes II and III to the report of the Secretary-General,<sup>3</sup> and requests the Secretary-General to issue a corrigendum that will reflect the current organizational structure of the Secretariat for managing the capital master plan, both at present and over the course of its implementation;

#### Appropriation and funding

- 24. Decides that a special account for the capital master plan should be established, and requests the Secretary-General to make the necessary arrangements in this regard, in accordance with the provisions of regulation 6.6 of the Financial Regulations and Rules of the United Nations;
- 25. Decides to appropriate 25.5 million dollars to the special account for the capital master plan for the biennium 2002-2003, in accordance with the relevant resolutions on the scale of assessments applicable for the biennium 2002-2003, for design and related project management and management of pre-construction services for the baseline scope and scope options;
- 26. Authorizes the Secretary-General to enter into commitments of up to 26 million dollars for the biennium 2004-2005 to provide for the remaining work, related project management and management of pre-construction services for the baseline scope and scope options;
- 27. *Welcomes* the preparedness of the Secretary-General to initiate a campaign to encourage and secure private donations;
- 28. Reaffirms the importance of continuing efforts to secure financial resources from the public and private sectors for upgrading facilities and equipment, including the participation of private companies in infrastructural improvements, where such participation has no financial implications for the Organization, and also reaffirms that the acceptance of any donation should conform to the international and intergovernmental character of the Organization and should be in full compliance with the Financial Regulations and Rules of the United Nations;
- 29. *Requests* the Secretary-General to report to the General Assembly at its fifty-eighth session on:
- (a) The status of possible funding arrangements, including a financial package to be provided by the host country;
- (b) Other contributions, and on his efforts to secure such contributions from public and private sources;
- (c) All aspects of the outcome of negotiations with the City and State of New York:
  - (d) The progress of the design work;

#### Procurement

- 30. Requests the Secretary-General, considering the need to continue to explore ways to increase procurement opportunities for vendors from developing countries and countries with economies in transition, to take the provisions of General Assembly resolutions 54/14 of 29 October 1999 and 55/247 of 12 April 2001 on procurement reform fully into consideration in the implementation of the capital master plan;
- 31. *Also requests* the Secretary-General to report to it on an annual basis on the awarding of contracts for procurement for the capital master plan;

#### Final provisions

- 32. Decides that none of the provisions of the present resolution, with the exception of paragraphs 24 to 26 and all requested design specifications, are binding in the event that the City and State of New York cannot fulfil their commitments to the capital master plan and if the host country does not offer a financing package to cover the project, described in paragraph 5 above;
- 33. *Decides* to revert to the issue of the financing of the capital master plan at its fifty-eighth session;
- 34. *Requests* the Secretary-General to submit to it annual progress reports on the implementation of the capital master plan.

- 2. Approves, under the procedures provided for in paragraph 11 of annex I to its resolution 41/213 of 19 December 1986, an additional appropriation of 60,039,000 dollars for the nineteen special political missions presented in the report of the Secretary-General under section 3, Political affairs, of the programme budget for the biennium 2002-2003;
- 3. Also approves an appropriation of 8,183,100 dollars under section 32, Staff assessment, to be offset by a corresponding amount under Income section 1, Income from staff assessment, of the programme budget for the biennium 2002-2003.

- 1. *Reaffirms* the priorities of the Organization as set out in the medium-term plan for the period 2002-2005, <sup>10</sup> namely
  - (a) Maintenance of international peace and security;
- (b) Promotion of sustained economic growth and sustainable development in accordance with the relevant resolutions of the General Assembly and recent United Nations conferences;
  - (c) Development of Africa;
  - (d) Promotion of human rights;
  - (e) Effective coordination of humanitarian assistance efforts;
  - (f) Promotion of justice and international law;
  - (g) Disarmament;
- (h) Drug control, crime prevention and combating international terrorism in all its forms and manifestations;
- 2. Also reaffirms the role of the Centre for International Crime Prevention in contributing to the prevention of international terrorism in all its forms and manifestations, as mandated and reflected in the medium-term plan;<sup>11</sup>
- 3. Further reaffirms the role of the Centre in providing, at the request of Member States, technical assistance in the prevention of international terrorism in all its forms and manifestations;
- 4. *Approves*, as a charge against the contingency fund, an amount of 230,900 dollars for one D-1, one P-4, one P-3 and two General Service (Other level) posts under section 14, Crime prevention and criminal justice, of the programme budget for the biennium 2002-2003<sup>12</sup> and a related amount of 55,600 dollars under section 32, Staff assessment, offset by the amount of 55,600 dollars under income section 1, Income from staff assessment, and decides that the balance of resource requirements as detailed in the annex to the report of the Secretary-General<sup>13</sup> shall be reflected in the proposed programme budget for the biennium 2004-2005.

#### V. United Nations Institute for Training and Research

*Recalling* its resolutions 47/227 of 8 April 1993 and 56/208 of 21 December 2001,

Having considered the report of the Secretary-General on the United Nations Institute for Training and Research<sup>14</sup> and the related report of the Advisory Committee on Administrative and Budgetary Questions,<sup>15</sup>

- 1. *Emphasizes* the need to find a viable financial solution to ensure the future effective functioning of the United Nations Institute for Training and Research;
- 2. Notes with concern that the United Nations Institute for Training and Research has accumulated a debt to the United Nations and to the Fondation immobilière pour organisations internationales due to lack of payment of rent and maintenance for its liaison offices in New York and Geneva:
- 3. Requests the Secretary-General, based on consultations with the Executive Director of the United Nations Institute for Training and Research, to report to the General Assembly at its fifty-eighth session on the financial viability of the Institute, including the status regarding all voluntary contributions and the payment of the Institute's accumulated debt, as well as on provisions offered to other comparable organizations;
- 4. Also requests the Secretary-General to address, in the context of the programme budget for the biennium 2004-2005, based on the aforementioned consultations with the Institute, specific proposals and options on how best to address the issue of its past and future maintenance and rental costs, drawing on the provisions made for other organizations associated with the United Nations.

#### VI. First performance report on the programme budget for the biennium 2002-2003

Having considered the first performance report of the Secretary-General on the programme budget for the biennium 2002-2003<sup>16</sup> and the related report of the Advisory Committee on Administrative and Budgetary Questions,<sup>17</sup>

- 1. *Reaffirms* the budgetary process as approved in its resolution 41/213 of 19 December 1986 and as reaffirmed in subsequent resolutions;
- 2. Also reaffirms its resolutions 56/253 and 56/254 of 24 December 2001, and 56/274 B, 56/286 and 56/287 of 27 June 2002;
- 3. Takes note of the first performance report of the Secretary-General on the programme budget for the biennium 2002-2003, 16 and endorses the observations and recommendations of the Advisory Committee on Administrative and Budgetary Questions, 17 subject to the provisions of the present resolution;
- 4. Decides to appropriate an amount of 6,896,100 dollars to support the meeting requirements of the Counter-Terrorism Committee for the period from 1 January 2002 to 30 March 2003 under the following sections of the programme budget for the biennium 2002-2003: 6,531,900 dollars under section 2, General

- 5. *Notes* the continued unpredictability of the service requirements for the activities of the Counter-Terrorism Committee and the scope for absorption of some or all of the costs for the servicing of the Committee;
- 6. Reiterates paragraph 2 of its resolution 56/288 of 27 June 2002, in which it requested the Secretary-General to ensure the provision of conference and support services to the Counter-Terrorism Committee without adversely affecting other conference services:
- 7. *Decides* to consider further the conference and support servicing of the Counter-Terrorism Committee for 2003 in the light of the review by the Security Council of the activities of the Committee;
- 8. Decides to approve 9.9 million dollars for realized vacancy rates in 2002 and to consider the actual realized vacancy rates for 2003 in the context of the second performance report on the programme budget for the biennium 2002-2003;
  - 9. Reiterates paragraphs 133 to 136 of its resolution 56/253;
- 10. Requests the Secretary-General to continue to provide information on regular budget expenditures on a quarterly basis in the appropriate format;
- 11. *Notes with deep concern* the serious and continuing deterioration in the business of the United Nations Postal Administration;
- 12. Requests the Secretary-General to ensure, as a matter priority, that the continuing downward trend in the business of the United Nations Postal Administration is reversed, considering all possible courses of action for the future conduct of its business, and to report thereon to the General Assembly in the context of the second performance report;
- 13. Approves a net increase of 176,866,900 dollars in the appropriation approved for the biennium 2002-2003 and a net increase of 2,807,300 dollars in the estimates of income for the biennium, to be apportioned among expenditure and income sections as indicated in the report of the Secretary-General.<sup>16</sup>

- (c) Notes with appreciation the efforts made to date by the Secretary-General in implementing the provisions of General Assembly resolution 55/231;
- (d) Notes that the issues addressed in the above-mentioned reports of the Secretary-General and the Office of Internal Oversight Services are relevant to some measures outlined in the report of the Secretary-General entitled "Strengthening of the United Nations: an agenda for further change".<sup>49</sup>

  - (d) Recalls paragraph 66 of its resolution 57/\_\_\_;
- (e) Requests the Secretary-General, in this context, to keep the question of the equality between the six official languages on the web site under review and to submit proposals aimed at achieving full equality between the languages.

#### Draft decision XXI Future operation of the International Research and Training Institute for the Advancement of Women

The General Assembly:

- (a) Having considered the statement of programme budget implications submitted by the Secretary-General<sup>58</sup> and the related report of the Advisory Committee on Administrative and Budgetary Questions,<sup>59</sup> notes that the adoption of draft resolution A/C.3/57/L.16/Rev.1 would give rise to additional requirements of 500,000 United States dollars under section 9, Economic and social affairs, of the programme budget for the biennium 2002-2003,<sup>60</sup> and also notes that, under the procedures established by the General Assembly in its resolutions 41/213 and 42/211, this provision would represent a charge against the contingency fund;
- (b) Approves, in the context of the consolidated statement of programme budget implications, a charge in the amount of 250,000 dollars against the contingency fund to finance core activities of the Institute, defined as the salaries and common staff costs of the four Professional posts currently in the staffing table;
- (c) Decides that an amount of 250,000 dollars will be set aside in the contingency fund for the current biennium, as an additional provision to the Institute for core activities in 2003, which brings the total amount to 500,000 dollars, pending firm pledges and/or payments of voluntary contributions necessary for the viable operations of the Institute;
- (d) Requests the Secretary-General to report to the General Assembly, through the Fifth Committee, before the end of its resumed fifty-seventh session, on the financial situation of the Institute, including the status of voluntary contributions
