The meeting was called to order at 10.15 a.m.

Programme budget implications of the draft resolution contained in document A/AC.265/2006/L.8/Rev.1: Ad Hoc Committee on a Comprehensive and Integral International Convention on the Protection and Promotion of the Rights and Dignity of Persons with Disabilities (A/C.5/61/15)

Programme budget implications of draft resolution A/61/L.30: Oceans and the law of the sea (A/C.5/61/16)

Programme budget implications of draft resolution A/ES-10/L.20: Establishment of the United Nations Register of Damage caused by the Construction of the Wall in the Occupied Palestinian Territory (A/61/614; A/C.5/61/13)

- Ms. Van Buerle (Director, Programme Planning and Budget Division), introducing the statement of programme budget implications of the draft resolution contained in document A/AC.265/2006/L.8/Rev.1 (A/C.5/61/15), said that should draft resolution A/AC.265/2006/L.8/Rev.1 be adopted by the General Assembly, no immediate financial implications would arise. However, the document before the Committee described two possible scenarios, one based on the assumption that the Convention would be ratified and enter into force by mid-2007, and the other based on the assumption that it would not enter into force until late 2007. She drew attention to paragraphs 4, 5, 6 and 7 of the statement, which described the activities required under the Convention and requested in draft resolution A/AC.265/2006/L.8/Rev.1.
- 2. Should the Convention enter into force in 2007 and the Conference of the States Parties and the Committee on the Rights of Persons with Disabilities meet in 2007, additional requirements for the programme budget for the biennium 2006-2007 would amount to \$3.3 million. Provision had already been made under section 2 in the amount of \$1.5 million for servicing two annual sessions of the Ad Hoc Committee and two annual meetings of the presessional working groups in 2007. Accordingly, the net additional conference servicing requirements in 2007 related to the Convention would amount to \$1.3 million. In addition, should the Convention enter into

- force and the Conference of the States Parties and the first session of the Committee on the Rights of Persons with Disabilities be held in 2007, the Secretariat would revert to the General Assembly on meeting the conference servicing requirements in accordance with established procedures. It was envisaged that, to the fullest extent possible, the estimated expenditures attributable to the implementation of the proposed activities under section 23, Human rights, and section 28, Management and support services, would be met from within existing resources.
- 3. Should the Convention enter into force in late 2007 and the Conference of the States Parties and sessions of the Committee commence meeting in 2008, additional resources of \$10 million would be considered in the context of the proposed programme budget for the biennium 2008-2009.
- Turning to the statement of programme budget implications of draft resolution A/61/L.30 (A/C.5/61/16), she drew the Committee's attention to paragraphs 1, 3, 4, 5, 7 and 8 of document A/C.5/61/16. The conference servicing requirements, at full cost, for the four-day extension of the nineteenth session of the Commission on the Limits of the Continental Shelf would amount to \$108,100 under section 2, General Assembly and Economic and Social Council affairs and conference management, and section 28D, Office of Central Support Services, of the programme budget for the biennium 2006-2007. While every effort would be made to absorb the additional requirements, any further appropriations would be reported in the context of the second performance report for the biennium 2006-2007. The requirements for servicing the Ad Hoc Open-ended Working Group in 2008, estimated at \$264,300 under section 2 and \$20,100 under section 28D, would be considered in the context of the proposed programme budget for the biennium 2008-2009.
- 5. Lastly, introducing the statement of programme budget implications of draft resolution A/ES-10/L.20 (A/C.5/61/13), she drew attention to chapters I and III of document A/C.5/61/13. The estimated costs of the establishment and maintenance of the Register of Damage for a one-year period from 1 January to 31 December 2007 amounted to \$3,098,700. Paragraph 17 of the statement gave a detailed breakdown of those costs. Accordingly, should the General Assembly adopt draft resolution A/ES-10/L.20, an additional appropriation of \$3,098,700 would be required under section 3, Political affairs, and section 35, Staff

assessment, to be offset by the same amount under Income section 1, Income from staff assessment, of the programme budget for the biennium 2006-2007.

- 6. Mr. Saha (Chairman of the Advisory Committee Administrative and Budgetary introducing the oral report of the Advisory Committee on the statement of programme budget implications of draft resolution contained in document A/AC.265/2006/L.8/Rev.1. said that the Advisory Committee was recommending that the Fifth Committee should inform the General Assembly that, should it adopt the draft resolution contained in document A/AC.265/2006/L.8/Rev.1, no immediate financial implications would arise.
- 7. The statement of programme budget implications provided an unusual level of detail concerning resources that might be requested in the context of the proposed programme budget for 2008-2009. The adoption of the draft resolution contained in document A/AC.265/2006/L.8/Rev.1 should not be interpreted as prejudging in any way the outcome of the consideration of the proposed programme budget for the forthcoming biennium.
- 8. Referring to the statement of programme budget implications of draft resolution A/61/L.30, he pointed out that, as indicated in paragraph 11 of document A/C.5/61/16, it was envisaged that the additional requirements would be accommodated from within the appropriations for sections 2 and 28D of the programme budget for the biennium 2006-2007. Should the actual requirements for implementing the provisions of the draft resolution exceed the absorptive capacity of those sections, the additional requirements would be reported in the context of the second performance report for the biennium 2006-2007.
- 9. Introducing the Advisory Committee's report on the statement of programme budget implications of draft resolution A/ES-10/L.20 (A/61/614), he said that, while the additional estimated requirements for the programme budget for the biennium 2006-2007 for the establishment of the Register of Damage amounted to some \$3.1 million, that estimate reflected the application of a 50 per cent vacancy factor for 2007. The estimated annual requirements at full cost would amount to some \$3.9 million.
- 10. The Advisory Committee was recommending that the Fifth Committee should report to the General Assembly that, should it adopt draft resolution

- A/ES-10/L.20, an additional appropriation of up to \$3,098,700 would be required under the programme budget for the biennium 2006-2007, including \$2,812,000 under section 3, Political affairs, and \$286,700 under section 35, Staff assessment. The latter sum would be offset by the same amount under Income section 1, Income from staff assessment.
- 11. **Mr. Kozaki** (Japan), referring to the programme budget implications of draft resolution A/61/L.30, said that he trusted that the additional requirements would be met from within approved resources. With regard to the programme budget implications of the draft resolution contained in document A/AC.265/2006/L.8/Rev.1. he agreed with Advisory Committee that the outcome of the deliberations on the proposed programme budget for the biennium 2008-2009 should not be prejudged. At the present stage, any additional costs should be absorbed though the prioritization and redeployment of existing resources, in accordance with the provisions of General Assembly resolutions 41/213 and 42/211.
- 12. Lastly, he pointed out that the ongoing discussions on draft resolution A/ES-10/L.20 might have consequences for the programme budget implications of the draft resolution. He would require further information from the Secretariat before taking any action.
- 13. **Mr. Fluss** (Israel) said that, while he recognized the Fifth Committee's competence to consider budgetary matters, the programme budget implications of draft resolution A/ES-10/L.20 were far greater than those originally envisaged in the relevant report of the Secretary-General (A/ES-10/361). It was clear that the issue had become politicized, even though the construction of the fence had been motivated by security rather than political concerns. In the face of Palestinian terror, the fence had become a necessity and, while the inconveniences it caused were reversible, the murder of Israeli citizens by Palestinian terrorists was not. Moreover, the Israeli judicial system had already implemented appropriate compensation mechanisms.
- 14. Draft resolution A/ES-10/L.20 was the result of a politicized process. The Palestinians and their supporters had become all too confident of their ability to hijack the General Assembly for their own purposes. Such actions ran counter to the objective of the tenth emergency special session, namely, uniting for peace.

15. **Mr. Abelian** (Secretary of the Committee) read out the following draft decision:

"The Fifth Committee, having considered the statement of programme budget implications submitted by the Secretary-General arising from the draft resolution on the establishment of the United Nations Register of Damage caused by the Construction of the Wall in the Occupied Palestinian Territory and the related report of the Advisory Committee on Administrative and Budgetary Questions:

- (a) *Decides* to endorse the observations and recommendations of the Advisory Committee on Administrative and Budgetary Questions;
- (b) *Reaffirms* rule 153 of the rules of procedure of the General Assembly;
- (c) *Decides* to appropriate up to \$3,098,700 under section 3, Political affairs (\$2,812,000), and section 35, Staff assessment (\$286,700), to be offset by the same amount under Income section 1, Income from staff assessment, of the programme budget for the biennium 2006-2007, for the establishment and maintenance of the Register of Damage."
- 16. **Ms. Lock** (South Africa), speaking on behalf of the Group of 77 and China, requested a written text of the draft decision.

The meeting rose at 12.30 p.m.
