### Financing of the United Nations Operation in Burundi

#### Draft resolution submitted by the Chairman following informal consultations

#### Financing of the United Nations Operation in Burundi

*The General Assembly,*

*Having considered* the report of the Secretary-General on the financing of the United Nations Operation in Burundi,<sup>1</sup> the related report of the Advisory Committee on Administrative and Budgetary Questions<sup>2</sup> and the statements made by the representative of the Secretary-General and the Chairperson of the Advisory Committee,<sup>3</sup>

*Recalling* Security Council resolution 1545 (2004) of 21 May 2004, by which the Council authorized, for an initial period of six months as from 1 June 2004, with the intention to renew it for further periods, the deployment of a peacekeeping operation called the United Nations Operation in Burundi, and the subsequent resolutions by which the Council extended the mandate of the Operation, the last of which was resolution 1692 (2006) of 30 June 2006, by which the Council extended the mandate of the Operation until 31 December 2006,

*Recalling also* its resolution 58/312 of 18 June 2004 on the financing of the Operation and its subsequent resolutions thereon, the latest of which was resolution 61/9 B of 29 June 2007,

*Reaffirming* the general principles underlying the financing of United Nations peacekeeping operations, as stated in General Assembly resolutions 1874 (S-IV) of 27 June 1963, 3101 (XXVIII) of 11 December 1973 and 55/235 of 23 December 2000,

1. *Takes note* of the status of contributions to the United Nations Operation in Burundi as at 31 March 2008, including the credits in the amount of 27.5 million United States dollars;

2. *Endorses* the conclusions and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions,<sup>2</sup> subject to the provisions of the present resolution, and requests the Secretary-General to ensure their full implementation;

**Financial performance report for the period from 1 July 2006 to 30 June 2007**

3. *Takes note* of the report of the Secretary-General on the financial performance of the Mission for the period from 1 July 2006 to 30 June 2007;<sup>1</sup>

4. *Also takes note* of paragraphs 14 and 15 of the report of the Advisory Committee on Administrative and Budgetary Questions;<sup>2</sup>

5. *Decides* that, for Member States that have fulfilled their financial obligations to the Operation, there shall be credited their respective share of the unencumbered balance and other income in the amount of 30,729,800 dollars, in respect of the financial period ended 30 June 2007, in accordance with the levels updated in General Assembly resolution 61/243 of 22 December 2006, and taking into account the scale of assessments for 2007, as set out in its resolution 61/237 of 22 December 2006;

6. *Also decides* that, for Member States that have not fulfilled their financial obligations to the Operation, their share of the unencumbered balance and other income in the amount of 30,729,800 dollars in respect of the financial period ended 30 June 2007 shall be set off against their outstanding obligations, in accordance with the scheme set out in paragraph 5 above;

7. *Further decides* that the decrease of 378,700 dollars in the estimated staff assessment income in respect of the financial period ended 30 June 2007 shall be set off against the credits from the amount of 30,729,800 dollars referred to in paragraphs 5 and 6 above;

8. *Decides* to include in the provisional agenda of its sixty-third session the item entitled "Financing of the United Nations Operation in Burundi".
