- 6. **Mr. Hunte** (Antigua and Barbuda), speaking in explanation of position on behalf of the Group of 77 and China, said that delegations had worked hard to achieve a positive outcome. They were disappointed that their efforts had not brought about the desired result but would strive to make further progress in the fall.
- 7. **Mr. Muhith** (Bangladesh) said that his delegation attached great importance to streamlining contracts and improving the conditions of service of field staff. The Secretariat, the International Civil Service Commission and the Advisory Committee had provided adequate information, which should have enabled delegations to reach a consensus at the current session. Bangladesh deeply regretted that the agenda item was being deferred to the sixty-third session.
- 8. **Mr. Taula** (New Zealand), speaking on behalf of Canada, Australia and New Zealand (CANZ), said that the CANZ delegations also regretted that it had not been possible to reach a consensus on a more substantive resolution. They trusted that further progress would be made in the fall.

- 10. **Ms. Simkić** (Slovenia), speaking on behalf of the European Union, said that the European Union regretted the Committee's failure to reach consensus on the strengthening of the Department of Political Affairs, especially since all Member States had affirmed the importance of preventive diplomacy. The reports had been issued well before the start of the first part of the resumed session and, if all parties had been willing to engage, it would have been possible to reach a consensus.
- 11. **Mr. Wagle** (Nepal) said that Nepal was on the verge of holding crucial elections and expressed his delegation's gratitude to the Secretariat and the United Nations Mission in Nepal (UNMIN) for their support.
- 12. **The Chairman** declared that the Fifth Committee had completed its work at the first part of the resumed sixty-second session of the General Assembly.
