### Programme budget for the biennium 2008-2009

#### Draft report of the Fifth Committee

*Rapporteur:* Mr. Patrick A. Chuasoto (Philippines)

## I. Introduction

1. The previous recommendations made by the Fifth Committee to the General Assembly under agenda item 118 appear in the report of the Committee contained in documents A/63/648 and Add.1-3. In the report contained in document A/63/648, the Committee provided its recommendations on the question of conditions of service and compensation for officials other than Secretariat officials: members of the International Court of Justice and judges and ad litem judges of the International Tribunal for the Former Yugoslavia and the International Criminal Tribunal for Rwanda. In document A/63/648/Add.1, the Committee provided its recommendations on the question of development-related activities. In document A/63/648/Add.2, the Committee provided its recommendations on the question of strengthening the Department of Political Affairs. In document A/63/648/Add.3, the Committee provided its recommendations on the question of information and communications technology/enterprise resource planning/security, disaster recovery and business continuity. The present document provides the recommendations of the Committee on other questions relating to the programme budget for the biennium 2008-2009.

2. The Fifth Committee considered the item at its 3rd, 12th, 15th, 17th, 18th, 20th to 24th, 26th and 28th meetings, on 7 and 27 October, 6, 13, 14, 24 and 26 November and 4, 15, 16, 19 and 23 December 2008. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary records (A/C.5/63/SR.3, 12, 15, 17, 18, 20-24, 26 and 28).

3. Section II of the present report contains a summary of the recommendations made by the Fifth Committee during the sixty-third session of the General Assembly on the revised estimates submitted by the Secretary-General and on the programme budget implications of resolutions adopted by the Assembly, either on the

recommendation of its Main Committees or in respect of items considered in plenary meeting.

4. Section III contains a summary of the questions, in particular those relating to the programme budget for the biennium 2008-2009, considered by the Fifth Committee that led to the adoption of specific decisions to be recommended for adoption by the General Assembly. A summary of other questions relating to the item are contained in documents A/63/648 and Add.1-3 (see para. 1 above).

5. The recommendations of the Fifth Committee are contained in section IV.

## II. Programme budget for the biennium 2008-2009

6. In its resolutions 62/237 A and B, the General Assembly approved budget appropriations for the biennium 2008-2009 in the amount of \$4,171,359,700 and income estimates in the amount of \$515,460,600. By its resolution 62/245, further appropriations were approved resulting in an additional appropriation of \$31,631,600 and additional income estimates in the amount of \$4,617,100.

7. Recommendations of the Fifth Committee during the current session of the General Assembly on revised estimates submitted by the Secretary-General, as well as on the programme budget implications of resolutions adopted by the Assembly under items considered by other Main Committees or in respect of items considered in plenary meeting, have resulted in a net increase in the approved level of appropriations in the amount of \$657,471,800 and a net increase in the approved income estimates in the amount of \$35,198,700.

8. The revised estimates of expenditure and income approved by the Fifth Committee and the financial implications of resolutions recommended by other Main Committees and subsequently by the General Assembly are indicated, by expenditure and income section, in the following table:

9. At its 28th meeting, on 23 December 2008, the Committee considered the revised estimates of expenditure and income to be recommended for approval by the General Assembly for the biennium 2008-2009, as well as the financing of the appropriations for the year 2009. The Committee took the following action in that regard:

(a) It approved the revised budget appropriations for the biennium 2008-2009 (see para. 44, draft resolution II.A);

(b) It approved the revised income estimates for the biennium 2008-2009 (see para. 44, draft resolution II.B);

(c) It approved the draft resolution on the financing of the appropriations for the year 2009 (see para. 44, draft resolution II.C).

### **III. Consideration of questions relating to the programme budget for the biennium 2008-2009**

#### **Construction of additional conference facilities at the Vienna International Centre and additional office facilities at the Economic Commission for Africa in Addis Ababa, and improving and modernizing the conference facilities and construction of additional office facilities at the United Nations Office at Nairobi**

10. The Committee considered this question at its 3rd and 21st meetings, on 7 October and 26 November. It had before it the reports of the Secretary-General (A/62/794 and A/63/303) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/63/465).

11. At the 28th meeting, on 23 December, the Chairman of the Committee introduced a draft resolution entitled “Construction of additional conference facilities at the Vienna International Centre and additional office facilities at the Economic Commission for Africa in Addis Ababa, and improving and modernizing the conference facilities and construction of additional office facilities at the United Nations Office at Nairobi” (A/C.5/63/L.23, sect. I), informal consultations on which had been coordinated by the representative of Sweden. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 44, draft resolution I, sect. I).

#### **Revised estimates relating to the Rule of Law Unit**

12. The Committee considered this question at its 23rd meeting, on 15 December. It had before it the report of the Secretary-General (A/63/154) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/63/594).

13. At the 28th meeting, on 23 December, the Chairman of the Committee introduced a draft resolution entitled “Revised estimates relating to the Rule of Law Unit” (A/C.5/63/L.23, sect. II), informal consultations on which had been coordinated by the representative of Sweden. The Chairman of the Committee orally revised the draft resolution by adding two paragraphs after operative paragraph 3, reading:

*“Requests the Secretary-General to ensure that the Director of the Unit continues to be provided, for 2009, through secondment;*

*“Decides to revert to this issue in the context of the proposed programme budget for the biennium 2010-2011.”*

14. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 44, draft resolution I, sect. II, as orally revised).

**Administrative and financial implications of the decisions and recommendations contained in the report of the International Civil Service Commission for 2008**

15. The Committee considered this question at its 12th meeting, on 27 October. It had before it the report of the Secretary-General (A/63/360) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/63/501).

16. At the 28th meeting, on 23 December, the Chairman of the Committee introduced a draft resolution entitled “Administrative and financial implications of the decisions and recommendations contained in the report of the International Civil Service Commission for 2008” (A/C.5/63/L.23, sect. III), informal consultations on which had been coordinated by the representative of the Netherlands. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 44, draft resolution I, sect. III).

**Revised estimates resulting from resolutions and decisions adopted by the Economic and Social Council at its substantive session of 2008**

17. The Committee considered this question at its 22nd meeting, on 4 December. It had before it the report of the Secretary-General (A/63/371) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/63/567).

18. At the 28th meeting, on 23 December, the Chairman of the Committee introduced a draft resolution entitled “Revised estimates resulting from resolutions and decisions adopted by the Economic and Social Council at its substantive session of 2008” (A/C.5/63/L.23, sect. IV), informal consultations on which had been coordinated by the representative of Sweden. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 44, draft resolution I, sect. IV).

**Revised estimates resulting from resolutions and decisions adopted by the Human Rights Council at its seventh, eighth and ninth sessions, proposals to improve the procedure for presenting to the General Assembly the financial requirements arising from the resolutions and decisions of the Council, and a consolidated statement on resolutions and decisions adopted by the Council arising from its continuing review of its subsidiary machinery and related programme budget implications**

19. The Committee considered this question at its 26th meeting, on 19 December. It had before it the reports of the Secretary-General (A/63/541 and Add.1 and A/63/587) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/63/629).

20. At the 28th meeting, on 23 December, the Chairman of the Committee introduced a draft resolution entitled “Revised estimates resulting from resolutions and decisions adopted by the Human Rights Council at its seventh, eighth and ninth sessions, proposals to improve the procedure for presenting to the General Assembly the financial requirements arising from the resolutions and decisions of the Council, and a consolidated statement on resolutions and decisions adopted by the Council

arising from its continuing review of its subsidiary machinery and related programme budget implications” (A/C.5/63/L.23, sect. V), informal consultations on which had been coordinated by the representative of Sweden. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 44, draft resolution I, sect. V).

#### **Revised estimates resulting from the entry into force of the Convention on the Rights of Persons with Disabilities and the Optional Protocol thereto**

21. The Committee considered this question at its 26th meeting, on 19 December. It had before it the report of the Secretary-General (A/63/583) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/63/628).

22. At the 28th meeting, on 23 December, the Chairman of the Committee introduced a draft resolution entitled “Revised estimates resulting from the entry into force of the Convention on the Rights of Persons with Disabilities and the Optional Protocol thereto” (A/C.5/63/L.23, sect. VI), informal consultations on which had been coordinated by the representative of Sweden. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 44, draft resolution I, sect. VI).

#### **Review of the lump-sum arrangement of the Office of the United Nations High Commissioner for Refugees**

23. The Committee considered this question at its 26th meeting, on 19 December. It had before it the report of the Secretary-General (A/63/537) and the report of the Advisory Committee on Administrative and Budgetary Questions (A/63/616).

24. At the 28th meeting, on 23 December, the Chairman of the Committee introduced a draft resolution entitled “Review of the lump-sum arrangement of the Office of the United Nations High Commissioner for Refugees” (A/C.5/63/L.23, sect. VII), informal consultations on which had been coordinated by the representative of Sweden. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 44, draft resolution I, sect. VII).

#### **Human resources management**

25. The Committee considered this question at its 17th and 18th meetings, on 13 and 14 November.

26. At the 28th meeting, on 23 December, the Chairman of the Committee introduced a draft resolution entitled “Human resources management” (A/C.5/63/L.23, sect. VIII), informal consultations on which had been coordinated by the representative of Australia. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 44, draft resolution I, sect. VIII).

#### **Administrative and financial implications arising from the report of the United Nations Joint Staff Pension Board**

27. The Committee considered this question at its 20th meeting, on 24 November. It had before it the report of the Secretary-General (A/63/363) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/63/556).

28. At the 28th meeting, on 23 December, the Chairman of the Committee introduced a draft resolution entitled “Administrative and financial implications arising from the report of the United Nations Joint Staff Pension Board” (A/C.5/63/L.23, sect. IX), informal consultations on which had been coordinated by the representative of the Philippines. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 44, draft resolution I, sect. IX).

**Revised estimates relating to the programme budget for the biennium 2008-2009 under section 32, construction, alteration, improvement and major maintenance, related to the provision of an integrated headquarters facility for the United Nations Assistance Mission for Iraq, in Baghdad**

29. The Committee considered this question at its 24th meeting, on 16 December. It had before it the report of the Secretary-General (A/62/828), the relevant parts of the report of the Secretary-General on the estimates in respect of the United Nations Assistance Mission for Iraq (A/63/346 and Add.5) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/63/601).

30. At the 28th meeting, on 23 December, the Chairman of the Committee introduced a draft resolution entitled “Revised estimates relating to the programme budget for the biennium 2008-2009 under section 32, construction, alteration, improvement and major maintenance, related to the provision of an integrated headquarters facility for the United Nations Assistance Mission for Iraq, in Baghdad” (A/C.5/63/L.23, sect. X), informal consultations on which had been coordinated by the representative of Bulgaria. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 44, draft resolution I, sect. X).

**Estimates in respect of special political missions, good offices and other political initiatives authorized by the General Assembly and/or the Security Council**

31. The Committee considered this question at its 24th meeting, on 16 December. It had before it the reports of the Secretary-General (A/63/346 and Corr.1, Add.1 and Corr.1 and 2 and Add.2-5) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/63/593).

32. At the 28th meeting, on 23 December, the Chairman of the Committee introduced a draft resolution entitled “Estimates in respect of special political missions, good offices and other political initiatives authorized by the General Assembly and/or the Security Council” (A/C.5/63/L.23, sect. XI), informal consultations on which had been coordinated by the representative of Bulgaria.

33. At the same meeting, the representative of Lebanon orally proposed an amendment to the draft resolution by which a new paragraph would be inserted after operative paragraph 3, reading:

“*Requests* the Secretary-General to revise the narrative and the logical framework of the budget of the Special Envoy of the Secretary-General for the implementation of Security Council resolution 1559 (2004), taking into account recent developments and the concerns raised by Member States, and to submit a report thereon to the General Assembly before the first part of its resumed sixty-third session.”

34. Also at the same meeting, the representative of France, speaking on behalf of the States Members of the United Nations that are members of the European Union, requested a recorded vote on the proposed amendment.

35. At the same meeting, the Committee adopted, by a recorded vote of 86 to 50, with 4 abstentions, the proposed amendment to section XI of draft resolution A/C.5/63/L.23. The voting was as follows:<sup>1</sup>

*Against:*

Albania, Australia, Austria, Belgium, Bosnia and Herzegovina, Bulgaria, Canada, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Georgia, Germany, Greece, Hungary, Iceland, Ireland, Israel, Italy, Jamaica, Japan, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Montenegro, Netherlands, New Zealand, Norway, Poland, Portugal, Republic of Korea, Republic of Moldova, Romania, Serbia, Slovakia, Slovenia, Spain, Sweden, Switzerland, the former Yugoslav Republic of Macedonia, Trinidad and Tobago, Turkey, Ukraine, United Kingdom of Great Britain and Northern Ireland, United States of America.

*Abstaining:*

36. At the same meeting, the Committee then adopted the draft resolution as a whole, as orally amended, without a vote (see para. 44, draft resolution I, sect. XI).

**First performance report on the programme budget for the biennium 2008-2009**

37. The Committee considered this question at its 26th meeting, on 19 December. It had before it the report of the Secretary-General (A/63/573) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/63/620).

38. At the 28th meeting, on 23 December, the Chairman of the Committee introduced a draft resolution entitled "First performance report on the programme

39. The Committee considered this question at its 28th meeting, on 23 December. It had before it the report of the Secretary-General (A/C.5/63/20). At the same meeting the Committee decided, without a vote, to recommend to the General Assembly that it note that a balance of \$5,122,000 remained in the contingency fund (see para. 44, draft resolution I, sect. XIII).

#### **United Nations Fund for International Partnerships**

40. The Committee considered this question at its 15th meeting, on 6 November. It had before it the report of the Secretary-General (A/63/257).

41. At the 15th meeting, on 6 November, the Chairman of the Committee orally introduced a draft decision entitled “United Nations Fund for International Partnerships” (see A/C.5/63/SR.15). At the same meeting, the Committee adopted the draft decision without a vote (see para. 45, draft decision I).

#### **Rental of office space in the Secretariat by the Group of 77 and China**

42. The Committee, at its 24th meeting, on 16 December, was requested by the representative of Antigua and Barbuda, on behalf of the States Members of the United Nations that are members of the Group of 77 and China, to consider, under an additional agenda item, the question of the rental of office space in the Secretariat by the Group of 77 and China (see A/C.5/63/SR.24).

43. At the 28th meeting, on 23 December, the Chairman of the Committee introduced a draft decision entitled “Rental of office space in the Secretariat by the Group of 77 and China”, informal consultations on which had been coordinated by the representative of Canada (see A/C.5/63/SR.28). At the same meeting, the Committee adopted the draft decision without a vote (see para. 45, draft decision II).

*Mindful* of the fact that it is essential to construct, improve and modernize facilities at the Economic Commission for Africa in Addis Ababa, the United Nations Office at Nairobi and the Vienna International Centre to ensure the efficient work of the Organization,

1. *Takes note with appreciation* of the efforts of the Governments of Ethiopia and Kenya, as host countries, in facilitating the construction of additional office facilities at the Economic Commission for Africa in Addis Ababa and the improvement and modernization of the conference facilities and the construction of additional office facilities at the United Nations Office at Nairobi, and of the efforts of the Government of Austria, as host country, in completing the construction of new conference facilities at the Vienna International Centre, as well as in achieving good progress in the asbestos removal project;

2. *Takes note* of the reports of the Secretary-General;<sup>4</sup>

3. *Endorses* the conclusions and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions,<sup>3</sup> subject to the provisions of the present resolution;

4. *Underlines* the risks inherent in the execution of construction projects, and stresses the importance of adequate planning, coordination and project supervision to avoid going over budget;

5. *Expresses concern* about the delays and procedural difficulties in the execution of the projects at the Economic Commission for Africa in Addis Ababa and the United Nations Office at Nairobi, which are contributing to project cost escalation;

6. *Requests* the Secretary-General to undertake management reviews of the projects at the Economic Commission for Africa in Addis Ababa and the United Nations Office at Nairobi with a view to expediting their implementation, to ensure that a dedicated project management capacity is in place at the Economic Commission for Africa in Addis Ababa and the United Nations Office at Nairobi and to report thereon in the context of his next annual progress reports;

7. *Emphasizes* the importance of guidance, interaction and coordination between the Secretariat in New York, on the one hand, and the Economic Commission for Africa in Addis Ababa and the United Nations Office at Nairobi, on the other hand, with clear reporting lines;

8. *Requests* the Secretary-General to ensure full accountability for the delays, lack of responsiveness of management to the needs of the construction projects in Addis Ababa and Nairobi and other factors that have contributed to delays in the implementation of the projects and project cost escalation and to include that information in his next annual progress reports;

9. *Stresses* the importance of the leadership and guidance of the Secretary-General and senior management as well as a commitment to the construction projects at the Economic Commission for Africa in Addis Ababa and the United Nations Office at Nairobi by all concerned parties during the execution and completion of the projects;

10. *Requests* the Secretary-General to update the Member States through regular informal briefings on the construction projects at the Economic Commission for Africa in Addis Ababa and the United Nations Office at Nairobi;

11. *Also requests* the Secretary-General to complete the construction projects at the Economic Commission for Africa in Addis Ababa and the United Nations Office at Nairobi as planned, without any further delays or additional requirements from the regular budget, and to ensure that progress is monitored by the Under-Secretary-General for Management, and to report thereon to the General Assembly at its sixty-fourth session;

12. *Further requests* the Secretary-General to ensure that the construction regulations and rules of the Organization, including the provisions of the Convention on the Rights of Persons with Disabilities, are abided by and fully upheld in all phases of the construction projects at the Economic Commission for Africa in Addis Ababa and the United Nations Office at Nairobi;

13. *Approves* the revised estimated cost of 25,252,200 United States dollars for the construction of additional office facilities at the United Nations Office at Nairobi;

14. *Also approves* the use of interest income of 798,200 dollars as at 31 December 2007, and further approves the use of future interest income generated by accumulated rental income for the construction of additional office facilities at the United Nations Office at Nairobi;

15. *Further approves* the revised estimated cost of 3,479,000 dollars for improving and modernizing the conference facilities at the United Nations Office at Nairobi;

16. *Requests* the Secretary-General to entrust the Office of Internal Oversight Services with ensuring continuing effective audit coverage as well as regular, thorough management reviews of the construction of additional office facilities at the Economic Commission for Africa in Addis Ababa and the United Nations Office at Nairobi, to be reported on in the annual report of the Office of Internal Oversight Services to the General Assembly;

17. *Recalls* paragraphs 24, 25, 35 and 44 of the report of the Advisory Committee on Administrative and Budgetary Questions,<sup>3</sup> and requests the Secretary-General to submit, in the context of the proposed programme budget for the biennium 2010-2011, information that outlines clearly the interaction between the Secretariat in New York and other duty stations for construction and long-term renovation projects, and that specifies all aspects of the division of responsibility and accountability;

3. *Welcomes* the contribution of the Government of Iraq, and recognizes the importance of the proposal for the construction of a purpose-built integrated headquarters for the United Nations Assistance Mission for Iraq;
4. *Approves* commitment authority for 2009 for the United Nations Assistance Mission for Iraq in the amount of 5 million dollars under section 32 of the programme budget for the biennium 2008-2009 to undertake design work in connection with the construction of the United Nations integrated compound in Baghdad;
5. *Emphasizes* the importance of ensuring that the project is based on accurate assumptions and that its planning phase takes into account the experience of the execution of other construction projects in the United Nations as well as ensuring proper accountability with regard to the implementation of the project;

1. *Reaffirms* the budgetary process as approved in its resolution 41/213 and reaffirmed in subsequent resolutions;

2. *Takes note* of the first performance report of the Secretary-General on the programme budget for the biennium 2008-2009,<sup>25</sup> and endorses the observations and recommendations of the Advisory Committee on Administrative and Budgetary Questions contained in its report,<sup>26</sup> subject to the provisions of the present resolution;

Budget appropriations totalling 2,779,400,350 United States dollars and consisting of 2,085,679,850 dollars, being half of the appropriation initially approved for the biennium 2008-2009 in its resolution 62/237 A of 22 December 2007, 36,248,700 dollars, being the additional appropriation approved for the biennium in its resolution 62/245 of 3 April 2008, and 657,471,800 dollars, being the increase approved in resolution A above, shall be financed in accordance with regulations 3.1 and 3.2 of the Financial Regulations and Rules of the United Nations,<sup>1</sup> as follows:

(a) 14,890,800 dollars, consisting of:

(i) 24,840,100 dollars, being half of the estimated income other than staff assessment approved for the biennium in its resolution 62/237 B of 22 December 2007;

(ii) 9,949,300 dollars, being the decrease in income other than staff assessment approved for the biennium in resolution B above;

(b) 2,764,509,550 dollars, being the assessment on Member States in accordance with its resolution 61/237 of 22 December 2006, of which 45 million

dollars is subject to assessment in accordance with paragraph 8 of section XII of resolution 63/263 of 24 December 2008;

2. There shall be set off against the assessment on Member States, in accordance with the provisions of General Assembly resolution 973 (X) of 15 December 1955, their respective share in the Tax Equalization Fund in the total amount of 283,193,400 dollars, consisting of:

(a) 232,890,200 dollars, being half of the estimated staff assessment income approved by the Assembly in its resolution 62/237 B;

(b) 4,617,100 dollars, being the estimated increase in income from staff assessment approved by the Assembly in its resolution 62/245;

(c) 45,148,000 dollars, being the estimated increase in income from staff assessment approved by the Assembly in resolution B above;

(d) 538,100 dollars, being the increase in income from staff assessment for the biennium 2006-2007 compared with the revised estimates approved by the Assembly in its resolution 62/235 B of 22 December 2007.

**United Nations Fund for International Partnerships**

The General Assembly takes note of the report of the Secretary-General on the United Nations Office for Partnerships.<sup>1</sup>

**Draft decision II**  
**Rental of office space in the Secretariat by the Group of 77 and China**

The General Assembly, recalling its resolution 41/213 of 19 December 1986 and recalling also its resolution 56/253 of 24 December 2001, whereby the General Assembly established the arrangements for rental charges for the Office of the Group of 77 and China located at United Nations Headquarters:

(a) Decides to establish, effective 1 January 2009, a rental charge in the amount of 6 United States dollars per square foot per annum for the office space occupied by the Office of the Group of 77 and China at United Nations Headquarters, which includes the provision of furniture and photocopying machine;

(b) Recognizes the receivables associated with the rental obligations of the Group of 77 and China for the office space occupied by the Group at United Nations Headquarters, and decides that, as an exceptional measure, the outstanding receivables as at 31 December 2008 shall be written off;

(c) Emphasizes the need for all United Nations tenants to pay their rents on time, in full and without conditions;

(d) Also emphasizes that in the future, the Secretary-General, as Chief Administrative Officer, should handle rental issues with individual tenants in accordance with existing procedures, without recourse to the General Assembly.
