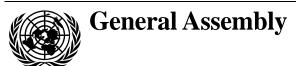

## **Imtiaz Hussain**

Imtiaz Hussain joined the Diplomatic Service on 1 November 1986 and has served in various capacities both in the Ministry of Foreign Affairs and Pakistan's Missions abroad. At the Foreign Ministry, as Desk Officer for Audit and Inspection he was responsible for the implementation of the Inspector General's reports in coordination with all relevant departments. As Director (OIC) in the Ministry of Foreign Affairs, apart from responsibility for political, economic, social and cultural issues, he was in charge of the administrative and budgetary aspects of the OIC. He was the delegate of Pakistan to the Working Group on the OIC administrative reforms in his tenure from 1997 to 2000. As Director Security Council and Human Rights he is familiar with the Security Council's role in peacekeeping and special political missions.

Imtiaz Hussain has been posted to the Embassies of Pakistan in Belgrade, Copenhagen, Zagreb, Sarajevo and Seoul. He has served at the Permanent Missions of Pakistan to the Office of the United Nations and other international organizations in Geneva and is currently posted as Minister in the Permanent Mission of Pakistan to the United Nations in New York. In Geneva he was in charge of affairs relating to the Commission on Human Rights, the Office of the United Nations High Commissioner for Refugees, the World Health Organization, the International Labour Organization, and the International Organization for Migration, including administrative and budgetary matters. At the Permanent Mission in New York, he is the delegate of Pakistan to the Fifth Committee and is familiar with the whole gamut of administrative and budgetary matters on its agenda.

Through his assignments in the United Nations Division in the Ministry of Foreign Affairs and the Permanent Missions of Pakistan in Geneva and New York he has hands-on experience in dealing with all aspects of the work of the United Nations, including its administrative and budgetary aspects, and management and Secretariat reforms. He has been the Coordinator of the Group of 77 for several important negotiations, in which he has helped in forging consensus.

Imtiaz Hussain has attended numerous summits and ministerial meetings of the Organization of the Islamic Conference, the Non-Aligned Movement and the United Nations during his career.

He holds a Master's Degree in Chemistry from the Punjab University, Lahore, Pakistan, and has attended several training programmes, including an advanced course in Public Administration. He is married and has three children.

## Carlos Ruiz Massieu

Carlos Ruiz Massieu is a career diplomat who joined the Mexican Foreign Service in 1999. He has a Law Degree from Iberoamericana University (Mexico City) and a Master's degree in Political Science from the University of Essex in the United Kingdom of Great Britain and Northern Ireland.

Since August 2004, he has been posted at the Permanent Mission of Mexico to the United Nations in New York, where he has acquired thorough experience in the United Nations system, having been responsible for many issues under consideration by various intergovernmental bodies within the Organization. He has represented Mexico in the Economic and Social Council and in the Second Committee (economic issues) of the General Assembly, and has chaired negotiations on the reform of the Economic and Social Council and on development issues after the 2005 World Summit. Since 2004, he has also represented Mexico on the Executive Boards of the United Nations Development Programme and the United Nations Children's Fund and during the current tenure of Mexico as a non-permanent member (2009-2010) of the United Nations Security Council, has served as Alternate Representative in charge of African issues and the situation in Haiti.

Since 2007, he has served as Coordinator of the Mexican delegation that participates in the Fifth Committee (administrative and budgetary issues) of the General Assembly, as well as in the work of various United Nations funds and programmes. In that position, he has promoted measures aimed at making the Organization more efficient and effective and at increasing the budgetary discipline of the United Nations.

He has been posted to the Department of Legal Affairs in the Ministry of Foreign Affairs of Mexico and to the Embassy of Mexico in Costa Rica. In addition to his diplomatic career, he has complemented his work experience in the Mexican public sector by holding positions in the Ministry of the Interior and the Ministry of Social Development.

#### **Experience**

More than 20 years' experience in multilateral diplomacy has provided Ambassador Zhang with abundant knowledge and a deep understanding of international organizations, especially of United Nations conferences and meetings.

Ambassador Zhang had been in charge of United Nations administrative and budgetary issues for many years. As a representative of the Government of China, he was a regular participant in the meetings of the Fifth Committee of the General Assembly and the Committee for Programme and Coordination. Being an excellent negotiator, he was actively involved in relevant discussions and negotiations and put forward many constructive suggestions in terms of United Nations budgetary and personnel issues. In the late 1980s, under the circumstances of a great increase in the United Nations peacekeeping operations, he was the first to suggest the addition to the agenda of the General Assembly of the item entitled "Administrative and budgetary aspects of peacekeeping operations". He also presided over the joint meeting of the Advisory Committee of Permanent Representatives and other Representatives Designated by Members of the Commission and the Advisory Committee on Administrative and Budgetary Questions when the latter undertook a field mission to ESCAP in 2006.

He worked on United Nations Security Council affairs and issues related to United Nations peacekeeping operations and joined the United Nations observation and assistance missions to Namibia, South Africa and Mozambique while he was

working at the Department of International Organizations and Conferences in the Ministry of Foreign Affairs of China.

During his tenure as the Permanent Representative of the People's Republic of China to ESCAP, he served many times as the chairman of the Advisory Committee of the Permanent Representatives and other Representatives Designated by Members of the Commission and acted as the rapporteur of that Committee and the chairman of the Working Group on Draft Resolutions of the Sixty-Second Session of ESCAP.
