

Note by the Secretary-General

- 1. Bruno N. Brant (Brazil)

Bruno Brant is a First Secretary at the Permanent Mission of Brazil to the United Nations and has been the Brazilian delegate to the Fifth Committee since 2008. Prior to that, he served as an adviser to the President of the sixty-second session of the General Assembly on Fifth Committee and management reform issues. Mr. Brant joined the Brazilian Foreign Service in 2003. After completing his Master's Degree in Diplomacy in the Brazilian Diplomatic Academy, he worked for three years in the United Nations Division, with responsibilities in the areas of budget and administration of the United Nations, United Nations reform and peacekeeping operations. Before joining the public sector, he also obtained work experience from the private sector, having occupied positions in the banking and international trade industries. He was awarded a Fulbright Scholarship and completed his Master's Degree in International Political Economy and Development at Fordham University in 2001, and holds a Bachelor's Degree in Economics, from the Federal University of Minas Gerais, in Brazil.
