Appointments to fill vacancies in subsidiary organs and other appointments

Confirmation of the appointment of members of the Investments Committee

Note by the Secretary-General

1. As indicated in document [A/71/103](#) of 10 March 2016, the General Assembly will be required, at its current session, to confirm the appointment by the Secretary-General of nine persons to fill vacancies in the Investments Committee resulting from the expiration, on 31 December 2016, of the terms of office of Masakazu Arikawa (Japan), Madhav Dhar (India), Simon Jiang (China), Achim Kassow (Germany), Nemir Kirdar (Iraq), Michael S. Klein (United States of America), Linah K. Mohohlo (Botswana) and Gumersindo Oliveros (Spain).
2. In accordance with the provisions of article 20 of the regulations of the United Nations Joint Staff Pension Fund, the Secretary-General, after consultation with the United Nations Joint Staff Pension Board and the Advisory Committee on Administrative and Budgetary Questions, submits for confirmation by the General Assembly the reappointment of Mr. Arikawa, Mr. Dhar, Mr. Jiang, Mr. Kassow, Mr. Kirdar, Mr. Klein, Ms. Mohohlo and Mr. Oliveros as regular members of the Investments Committee, for three-year terms of office beginning on 1 January 2017.
3. In addition, it will be necessary for the General Assembly to confirm the appointment of Ms. Luciane Ribeiro (Brazil) as a regular member of the Investments Committee for a three-year term of office beginning on 1 January 2017.
