

Financing of the support account for peacekeeping operations, the United Nations Logistics Base at Brindisi, Italy, and the Regional Service Centre in Entebbe, Uganda

Note by the Secretary-General

- 1. The present note is issued in accordance with the prorating procedures approved by the General Assembly in its resolution 50/221 B and its resolution on the financing of the Regional Service Centre in Entebbe, Uganda (A/C.5/72/L.48). The annex to the note reflects the resources to be approved by the Assembly in respect of each peacekeeping mission, including the prorated shares of the support account, the United Nations Logistics Base at Brindisi, Italy, and the Regional Service Centre.
- 2. Once the General Assembly has taken action on the recommendations of the Fifth Committee, a note will be issued on the approved level of resources for all peacekeeping operations.
- 3. The Fifth Committee is requested to take note of the present note.

- ^a Approved requirements for the support account for peacekeeping operations of \$324,703,500, net of an unencumbered balance of \$324,400, other revenue of \$813,800 and excess of the Peacekeeping Reserve Fund of \$928,800 in respect of the financial period 2016/17.
- ^b Approved cost estimates for the United Nations Logistics Base at Brindisi of \$82,448,900, net of an unencumbered balance of \$633,300 and other revenue of \$647,300 in respect of the financial period 2016/17.
- ^c Approved cost estimates for the Regional Service Centre of \$27,860,200, representing the total cost of \$31,438,900, net of an unencumbered balance of \$2,871,000 and other revenue of \$112,200 in respect of the financial period 2016/17, less the amount of \$595,500 to be charged against the appropriation for the programme budget for the biennium 2018–2019 under section 3, Political affairs, approved by the General Assembly in its resolutions 72/263 A to C. The amount of \$27,860,200 will be charged on a prorated basis to the Centre's peacekeeping client missions: MINURSO, MINUSCA, MINUSMA, MONUSCO, UNAMID, UNISFA, UNMISS and UNSOS.

- ^e The General Assembly authorized the Secretary-General to enter into commitments for the period from 1 July to 31 December 2018 in a total amount not exceeding \$385,678,500 for the maintenance of the Operation.
