# REPORT OF THE 1996 UNITED NATIONS PLEDGING CONFERENCE FOR DEVELOPMENT ACTIVITIES

## A. Opening and duration of the session

- 1. By its resolution 45/215 of 21 December 1990, the General Assembly decided, inter alia, that the adoption and signing of the Final Act of the United Nations Pledging Conference for Development Activities should be replaced by the adoption of a procedural report of the Conference.
- 2. The Conference met at United Nations Headquarters on 4 and 5 November 1996.
- 3. The Conference was opened by the Secretary-General.

#### B. Attendance
