1998 United Nations Pledging Conference for Development Activities

4 and 5 November 1998

Report of the United Nations Pledging Conference for Development Activities

A. Opening and duration of the session

- 1. By its resolution 45/215 of 21 December 1990, the General Assembly decided, *inter alia*, that the adoption and signing of the Final Act of the United Nations Pledging Conference for Development Activities should be replaced by the adoption of a procedural report of the Conference.
- 2. The Conference was held at United Nations Headquarters on 4 and 5 November 1998.
- 3. The Conference was opened by Mr. Nitin Desai, Under-Secretary-General for Economic and Social Affairs.

B. Attendance

4. The Conference was attended by the representatives of the Governments of the following States:

5. Representatives of the following organs, organizations and bodies of the United Nations and specialized and related agencies also attended the Conference:

E. Announcement of pledges

The Conference heard the announcement of pledges by a number of Governments to one or more programmes and funds, and took note of the fact that several Governments were not in a position to announce their contributions but proposed to communicate their announcement of such contributions to the Secretary-General as soon as they were in a position to do so after the closure of the Conference.
