Report of the Preparatory Committee for the United Nations Conference to Review Progress Made in the Implementation of the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects

I. Introduction

1. At its sixty-sixth session, the General Assembly adopted resolution 66/47, by which it decided that, pursuant to resolution 65/64, the second conference to review progress made in the implementation of the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects would be held in New York from 27 August to 7 September 2012; and that the preparatory committee for the review conference would be convened in New York from 19 to 23 March 2012. In addition, the Assembly invited States, at the second review conference, to review progress made in the implementation of the Programme of Action, and, subject to the agenda of the conference to be agreed by the preparatory committee, encouraged them to explore ways to strengthen its implementation, including consideration of the possibility of convening a further open-ended meeting of governmental experts.

II. Organizational matters

A. Opening and duration of the session and list of participants

2. The Preparatory Committee held its session at United Nations Headquarters from 19 to 23 March 2012. The session was opened by the High Representative for Disarmament Affairs, who also made a statement. During the session, the Preparatory Committee held a total of 10 formal meetings.





- 3. The Chief of the Disarmament and Peace Affairs Branch in the Department for General Assembly and Conference Management served as Secretary of the Preparatory Committee.
- 4. The list of participants is contained in document A/CONF.192/2012/PC/INF/2; and the list of non-governmental organizations is contained in document A/CONF.192/2012/PC/INF/1.

6. At its 1st meeting, on 19 March, the Preparatory Committee adopted its agenda as contained in document A/CONF.192/2012/PC/L.1.

D. Adoption of the rules of procedure

7. At its 1st meeting, on 19 March, the Preparatory Committee decided to follow the rules of procedure of the United Nations Conference to Review Progress Made in the Implementation of the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects as contained in document A/CONF.192/2006/RC/5.

E. Documentation

- 8. The documents of the Preparatory Committee are listed in the annex to the present report.
- 9. The Preparatory Committee had also before it working papers submitted by the Non-Aligned Movement (A/CONF.192/2012/PC/CRP.8), the European Union

10. At the 8th meeting, on 22 March, a Chair's summary was circulated (A/CONF.192/2012/PC/CRP.13). At the 9th and 10th meetings, on 23 March, delegations expressed their general views regarding the status of the Chair's summary. The Chair's summary, prepared under her own responsibility, reflects her interpretation of the main points that were discussed during the meetings of the Committee. It does not represent a full record of all issues discussed during the Preparatory Committee, nor should it be seen as reflecting the consensus view of States on any specific points covered in it. The issues summarized by the Chair could be further discussed, along with other documents submitted by Member States, during the informal consultations prior to the Review Conference, without prejudice to the position of any delegation and the right of any State to put forward any proposals in future and during the Review Conference, and does not prejudge the outcome document of the Review Conference.

III. Proceedings of the session

- 11. At its 1st to 6th meetings, from 19 to 21 March, the Preparatory Committee held a thematic debate on progress made in the implementation of the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects and of the International Instrument to Enable States to Identify and Trace, in a Timely and Reliable Manner, Illicit Small Arms and Light Weapons, in which 58 participating States and an observer delivered statements.
- 12. The Preparatory Committee also heard statements made by representatives of five intergovernmental organizations at its 5th and 6th meetings, on 21 March.
- 13. At the 6th meeting, on 21 March, statements by representatives of six non-governmental organizations were heard.
- 14. At its 7th to 10th meetings, on 22 and 23 March, the Preparatory Committee considered agenda item 10, entitled "Recommendations to the Conference on all relevant matters, including the draft agenda, draft rules of procedure, draft final documents, background documentation and nominations for President and Secretary-General of the Conference".

IV. Adoption of the report of the Preparatory Committee

- 15. At the 10th meeting, on 23 March, the Chair introduced the revised draft report of the Preparatory Committee as contained in conference room paper A/CONF.192/2012/PC/CRP.12/Rev.1 in English only.
- 16. At the same meeting, the Preparatory Committee adopted its report.

V. Decisions of the Preparatory Committee

17. At its 10th meeting, on 23 March, the Preparatory Committee adopted the following decisions:

Decision I

Nomination of the President of the Conference

The Preparatory Committee, taking into account General Assembly resolution 66/47, in which the Assembly welcomed the early designation of Nigeria as the Chair of the second Review Conference and its Preparatory Committee, decides to unanimously recommend the candidacy of U. Joy Ogwu of Nigeria, the Chair of the Preparatory Committee, for the presidency of the Conference.

The Preparatory Committee requests the President-designate to undertake informal consultations, including open-ended informal consultations, if required, in the period before the Conference.

Decision II

Nomination of the Secretary-General of the Conference

The Preparatory Committee decides to invite the Secretary-General of the United Nations, in consultation with Member States, to nominate an official to act as Secretary-General of the Conference.

Decision III

Background documentation of the Conference

The Preparatory Committee decides to request the United Nations Secretariat to make available the following background documents for the Review Conference:

VI. Recommendations of the Preparatory Committee to the Conference

18. At its 10th meeting, on 23 March, the Preparatory Committee submitted the following recommendations to the Review Conference:

Recommendation I Provisional agenda of the Conference

The Preparatory Committee decides to recommend to the United Nations Conference to Review Progress Made in the Implementation of the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects the provisional agenda as follows:

- Opening of the Conference by the Secretary-General of the United Nations.
- 2. Election of the President.
- 3. Statement by the President.
- 4. Address by the President of the General Assembly.
- 5. Address by the Secretary-General of the United Nations.
- 6. Adoption of the rules of procedure.

- 8. Organization of work.
- 9. Election of officers other than the President.

Recommendation II Other officers of the Conference

The Preparatory Committee decides to recommend that the United Nations Conference to Review Progress Made in the Implementation of the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects re-elect 14 Vice-Chairs of the Preparatory Committee, comprising two representatives of the African States and three of each of the other regional groups, as its Vice-Presidents.

The rules of procedure as contained in document A/CONF.192/2006/RC/5 shall be amended accordingly.

Recommendation III Draft provisional rules of procedure of the Conference

The Preparatory Committee decides to recommend for adoption by the United Nations Conference to Review Progress Made in the Implementation of the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects the rules of procedure as contained in document A/CONF.192/2006/RC/5, as amended.
