

## **2000 United Nations Pledging Conference** for Development Activities

1 and 2 November 2000

# Report of the 2000 United Nations Pledging Conference for Development Activities

#### A. Opening and duration of the session

- 1. By its resolution 45/215 of 21 December 1990, the General Assembly decided, inter alia that the adoption and signing of the Final Act of the United Nations Pledging Conference for Development Activities should be replaced by the adoption of a procedural report of the Conference.
- 2. The Conference was held at United Nations Headquarters on 1 and 2 November 2000.
- 3. The Conference was opened by the Under-Secretary-General for Economic and Social Affairs.

#### **B.** Attendance

4. The Conference was attended by representatives of the Governments of the following States:

The Conference heard the announcement of pledges by a number of Governments to one or more programmes and funds, and took note of the fact that several Governments were not in a position to announce their contributions but proposed to communicate their announcement of such contributions to the Secretary-General as soon as they were in a position to do so after the closure of the Conference.
