Chapter I

Introduction

Opening and duration of the session

1. In accordance with paragraph 2 of General Assembly resolution 55/213, the fourth session of the Preparatory Committee for the International Conference on Financing for Development was held in New York from 14 to 25 January and on 15 February 2002. The Committee held seven meetings (1st to 7th), as well as a number of informal meetings.

Chapter II

Organizational matters

A. Adoption of the agenda

2. At its 1st meeting, on 14 January, the Committee adopted the provisional agenda for its fourth session as contained in document A/AC.257/31. The agenda was as follows:

Chapter IV

Review of the inputs to the substantive preparatory process and the Conference

26. The Committee considered agenda item 2 at its 2nd meeting, on 14 January. It had before it the following documents:

27. At the 2nd meeting, the Co-Chairman, Shamshad Ahmad (Pakistan), made a statement.
28. At the same meeting, a statement was made by the representative of the Sudan.
29. No proposals were submitted and no action was taken under this item.

Chapter V

Finalization of the draft outcome of the Conference

30. The Committee considered agenda item 3 at its 2nd to 4th and 7th meetings, on 14, 15 and 17 January and on 15 February 2002. It had before it the following documents:

32. 36. At the 3rd meeting, on 15 January, a statement was made by the Deputy Secretary-General of OECD.

37. At the 4th meeting, on 17 January, David Aptsiauri, Deputy Minister of Foreign Affairs of Georgia, addressed the Committee.

38. At the same meeting, a statement was made by the Executive Secretary of ECLAC.

39. At the 7th meeting, on 15 February, a statement was made by the Co-Chairman, Ruth Jacoby (Sweden).

40. At the same meeting, statements were made by the representatives of Azerbaijan, Venezuela (on behalf of the States Members of the United Nations that are members of the Group of 77 and China), the Islamic Republic of Iran, Benin,

France and Spain (on behalf of the States Members of the United Nations that are members of the European Union).

41. Also at the same meeting, the Committee approved the draft outcome as revised by the Committee at its fourth session (A/AC.257/L.13), as a whole, for adoption by the Conference (see chap. VII, sect. A, decision 4/1).

42. At the same meeting, statements were made by the representatives of Mexico, Venezuela (on behalf of the States Members of the United Nations that are members of the Group of 77 and China), Spain (on behalf of the States Members of the United Nations that are members of the European Union), Benin (on behalf of the least developed countries) and Suriname.

Chapter VI

Provisional agenda and other arrangements for the Conference

43. The Committee considered item 4 of its agenda at its 5th meeting, on 25 January. It had before it the draft provisional agenda for the Conference (A/AC.257/L.12) and the draft organization of work for the Conference, which was contained in an informal paper in English only.

44. At the same meeting, a statement was made by the representative of the Sudan, after which a statement was made by the Secretary of the Committee.

45. Also at the same meeting, the Committee approved the draft provisional agenda for the Conference for adoption by the Conference (see chap. VII, sect. A, decision 4/2).

46. At the same meeting, after statements were made by the Vice-Chairman of the Committee, Jana Simonová (Czech Republic) and the representative of the Sudan, the Committee approved the draft organization of work for the Conference for adoption by the Conference (see chap. VII, sect. A, decision 4/3).

47. At its 5th meeting, on 25 January, on the proposal of the Co-Chairman, Shamshad Ahmad (Pakistan), the Committee decided on a number of additional arrangements for the Conference (see chap. VII, sect. B, decision 4/8).

48. At the same meeting, a statement was made by the representative of Malaysia.

49. At its 7th meeting, on 15 February, on the proposal of the Co-Chairman, Ruth Jacoby (Sweden), the Committee decided to extend the mandate of its Bureau beyond the closure of its fourth session until the opening of the Conference (see chap. VII, sect. B, decision 4/9).

Chapter VII
