Credentials of representatives to the international meeting: report of the Credentials Committee

Report of the Credentials Committee

Chair: Ms. Anna Karin Eneström (Sweden)

- 1. The General Assembly decided, in its resolution 75/326, that the rules relating to the procedure and the established practice of the Assembly applied, mutatis mutandis, to the procedure of the international meeting.
- 2. The General Assembly further decided in the resolution that the Credentials Committee would be appointed in accordance with the rules of procedure of the Assembly and that its composition should be based on that of the Credentials Committee of the Assembly at its seventy-sixth session.
- 3. Accordingly, at its first plenary meeting, held on 2 June 2022, the international meeting appointed a Credentials Committee consisting of the following States: Bahamas, Bhutan, Chile, China, Namibia, Russian Federation, Sierra Leone, Sweden and United States of America.
- 4. The Credentials Committee held one meeting, on 2 June 2022.
- 5. At the meeting on 2 June, Anna Karin Eneström (Sweden) was elected Chair of the Committee.
- 6. The Committee had before it a memorandum of the Secretary-General dated 1 June 2022 concerning the credentials of representatives of States and of the European Union. A representative of the Office of Legal Affairs made a statement related to the memorandum.
- 7. As indicated in paragraph 1 of the memorandum, as updated by the statement of the representative of the Office of Legal Affairs, formal credentials of representatives to the international meeting in the form required under rule 27 of the rules of procedure of the General Assembly, had been submitted to the Secretary-General, as at the time of the meeting of the Committee, by the following 40 States: Andorra, Angola, Austria, Barbados, Brazil, Bulgaria, Cambodia, Cook Islands, Cyprus, Democratic People's Republic of Korea, Denmark, Estonia, Iceland, Indonesia, Iran (Islamic Republic of), Ireland, Jamaica, Japan, Kazakhstan, Madagascar, Maldives, Mexico, Monaco, Morocco, New Zealand, Norway, Oman, Peru, Poland, Republic of Moldova, Romania, Saint Lucia, Singapore, Slovakia, Slovenia, Sudan, Sweden, Switzerland, Türkiye and Viet Nam.





- As indicated in paragraph 2 of the memorandum, as updated by the statement of the representative of the Office of the Legal Affairs, information concerning the appointment of representatives to the international meeting had been communicated to the Secretary-General, at the time of the meeting of the Committee, by means of a copy of formal credentials signed by the Head of State or Government or the Minister for Foreign Affairs, or by means of a letter or note verbale from the ministry, embassy or mission concerned, by the European Union and the following 125 States: Albania, Algeria, Antigua and Barbuda, Argentina, Armenia, Australia, Azerbaijan, Bahamas, Bangladesh, Belarus, Belgium, Belize, Bhutan, Bolivia (Plurinational State of), Botswana, Burkina Faso, Cabo Verde, Cameroon, Canada, Chile, China, Central African Republic, Colombia, Comoros, Costa Rica, Côte d'Ivoire, Croatia, Cuba, Czechia, Democratic Republic of the Congo, Djibouti, Dominican Republic, Ecuador, Egypt, El Salvador, Eritrea, Ethiopia, Fiji, Finland, France, Gabon, Gambia, Georgia, Germany, Ghana, Greece, Guatemala, Guinea, Guinea-Bissau, Holy See, Hungary, India, Iraq, Israel, Italy, Jordan, Kenya, Kuwait, Kyrgyzstan, Lao People's Democratic Republic, Latvia, Lebanon, Liberia, Libya, Lithuania, Luxembourg, Malawi, Malaysia, Malta, Marshall Islands, Mauritania, Mauritius, Micronesia (Federated States of), Mongolia, Mozambique, Namibia, Nepal, Netherlands, Nicaragua, Niger, Nigeria, North Macedonia, Pakistan, Palau, Panama, Papua New Guinea, Paraguay, Philippines, Portugal, Qatar, Republic of Korea, Russian Federation, Rwanda, San Marino, Saudi Arabia, Senegal, Serbia, Seychelles, Sierra Leone, Solomon Islands, Somalia, South Africa, Spain, Sri Lanka, State of Palestine, Thailand, Timor-Leste, Togo, Trinidad and Tobago, Tunisia, Turkmenistan, Tuvalu, Uganda, Ukraine, United Arab Emirates, United Kingdom of Great Britain and Northern Ireland, United Republic of Tanzania, United States of America, Uruguay, Uzbekistan, Vanuatu, Venezuela (Bolivarian Republic of), Yemen, Zambia and Zimbabwe.
- 9. As indicated in paragraph 3 of the memorandum, as updated by the statement of the representative of the Office of Legal Affairs, the Secretary-General had not received formal credentials or the information referred to in paragraph 8 above from the following 31 States invited to participate in the international meeting: Afghanistan, Bahrain, Benin, Bosnia and Herzegovina, Brunei Darussalam, Burundi, Chad, Congo, Dominica, Equatorial Guinea, Eswatini, Grenada, Guyana, Haiti, Honduras, Kiribati, Lesotho, Liechtenstein, Mali, Montenegro, Nauru, Niue, Saint Kitts and Nevis, Saint Vincent and the Grenadines, Samoa, Sao Tome and Principe, South Sudan, Suriname, Syrian Arab Republic, Tajikistan and Tonga.
- 10. The Chair recommended that the Committee accept the credentials of the representatives of the States and the European Union listed in paragraphs 1 and 2 of the memorandum, as updated, on the understanding that formal credentials of representatives of States and the European Union referred to in paragraph 2 of the memorandum, as updated, as well as for representatives of the States referred to in paragraph 3 of the memorandum, as updated, and where applicable, would be communicated to the Secretary-General as soon as possible.
- 11. In relation to Myanmar, acknowledging the report of the Credentials Committee of the General Assembly at its seventy-sixth session (A/76/550), the Chair proposed that the Committee defer its decision on the credentials pertaining to the representatives of Myanmar to the international meeting. The proposal was adopted without a vote.
- 12. The Chair proposed the following draft resolution for adoption by the Committee:

The Credentials Committee,

Having examined the credentials of the representatives to the international meeting entitled "Stockholm+50: a healthy planet for the prosperity of all – our responsibility, our opportunity",

Accepts the credentials of the representatives referred to in paragraphs 1 and 2 of the memorandum of the Secretary-General, as updated.

- 13. The draft resolution proposed by the Chair was adopted without a vote.
- 14. The Chair then proposed that the Committee recommend to the international meeting the adoption of a draft resolution entitled "Credentials of representatives to the international meeting entitled "Stockholm+50: a healthy planet for the prosperity of all our responsibility, our opportunity" (see para. 16 below). The proposal was adopted without a vote.
- 15. In the light of the foregoing, the present report is submitted to the international meeting.

Recommendation of the Credentials Committee

16. The Credentials Committee recommends to the international meeting the adoption of the following draft resolution:
