

Discrimination against migrants based on originality in violation against Human rights

More than ever before the migration and displacement issues is an important toll for national politics of many countries were the rhetoric against migrant issues has been used and continuously will be used by nationalist group to strength their populist idea.

Recently the international community witnessed the clear sign of different treatment by western countries for white migrant/refugees from eastern Europe, this clearly have widen the gap between north and south nations and no doubt this policy will have severe impact on future migration issues, It is true that the majority of migrant who risk their live to cross many land and water borders to seek safe heaven from western countries are from Middle east and Africa, however, we all knows that the people who are fleeing are the once who do not want to fight a civil war and fleeing because they do not want to be a useful weapons for corrupt politicians who dragged their countries into conflict, destroyed the livelihood of their citizens and morally and financially bankrupted their country .

Through our intervention with refugees and IDPs in the 10 years in Iraq we noticed that most internally displaced people do not want to migrate beyond their country borders, but their opinion and behavior normally change within a year as they lose hope for peace at the same time their aid from international community cut even in many cases fund for camp management and services fully stopped, that what currently happening in Iraq, majority of IDPs who fled during ISIS attack still leaving at the IDP camp in Kurdistan region of Iraq, but their aid and fund for services cut by the UN agencies and because of new crisis in Ukraine the international humanitarian agencies have shifted their focuses toward Ukraine war, therefore IDPs and refugees are in disparate situation, many of them will leave Iraq and migrate to Europe if they afford.

The post covid-19 proven to be very difficult for developing countries to recover and citizens hardly able to meet their basic needs especially the citizens of those countries were conflict and climate change is in full force, therefore, today Barzani charity foundation join other organizations who are seeking fair, equal treatment for all migrant regardless of their identities, also we ask international community to strengthen collaboration among all actors toward refugees and IDPs to help them to settle permanently where they are instead forcing them to re-migrate to another countries.
