ESTIMATED COSTS FOR CONVENING THE FIRST MEETING
OF THE STATES PARTIES TO THE CONVENTION ON THE PROHIBITION
OF THE USE, STOCKPILING, PRODUCTION AND TRANSFER OF ANTI-PERSONNEL
MINES AND ON THEIR DESTRUCTION

- 1. The General Assembly by operative paragraph 5 of its resolution 53/77N, requested the Secretary-General of the United Nations, in accordance with article 11 (2) of the Convention on the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on Their Destruction, to undertake the preparations necessary to convene the First Meeting of the States Parties, to take place in Maputo during the week of 3 May 1999. Pursuant to the General Assembly's request, the Secretariat submits below a summary of the estimated costs for convening the First Meeting, including the actual costs of the planning mission undertaken in November 1998 for the purpose of evaluating local facilities and logistic infra-structure and determining the requirements for holding the First Meeting of the States Parties away from a United Nations Headquarters location, namely in Maputo.
- 2. Subject to the terms of the host country agreement to be entered into with the Government of Mozambique, all costs associated with the meeting, including the planning mission, would be met by States Parties and States not parties to the Convention participating therein. The practice followed by the United Nations is to levy a charge, at a rate of 13 per cent of expenditures for such activities, to defray its administrative and other support costs incurred in their implementation. Accordingly, such an expense would also be borne by the States Parties and States not parties to the convention participating in the First Meeting.
- 3. The estimated costs, on the basis of which States Parties and States not parties participating in the First Meeting would be assessed, comprise conference-servicing costs, non conferencing-servicing costs, programme support costs, and other additional costs associated with the convening of the meeting in Maputo. Annex I provides a breakdown of the estimated costs in tabular form.

I. Estimated conference-servicing costs

- 4. The estimates of the conference-servicing costs have been compiled upon certain assumptions, including working languages in Arabic, Chinese, English, French, Russian and Spanish. The host Government will provide interpreters for the Portuguese language. It is assumed that summary records would not be provided. It is envisaged that two meetings per day would be held for 5 days: 3 days or six plenary meetings with interpretation and 2 days or four "open-ended" informal consultations with interpretation. Were States Parties to decide that any two meetings should be held simultaneously, an additional team of interpreters would be required and the estimates would necessarily be revised upward.
- 5. Documentation requirements for the Meeting are assumed to comprise: 75 pages of pre-session (provisional agenda, draft Rules of Procedure, draft forms for reporting under Article 7 of the Convention), 30 pages of in-session (including the report of the Credentials Committee, decisions/resolutions and the draft report of the First Meeting) and 75 pages of post-session documentation.
- 6. Based on the abovementioned assumptions, conference-servicing requirements are estimated as follows:

II. Estimated non-conference-servicing costs

7. The significance of the First Meeting of the States Parties necessitates the involvement of an adequate number of Secretariat staff. Were the meeting held at United Nations Headquarters in New York, requirements associated with staff or other costs estimated at a minimal level would cover: (a) provision under temporary assistance for clerk-typist support to assist in all administrative arrangements related to the Meeting and (b)

travel and subsistence allowance to provide for the Executive Secretary of the Meeting, who would be a staff member from the Department for Disarmament Affairs, Geneva. For convening the meeting in Maputo, similar provision is also made.

- 8. Provision for miscellaneous supplies and services to cover the cost of stationery, office supplies and communications costs estimated at \$3,000 is also included.
- 9. On the basis of the above assumptions, estimated non-conference-servicing costs anticipated for servicing the First Meeting of the States Parties is summarized as follows:

III. Other costs associated with convening the meeting in Maputo

- 10. When meetings are held away from a United Nations Headquarters location (i.e. New York, Geneva, Vienna), the host country is expected to defray the direct and indirect additional costs involved. It may be recalled that in the Note of the Secretariat A/C.1/53/L.60, attention was drawn to the fact that while it was not possible at that stage to estimate the cost of holding the meeting in Maputo, it was expected that direct costs such as travel of conference servicing staff and substantive staff to Maputo, and indirect costs such as conference facilities, equipment, local transport and personnel, communications, etc. would be incurred.
- 11. Stemming from the findings of the planning mission and ensuing discussions, it has been determined that travel, DSA and terminal expenses from New York and Geneva to Maputo, estimated at \$360,100 would be incurred for the following staff to service the Meeting:
 - a) Substantive and other staff: i) One Political Affairs Officer from the Department for Disarmament Affairs); ii) One Legal Affairs Officer; iii) Two Security and Safety Officers; iv) Two Public Information Officers; and v) One Administrative Assistant/Secretary. Provision has also been made for the travel of the Deputy Secretary-General of the United Nations (party of three).

- b) Conference servicing and support staff; i) One Conference Services Coordinator, ii) 28 Interpreters, iii) Two Conference Officers, iv) Two Documents Control Officers, v) Two Documents Distribution Officers, vi) Two Reproduction Officers, vii) Two Technical Specialists (remote translation).
- 12. Other estimated costs include those for communications (\$3,000) and miscellaneous supplies and services (primarily for freight) (\$3,000).
- 13. The Government of Mozambique has conveyed that in order to meet United Nations requirements for holding the meeting in Maputo, the additional costs to be borne by States Parties and States not parties participating in the Meeting are estimated at \$842,842.

IV. Estimated programme support costs

14. As mentioned above, the United Nations levies a charge, at a rate of 13 per cent of the expenditures, to defray administrative and other support costs incurred in the implementation of the activities associated with the convening of the Meeting. Accordingly, a provision of \$77,207 is included in the estimates, representing 13% of \$593,900 covering conference-servicing costs, non-conference-servicing costs and other costs estimated by the United Nations. There is also a provision of \$2,504 for programme support costs related to the planning mission. An administrative fee of \$70,000 would also be charged by UNDP for verification of expenditures and disbursements of funds in Maputo.

- 15. It should be noted that the costs provided in this note are estimated on the basis of past experience and anticipated workload. Actual costs will be determined after the closure of the Meeting when the actual expenditures become known. At that time it is expected that adjustments to the contributions by the participating States parties sharing the costs will be made accordingly.
- 16. Decisions on budgetary matters, the financing of activities under the Convention and on related procedures can only be made by a formal meeting of the States Parties. Until this is done, assessments cannot be issued to States parties and States not parties to the Convention participating in the Meeting, pursuant to Article 14 of the Convention. In line with past practice, assessment letters would then be prepared, based on the overall estimated costs for the Meeting, on the cost-sharing formula to be agreed upon by the States Parties.
- 17. Since the costs associated with the preparation and holding of the Meeting should not have financial implications for the regular budget of the United Nations, ¹ and given the time-frame for making the necessary arrangements for the Meeting, voluntary contributions or advance payments against prospective assessments would need to be made prior to the Meeting, and as soon as possible, so as to meet the costs associated with the convening of the Meeting in Maputo. It should be understood in this context that the amount of eventual credits for such advance payments would depend on appropriate action being taken by the States.
