Meeting of the States Parties to the Convention on the Prohibition of the Development, Production and Stockpiling of Bacteriological (Biological) and Toxin Weapons and on Their Destruction

2023 Meeting Geneva, 11-13 December 2023

Report of the 2023 Meeting of States Parties^{*}

I. Introduction

1. The Final Document of the Ninth Review Conference of the States Parties to the Convention on the Prohibition of the Development, Production and Stockpiling of Bacteriological (Biological) and Toxin Weapons and on Their Destruction (BWC/CONF.IX/9), in Section B of Part II, contained the following decisions:

"4. Reaffirming the utility of having an intersessional programme, the Conference decides that States Parties will hold annual meetings between 2023 and 2026 in Geneva, in in-person format in accordance with the regular practice under the Convention, for a duration of three days each year. The first such meeting will be held from 11 to 13 December 2023.

5. The Conference decides that the Meetings of States Parties will be responsible for managing the intersessional programme in support of the Convention, including taking necessary actions with respect to budgetary, financial and organisational matters, with a view to ensuring the proper implementation of the intersessional programme. The Meetings of the States Parties will also consider, on an annual basis, progress on universalisation of the Convention, the annual report of the Implementation Support Unit and, as appropriate, the implementation of decisions taken by the Conference.

6. The Conference decides that the 2023 Meeting of the States Parties will be chaired by a representative of the Group of the Non-Aligned Movement and Other States. The Chairperson will be supported by two Vice-Chairpersons.

7. The Tenth Review Conference will consider the work and outcomes of these meetings and decide on any further action."

2. By resolution 78/67, adopted without a vote on 4 December 2023, the General Assembly, inter alia, requested the Secretary-General to continue to render the necessary assistance to the depositary Governments of the Convention and to continue to provide such services as may be required for the conduct and the implementation of the decisions and recommendations of the review conferences.

II. Organization of the Meeting of States Parties

3. In accordance with the decisions of the Ninth Review Conference, the 2023 Meeting of States Parties was convened at the Palais des Nations in Geneva, Switzerland, from 11 to 13 December 2023, chaired by Mr. Cristian Espinosa Cañizares, Ambassador and Permanent Representative of Ecuador to the United Nations Office at Geneva. Mr. Thomas Göbel,

Ambassador and Permanent Representative of Germany to the Conference on Disarmament and Mr. Nikola Yakov, Counsellor, Permanent Mission of Bulgaria to the United Nations Office and other International Organizations, served as the two Vice-Chairs.

4. The United Nations Under-Secretary-General and High Representative for Disarmament Affairs, Ms. Izumi Nakamitsu, made remarks via a pre-recorded video message.

5. At its first meeting, on 11 December 2023, the Meeting of States Parties adopted its agenda (BWC/MSP/2023/1), as contained in Annex I to this report. The Chairperson drew the attention of delegations to three reports: a report on universalization activities prepared by the Chairperson (BWC/MSP/2023/3); the report of the Implementation Support Unit (BWC/MSP/2023/4); and a report on the overall financial situation of the Convention prepared by the Chairperson (BWC/MSP/2023/5).

6. The Meeting of States Parties was not able to adopt its programme of work (BWC/MSP/2023/2), as no consensus on this matter was reached.

7. The Meeting of States Parties was also not able to adopt its rules of procedure as contained in document BWC/CONF.IX/2, as no consensus on this matter was reached.

8. Mr. Daniel Feakes, Chief, Implementation Support Unit, served as Secretary of the Meeting of States Parties. Mr. Hermann Lampalzer, Political Affairs Officer, Implementation Support Unit, served as Deputy Secretary and Mr. Oscar Meless, Political Affairs Officer, Implementation Support Unit, and Ms. Clarissa Rios Rojas, Political Affairs Officer, Implementation Support Unit, also served in the secretariat.

III. Participation at the Meeting of States Parties

9. 120 delegations participated in the Meeting of States Parties as follows: Algeria, Angola, Argentina, Armenia, Australia, Austria, Azerbaijan, Bahamas, Belarus, Belgium, Benin, Bolivia (Plurinational State of), Botswana, Brazil, Brunei Darussalam, Bulgaria, Burkina Faso, Cambodia, Cameroon, Canada, Chile, China, Colombia, Costa Rica, Côte d'Ivoire, Croatia, Cuba, Czech Republic, Denmark, Dominican Republic, Ecuador, El Salvador, Estonia, Finland, France, Gambia, Georgia, Germany, Ghana, Greece, Guyana, Holy See, Hungary, Iceland, India, Indonesia, Iran (Islamic Republic of), Iraq, Ireland, Italy, Japan, Jordan, Kazakhstan, Kenya, Kuwait, Kyrgyzstan, Lao People's Democratic Republic, Latvia, Lesotho, Libya, Lithuania, Luxembourg, Madagascar, Malawi, Malaysia, Maldives, Malta, Mauritania, Mauritius, Mexico, Mongolia, Montenegro, Morocco, Mozambique, Myanmar, Namibia, Nauru, Nepal, Netherlands (Kingdom of the), Nicaragua, Niger, Nigeria, Norway, Pakistan, Panama, Paraguay, Peru, Philippines, Poland, Portugal, Republic of Korea, Romania, Russian Federation, San Marino, Saudi Arabia, Serbia, Sierra Leone, Singapore, Slovakia, Slovenia, South Africa, Spain, Sri Lanka, State of Palestine, Sweden, Switzerland, Thailand, Timor-Leste, Togo, Tunisia, Türkiye, Uganda, Ukraine, United Arab Emirates, United Kingdom of Great Britain and Northern Ireland, United States of America, Uruguay, Venezuela (Bolivarian Republic of), Zambia, Zimbabwe.

10. In addition, two States that had signed the Convention but had not yet ratified it participated in the Meeting of States Parties without taking part in the making of decisions, as provided for in rule 44, paragraph 1 of the rules of procedure, as contained in document BWC/CONF.IX/2: Egypt; Syrian Arab Republic.

11. Three States, Chad, Comoros and Israel, neither parties nor signatories to the Convention, applied for observer status, in accordance with rule 44, paragraph 2.

12. The United Nations, including the United Nations Institute for Disarmament Research, the United Nations Interregional Crime and Justice Research Institute and the United Nations Office for Disarmament Affairs attended the Meeting of States Parties in accordance with rule 44, paragraph 3.

13. The Cooperative Security Treaty Organization, European Union, Food and Agriculture Organization of the United Nations, International Atomic Energy Agency, International Committee of the Red Cross, Organization of American States, Organization

for the Prohibition of Chemical Weapons and the World Health Organization applied for observer agency status, in accordance with rule 44, paragraph 4.

14. Twenty-five non-governmental organizations and research institutes attended the Meeting of States Parties under rule 44, paragraph 5.

15. A list of all participants in the Meeting of States Parties is contained in document BWC/MSP/2023/INF.1.

IV. Update by the Chairperson of the Working Group on the Strengthening of the Convention

16. The Chairperson of the Working Group on the Strengthening of the Convention, Ambassador Flavio Soares Damico of Brazil, provided an update on the work of the Working Group during 2023. The Working Group held three sessions, from 15 to 16 March, from 7 to 18 August and from 4 to 8 December, adopting the procedural reports contained in documents BWC/WG/1/2, BWC/WG/2/1 and BWC/WG/3/1 respectively.

V. Arrangements for the meetings in 2024

17. The Meeting of States Parties decided to organize in 2024, in in-person format in accordance with the regular practice under the Convention, the following BWC-related meetings:

(a) Fourth session of the Working Group on the Strengthening of the Convention from 19 to 23 August 2024;

(b) Fifth session of the Working Group on the Strengthening of the Convention from 2 to 13 December 2024; and

(c) 2024 Meeting of States Parties from 16 to 18 December 2024.

VI. Documentation
