Procedural report of the third session of the Working Group on the Strengthening of the Convention¹

I. Opening of the third session of the Working Group

- 1. In accordance with the decisions of the Ninth Review Conference, the third session of the Working Group was convened at the Palais des Nations in Geneva from 4 to 8 December 2023. The Working Group held ten meetings during that period under the Chairpersonship of Ambassador Flavio Soares Damico, Special Representative of Brazil to the Conference on Disarmament. Ambassador Camille Petit, Permanent Representative of France to the Conference on Disarmament, and Mr. Irakli Jgenti, Deputy Permanent Representative of Georgia to the United Nations Office in Geneva, served as its Vice-Chairpersons.
- 2. Mr. Daniel Feakes, Chief, Implementation Support Unit, Office for Disarmament Affairs, Geneva, served as Secretary of the Meeting. Mr. Hermann Lampalzer, Political Affairs Officer, Implementation Support Unit, served as Deputy Secretary. Ms. Clarissa Rios Rojas, Political Affairs Officer, and Mr. Oscar Meless, Political Affairs Officer, served in the Secretariat.

II. Participation at the third session of the Working Group

3. - 4. In addition, two States that had signed the Convention but had not yet ratified it participated in the third session of the Working Group without taking part in the making of decisions, as provided for in rule 44, paragraph 1 of the rules of procedure: Arab Republic of Egypt, Syrian Arab Republic.
- 5. One State, Israel, neither party nor signatory to the Convention, participated in the third session of the Working Group as an observer, in accordance with rule 44, paragraph 2.
- 6. The United Nations Institute for Disarmament Research and the United Nations Office for Disarmament Affairs attended the third session of the Working Group in accordance with rule 44, paragraph 3.
- 7. The Comprehensive Nuclear Test-Ban Treaty Organization, the European Union, the International Atomic Energy Agency, the International Centre for Genetic Engineering and Biotechnology, the International Committee of the Red Cross, the Organization for the Prohibition of Chemical Weapons, the Organization of American States and the World Health Organization were granted observer status to participate in the third session of the Working Group in accordance with rule 44, paragraph 4.
- 8. In addition, at the invitation of the Chairperson, in recognition of the special nature of the issues under consideration at this session and without creating a precedent, experts from international organizations and non-governmental organizations participated as guests in panel sessions organized by the Chairperson as reflected in paragraphs 13 and 14.
- 9. Twenty-eight non-governmental organizations and research institutes attended the third session of the Working Group under rule 44, paragraph 5.
- 10. A list of all participants in the third session of the Working Group is contained in document BWC/WG/3/INF.1.

III. Identifying, examining and developing specific and effective measures, including possible legally-binding measures, and making recommendations to strengthen and institutionalize the Convention in all its aspects within the mandate of the Working Group

- 11. In accordance with the indicative schedule of activities as adopted at its first session (see Annex II of BWC/WG/1/2), the Working Group continued its consideration of agenda item 6 on "Identifying, examining and developing specific and effective measures, including possible legally-binding measures, and making recommendations to strengthen and institutionalize the Convention in all its aspects within the mandate of the Working Group".
- 12. At the third session of the Working Group, the Chairperson was assisted in his consultations and negotiations by the following Friends of the Chair on the particular issues allocated by the first session of the Working Group:

- 13. The Working Group held two meetings on 4 December 2023 devoted to the issue of "Measures on confidence-building and transparency". The following States Parties introduced working papers on this issue: the Russian Federation (BWC/WG/3/WP.4) and Uganda (BWC/WG/3/WP.7). In panel sessions on this issue organized by the Chairperson, technical

briefings were provided by Mr. Daniel Feakes representing the BWC Implementation Support Unit and Dr. James Revill representing the United Nations Institute for Disarmament Research. There then followed an interactive discussion in which the following States Parties participated: Algeria, Argentina, Australia, Austria, Botswana, Brazil, Cambodia, Canada, China, Colombia, Cuba, Ecuador, France, Georgia, Germany, Ghana, Indonesia, Iran (Islamic Republic of), Ireland, Italy, Japan, Lao People's Democratic Republic, Lesotho, Mali, Mexico, Nigeria (on behalf of the African Group of States Parties to the BWC), Pakistan, Panama, Russian Federation, Singapore, South Africa, Sudan, Switzerland, Thailand, Ukraine, United Kingdom of Great Britain and Northern Ireland, United States of America.

- The Working Group held six meetings from 5 to 7 December 2023 devoted to the issue of "Measures on compliance and verification". The following States Parties introduced working papers on this issue: China (BWC/WG/3/WP.10), Denmark and Panama (on behalf of Denmark, Kenya Malawi, Montenegro, Norway, Panama, Singapore, Thailand and Uruguay) (BWC/WG/3/WP.8 and Rev.1), Iran (Islamic Republic of) (BWC/WG/3/WP.11), Panama (BWC/WG/3/WP.14), Russian Federation (BWC/WG/3/WP.3, BWC/WG/3/WP.5 and BWC/WG/3/WP.13), Ukraine (BWC/WG/3/WP.15), United Kingdom of Great Britain and Northern Ireland (BWC/WG/3/WP.6), United States of America (BWC/WG/3/WP.9 and BWC/WG/3/WP.12). - 15. The Working Group held two meetings on 8 December 2023 devoted to the issue of "Measures on organizational, institutional and financial arrangements". The following State Party introduced working papers on this issue: Kazakhstan (BWC/WG/3/WP.1 and BWC/WG/3/WP.2). The Implementation Support Unit provided a technical presentation. There then followed an interactive discussion in which the following States Parties participated: Algeria, Australia, Austria, Canada, China, Cuba, Czechia, Dominican Republic, France, Germany, Iran (Islamic Republic of), Iraq, Italy, Kazakhstan, Libya, Panama, Peru, Republic of Korea, Russian Federation, Sierra Leone, South Africa, Spain, Switzerland, Togo, United Kingdom of Great Britain and Northern Ireland, United States of America.
