

## **Election of 12 members of the Subcommittee on Prevention** of Torture and Other Cruel, Inhuman or Degrading **Treatment or Punishment**

## Note by the Secretary-General

- In accordance with articles 7 and 9 of the Optional Protocol to the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, the eighth meeting of the States parties to the Optional Protocol will be held at the United Nations Office at Geneva on 22 October 2020, for the purpose of electing 12 members of the Subcommittee from a list of persons nominated by States parties (section II), to replace those whose terms of office will expire on 31 December 2020 (section I). Thirteen members will continue to serve on the Subcommittee until 31 December 2022 (section III).
- In addition, in compliance with paragraph 12 of General Assembly resolution 68/268, the current situation with respect to the composition of the Subcommittee, reflecting the balance in terms of geographical distribution, gender representation and different legal systems, as well as the tenure of current members, is contained in sections I and III of the present document; the biographical data, including in respect of professional background, of current members can be found on the web page of the Subcommittee (www.ohchr.org/EN/HRBodies/OPCAT/Pages/Membership.aspx).
- In paragraph 13 of its resolution 68/268, the General Assembly encouraged States parties, in the election of treaty body experts, to give due consideration, as stipulated in the relevant human rights instruments, to equitable geographical distribution, the representation of the different forms of civilization and the principal legal systems, balanced gender representation and the participation of experts with disabilities in the membership of the human rights treaty bodies.

#### Professional and educational background

Diplôme d'études approfondies en droit international public (postgraduate diploma in public international law). Until 11 June 2018, I held a ministerial-level position as Commissioner for Human Rights in the Government of Mauritania. During my tenure, I supervised the establishment of the national mechanism for the prevention of torture. I also served as Director of Human Rights in the Ministry of Justice for two years, which allowed me to gain familiarity with the prison service and detention procedures and to visit several places of deprivation of liberty.

## **Current position/function**

I currently work as a consultant, and in this capacity I have been asked by various partner organizations to provide technical support to national human rights institutions. For example, I led workshops for the national mechanism for the prevention of torture with funding from the German Agency for International Cooperation and prepared an action plan for the National Human Rights Commission with funding from the Office of the United Nations High Commissioner for Human Rights.

#### Main professional activities

A lawyer by training, between 2000 and 2015 I held the positions of Head of Department, Director and Director-General of Human Rights.

I was a founder member of the National Human Rights Commission (serving from 2007 to 2013), the principal interface with international human rights mechanisms between 2007 and 2018, and a member of several commissions, including the one tasked with drafting the law establishing the national mechanism for the prevention of torture. I have also been one of the main contributors to the reports of Mauritania to the treaty bodies, including the one considered by the Committee on the Elimination of Racial Discrimination in May 2018. As already mentioned, I now offer consultancy services in the area of human rights.

#### Other main activities relevant to the mandate of the Subcommittee

I have participated in several events and workshops related to the prevention of torture, including those organized by the Association for the Prevention of Torture.

Between 2007 and 2008, I coordinated the project Access to Justice for the Poor, implemented in partnership with the World Bank, which enabled human rights organizations to take several measures for the benefit of persons deprived of their liberty.

A member of the Subcommittee active since 10 February 2020, I participated in its first session of 2020 and have overseen a number of tasks as country rapporteur.
