Extensions of country programmes

Note of the Administrator

Summary

The present note contains information on the extensions of the country programmes for the Democratic People's Republic of Korea, Ethiopia, Kyrgyzstan, Mozambique, United Republic of Tanzania, and Yemen. Requests for first one-year extensions of country programmes are approved by the Administrator and presented to the Executive Board for information. Requests for second one-year extensions, two-year extensions and exceptional extensions of country programmes are submitted to the Executive Board for approval.

Elements of a decision

The Executive Board may wish to take note of the first six-months extension of the country programme for Ethiopia from 1 January to 30 June 2016; take note of the first one-year extension of the country programme for the United Republic of Tanzania from 1 July 2015 to 30 June 2016; take note of the first one-year extension of the country programme for the Democratic People's Republic of Korea, Mozambique and Yemen from 1 January to 31 December 2016; and take note of the first one-year extension of the country programme for Kyrgyzstan from 1 January to 31 December 2017.
