Summary

The thirty-fourth session of the Commission on Population and Development was held at United Nations Headquarters from 2 to 6 April 2001. Its central theme was population, environment and development.

The documents before the Commission included a report on world population monitoring, focusing on the theme of the session. The report analysed recent information and policy perspectives on population, environment and development. The topics investigated in the report included: temporal trends in population, environment and development; government views and policies concerning population, environment and development; population size and growth, environment and development; migration, population change and the rural environment; health, mortality, fertility and the environment; and population, environment and development in urban settings. Other reports covered the inter-sessional meeting of the Bureau of the Commission; flows of international financial resources for assisting in the implementation of the Programme of Action of the International Conference on Population and Development; world demographic trends; programme implementation and progress of work in the field of population in 2000: Population Division, Department of Economic and Social Affairs; and the draft programme of work of the Population Division for the biennium 2002-2003.

The Commission considered follow-up actions to the recommendations of the International Conference on Population and Development and adopted a resolution concerning population, environment and development. In that resolution, the Commission requested the Population Division to continue its research on the linkages among population, consumption and production, the environment and natural resources, and human health, giving particular attention to levels, trends and differentials of mortality, fertility, distribution and mobility, and the role of population and development policies as well as the mainstreaming of a gender perspective. It also requested the Population Division to contribute its research findings to the preparatory processes for the special session of the General Assembly for an overall review and appraisal of the implementation of the outcome of the United Nations Conference on Human Settlements (Habitat II), the World Summit on Sustainable Development and other relevant intergovernmental meetings and conferences. It further requested that the findings from this and related research on population, environment and development should contribute to the next review and appraisal of the implementation of the Programme of Action of the International Conference on Population and Development scheduled for 2004.

The Commission approved the draft provisional agenda for its thirty-fifth session, to be held in 2002, and adopted its report on its thirty-fourth session.

Reaffirming the Programme of Action of the International Conference on Population and Development, in particular those recommendations relating to population, environment and development,

Reaffirming also the key actions for the further implementation of the Programme of Action of the International Conference on Population and Development relating to population, environment and development,²

Bearing in mind the relevant objectives on population, environment and development of the United Nations Millennium Declaration,³

Bearing in mind also the relevant recommendations on population, environment and development of the World Summit for Social Development⁴ and the twenty-fourth special session of the General Assembly,⁵

Recalling that the theme for the thirty-fourth session of the Commission on Population and Development was population, environment and development,

Welcoming the special session of the General Assembly for an overall review and appraisal of the implementation of the outcome of the United Nations Conference on Human Settlements (Habitat II), to be held in 2001, and in this context emphasizing the importance of the twin goals of the Habitat Agenda: adequate shelter for all and sustainable human settlements development in an urbanizing world,

Bearing in mind the relevant recommendations on population, environment and development in Agenda 21,7 as well as in the Programme for the Further Implementation of Agenda 21,8

Noting that the World Summit on Sustainable Development will be held in 2002 for the ten-year review of progress achieved in the implementation of the outcome of the United Nations Conference on Environment and Development,⁹

Noting also the critical linkages among population, environment and development,

- 1. Requests the Population Division of the Department of Economic and Social Affairs of the United Nations Secretariat to continue its research, in close cooperation with all relevant offices of the Secretariat, and with all relevant bodies, funds and programmes of the United Nations system, on the linkages among population, consumption and production, the environment and natural resources, and human health, giving particular attention to levels, trends and differentials of mortality, fertility, distribution and mobility, and the role of population and development policies, as well as mainstreaming of a gender perspective;
- 2. Also requests the Population Division to work in close cooperation with all relevant offices of the Secretariat and other relevant bodies, funds and programmes of the United Nations system to contribute its research findings to the preparatory processes for the special session of the General Assembly for an overall review and appraisal of the implementation of the outcome of the United Nations Conference on Human Settlements (Habitat II), the World Summit on Sustainable Development and other relevant intergovernmental meetings and conferences;

- 3. Requests that the findings from this and related research on population, environment and development should contribute to the next review and appraisal of the implementation of the Programme of Action of the International Conference on Population and Development, scheduled for 2004;
- 4. *Encourages* the Population Division, in close cooperation with all relevant offices of the United Nations Secretariat, and with all relevant bodies, funds and programmes of the United Nations system, to disseminate widely the results of its research, as a contribution to greater understanding and awareness of the interrelationships among population, environment and development.

- 8. At the 3rd meeting, on 3 April, statements were made by the representatives of the United States of America and Brazil.

- 22. At the 6th meeting, on 5 April, statements were made by the representatives of the Food and Agriculture Organization of the United Nations and the International Labour Organization.
- 23. Statements were also made by the representatives of the Economic Commission for Africa, the Economic Commission for Europe, the Economic and Social Commission for Asia and the Pacific and the Economic and Social Commission for Western Asia.
