#### 4. Elections, nominations, confirmations and appointments

The Council is to take action with respect to the following bodies:

#### Statistical Commission (E/2002/L.1/Add.1)

There remains one outstanding vacancy in the Latin American and Caribbean States group for a member whose term would begin on the date of election and expire on 31 December 2005.

#### **Commission on Population and Development** (E/2002/L.1/Add.1)

Eight members are to be elected according to the following pattern:

Two members from African States;

Two members from Asian States;

One member from Eastern European States;

Two members from Latin American and Caribbean States;

One member from Western European and other States.

In addition, there remain three outstanding vacancies in the Asian States group for members whose terms would begin on the date of election and expire on 31 December 2005 and two outstanding vacancies in the Latin American and Caribbean States group for members whose terms would begin on the date of election and expire on 31 December 2004.

#### **Commission for Social Development** (E/2002/L.1/Add.1)

Fourteen members are to be elected according to the following pattern:

Four members from African States;

Three members from Asian States;

One member from Eastern European States;

Three members from Latin American and Caribbean States;

Three members from Western European and other States.

#### Commission on Human Rights (E/2002/L.1/Add.1)

Fifteen members are to be elected according to the following pattern:

Four members from African States;

Three members from Asian States;

One member from Eastern European States;

Three members from Latin American and Caribbean States;

Four members from Western European and other States.

#### Commission on the Status of Women (E/2002/L.1/Add.1)

Eleven members are to be elected according to the following pattern:

Three members from African States;

Two members from Asian States;

Two members from Eastern European States;

One member from Latin American and Caribbean States;

Three members from Western European and other States.

#### Commission on Crime Prevention and Criminal Justice (E/2002/L.1/Add.1)

Twenty members are to be elected according to the following pattern:

Eight members from African States;

Four members from Asian States;

Two members from Eastern European States;

Three members from Latin American and Caribbean States;

Three members from Western European and other States.

#### Commission on Sustainable Development (E/2002/L.1/Add.1)

Sixteen members are to be elected according to the following pattern:

Four members from African States;

Three members from Asian States;

Two members from Eastern European States;

Three members from Latin American and Caribbean States;

Four members from Western European and other States.

In addition, there remain two outstanding vacancies in the African States group for members whose terms would begin at the organizational meeting of the Commission's eleventh session in 2002 and expire at the close of the Commission's thirteenth session in 2005.

#### Commission on Science and Technology for Development (E/2002/L.1/Add.1)

Seventeen members are to be elected according to the following pattern:

Four members from African States;

Four members from Asian States;

Two members from Eastern European States;

Three members from Latin American and Caribbean States;

Four members from Western European and other States.

In addition, there remains one outstanding vacancy in the Asian States group and two outstanding vacancies in the Western European and other States group for members whose terms would begin on the date of election and expire on 31 December 2004.

#### **Committee for Programme and Coordination** (E/2002/L.1/Add.2)

Twenty members are to be nominated for election by the General Assembly according to the following pattern:

Four members for African States;

Four members for Asian States;

Three members for Eastern European States;

Four members for Latin American and Caribbean States;

Five members for Western European and other States.

#### Commission on Human Settlements (E/2002/L.1/Add.3)

Twenty members are to be elected according to the following pattern:

Six seats for African States;

Four seats for Asian States;

Two seats for Eastern European States;

Four seats for Latin American and Caribbean States;

Four seats for Western European and other States.

#### Committee on Non-Governmental Organizations (E/2002/L.1/Add.4)

Nineteen members are to be elected according to the following pattern:

Five members from African States;

Four members from Asian States;

Two members from Eastern European States;

Four members from Latin American and Caribbean States;

Four members from Western European and other States.

## Intergovernmental Working Group of Experts on International Standards of Accounting and Reporting (E/2002/L.1/Add.5)

Twenty-one members are to be elected according to the following pattern:

Five members from African States;

Three members from Asian States;

One member from Eastern European States;

Three members from Latin American and Caribbean States;

Nine members from Western European and other States.

There remains one outstanding vacancy in the Eastern European States group and one vacancy in the Latin American and Caribbean States group for members whose terms would begin on the date of election and expire on 31 December 2003.

#### **Committee of Experts on Public Administration**

In accordance with paragraph 1 of the annex to Council resolution 2001/45 of 20 December 2001, the Group of Experts on the United Nations Programme in Public Administration and Finance was renamed the Committee of Experts on Public Administration. Pursuant to that resolution, the Council is to consider the nomination of 24 experts by the Secretary-General who will serve on the Committee in their personal capacity for a four-year term beginning 1 January 2002.

#### Committee on Economic, Social and Cultural Rights (E/2002/L.1 and L.1/Add.10)

Pursuant to its resolution 1985/17, the Council is to elect, for a four-year term beginning on 1 January 2003, nine experts who shall serve in their personal capacity and have recognized competence in the field of human rights, with due consideration being given to equitable geographical distribution and to the representation of different forms of social and legal systems. The Committee is composed of 18 members: 15 seats are equally distributed among the regional groups, while the other 3 seats are allocated in accordance with the increase in the total number of States parties per regional group. Therefore, the nine experts are to be elected according to the following pattern:

Two members from African States;

Two members from Asian States;

One member from Eastern European States;

Two members from Latin American and Caribbean States;

Two members from Western European and other States.

Information regarding the candidates submitted by Governments and their curricula vitae are contained in the above-referenced documents.

### **Committee on Energy and Natural Resources for Development**

(E/2002/L.1/Add.6)

Twenty-four experts are to be elected according to the following pattern:

Six members from African States;

Five members from Asian States;

Three members from Eastern European States;

Four members from Latin American and Caribbean States;

Six members from Western European and other States.

Information regarding the candidates submitted by Governments and their curricula vitae will be circulated in additional addenda.

#### **Permanent Forum on Indigenous Issues**

There remains one outstanding vacancy in the Asian States group for an expert whose term would begin on the date of election and expire on 31 December 2004.

#### Executive Board of the United Nations Children's Fund (E/2002/L.1/Add.7)

Eleven members are to be elected according to the following pattern:

Two members from African States;

Two members from Asian States;

One member from Eastern European States;

Two members from Latin American and Caribbean States;

Four members from Western European and other States.

# **Executive Committee of the Programme of the United Nations High Commissioner for Refugees**

In accordance with General Assembly resolution 56/133, the Council is to elect four additional members to the Executive Committee.

## Executive Board of the United Nations Development Programme/United Nations Population Fund (E/2002/L.1/Add.8)

Eleven members are to be elected according to the following pattern:

Two members from African States;

Two members from Asian States;

One member from Eastern European States;

Two members from Latin American and Caribbean States;

Four members from Western European and other States.

#### Executive Board of the World Food Programme (E/2002/L.1/Add.11)

Six members are to be elected from the States included in Lists A to E contained in the annex to the above-referenced document in accordance with the following pattern:

One member from the States included in List A;

One member from the States included in List B;

One member from the States included in List C;

One member from the States included in List D;

Two members from the States included in List E.

## **Board of Trustees of the International Research and Training Institute for the Advancement of Women** (E/2002/L.1/Add.12)

In accordance with article III of the statute of the Institute, the Council is to appoint three members to the Board. Taking into account the existing de facto geographical balance of the Board, endorsed by the Council at previous sessions, the Council is to appoint one member from African States, one member from Asian States and one member from Western European and other States. The names of the candidates submitted by their Governments and their curricula vitae will be before the Council in the above-referenced document.

#### Committee for the United Nations Population Award

There remain two outstanding vacancies in the Asian States group and one outstanding vacancy in the Latin American and Caribbean States group for members whose terms would begin on the date of election and expire on 31 December 2003.

# Programme Coordination Board of the Joint United Nations Programme on Human Immunodeficiency Virus/Acquired Immunodeficiency Syndrome (HIV/AIDS) (UNAIDS) (E/2002/L.1/Add.9)

Five members are to be elected according to the following pattern:

Two members from Western European and other States.
