II. Annotations

1. Adoption of the agenda and other organizational matters

At its organizational session for 2003, the Council approved the provisional agenda for its substantive session (decision 2003/202).

In accordance with rule 12 of the rules of procedure of the Council (E/5715/Rev.2), should any proposals be submitted for the inclusion of supplementary items in the agenda, they will be circulated as soon as they are received, and a supplementary list of items will be issued as an addendum to the provisional agenda.

In accordance with General Assembly resolution 50/227, annex I, the Council will have before it a note by the Secretary-General on proposed themes for the high-level and coordination segments of the substantive session of 2004 of the Council.

Participation of intergovernmental organizations in the work of the Council

At its resumed organizational session for 2003, the Council decided to include in the agenda of its substantive session of 2003 the applications for observer status of three intergovernmental organizations: the Islamic Development Bank and the Islamic Educational, Scientific and Cultural Organization (Council decision 2003/208), and the Common Fund for Commodities (Council decision 2003/213).

A. High-level segment

2. Promoting an integrated approach to rural development in developing countries for poverty eradication and sustainable development

In accordance with General Assembly resolution 50/227, the Council will devote the first day of the high-level segment to a high-level policy dialogue with the executive heads of international trade and finance institutions on key issues on the global economy.

The Council, during its resumed substantive session of 2002, decided that the high-level segment of its substantive session of 2003 would consider the following theme: "Promoting an integrated approach to rural development in developing countries for poverty eradication and sustainable development" (Council decision 2002/309).

The Council will have before it a report of the Secretary-General which analyses the role of rural development in developing countries in poverty eradication and sustainable development and examines how to promote an integrated approach that would contribute to the attainment of the internationally agreed development goals, including those contained in the United Nations Millennium Declaration. The report will incorporate inputs from a number of relevant United Nations organizations, in particular the International Fund for Agricultural Development, the Food and Agriculture Organization of the United Nations and the World Food Programme.

(c) Economic and technical cooperation among developing countries

The High-level Committee on the Review of Technical Cooperation among Developing Countries is entrusted with the overall intergovernmental review of technical cooperation among developing countries within the United Nations system. It reports to the General Assembly through the Governing Council of the United Nations Development Programme and the Economic and Social Council in accordance with the Buenos Aires Plan of Action for Promoting and Implementing Technical Cooperation among Developing Countries. The Committee meets once every two years in odd-numbered years (General Assembly resolution 33/134).

C. Coordination segment

4. The role of the Economic and Social Council in the integrated and coordinated implementation of the outcomes of and follow-up to major United Nations conferences and summits

During its resumed substantive session of 2002, the Council decided on the following theme for the coordination segment of its substantive session of 2003: "The role of the Economic and Social Council in the integrated and coordinated implementation of the outcomes of and follow-up to major United Nations conferences and summits" (Council decision 2002/309).

The coordination segment provides an occasion for the Council to reflect on its role, building on the work of the Ad Hoc Working Group on the Integrated and Coordinated Implementation of and Follow-up to the Outcomes of Major United Nations Conferences and Summits in the Economic and Social Fields, which was established by the General Assembly in accordance with its resolution 57/270.

In its decision 2002/311, the Economic and Social Council requested the Statistical Commission to provide a separate comprehensive report on the work related to chapter VI, section E, of the report of the Commission on its thirty-third session (E/2002/24, Supplement No. 4) and on the basic indicators for the integrated and coordinated implementation of and follow-up to major United Nations conferences and summits at all levels, including the report on indicators on means of implementation and to report to it at its substantive session of 2003.

At its organizational session for 1999, the Council invited the Director-General of the Food and Agriculture Organization of the United Nations to transmit to the

Council every four years, starting in 1999, a report prepared by the Committee on World Food Security on progress in the implementation of the World Food Summit Plan of Action, highlighting its linkages with the coordinated and integrated follow-up to major United Nations conferences and summits undertaken by the United Nations system (Council decision 1999/212).

D. Humanitarian affairs segment

5. Special economic, humanitarian and disaster relief assistance

At its resumed organizational session for 2003, the Council decided that the theme of the humanitarian affairs segment of the substantive session of 2003 of the Council would be:

“Strengthening of the coordination of United Nations humanitarian assistance, with particular attention to: (a) humanitarian financing and effectiveness of humanitarian assistance; (b) transition from relief to development”.

The Council will also hold a panel, within the framework of the theme, on “Responding to the effects of HIV/AIDS and other widespread diseases on humanitarian relief operations” (Council decision 2003/210).

At its fifty-seventh session, in its resolution 57/153, the General Assembly requested the Secretary-General to report to it at its fifty-eighth session, through the Economic and Social Council at its substantive session of 2003, on the progress made in strengthening the coordination of emergency humanitarian assistance of the United Nations, including the implementation of and follow-up to Economic and Social Council resolution 2002/32.

In accordance with Council resolution 1983/46, the Secretary-General appraises the Council annually on the status of the assistance to the drought-stricken areas of Djibouti, Ethiopia, Kenya, Somalia, the Sudan and Uganda.

E. General segment

6. Implementation of and follow-up to major United Nations conferences and summits

Under this agenda item, the Council will consider implementation of and follow-up to selected major United Nations conferences and summits. While the Council's work under this agenda item is guided by the need to promote an integrated and coordinated approach, the focus is on individual conferences. It may be noted that the Council, in its agreed conclusions 2002/1, agreed to avoid addressing the same issues in more than one segment, unless specifically decided. As reiterated in the same agreed conclusions, the Council has carried out each year, at its coordination segment, a review of cross-cutting themes common to major international conferences. In 2003, the theme of that segment is "The role of the Economic and Social Council in the integrated and coordinated implementation of the outcomes of and follow-up to major United Nations conferences and summits".

(a) Follow-up to the International Conference on Financing for Development

At its substantive session of 2002, the Council adopted resolution 2002/34 on the follow-up to the International Conference on Financing for Development, held in Monterrey, Mexico, from 18 to 22 March 2002. In that resolution, the Council, *inter alia*, affirmed its commitment to contribute to the implementation of the Monterrey Consensus of the International Conference on Financing for Development (A/CONF.198/11, chap. I, resolution 1, annex) and decided to promote a coherent and integrated response within the United Nations. To that end, at the resumed substantive session of 2002 or, at the latest, at its organizational session for 2003, the Secretary-General was called upon to provide information on the different follow-up activities undertaken within the United Nations in support of implementation of the Monterrey Consensus.

At its resumed substantive session of 2002, the Council decided to defer its consideration of the report of the Secretary-General on the follow-up efforts to the International Conference on Financing for Development (A/57/319-E/2002/85) to its substantive session of 2003 (Council decision 2002/306).

In its resolution 2002/34, the Council also affirmed its commitment to make full use of the dialogue that takes place during its annual spring meeting with the Bretton Woods institutions and the World Trade Organization to address, in addition to general matters of common interest, the issues of coherence, coordination and cooperation related to the follow-up to the International Conference on Financing for Development.

At its organizational session of 2003, the Council decided that its high-level meeting with representatives of the Bretton Woods institutions and the World Trade Organization would be held at United Nations Headquarters, on 14 April 2003 (Council decision 2003/206). Furthermore, the Council took note of a memorandum dated 24 January 2003 from the Bureau of the Council to the members of the Council, concerning the general parameters of the spring 2003 meeting of the Council with the Bretton Woods institutions and the World Trade Organization, as well as the theme of the meeting, "Increased coherence, coordination and cooperation for the implementation of the Monterrey Consensus of the International

Conference on Financing for Development at all levels one year after the Conference” (Council decision 2003/209).

(b) Review and coordination of the implementation of the Programme of Action for the Least Developed Countries for the Decade 2001-2010

In its resolution 57/276, the General Assembly, having taken note of the report of the Secretary-General on implementation of General Assembly resolution 56/227 on the Third United Nations Conference on the Least Developed Countries (A/57/496), requested the Secretary-General to submit to the General Assembly, through the Economic and Social Council, a comprehensive annual progress report on the implementation of the Programme of Action for the Least Developed Countries for the Decade 2001-2010.

At its substantive session of 2001, the Council decided to consider, at a substantive session before 2005, devoting a high-level segment to the review and coordination of the implementation of the Programme of Action and to consider further options for such review and coordination late in the decade (Council decision 2001/320).

At its substantive session of 2002, the Council, having taken note of the oral report of the High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States on the Implementation of the Programme of Action for the Least Developed Countries for the Decade 2001-2010, requested the High Representative to submit a comprehensive progress report on the implementation of the Programme of Action to the Economic and Social Council at its substantive session of 2003 and invited all development partners, organizations of the United Nations system and other multilateral organizations to contribute to that end. The Council also invited the High Representative to consult with Member States on the appropriate format, such as, inter alia, a matrix of achievement, for such a comprehensive report (Council resolution 2002/33).

(a) Reports of coordination bodies

The United Nations System Chief Executives Board for Coordination will submit an annual overview report to the Council (Council resolution 13 (III)), which will provide the Council with a summary of the work carried out by the United Nations System Chief Executives Board machinery in 2002.

The report of the Committee for Programme and Coordination on its forty-third session (Headquarters, 9 June-3 July 2003) will include the Committee's views on its consideration of the report of the United Nations System Chief Executives Board for Coordination.

(b) Proposed programme budget for the biennium 2004-2005

In accordance with rule 31 of the rules of procedure of the Council, the Secretary-General will circulate the sections of the proposed programme budget for the biennium 2004-2005 covering activities in the economic, social and human rights fields. The Council will consider the relevant sections of the proposed programme budget in the light of the recommendations of the Committee for Programme and Coordination on the matter, with a view to submitting its own recommendations thereon to the General Assembly (Council resolution 1988/77).

(d) International cooperation in the field of informatics

At its substantive session of 2002, the Council requested the President of the Council to convene the Ad Hoc Open-ended Working Group on Informatics for one

more year, to enable it to carry out, from within existing resources and according to its mandate as set forth in Council resolution 1995/61, its work of facilitating the successful implementation of the initiatives being taken by the Secretary-General with regard to the use of information technology and continuing the implementation of measures required to achieve its objectives and called upon the Secretary-General to report to it at its substantive session of 2003 on the follow-up action taken on the resolution, including the findings of the Working Group and an assessment of its work and mandate (Council resolution 2002/35).

(e) Long-term programme of support for Haiti

At its substantive session of 2002, the Council took note of the comprehensive report of the Secretary-General (E/2002/56) submitted to it in accordance with Council resolution 2001/25 and requested the Secretary-General, in coordination with the United Nations resident coordinator in Haiti, to report on progress achieved in implementing a long-term programme of support for Haiti, and also requested that the report be prepared for the Economic and Social Council on the basis of developments in Haiti (Council resolution 2002/22).

(f) Mainstreaming a gender perspective into all policies and programmes in the United Nations system

At its substantive session of 2001, the Council, in its resolution 2001/41, called upon the Secretary-General and all bodies reporting to the Council to address the gender aspects of issues before the Council in their reports and decided to devote the coordination segment of one of its substantive sessions, before 2005, to the review and appraisal of the system-wide implementation of agreed conclusions 1997/2 of the Council on mainstreaming the gender perspective into all policies and programmes in the United Nations system.

At its substantive session of 2002, the Council requested the Secretary-General to submit to it, at its substantive session of 2003, a report on the follow-up to the implementation of the Beijing Declaration and Platform for Action and the outcome of the twenty-third special session of the General Assembly, including progress in the area of gender mainstreaming (Council resolution 2002/23).

At its fifty-seventh session, the General Assembly, in its resolution 57/182, requested the Secretary-General to report annually to the Assembly, the Economic and Social Council and the Commission on the Status of Women on follow-up to and progress in the implementation of the Beijing Declaration and Platform for Action and the outcome of the twenty-third special session with an assessment of progress made in mainstreaming a gender perspective within the United Nations system.

At its substantive session of 2001, the Council requested the Secretary-General to transmit to the Council, at its substantive session of 2003, a report prepared by the Executive Director of the Joint United Nations Programme on HIV/AIDS (UNAIDS), in collaboration with other relevant organizations and bodies of the United Nations system, which should include the progress made in developing a coordinated response by the United Nations system to the HIV/AIDS pandemic (Council resolution 2001/23).

At its resumed substantive session of 2002, the Council decided to establish an Ad Hoc Advisory Group on Guinea-Bissau, appointed its members and requested it to submit a report on its recommendations to the Council by mid-January 2003 (Council decision 2002/304).

At its organizational session of 2003, the Council, having taken note with appreciation of the report of the Ad Hoc Advisory Group on Guinea-Bissau (E/2003/8), decided to extend the mandate of the Group until its substantive session of 2003 (Council resolution 2003/1).

At its resumed organizational session for 2001, the Council, in its decision 2001/210, took note of the report of the Secretary-General (E/2001/7) on the creation of the Information and Communication Technologies (ICT) Task Force and requested the Secretary-General to establish it, in consultation with the regional groups, as recommended in his report. The report also stated, in paragraph 35, that the ICT Task Force shall submit an annual report to the Secretary-General focusing on the major emerging issues, including recommendations thereon, in the context of

information and communication technologies and that the Secretary-General will report annually to the Economic and Social Council on its work.

At its substantive session of 2002, the Council adopted agreed conclusions 2002/1 on further strengthening of the Council, building on its recent achievements, to help it fulfil the role ascribed to it in the Charter of the United Nations, as stated in the Millennium Declaration.

The Council will have before it a report of the Secretary-General on the implementation of agreed conclusions 2002/1. In accordance with General Assembly resolutions 45/264 and 50/227, the implementation of the agreed conclusions of the coordination segment should be followed up at the general segment in the following year.

At its substantive session of 2001, the Council, guided by the principles set forth in the Charter of the United Nations and by the Universal Declaration of Human Rights, the International Covenants on Human Rights and the other relevant international human rights instruments, recalled Commission on Human Rights resolution 2001/71 on the question of human rights and bioethics, acknowledged the importance of advances in genetic research, which has led to the identification of strategies for early detection, prevention and treatment of diseases and requested the

Secretary-General to bring its resolution on “genetic privacy and non-discrimination” to the attention of all Governments and relevant international organizations and functional commissions, in order to collect the information and comments received pursuant to it, and to submit a report thereon to the Council at its substantive session of 2003 (Council resolution 2001/39).

16. Negotiation of an agreement between the United Nations and the World Tourism Organization to constitute it as a specialized agency of the United Nations system

At its substantive session of 2002, the Council authorized its President to appoint, from among States members of the Council, in consultation with the Chairmen of the regional groups, the members of the Committee on Negotiations with Intergovernmental Agencies. It requested the Committee to meet at an appropriate time to negotiate with the World Tourism Organization a relationship agreement between the United Nations and the World Tourism Organization, on the basis of proposals submitted by the Secretary-General. It further requested the Committee to submit a draft relationship agreement between the United Nations and the World Tourism Organization for the Council’s consideration at its substantive session of 2003 (Council resolution 2002/24).
