In accordance with General Assembly resolution 50/227, annex I, the Council will have before it a note by the Secretary-General on proposed themes for the high-level and coordination segments of the substantive session of 2005 of the Council.

Participation of intergovernmental organizations in the work of the Council

At its organizational session for 2004, the Council decided to include in the agenda of its substantive session of 2004 the application for observer status with the Council of the World Deserts Foundation, an intergovernmental organization (Council decision 2004/208).

A. High-level segment

In accordance with General Assembly resolution 50/227, the Council will devote the first day of the high-level segment to a high-level policy dialogue with the executive heads of international trade and finance institutions on key issues on the global economy.

The Council will have before it a report of the Secretary-General on the theme (Council decision 2003/287). The Council will also have before it the World Economic and Social Survey, 2004, prepared pursuant to General Assembly resolutions 118 (II) and 52/180 and Council resolution 1983/50, and the relevant part of the report of the Committee for Development Policy on its sixth session.

3. Operational activities of the United Nations for international development cooperation

(a) Follow-up to policy recommendations of the General Assembly and the Council

In its resolution 56/201, the General Assembly requested the Secretary-General to submit to it at its fifty-ninth session, through the Council, a comprehensive analysis of the implementation of that resolution in the context of the triennial policy review, and to make appropriate recommendations.

At its substantive session of 2003, the Council, in its resolution 2003/3, paragraph 37, requested the Secretary-General to focus the analysis for the triennial comprehensive policy review in 2004, in the context of the implementation of the internationally agreed development goals, including those contained in the United Nations Millennium Declaration, pursuant to the guidelines set out in that resolution.

In paragraph 28 of the same resolution, the Council also requested the Secretary-General, in due consultation with the funds and programmes of the United Nations system, through the Executive Committee of the United Nations Development Group, to submit to the next substantive session of the Council in 2004, a report on the assessment of the value added of the joint meetings of their Executive Boards, and their impact on the operational activities segment of the Council, and to make recommendations as appropriate.

The Council will have before it a note by the Secretary-General transmitting the progress report of the Administrator of the United Nations Development Programme on the operationalization of the World Solidarity Fund (Council resolution 2003/4).

At its fifty-seventh session, in its resolution 57/104 on assistance to Mozambique, the General Assembly requested the Secretary-General to report to it at its fifty-ninth session, through the Council at the humanitarian segment of its substantive session in 2004, on the implementation of that resolution.

At its fifty-eighth session, in its resolution 58/114, the General Assembly requested the Secretary-General to report to it at its fifty-ninth session, through the Council at its substantive session of 2004, on the progress made in strengthening the coordination of emergency humanitarian assistance of the United Nations, including the implementation of and follow-up to Council resolution 2003/5.

In accordance with Council resolution 1983/46, the Secretary-General orally appraises the Council annually on the status of the assistance to the drought-stricken areas of Djibouti, Ethiopia, Kenya, Somalia, the Sudan and Uganda.

E. General segment

At its substantive session of 2003, the Council took note of the report of the Secretary-General on the role of the Council in the integrated and coordinated implementation of the outcomes of and follow-up to major United Nations conferences and summits (E/2003/67), and, in this regard, requested the Secretary-General to update the report and its recommendations in the light of General Assembly resolution 57/270 B and to submit it for consideration by the Council at its next substantive session (Council resolution 2003/6).

(a) Follow-up to the International Conference on Financing for Development

At its fifty-eighth session, the General Assembly requested the President of the Council, with support from the Vice-Presidents, to enhance the Council's interactions through regular exchanges with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development on organizational matters related to the follow-up to the International Conference on Financing for Development, within the context of the preparations of the high-level meeting with those institutions, bearing in mind Assembly resolution 57/270 B and Council resolution 2003/47, and to report thereon to the Council (Assembly resolution 58/230).

(c) International cooperation in the field of informatics

At its substantive session of 2003, the Council requested the President of the Council to convene the Ad Hoc Open-ended Working Group on Informatics for one more year to enable it to carry out, from within existing resources, its work of facilitating the successful implementation of the initiatives being taken by the Secretary-General with regard to the use of information technology and of continuing the implementation of measures required to achieve its objectives, and requested the Secretary-General to report to the Council at its substantive session of 2004 on the action taken to follow up on the need to harmonize and improve United Nations informatics systems for optimal utilization and accessibility by all States, including the findings of the Working Group and an assessment of its work and mandate (Council resolution 2003/48).

At its substantive session of 2003, the Council reiterated the need to undertake an assessment of lessons learned based on the initial experience of the Ad Hoc Advisory Groups on Burundi and Guinea-Bissau, no later than at its substantive session of 2004, stressed the need to assess also progress achieved in the implementation of recommendations made by the Ad Hoc Advisory Groups, and requested the Secretary-General to provide a report on the subject to the Council at its substantive session in 2004 (Council resolution 2003/50).

8. Implementation of General Assembly resolutions 50/227 and 52/12 B

The Council devoted the coordination segment of its substantive session of 2003 to the following theme: "The role of the Council in the integrated and coordinated implementation of the outcomes of and follow-up to major United Nations conferences and summits".

At its substantive session of 2003, the Council, in resolution 2003/6, adopted as an outcome of its coordination segment, decided to undertake the necessary steps for the effective implementation of the provisions of General Assembly resolution 57/270 B that were relevant to the work of the Council and its subsidiary machinery and to keep that implementation under review. In the same resolution, the Council took note of the report of the Secretary-General on the role of the Council in the integrated and coordinated implementation of the outcomes of and follow-up to major United Nations conferences and summits (E/2003/67), and, in that regard, requested the Secretary-General to update the report and its recommendations in the light of Assembly resolution 57/270 B and to submit the updated report for consideration by the Council at its next substantive session.

In accordance with General Assembly resolutions 45/264 and 50/227 (annex I, para. 59), the implementation of the agreed conclusions of the coordination segment should be followed up in the general segment of the following year.

At its substantive session of 2003, the Council, in its resolution 2003/59, requested the Secretary-General to submit to the General Assembly at its fifty-ninth session, through the Council, a report on the implementation of that resolution and to continue to include, in the report of the United Nations Special Coordinator for the Middle East Peace Process, an update on the living conditions of the Palestinian people, in collaboration with relevant United Nations agencies.

13. Economic and environmental questions

The General Assembly, in resolution 57/270 B, paragraph 49, urged the Council to make better use of the existing consolidated report of the Secretary-General on the work of the functional commissions and to dedicate more time to its review.

At its substantive session of 2003, the Council, in its resolution 2003/6, decided to take the necessary steps for the effective implementation of the provisions of General Assembly resolution 57/270 B that were relevant to the work of the Council and its subsidiary machinery and to keep that implementation under review.

The Council will have before it the consolidated report of the Secretary-General on the work of the functional commissions in 2004 to help it review the work of the functional commissions. See also under the chapeau of item 14.

At its twenty-ninth session, the General Assembly adopted the Charter of Economic Rights and Duties of States (resolution 3281 (XXIX) of 12 December 1974). Article 34 of the Charter provided that the Assembly should carry out periodically a systematic and comprehensive consideration of the implementation of the Charter. At its thirtieth session, the Assembly, inter alia, decided to entrust the Council with the task of reviewing the implementation of the Charter with a view to preparing adequately the above-mentioned systematic and comprehensive consideration by the Assembly (resolution 3486 (XXX) of 12 December 1975). In accordance with article 34, the review is to be undertaken every five years. The Council considered the issue at its substantive sessions of 1979, 1984, 1989 and 1994. In 1999, the review was embodied in the report of the Secretary-General to the Assembly on the
