1. Adoption of the agenda and other organizational matters

At its organizational session for 2005, the Council approved the provisional agenda for its substantive session (Council decision 2005/203).

In accordance with General Assembly resolution 50/227, annex I, the Council will have before it a note by the Secretary-General on proposed themes for the high-level and coordination segments of the substantive session of 2006 of the Council.

A. High-level segment

In accordance with General Assembly resolution 50/227, the Council will devote the first day of the high-level segment to a high-level policy dialogue with the executive heads of international trade and finance institutions on key issues of the global economy.

2. Achieving the internationally agreed development goals, including those contained in the Millennium Declaration, as well as implementing the outcomes of the major United Nations conferences and summits: progress made, challenges and opportunities

The Council will have before it a report of the Secretary-General on the theme (Council decision 2004/294). The report will incorporate inputs from a number of relevant United Nations organizations and draw upon the outcomes of the special preparatory round tables of the Council held on 16 and 17 March 2005 and of the NGO/Civil Society Forum, sponsored by the NGO Section of the Department of Economic and Social Affairs, held on 10 March 2005.

The Council will also have before it the *World Economic and Social Survey*, 2005, prepared pursuant to General Assembly resolutions 118 (II) and 52/180 and Council resolution 1983/50, and the relevant part of the report of the Committee for Development Policy on its seventh session (Council resolution 2004/66).

B. Operational activities of the United Nations for international development cooperation segment

3. Operational activities of the United Nations for international development cooperation

(a) Follow-up to policy recommendations of the General Assembly and the Council

At its fifty-ninth session, the General Assembly requested the Secretary-General to improve his *annual* statistical compendium to the operational activities segment of the Council by adding a multi-year perspective, fully incorporating available information and statistics, and requested the Council to undertake triennially, as of 2006, a comprehensive review of trends and perspectives in funding for development cooperation (Assembly resolutions 35/81 and 59/250).

In paragraph 24 of its resolution 59/250, the General Assembly requested the Secretary-General, in consultation with Member States, to explore various funding options for increasing financing for operational activities and to submit a report to the Assembly through the substantive session of the Council in 2005.

The Council will have before it the report of the Secretary-General on the implementation of paragraphs 37 and 101 of General Assembly resolution 59/250 on an appropriate management process, containing clear guidelines, targets, benchmarks and time frames for the full implementation of the resolution.

The Council will have before it a consolidated list of issues related to the coordination of operational activities (Council resolution 1998/27, para. 4).

(c) South-South cooperation for development

At its fifty-eighth session, the General Assembly decided to change the name of the High-level Committee on the Review of Technical Cooperation among Developing Countries to the *High-level Committee on South-South Cooperation* (Assembly resolution 58/220).

The High-level Committee is entrusted with the overall intergovernmental review of South-South cooperation within the United Nations system. It reports to the Assembly through the Governing Council of the United Nations Development Programme and the Economic and Social Council in accordance with the Buenos Aires Plan of Action for Promoting and Implementing Technical Cooperation among

Developing Countries (Assembly resolution 33/134). The Committee meets once *every two years* in odd-numbered years.

C. Coordination segment

4. Towards achieving internationally agreed development goals, including those contained in the Millennium Declaration

At its substantive session of 2004, in decision 2004/292, the Council decided to adopt the following theme for its 2005 coordination segment: "Towards achieving internationally agreed development goals, including those contained in the Millennium Declaration".

D. Humanitarian affairs segment

5. Special economic, humanitarian and disaster relief assistance

At its organizational session for 2005, the Council decided that the theme of the humanitarian affairs segment of its substantive session of 2005 would be: "Strengthening of the coordination of the United Nations humanitarian assistance, including capacity as well as organizational aspects".

At its fifty-ninth session, in resolution 59/141, the General Assembly requested the Secretary-General to report to it at its sixtieth session, through the Council at its substantive session of 2005, on the progress made in strengthening the coordination of emergency humanitarian assistance of the United Nations, including the implementation of and follow-up to Council resolution 2004/50.

Also at its fifty-ninth session, the General Assembly requested the Secretary-General to report to it at its sixtieth session on the implementation of its resolution entitled "Strengthening emergency relief, rehabilitation, reconstruction and prevention in the aftermath of the Indian Ocean tsunami disaster" under the item entitled "Strengthening of the coordination of humanitarian and disaster relief assistance of the United Nations, including special economic assistance" and to report to the Council at its substantive session in 2005 (Assembly resolution 59/279).

The Council will have before it a report on the post-tsunami actions undertaken by the World Tourism Organization. In accordance with article 7 of its statute

(Assembly resolution 58/232, annex), the World Tourism Organization shall submit to the United Nations regular reports on its activities.

In accordance with Council resolution 1983/46, the Secretary-General orally apprises the Council *annually* on the status of the assistance to the drought-stricken areas of Djibouti, Ethiopia, Kenya, Somalia, the Sudan and Uganda.

At its resumed substantive session of 2004, the Council stressed the need for the effective implementation of the Programme of Action for the Least Developed Countries for the Decade 2001-2010 and its *annual* assessment at the substantive session of the Council (Council resolution 2004/65).

At its fifty-ninth session, the General Assembly requested the Secretary-General to submit, through the Council, an *annual* progress report on the implementation of the Programme of Action for the Least Developed Countries for the Decade 2001-2010 (Assembly resolution 59/244).

At its substantive session of 2004, the Council requested the President of the Council to convene the Ad Hoc Open-ended Working Group on Informatics for one more year to enable it to carry out, from within existing resources, the due fulfilment of the provisions of the Council resolutions on that item, to facilitate the successful implementation of the initiatives being taken by the Secretary-General with regard to the use of information technology and to continue the implementation of measures required to achieve its objectives, and requested the Secretary-General to report to the Council at its substantive session of 2005 on the action taken to follow up on the need to harmonize and improve United Nations informatics systems for optimal utilization and accessibility by all States, including the findings of the Working Group and an assessment of its work and mandate (Council resolution 2004/51).

The Council will have before it the *annual* report of the Secretary-General on the follow-up to and progress made in the implementation of the Beijing Declaration and Platform for Action and the outcome of the twenty-third special session of the General Assembly, with an assessment of progress made in mainstreaming a gender perspective within the United Nations system, including by providing information

on key achievements, lessons learned and best practices, and recommendations for further measures and strategies for future action within the United Nations system (Assembly resolution 59/168). See also under item 14 (a).

At its substantive session of 2004, the Council encouraged the Task Force to continue promoting information and communication technologies for development worldwide, including through contributing to the World Summit on the Information Society process (Council decision 2004/296).

The Council also decided to consider the reports of the Group³ during its

substantive session in 2005, and requested that the report of the Group to that session describe, inter alia, how the Group had fulfilled its mandate. The Council further decided to hold a discussion on the work of the Group and on how it had fulfilled its mandate (Council resolution 2005/1).

Also, at its organizational session for 2005, the Council decided to extend the mandate of the Ad Hoc Advisory Group on Guinea-Bissau until its substantive session in 2005, and requested that in its report to the Council at that session, the Group describe how it had fulfilled its mandate and, if necessary, include a discussion of the tasks remaining to be accomplished as well as an estimated timetable for the completion of those tasks, in the light of the prevailing situation, as well as a discussion of the implementation of its recommendations. The Council also decided to consider the reports of the Group³ during its substantive session of 2005 (Council resolution 2005/2).
