Addendum

1. In accordance with Economic and Social Council resolution 2008 (LX) and General Assembly decision 42/450, the Council is required to nominate 20 members for election by the Assembly at its sixty-third session to fill the vacancies in the Committee for Programme and Coordination that will occur on 31 December 2008 upon the expiration of the terms of the following members: Argentina, Armenia, Belarus, Benin, Brazil, Bulgaria, Central African Republic, Cuba, India, Indonesia, Iran (Islamic Republic of), Israel, Italy, Pakistan, Portugal, Senegal, South Africa, Switzerland and Uruguay, as well as a member from the Western European and other States group, whose seat remains vacant. The term of office is three years, beginning on 1 January 2009.
2. The Council is reminded that the General Assembly, in section III of its resolution 3392 (XXX) on the review of the intergovernmental and expert machinery dealing with the formulation, review and approval of programmes and budgets, encouraged Member States to be represented in the Committee for Programme and Coordination at an adequate level in order to raise the expertise of the Committee.
3. The vacancies are to be filled according to the following pattern:
 - Four members from African States;
 - Four members from Asian States;
 - Three members from Eastern European States;
 - Four members from Latin American and Caribbean States;
 - Five members from Western European and other States.
4. The membership of the Committee in 2008 is given in the annex to the present note.
