#### **2. High-level segment**

##### **(a) High-level policy dialogue with international financial and trade institutions**

In accordance with General Assembly resolutions 48/162 and 61/16, the Council will hold a high-level policy dialogue with the executive heads of international financial and trade institutions on current developments in the world economy during its high-level segment.

**(b) Annual ministerial review:****Implementing the internationally agreed goals and commitments in regard to education**

Pursuant to paragraph 155 of General Assembly resolution 60/1, entitled “2005 World Summit Outcome”, and paragraph 10 of Assembly resolution 61/16, on the strengthening of the Economic and Social Council, the Council will have before it the report of the Secretary-General on the theme of the annual ministerial review (Council decision 2008/258). The report will incorporate inputs from a number of relevant United Nations entities and will also provide policy recommendations for consideration by the Council.

Pursuant to paragraphs 155 and 156 of the 2005 World Summit Outcome, the General Assembly, in its resolution 61/16, decided that the Council should continue to promote global dialogue, inter alia, through strengthening existing arrangements, including a thematic discussion on a theme from the economic, social and related fields to be decided by the Council and informed by a report of the Secretary-General.

Pursuant to Council decision 2010/262, the theme for the thematic discussion at its substantive session of 2011 will be “Current global and national trends and challenges and their impact on education”.

**B. Operational activities segment****3. Operational activities of the United Nations for international development cooperation****(a) Follow-up to policy recommendations of the General Assembly and the Council**

At its sixty-second session, in its resolution 62/208, the General Assembly:

- In paragraph 93, requested the Secretary-General to report on an annual basis to the Economic and Social Council at its substantive session on the functioning of the resident coordinator system, including costs and benefits. In that regard, in paragraph 13 of its resolution 2008/2, the Council requested the Secretary-General, in his annual report on the functioning of the resident coordinator system, to report on the participation and support to the functioning of the resident coordinator system of the United Nations system, including the non-resident agencies, and on progress in enhancing development impact, coherence, effectiveness and efficiency and costs and benefits of coordination through the resident coordinator system, with specific attention to the regional and country levels.
- In paragraph 112, requested the executive boards and governing bodies of the United Nations funds, programmes and specialized agencies to assess the progress achieved, including costs and benefits, in the area of simplification and harmonization of the United Nations development system at the global, regional and country levels, analyse the potential impacts on development programming and report to the Economic and Social Council at its substantive session on an annual basis.
- In paragraph 142, requested the Secretary-General, on the basis of information provided by the funds, programmes and specialized agencies of the United Nations development system, to submit to the Economic and Social Council, at its substantive sessions of 2009 and 2010, detailed reports on results achieved and measures and processes implemented in follow-up to the resolution on the triennial comprehensive policy review in order to evaluate the implementation of the resolution, with a view to ensuring its full implementation.

At its sixty-third session, the General Assembly:

- In paragraph 17 of its resolution 63/232, requested the Secretary-General to report, in the context of his annual report on the implementation of resolution 62/208, on measures taken to improve the quantity and quality of funding, including feedback from Member States on ways to achieve that objective.
- In paragraph 21 of its resolution 63/311, requested the Secretary-General, in consultation with the United Nations System Chief Executives Board for Coordination, to regularly inform the Council about progress being made and challenges encountered in the simplification and harmonization of business practices within the United Nations development system and to refer any matter requiring an intergovernmental decision to the relevant intergovernmental bodies.

At its sixty-fourth session, the General Assembly:

- In paragraph 5 of its resolution 64/220, requested the Secretary-General to postpone to its sixty-seventh session the submission, through the Economic and Social Council, of the comprehensive analysis of the implementation of General Assembly resolution 62/208 to be prepared in accordance with the guidance contained in paragraph 143 thereof.

The Council, in paragraph 13 of its resolution 2008/2, requested the Secretary-General, in his annual report on the functioning of the resident coordinator system, to report on the participation and support of the United Nations system, including the non-resident agencies, and on progress in enhancing development impact,

coherence, effectiveness and efficiency and costs and benefits of coordination through the resident coordinator system, with specific attention to the regional and country levels. The Council also requested the Secretary-General, in paragraph 20 of the resolution, to continue to improve the financial reporting of operational activities for development of the United Nations system. The Council further requested the Secretary-General, in paragraph 22 of the resolution, to make every effort to ensure that the information provided in response to paragraph 112 of General Assembly resolution 62/208 would be presented at future sessions of the Economic and Social Council in the form of a report.

The Council, in paragraph 4 of its resolution 2009/1, reiterated the request of the General Assembly to the executive heads of the United Nations funds, programmes and specialized agencies to continue to report annually to their governing bodies on measures taken and envisaged for the implementation of resolution 62/208. In paragraph 18 of resolution 2009/1, the Council requested the Secretary-General to continue to submit to the Council detailed reports on results achieved and measures and processes implemented, in accordance with paragraph 142 of Assembly resolution 62/208, at its substantive sessions of 2011 and 2012. The Council, in paragraph 27 of the resolution, also requested the Secretary-General to include in his annual reports to the Council on the functioning of the resident coordinator system, information on the operational modalities and the implementation of the management and accountability system of the United Nations development and resident coordinator system, including the functional firewall of the resident coordinator system, and to report on the independent comprehensive assessment thereof to the Council at its substantive session of 2012, within the framework of the comprehensive analysis of implementation of Assembly resolution 62/208.

The Council, in paragraph 4 of its resolution 2010/22, requested the Secretary-General to include in his report to the Council at its substantive session of 2011 information on further progress on an inter-agency collaborative framework on South-South cooperation and triangular cooperation, and on progress in the preparation of the operational guidelines to support the implementation of the Nairobi outcome document of the High-level United Nations Conference on South-South Cooperation, to be prepared as mandated by the High-level Committee on South-South Cooperation at its sixteenth session.

**(b) Reports of the Executive Boards of the United Nations Development Programme/United Nations Population Fund/United Nations Office for Project Services, the United Nations Children's Fund, the United Nations Entity for Gender Equality and the Empowerment of Women and the World Food Programme**

The Council will have before it the annual reports of the Executive Boards of the United Nations Development Programme/United Nations Population Fund/United Nations Office for Project Services, the United Nations Children's Fund, the United Nations Entity for Gender Equality and the Empowerment of Women and the World Food Programme (General Assembly resolutions 48/162, annex, 62/208 and 64/289, and Council resolutions 1995/51 and 2010/23).

The Council requested the funds and programmes, through their executive boards, to include in their annual reports to the Council: (a) a section outlining measures taken in the implementation of the provisions of the quadrennial policy review of operational activities; and (b) a section on the activities and measures undertaken within the designated theme of the high-level meeting of the operational activities segment (General Assembly resolutions 62/208, 63/232, and 64/289, and Council resolutions 1994/33 and 2010/23).

The reports include a thorough analysis of problems encountered and lessons learned, with emphasis on issues arising from the implementation of the reform programme of the Secretary-General, the comprehensive policy review and the follow-up to international conferences, so as to allow the Council to fulfil its coordinating role (General Assembly resolution 48/162, annex, Assembly resolutions 53/192 and 62/208 and Council resolutions 1995/51 and 2010/23).

## **C. Coordination segment**

### **4. The role of the United Nations system in implementing the ministerial declaration of the high-level segment of the 2010 substantive session of the Economic and Social Council**

The Council, in paragraph 10 of its resolution 2008/29, requested the Secretary-General to submit a report on measures taken to implement the ministerial declaration of the high-level segment of the Council for consideration by the Council at the coordination segment of its substantive session of the following year.

The Council, in paragraph 10 of its resolution 2009/29, requested the Secretary-General to prepare, taking into account the views of Member States, a report on the integrated and coordinated implementation of and follow-up to the outcomes of the major United Nations conferences and summits, in the light of relevant General Assembly resolutions, including resolution 61/16, which should additionally include recommendations on the periodicity of future reports, and to submit the report for consideration at its 2010 substantive session. In its decision 2010/252, the Council took note of the report of the Secretary-General on the role of the Council in that matter (A/65/84-E/2010/90), and decided that the scope and periodicity of future reports of the Secretary-General on the subject should be reviewed in connection with the review by the Assembly of the implementation of resolution 61/16.

### **6. Implementation of and follow-up to major United Nations conferences and summits**

#### **(a) Follow-up to the International Conference on Financing for Development**

The Council's attention is drawn to General Assembly resolution 64/193, in which the Assembly reaffirmed the need for a strengthened and more effective intergovernmental inclusive process to carry out the financing for development follow-up and to review progress in the implementation of commitments, identify obstacles, challenges and emerging issues and propose concrete recommendations and actions, and endorsed, in that regard, the recommendations of the Council as contained in its resolution 2009/30.

In its resolution 2010/26, the Council welcomed the new modalities of the special high-level meeting of the Council with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development, encouraged the President of the Council, in consultation with Member States, to continue to work with the appropriate representatives of the Bretton Woods institutions to improve the agenda and the format of the Council's high-level

meeting, considering innovative approaches conducive, inter alia, to the high-level participation of those institutions, and welcomed the efforts undertaken to give more prominence to the consideration of the agenda item on financing for development during the annual substantive session of the Council, including the allocation of the item to its coordination segment.

In its decision 2010/264, the Council decided to continue its consideration of the draft resolution on the establishment of an ad hoc panel of experts on the world financial and economic crisis and its impact on development (E/2010/L.37), with a view to making final recommendations to the General Assembly, in accordance with the mandate of paragraph 56 (e) of the Outcome of the Conference on the World Financial and Economic Crisis and its Impact on Development, during its substantive session of 2011.

In its resolution 2010/25, the Council requested the Secretary-General to report to it at its substantive session of 2011 on progress made in implementing the resolution entitled “Recovering from the world financial and economic crisis: a Global Jobs Pact”.

#### **(e) Mainstreaming a gender perspective into all policies and programmes in the United Nations system**

At its substantive session of 2010, the Council, in its resolution 2010/29, requested the Secretary-General to submit to the Council at its substantive session of 2011 a detailed report on the efforts and progress made by United Nations entities and on gaps and challenges that they still face in mainstreaming a gender perspective in the design, implementation, monitoring and evaluation of all policies and programmes and in capacity development, and include in the report a section on how UN Women will carry out its work, including by strengthening coordination, identifying areas for improvement and elevating the level of attention given to this cross-cutting issue.

At its sixty-fifth session, the General Assembly, in its resolution 65/191, requested the Secretary-General to continue to report annually to the Assembly under the item entitled “Advancement of women”, as well as to the Commission on the Status of Women and the Economic and Social Council, on the follow-up to and progress made in the implementation of the Beijing Declaration and Platform for Action and the outcomes of the twenty-third special session, with an assessment of progress in gender mainstreaming, including information on key achievements, lessons learned and good practices, and recommendations on further measures to enhance implementation.

### **D. Humanitarian affairs segment**

#### **5. Special economic, humanitarian and disaster relief assistance**

At its organizational session for 2011, the Council decided that the theme of the humanitarian affairs segment for its substantive session of 2011 would be “Working in partnership to strengthen coordination of humanitarian assistance in a changing world” (General Assembly resolution 52/12 B and Council decisions 1999/208 and 2011/\_\_\_).

In its resolution 65/133, the General Assembly requested the Emergency Relief Coordinator to continue her efforts to strengthen the coordination of humanitarian assistance, called upon relevant United Nations organizations and other relevant intergovernmental organizations, as well as other humanitarian and development actors, to continue to work with the Office for the Coordination of Humanitarian Affairs of the Secretariat to enhance the coordination, effectiveness and efficiency of humanitarian assistance, and requested the Secretary-General to report to the Assembly at its sixty-sixth session, through the Council at its substantive session of 2011, on progress made in strengthening the coordination of emergency humanitarian assistance of the United Nations and to submit a report to the Assembly on the detailed use of the Central Emergency Response Fund (see also Council resolution 2010/1).

#### **6. Implementation of and follow-up to major United Nations conferences and summits**

The Council, in paragraph 10 of its resolution 2009/29, requested the Secretary-General to prepare, taking into account the views of Member States, a report on the integrated and coordinated implementation of and follow-up to the outcomes of the major United Nations conferences and summits, in the light of relevant General

Assembly resolutions, including resolution 61/16, which should additionally include recommendations on the periodicity of future reports, and to submit the report for consideration at its substantive session of 2010. In its decision 2010/252, the Council took note of the report of the Secretary-General on the role of the Council in that matter (A/65/84-E/2010/90), and decided that the scope and periodicity of future reports of the Secretary-General on the subject should be reviewed in connection with the review by the Assembly of the implementation of resolution 61/16.

In its decision 1999/212, the Council invited the Director-General of the Food and Agriculture Organization of the United Nations to transmit every four years, starting in 1999, a report prepared by the Committee on World Food Security on progress in the implementation of the World Food Summit Plan of Action, highlighting its linkages with the coordinated and integrated follow-up to major United Nations conferences and summits undertaken by the United Nations system. In its resolution 65/178, the General Assembly invited the Chair of the Committee on World Food Security to report, as part of the Committee's report to the General Assembly at its sixty-sixth session, through the Economic and Social Council, on the implementation of the reform of, and on progress made towards achieving the vision of the Committee.

At its substantive session of 2010, the Council, in its resolution 2010/27, requested the Secretary-General to submit a 10-year comprehensive report on the implementation of the Programme of Action for the Least Developed Countries for the Decade 2001-2010 to the Fourth United Nations Conference on the Least Developed Countries, identifying, inter alia, lessons learned and best practices as well as structural constraints and handicaps encountered, resource requirements and resource gaps in achieving the set objectives of the Programme of Action.

#### **(b) Proposed programme budget for the biennium 2012-2013**

In accordance with rule 31 of the rules of procedure of the Council, the Secretary-General will circulate the proposed programme budget for the biennium 2012-2013 covering activities in the economic, social and human rights fields. The Council will consider the relevant sections of the proposed programme budget for the biennium 2012-2013 (General Assembly resolution 58/269 and Council resolution 1988/77).

#### **(c) International cooperation in the field of informatics**

At its substantive session of 2010, the Council, in its resolution 2010/38, requested the President of the Council to convene the Ad Hoc Open-ended Working Group on Informatics for one more year to enable it to carry out, from within existing resources, the due fulfilment of the provisions of the Council resolutions on the item, to facilitate the successful implementation of the initiatives being taken by the Secretary-General with regard to the use of information technology and to continue the implementation of measures required to achieve its objectives, and in that regard requested the Working Group to continue its efforts to act as a bridge between the evolving needs of Member States and the actions of the Secretariat, and also requests the Working Group to consider its future role, status and mandate and develop findings in that regard.

In the same resolution, the Council requested the Secretary-General to report to it at its substantive session of 2011 on action taken in follow-up to the resolution, including the findings of the Working Group and an assessment of its work and mandate.

**(d) Long-term programme of support for Haiti**

At its substantive session of 2010, the Council, in its resolution 2010/28, decided to extend the mandate of the Ad Hoc Advisory Group on Haiti until the substantive session of the Council in 2012, with the purpose of closely following and providing advice on Haiti's long-term development strategy to promote post-disaster socio-economic recovery, stability and reconstruction, with particular attention to the need to ensure coherence and sustainability in international support for Haiti, based on the long-term national development priorities, as contained in the Government's Action Plan for the Reconstruction and National Development of Haiti, and stressed the need to avoid overlap and duplication with respect to existing mechanisms.
