A. High-level segment

2. High-level segment

(a) High-level policy dialogue with international financial and trade institutions

In accordance with General Assembly resolutions 48/162 and 61/16, the Council will hold a high-level policy dialogue with the executive heads of international financial and trade institutions on current developments in the world economy during its high-level segment.

Pursuant to paragraph 155 of General Assembly resolution 60/1 entitled “2005 World Summit Outcome”, and paragraph 10 of Assembly resolution 61/16, on the strengthening of the Economic and Social Council, the Council will have before it the report of the Secretary-General on the theme of the annual ministerial review (Council decision 2011/208). The report will incorporate inputs from a number of relevant United Nations entities and will also provide policy recommendations for consideration by the Council.

Pursuant to paragraphs 155 and 156 of General Assembly resolution 60/1 entitled “2005 World Summit Outcome”, the Assembly, in its resolution 61/16, decided that

the Council should continue to promote global dialogue, inter alia, through strengthening existing arrangements, including a thematic discussion on a theme from the economic, social and related fields to be decided by the Council and informed by a report of the Secretary-General.

In accordance with Council decision 2012/263, the theme for the thematic discussion at its substantive session of 2013 will be “The contribution of the Economic and Social Council to the elaboration of the post-2015 development agenda as a principal body for policy review, policy dialogue and recommendations on issues of economic and social development and for the follow-up to the Millennium Development Goals”.

B. Operational activities segment

3. Operational activities of the United Nations for international development cooperation

(a) Follow-up to policy recommendations of the General Assembly and the Council

The General Assembly, in its resolution 67/226, requested the Secretary-General to report on the progress made in the context of his annual report on the funding of operational activities for development, including options for incentive mechanisms for increasing core resources, to be applied at a system-wide level.

In the same resolution, the General Assembly requested the Secretary-General, in consultation with the members of the United Nations development system, and based on the recent review of existing funding modalities in support of the resident coordinator system called for in Council resolution 2011/7, to submit, for the consideration of the Council and the General Assembly in 2013, concrete proposals on the modalities for the funding of the resident coordinator system in order to ensure that resident coordinators have the necessary stable and predictable resources to fulfil their mandate effectively, without compromising resources allocated to programmatic activities, with due regard for the principle of fairness, which should reflect the direct involvement of each agency, based on the proportion of services used.

Also in the same resolution, the General Assembly requested the Secretary-General to regularly assess and report, on a comprehensive and quantitative basis, on progress in furthering programme and operational coordination at the country level in order to inform annual reporting to the Council on the functioning of the resident coordinator system.

Also in resolution 67/226, the General Assembly requested the United Nations development system to identify and address challenges and bottlenecks, in particular at the headquarters level, which have prevented United Nations country teams in “Delivering as one” countries from fully realizing the efficiency gains under the “Delivering as one” approach and to report thereon as part of the annual reporting on the implementation of the resolution for the consideration of the Council and the Assembly. It also requested the United Nations system to build on the best practices and lessons learned in implementing “Delivering as one” by a number of countries and to further consolidate the process by clearly outlining the core elements of each of the “ones”, based on lessons learned, including by formulating standard operational procedures as guidelines for the successful work of the United Nations country teams in “Delivering as one” countries, as well as for other countries that consider joining “Delivering as one”, and to report on the process and standard operating procedures to the Council during its operational activities segment. In that regard, the Assembly requested the Secretary-General to come up with proposals for the consideration of Member States, to include in his annual report options for the review and approval of the common country programme documents of the “Delivering as one” countries and to make appropriate recommendations for the consideration of the Council and the Assembly by 2013.

In the same resolution, the General Assembly requested the Secretary-General to articulate and report to the Council at its operational activities segment in 2013, with a view to the implementation, by 2014, of a more robust, coherent and harmonized approach to operational activities for development, focused on results, which would streamline and improve the planning, monitoring, measurement and reporting on system-wide results, and in that regard invited the executive boards of the funds and programmes and the governing bodies of the specialized agencies and other relevant United Nations entities to engage in a focused dialogue on how to balance most effectively the need for reporting on system-wide results at all levels with the current agency-specific reporting requirements, taking into account the challenges in developing results frameworks that demonstrate the United Nations contribution to national development results.

Also in the same resolution, the General Assembly requested the Secretary-General to establish an interim coordination mechanism for system-wide evaluation of operational activities for development of the United Nations system composed of the Joint Inspection Unit, the United Nations Evaluation Group, the Department of Economic and Social Affairs, the Office for the Coordination of Humanitarian Affairs and the Office of Internal Oversight Services, and to develop, through the interim coordination mechanism, a policy for independent system-wide evaluation of operational activities for development of the United Nations system, including submitting a proposal for pilot system-wide evaluations, for discussion at the operational activities segment of the Council in 2013.

Also in resolution 67/226, the General Assembly requested the Secretary-General, on the basis of information provided by the funds, programmes and specialized agencies of the United Nations development system, to submit to the Council, at its substantive sessions of 2013, 2014 and 2015, analytical reports on results achieved and measures and processes implemented in follow-up to the present resolution on the quadrennial comprehensive policy review, with a view to ensuring its full implementation.

The Council will have before it the annual reports of the Executive Boards of the United Nations Development Programme/United Nations Population Fund/United Nations Office for Project Services, the United Nations Children's Fund, the United Nations Entity for Gender Equality and the Empowerment of Women, and the World Food Programme (General Assembly resolutions 48/162, 62/208, 64/289 and 65/176, and Council resolutions 1995/51 and 2011/5).

The Council requested the funds and programmes, through their executive boards, to include in their annual reports to the Council: (a) a section outlining measures taken in the implementation of the provisions of the quadrennial policy review of operational activities; and (b) a section on the activities and measures undertaken within the designated theme of the high-level meeting of the operational activities segment (General Assembly resolutions 48/162, 50/8 and 62/208, and Council resolutions 1995/51 and 2011/5).

The reports include a thorough analysis of problems encountered and lessons learned, with emphasis on issues arising from the implementation of the reform programme of the Secretary-General, the comprehensive policy review and the follow-up to international conferences, so as to allow the Council to fulfil its coordinating role (General Assembly resolutions 48/162, 53/192, 62/208, 63/232 and 64/289, and Council resolutions 1995/51 and 2011/5).

The High-level Committee on South-South Cooperation, in its decision 17/2, decided that the eighteenth session of the Committee would be held in 2014. The Council will therefore consider the report of the eighteenth session of the Committee at the 2014 session of the Council.

C. Coordination segment

4. The role of the United Nations system in implementing the ministerial declaration of the high-level segment of the 2012 substantive session of the Economic and Social Council

The Council, in paragraph 10 of its resolution 2008/29, requested the Secretary-General to submit a report on measures taken to implement the ministerial declaration of the high-level segment of the Council for consideration by the Council at the coordination segment of its substantive session of the following year.

6. Implementation of and follow-up to major United Nations conferences and summits

(a) Follow-up to the International Conference on Financing for Development

In its resolution 2012/31, the Council stressed the need to further improve the dialogue between Member States and representatives of the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development during the special high-level meeting of the Council, as part of a forum for multi-stakeholder dialogue, and requested the President of the Council to seek a more interactive, dynamic and substantive discussion on key issues related to the financing for development framework. It also welcomed the

efforts undertaken to give more prominence to the consideration of the agenda item on financing for development during the annual substantive session of the Council, including the allocation of the item to its coordination segment.

In the same resolution, the Council also recalled paragraphs 255 to 257 of the outcome document of the United Nations Conference on Sustainable Development, and in that regard, stressed the need to reinforce coherence and coordination and to avoid duplication of efforts with regard to the financing for development follow-up process.

10. Regional cooperation

In its resolution 2004/323, the Council, recalling General Assembly resolution 57/270 B and Council resolution 1998/46, decided to hold a dialogue with the executive secretaries of the regional commissions immediately after the high-level segment of the substantive session of the Council.

The Council, in its decision 2013/211, decided that the theme for the item on regional cooperation at its substantive session of 2013 would be “Regional perspectives on the post-2015 development agenda”.

The Council will also consider the report of the Secretary-General on regional cooperation and take the necessary action on the decisions and recommendations of the regional commissions contained therein that statutorily require its approval (General Assembly resolution 1823 (XVII) and Council resolution 1817 (LV) and decision 1979/1).

D. Humanitarian affairs segment

5. Special economic, humanitarian and disaster relief assistance

The General Assembly, in its resolution 67/87, and the Council, in its resolution 2012/3, requested the Emergency Relief Coordinator to continue her efforts to strengthen the coordination and accountability of humanitarian assistance and leadership within the United Nations humanitarian response system and called upon relevant United Nations organizations and other relevant intergovernmental organizations, as well as other humanitarian and development actors, to continue to work with the Office for the Coordination of Humanitarian Affairs of the Secretariat to enhance the coordination, effectiveness and efficiency of humanitarian assistance.

The General Assembly and the Council also requested the Secretary-General to continue strengthening the support provided to United Nations resident/humanitarian coordinators and to United Nations country teams, including by providing necessary training, identifying resources and improving the identification of and the selection process for United Nations resident/humanitarian coordinators, and enhancing their performance accountability, and to report on actions taken to enable the United Nations to continue to strengthen its ability to recruit and deploy staff quickly and flexibly, to procure emergency relief materials and services rapidly, cost-effectively and locally, where applicable, and to quickly disburse funds in order to support Governments and United Nations country teams in the coordination of international humanitarian assistance.

At its resumed organizational session for 2013, the Council decided that the theme of the humanitarian affairs segment for its substantive session of 2013 would be “The future of humanitarian affairs: towards greater inclusiveness, coordination, interoperability and effectiveness” (General Assembly resolution 52/12 B and Council decisions 1999/208 and 2013/212).

E. General segment

6. Implementation of and follow-up to major United Nations conferences and summits

The General Assembly, in its resolution 66/288, requested the Secretary-General to report, through the Council, on the progress made in further mainstreaming the three dimensions of sustainable development throughout the United Nations system.

The Council, in its resolution 2012/30, requested the Secretary-General to submit to the General Assembly at its seventy-sixth session, within the framework of the review of the implementation of Assembly resolution 61/16, a report containing proposals for strengthening the Council, including its working methods, so that it can effectively fulfil its functions, and giving special attention to the integrated and coordinated implementation of, and the regular and substantive follow-up to, the outcomes of all major United Nations conferences and summits in the economic, social, environmental and related fields, to be prepared in consultation with Member States and taking into account the contributions of the functional and regional commissions and other subsidiary bodies of the Council, as appropriate.

In its decision 2011/217, the Council invited the Chair of the Committee on World Food Security to transmit to the Council annually, starting in 2012, a report on the main decisions and policy recommendations made as well as the results achieved by the Committee in the area of food security and nutrition, in accordance with its new roles and vision.

At its sixty-seventh session, the General Assembly, in its resolution 67/221, requested the Committee for Development Policy to monitor the development progress of graduated countries, in consultation with the Governments of those countries, on a yearly basis for a period of three years after graduation becomes effective, and triennially thereafter, as a complement to two triennial reviews of the list of least developed countries, and to include its findings in its annual report to the Council.

At its substantive session of 2012, the Council, in its resolution 2012/26, requested the Secretary-General to submit to the Council at its substantive session of 2013 a progress report on the implementation of the Istanbul Programme of Action for the Least Developed Countries for the Decade 2011-2020 (Council resolutions 1079 (XXXIX) and 1998/46).

The report of the Committee for Programme and Coordination on its fifty-third session (3-28 June 2013) will include the Committee's views on its consideration of the report of the United Nations System Chief Executives Board for Coordination (General Assembly resolution 31/93 and Council resolution 2008 (LX)).

(b) Proposed programme budget for the biennium 2014-2015

The Council will consider the relevant sections of the proposed programme budget for the biennium 2014-2015 (General Assembly resolution 58/269 and Council resolution 1988/77).

The General Assembly, in its resolution 62/137, requested the Secretary-General to continue to report annually on the follow-up to and progress made in the implementation of the Beijing Declaration and Platform for Action and the outcomes of the twenty-third special session, with an assessment of progress in gender mainstreaming, including information on key achievements, lessons learned and good practices, and recommendations on further measures to enhance implementation.

At its substantive session of 2012, the Council, in its resolution 2012/24, requested the Secretary-General to submit, at its substantive session of 2013, a report on the implementation of the resolution, including the promotion of accountability and progress made in the implementation of the United Nations System-wide Action Plan on Gender Equality and the Empowerment of Women.

(d) Long-term programme of support for Haiti

At its substantive session of 2012, the Council, in its resolution 2012/21, decided to extend the mandate of the Ad Hoc Advisory Group on Haiti until the substantive session of the Council in 2013, with the purpose of following closely and providing advice on Haiti's long-term development strategy to promote socioeconomic recovery, reconstruction and stability, with particular attention to the need to ensure coherence and sustainability in international support for Haiti, based on the long-term national development priorities, building on the Strategic Development Plan for Haiti and stressing the need to avoid overlap and duplication with respect to existing mechanisms.

The Council, in the same resolution, requested the Advisory Group to submit a report on its work, with recommendations, as appropriate, to the Council for consideration at its substantive session of 2013.

(e) Joint United Nations Programme on HIV/AIDS (UNAIDS)

At its substantive session of 2011, the Council, in its resolution 2011/19, requested the Secretary-General to transmit to the Council a report prepared by the Executive Director of the Joint United Nations Programme on HIV/AIDS, in collaboration with its co-sponsors and other relevant organizations and bodies of the United Nations system, on progress made in implementing a coordinated response by the United Nations system to the HIV/AIDS epidemic.

In the same resolution, the Council also requested the Secretary-General to include in his report to the Council at its substantive session of 2013 options to effectively monitor the work of the Task Force and the integration of implementation efforts in respect of the World Health Organization Framework Convention on Tobacco Control within the United Nations Development Assistance Frameworks, where appropriate, in order to promote coordinated and complementary work among funds, programmes and specialized agencies.

The Council will be required to approve its calendar of conferences and meetings in the economic, social and related fields for 2014 and 2015 (Council decisions 52 (LVII) and 1988/103).

In its resolution 66/233 on pattern of conferences, the General Assembly requested the Secretary-General to propose, at its sixty-seventh session, a comprehensive review of conference servicing highlighting any duplications and redundancies.

Pursuant to Assembly resolution 66/233, the Secretary-General, in paragraph 13 of his report on the pattern of conferences (A/67/127 and Corr.1), indicated that the Secretariat had reviewed the process of preparing the biennial calendar of conferences and meetings, which incorporates the provisional biennial calendar of meetings in the economic, social and related fields. He further indicated that the biennial calendar contained almost two thirds of the meetings listed in the provisional biennial calendar and that the time and effort to prepare, translate and issue two almost identical calendars so close to each other might be considered a duplication and redundant.

In paragraph 15 of his report, the Secretary-General therefore recommended that the General Assembly might wish to invite the Council to reconsider the necessity of reviewing its provisional biennial calendar of conferences and meetings in the economic, social and related fields.

Subsequently, upon the recommendation of the Committee on Conferences, the General Assembly, in its resolution 67/237, concurred with the observations in paragraph 13 of the report of the Secretary-General on the pattern of conferences regarding the biennial calendar of meetings of the Council.

In addition, as indicated in paragraph 23 of the report of the Committee on Conferences (A/67/32), held in September 2012, most delegations had expressed the view that the issue should initially be brought to the attention of the Bureau of the Council, through its secretariat, and then to the Council as a whole.

Therefore, it was suggested that the Council might then wish to review paragraph (b) of its decision 281 (LXIII), on the need for a biennial calendar of conferences and meetings in the economic, social and related fields, in the context of the mandate set out by the Assembly in section II, paragraph 16, of its resolution 66/233.

In addition, the Council requested the President to report to it thereon and requested the Secretary-General to follow up on the implementation of the resolution, paying particular attention to cooperation and integration arrangements for maximizing the efficiency of the assistance activities undertaken by various organizations of the United Nations system and to report thereon to the Council at its substantive session of 2013.
