## Provisional calendar of conferences and meetings in the economic, social and related fields for 2014 and 2015

Note by the Secretariat

#### Summary

In the present note, the Economic and Social Council is invited to review the calendar of conferences and meetings for 2014 and 2015 in the economic, social and related fields and approve the meetings of its subsidiary bodies. Information on meetings of related bodies and conferences and meetings of governing bodies of specialized agencies and the International Atomic Energy Agency is also provided. The attention of the Council is drawn to the relevant provisions of General Assembly resolutions 45/264, 46/235, 50/227 and 61/16 on the restructuring and revitalization of the United Nations in the economic, social and related fields, which have been taken into account in the preparation of the calendar.

The Council is invited to consider further the biennialization of the sessions of its subsidiary bodies, in accordance with paragraph 2 (f) (ii) of its resolution 1988/77 and General Assembly resolution 50/206 A.

Attention is drawn to Council decision 1988/103, in which the Council decided to invite the Committee on Conferences to review the Council's draft calendar of conferences and meetings and submit, as appropriate, its recommendations thereon to the Council.

1. The provisional calendar of conferences and meetings in the economic, social and related fields for 2014 and 2015, contained in the annex to the present document, has been prepared in accordance with the relevant General Assembly resolutions, in particular resolutions 37/14 C, 39/68 B and D, 40/243, 41/177, 41/213, 42/207 B, 45/264, 46/235 50/227, 59/145 and 61/16 and the relevant decisions and resolutions of the Economic and Social Council. Attention is drawn to the following decisions of the Council and the Assembly:

(a) That the Council should hold an organizational session not to exceed four days' duration in early February and a resumed organizational session at the end of April for one or two days, and that the Council should hold one substantive session of four weeks to take place in alternate years in New York and Geneva in July (Assembly resolutions 45/264 and 50/227);

(b) That the Council, as a Charter body, is entitled to convene meetings as and when needed, with full substantive support and conference services, and that the Council, beginning with its 2007 session, is entitled to convene additional meetings of up to two weeks in order to facilitate the fulfilment of its newly assigned responsibilities for organizing the annual ministerial reviews and the Development Cooperation Forum and to hold ad hoc meetings, in order to effectively fulfil its mandate under the Charter (General Assembly resolution 61/16);

(c) That all meetings of subsidiary and associated organs should conform to the Council's schedule of meetings and not vice versa (decision adopted at the Council's 1837th meeting, on 28 July 1972, at the fifty-third session);

(d) That the Secretary-General should ensure that meetings of the subsidiary bodies of the Council end at least eight weeks before the session of the Council at which their reports are to be considered (Council resolutions 1982/50, para. 1 (l), and 1988/77, para. 2 (f) (i));

(e) That the subsidiary bodies of the Council, with the exception of the regional commissions, may not create either standing or ad hoc intersessional subsidiary bodies without prior approval of the Council (rule 24, para. 2, of the rules of procedure of the Council);

(f) That the regular sessions of the Economic and Social Commission for Asia and the Pacific, the Economic Commission for Latin America and the Caribbean, the Economic Commission for Africa and the Economic and Social Commission for Western Asia and meetings of their subsidiary bodies may be held away from their headquarters when the commission concerned so decides, subject, in the case of regular sessions of the commissions, to the approval of the Council and the Assembly (Assembly resolution 40/243, sect. I, para. 4 (f));

(g) To adopt, on a regular basis, a biennial cycle of meetings that would correspond to the programme budget cycle, for better administrative control (Council decision 281 (LXIII), para. (b));

(h) That (i) the regular sessions of the functional commissions and standing committees of the Council should normally have a duration of not more than eight working days; and (ii) once the calendar of meetings has been adopted by the Council, no additional meetings involving departures from the biennial cycle of meetings would be authorized during the biennium (Council decision 1979/81, paras. (b) to (d), and Assembly resolution 34/50) and that the waiver to the

headquarters rule contained in Assembly resolution 40/243 would be discontinued in the case of the functional commissions (Assembly resolution 49/221 A);

That, in the future, there should be an intervening period of at least two weeks after the closing of the sessions of relevant intergovernmental bodies and the beginning of the session of the Commission on Sustainable Development, in accordance with the multi-year programme of work of the Commission, and that such intergovernmental bodies and the Commission are encouraged to closely coordinate meeting dates and programmes of work so as to avoid overlap between sessions. In this regard, the Council's attention is drawn to General Assembly resolution 66/288 of 27 July 2012, in which the Assembly decided to establish a high-level political forum which would subsequently replace the Commission on Sustainable Development, and that an intergovernmental process under the Assembly would define the format and organizational aspects of the high-level political forum, with the aim of convening the first high-level forum at the beginning of the sixty-eighth session of the Assembly. The Assembly also decided in the same resolution that the high-level political forum should avoid overlap with existing structures, bodies and entities in a cost-effective manner. In view of this, the Commission has not been included in the present calendar and has been replaced by the high-level political forum, with dates and modalities to be determined.

2. The Council's attention is drawn to the decision taken by the Committee on Conferences at its 154th meeting, on 11 March 1981, that, in the future, requests for intersessional departures from the calendar of conferences should only be submitted to the Committee for its consideration if accompanied by a presentation of detailed substantive arguments supporting a proposed change in or an addition to the calendar. The Committee also decided to request the Secretariat to inform the Committee, as far in advance as possible, of the need for a postponement of sessions of United Nations bodies, together with a presentation of the substantive reasons necessitating a delay.

3. The Council may recall that, in its decision 1992/214, it decided to grant authority to its Bureau to approve intersessional departures from its approved calendar of conferences and meetings in respect of its subsidiary bodies when the Council was not in session and after consultation with the Committee on Conferences.

4. The Council's attention is drawn to Council decision 1988/103, in which the Council decided to invite the Committee on Conferences to review the Council's provisional biennial calendar of conferences and meetings, beginning with the calendar for 1990-1991, and submit, as appropriate, its recommendations thereon to the Council. The Committee on Conferences is scheduled to meet on 27 June 2013 to review the Council's provisional calendar of conferences and meetings for 2014 and 2015 and may submit recommendations to the Council at its substantive session, to be held from 1 to 26 July 2013.

5. The Council may recall that, in paragraph 2 (f) (ii) of its resolution 1988/77, it decided to further consider the biennialization of the sessions of its subsidiary bodies. As approved by the Council in its resolution 2006/49, the United Nations Forum on Forests biennialized its meeting schedules starting from 2007. The other subsidiary bodies of the Council that meet biennially are the Economic Commission for Latin America and the Caribbean, the Economic and Social Commission for Western Asia, the United Nations Group of Experts on Geographical Names and the

Committee of Experts on the Transport of Dangerous Goods and on the Globally Harmonized System of Classification and Labelling of Chemicals.

6. The Council may wish to take the opportunity of its review of the provisional calendar to consider further the question of the biennialization of its subsidiary bodies in the context of its review of the mandates, composition, functions and working methods of its functional commissions and expert groups and bodies (see Council resolution 1996/41 and General Assembly resolution 50/227).

7. In response to paragraph 16 of section II of General Assembly resolution 66/233 of 24 December 2011, in which the Assembly requested the Secretary-General to highlight any duplications and redundancies in conference servicing with a view to identifying innovative ideas, potential synergies and other cost-saving measures, the Secretariat made a proposal contained in paragraphs 13, 14 and 15 of the report of the Secretary-General on the pattern of conferences (A/67/127). The proposal briefly described the mandates of the Economic and Social Council and the Committee on Conferences to review the provisional biennial calendar of meetings in the economic, social and related fields in odd-numbered years, and examined the duplication and redundancy of preparing and issuing two almost identical draft calendars within a short period of time.

8. The above proposal was considered by the Committee on Conferences at its substantive session in September 2012 and its views and discussions were reflected in paragraphs 22, 23 and 24 of its report (A/67/32). While several delegations questioned the feasibility of the recommendation which, in their view, would affect the legislative mandate of those bodies and infringe on the prerogatives of the Council, numerous delegations expressed their support for the recommendation concerning the provisional biennial calendar. The Secretariat explained the alternative of preparing one consolidated document to include the bodies listed in the provisional biennial calendar, for consideration by the Committee on Conferences, which could then make separate recommendations to the Council and the Assembly.

9. Most delegations expressed the view that the issue should initially be brought to the attention of the Bureau of the Council, through its secretariat, and then to the Council as a whole. The Council may then wish to review paragraph (b) of its decision 281 (LXIII), on the need for a provisional biennial calendar of meetings in the economic, social and related fields, in the context of the mandate set out by the Assembly in paragraph 16 of section II of its resolution 66/233, and more recently in paragraph 8 of section I of its resolution 67/237 of 24 December 2012, wherein the General Assembly concurred with the observations in paragraph 13 of the report of the Secretary-General (A/67/127).

10. The Secretariat wishes to bring to the attention of the Economic and Social Council the information contained in paragraphs 7, 8 and 9 above when it considers the item on the provisional biennial calendar of conferences and meetings in the economic, social and related fields at its substantive session in July 2013, with a view to obtaining the Council's views on the matter. On the basis of its current mandate and practice, any observations or recommendations made by the Committee on Conferences when it meets on 27 June 2013 to review the provisional calendar will be transmitted by the Chair of the Committee to the President of the Council.

11. The Council's attention is drawn to General Assembly resolution 67/251 of 13 March 2013, in which the Assembly decided to change the designation of the Governing Council of the United Nations Environment Programme to the United Nations Environment Assembly of the United Nations Environment Programme. The Assembly also took note of Governing Council decision 27/2 of 22 February 2013, by which the Governing Council decided to discontinue the Global Ministerial Environment Forum, de facto replacing it with a high-level segment at the Assembly.

12. In the preparation of the provisional calendar, due regard has been taken of General Assembly resolution 53/208, in particular paragraph 11, whereby it was decided that United Nations bodies should be invited to avoid holding meetings on Orthodox Good Friday and that this arrangement should be taken into account when drafting future calendars and meetings. For the next biennium, Orthodox Good Friday occurs on 18 April in 2014 and on 10 April in 2015.
