## Latin American and Caribbean States

### Jesús Guadalupe Fuentes Blanco (Mexico)

[Original: Spanish]

I was awarded a Bachelor's degree in accounting from the Faculty of Accounting and Administration of the National Autonomous University of Mexico.

I was awarded a Bachelor's degree in law through the open education system of the Faculty of Law of the National Autonomous University of Mexico.

I currently work as an independent consultant on civil law, including family law, commercial law, inheritance law and, in particular, the exercise of indigenous law.

Since 1986, I have organized social activities relating to the management and support of indigenous groups in Mexico City to provide those groups with the support that they need to live in an environment that is opposed to their environment of origin in terms of culture, worldview, geography, climate and customs, among other things, and, above all, to help these groups of migrant indigenous brothers and sisters as they are systematically and continuously subjected to discrimination and social marginalization by the new society in which they have settled.

Since 1989, I have also been involved in the establishment of various indigenous working groups and civil associations dedicated to actively pursuing and working for the recognition of our peoples and their rights, full access to justice and recognition of our identity as persons with specific characteristics, whether they are physical, cultural, philosophical or related to our worldview.

In 1992 we established a working group called *Él es Dios* (He is God), which strengthened the work that we, a group of young people, had been doing since 1986. At that time our activities were not coordinated, but the creation of the working group bestowed formality, certainty and identity on the mission and vision that we brought to the activities, which have continued to this day. The working group is currently cooperating with the government of Mexico City on projects in such areas as social justice, support and development of commerce and production, and health.

The group is still active, and I have had the honour and responsibility of being its president on two occasions, from 1992 to 1995 and from 2005 to 2008, with the recognition of several bodies of the government of Mexico City, namely the Secretariat of Rural Development and Equity for Communities, the Secretariat of Health and the Secretariat of Education, as well as the political delegations of the boroughs of Iztapalapa and Gustavo A. Madero.

In 2008 I became a consulting adviser on the Mexico City Village and Neighbourhood Council established by the government of Mexico City. I stepped down in 2009, as the values displayed and manifested by the Council were not consistent with my ideology and indigenous struggle.

In 2011 I applied for a post as an adviser for the Mexico City Metropolitan Area, representing the Mixteco people, on the Advisory Council of the National Commission for the Development of Indigenous Peoples. I was elected and took up my post as national adviser in May 2011. I also joined the Working Group on the Exercise of Rights and Autonomy, whose members proposed that I should coordinate its work.

In May 2012, I was nominated as a candidate for President of the Advisory Council and elected to that post at our internal elections. My first mandate ran from May 2012 to December 2014.

As President of the Advisory Council, I had the great honour of participating in various projects, including work on electoral political rights in collaboration with the federal judiciary's electoral tribunal and the United Nations Development Programme (UNDP) and projects relating to environmental governance with the Ministry of the Environment and Natural Resources and UNDP.

Subsequently, I worked with the members of the Advisory Council to identify the cross-cutting themes that we should consider in our programme of work and create a national agenda, with the following results:

- We developed a consultation protocol, which was applicable on a temporary basis in the absence of a law on the matter.
- We were involved in the incorporation of the indigenous agenda in the National Development Plan for 2013 to 2018.
- We were involved in the incorporation of themes in the Special Programme for Indigenous Peoples for 2013 to 2018.
- We drew up national and international agendas.
- The President of the Republic participated in our events to mark the International Day of the World's Indigenous Peoples in San Juan Chamula, Chiapas, in 2014, and in the Otomi Ceremonial Centre in Temoaya, State of Mexico in 2015.
- Several indigenous councillors attended and participated in the sessions of the United Nations Permanent Forum on Indigenous Issues in New York as part of the Mexican delegation in 2013, 2014 and 2015, where we had the opportunity to give a presentation on the working model of the Advisory Council to the international indigenous community at a parallel event.
- Several indigenous councillors attended and participated in the sessions of the United Nations Expert Mechanism on the Rights of Indigenous Peoples in Geneva in 2013 and 2014.
- The Working Group was created to handle international issues.

In 2015 I once again stood for election to the Advisory Council of the National Commission for the Development of Indigenous Peoples as Mixteco Councillor for the Federal District Metropolitan Area. I was elected and joined the Council for its fifth session, which officially began in March 2015.

I have been re-elected President of the Advisory Council for the period 2015 to 2018.

## Tarcila Rivera Zea (Peru)

[Original: Spanish]

Tarcila Rivera Zea is one of the most well-known indigenous activists in Peru and the world.

Her accomplishments include founding the Continental Network of Indigenous Women of the Americas and the International Indigenous Women's Forum, networks that promote leadership and political participation for millions of indigenous women around the globe.

In 2011 she received a Ford Foundation Visionaries Award for her leadership, extraordinary vision and courageous work for indigenous women's rights. The following year she was selected by Michelle Bachelet to become a member of the Global Civil Society Advisory Group of the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women).

Rivera is the founder and president of the CHIRAPAQ Centre of Indigenous Cultures of Peru, an association that has been promoting the affirmation of indigenous identity and recognition of the rights of indigenous peoples for over 25 years with a view to building a more just, democratic and intercultural society.

Since the 1990s, CHIRAPAQ has promoted training for women indigenous leaders, many of whom have held public office in their communities, organizations and regional governments and are now active in the national and international indigenous movement.

She was born in the community of San Francisco de Pujas, Ayacucho, and moved to Lima at the age of 10, at which time she was monolingual. She became a domestic worker and completed her secondary education when she was 21 years old.

She went to work as a secretary at the National Institute of Culture in 1972, which at that time was under the leadership of Dr. Martha Hildebrandt. She was subsequently awarded a series of scholarships from the Organization of American States to specialize in archival and library science, which she studied in Argentina and the Vatican.

In the 1980s, she joined the Indian Council of South America as a journalist, contributing to the magazine *Pueblo Indio*. In that role, she collected testimonies of indigenous women who had been raped in prison during the political violence. In recognition of that work, she was invited by a Dutch foundation to study human rights at the International Institute of Social Studies in The Hague.

Through her membership of the Working Group on Indigenous Populations, which she joined in 1987, she contributed to the establishment of the Permanent Forum on Indigenous Issues and the adoption of the United Nations Declaration on the Rights of Indigenous Peoples.

She also participated in the International Conference on Population and Development (Cairo, 1994), the World Conference on Women (Beijing, 1995) and the Durban Declaration and Programme of Action against racism, racial discrimination, xenophobia and related intolerance (Durban, 2001), providing input into policies on intercultural education, empowerment and the visibility of indigenous women.

She is a member of the Indigenous Initiative for Peace headed by Rigoberta Menchú (winner of the Nobel Peace Prize); the Commission on Commercialization and Indigenous Intellectual Property of the Continental Network of Indigenous Women of the Americas, of which she was Coordinator until December 2015; the El Pedregal Pact Follow-up Commission; and the Board of Directors of the Association for Women's Rights in Development. Within Peru, she is a member of the Advisory Committee of the Bureau of Peruvian Women Parliamentarians.

In 2013 she received an award from the Committee of Women of the Congress of the Republic for her tireless efforts and dedication to serving the community.

In 2014 she was recognized by the Peruvian Ministry of Culture for her contribution to the defence of indigenous cultures and by the United Nations Children's Fund for her efforts to ensure the rights of indigenous children.

## **Gabriel Muyuy Jacanemejoy (Colombia)**

Member of the indigenous Inga people of Colombia, with extensive experience working in the areas of human and academic development; expert in indigenous law and legislation, human rights and ethnic affairs, and environmental law; specialist in the rights to consultation and free, prior and informed consent, and comprehensive life plans; adviser, consultant and speaker at the national and international levels on social, cultural, political, economic and environmental issues; author of various publications on his specialist subjects.
