Annotated agenda for the 2018 session of the Economic and Social Council

The Economic and Social Council, in its decision 2018/202, adopted the provisional agenda for its 2018 session (E/2018/1).

Section I of the present document reflects the list of items on the agenda for the 2018 session of the Council. Section II contains the annotations for the items. The annotations are intended to provide a brief history of each item and to indicate, where applicable, the documentation that is to be made available during the course of the session. The present document does not include items that are considered by the Council on a biennial basis.¹

The Council, in its resolution 2018/1, adopted the working arrangements for its 2018 session, which includes the coordination and management meetings, the operational activities for development segment, the integration segment and the humanitarian affairs segment.

The Council further updated its working arrangements for the 2018 session by determining, inter alia, the dates of the 2018 Development Cooperation Forum; the high-level political forum on sustainable development, convened under the auspices of the Council; and the high-level segment, including the three-day ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the auspices of the Council (Council decision 2018/204).²

The updated working arrangements for the 2018 session are set out in the annex to the present document.

II. Annotations

1. Election of the Bureau

Pursuant to General Assembly resolution 68/1, the programme of work of the Economic and Social Council is on a July-to-July cycle. The term of office of the officers of the Council (the Bureau) for the 2018 session will be from the date of their election until the date of the election of their successors, in accordance with rule 19 of the rules of procedure of the Council. In accordance with the principle of equitable geographical rotation of the office of the President among the regional groups, the President of the Council at its 2018 session should be from the Eastern European States. The four Vice-Presidents of the Council will be elected from the other regional groups.

In its decision 2018/200 A, the Council elected by acclamation Marie Chatardová of Czechia as President of the Council, and Mahmadamin Mahmadaminov of Tajikistan, Inga Rhonda King of Saint Vincent and the Grenadines and Marc Pecsteen de Buytswerve of Belgium as Vice-Presidents of the Council for its 2018 session.

In its decision 2018/200 B, the Council elected by acclamation Jerry Matthews Matjila of South Africa as Vice-President of the Council for its 2018 session.

On the recommendation of the President, the Council, in its decision 2018/203, decided on the following special responsibilities of the Bureau for the 2018 session: the President, Marie Chatardová (Czechia), would be responsible for the high-level segment, the high-level political forum on sustainable development convened under the auspices of the Council and the forum on financing for development follow-up, as well as the multi-stakeholder forum on science, technology and innovation for the Sustainable Development Goals; the Vice-President, Marc Pecsteen de Buytswerve (Belgium), would be responsible for the operational activities for development segment; the Vice-President, Mahmadamin Mahmadaminov (Tajikistan), would be responsible for the integration segment; the Vice-President, Jerry Matthews Matjila (South Africa), would be responsible for the humanitarian affairs segment; and the Vice-President, Inga Rhonda King (Saint Vincent and the Grenadines), would be responsible for the coordination and management meetings, including the elections to fill the vacancies in the Council's subsidiary bodies.

2. Adoption of the agenda and other organizational matters

The Council, at the 1st meeting of its 2018 session, on 27 July 2017, adopted the provisional agenda for the session (E/2018/1; Council decision 2018/202).

Pursuant to General Assembly resolution 68/1 and taking into account General Assembly resolution 70/299, the Council, in its decision 2017/208, decided that the main theme for its 2018 session would be "From global to local: supporting sustainable and resilient societies in urban and rural communities".

3. Basic programme of work of the Council

Pursuant to Council resolution 1988/77 on the revitalization of the Council, the President, with the cooperation of the other members of the Bureau, arranges consultations with members of the Council on the draft programme of work and makes proposals thereon for consideration by the Council.

Pursuant to Council decision 2006/206 on adapting the work of the Council, the President of the Council convenes consultations of the Council, on an "as available" basis, to adapt its organization of work and current methods of work in pursuance of the provisions set out in General Assembly resolutions 60/1, 61/16 and 68/1.

4. Elections, nominations, confirmations and appointments

The Council will schedule the elections to fill vacancies in its subsidiary bodies during the coordination and management meetings of the session, in particular at the coordination and management meeting to be held from 16 to 18 April 2018.

5. High-level segment

The General Assembly, in its resolution 68/1, decided that a high-level segment will be held in July. It will continue to discharge the functions of the high-level segment of the Council as provided for in General Assembly resolutions 45/264, 48/162, 50/227, 61/16 and 70/299.

Pursuant to Council decision 2018/204, the high-level segment, including the threeday ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the Council, will be held from 16 to 19 July 2018.

(a) Ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the Economic and Social Council

Pursuant to paragraph 11 (c) of the annex to General Assembly resolution 68/1 and paragraph 18 of General Assembly resolution 70/299, the three-day ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the Council, will be held during the high-level segment of the Council

in order to avoid duplication, enhance efficiency and strengthen complementarity and synergy.

(b) High-level policy dialogue with international financial and trade institutions

In accordance with General Assembly resolutions 48/162 and 61/16, the Council will hold a high-level policy dialogue with the executive heads of international financial and trade institutions on current developments in the world economy during its high-level segment.

(c) Development Cooperation Forum

Pursuant to General Assembly resolutions 60/1, 61/16 and 68/1, the Council will hold its biennial high-level Development Cooperation Forum to review trends in international development cooperation, including strategies, policies and financing, promote greater coherence among the development activities of different development partners and strengthen the links between the normative and operational work of the United Nations.

Pursuant to Council decision 2018/204, the 2018 Development Cooperation Forum will be held on 21 and 22 May 2018.

(d) Thematic discussion

Pursuant to General Assembly resolutions 60/1, 61/16 and 68/1, the Council continues to promote global dialogue, inter alia, by strengthening existing arrangements, including a thematic discussion on a theme from the economic, social and related fields to be decided by the Council and informed by a report of the Secretary-General.

6. High-level political forum on sustainable development, convened under the auspices of the Economic and Social Council

The General Assembly, in its resolution 67/290, decided that the high-level political forum on sustainable development under the auspices of the Council would be convened annually by the President of the Council and would have a thematic focus reflecting the integration of the three dimensions of sustainable development, in line with the thematic focus of the activities of the Council and consistent with the 2030 development agenda. The theme of the high-level political forum on sustainable development to be convened under the auspices of the Council during its 2018 session is "Transformation towards sustainable and resilient societies" (General Assembly resolution 70/299).

Pursuant to General Assembly resolutions 67/290 and 70/1, the high-level political forum, under the auspices of the Council, would carry out regular thematic reviews on the follow-up and implementation of sustainable development commitments and objectives, including those related to the means of implementation, within the context of the 2030 Agenda for Sustainable Development. In its resolution 70/299, the General Assembly further decided that the high-level political forum under the auspices of the Council, without prejudice to the integrated, indivisible and interlinked nature of the Sustainable Development Goals, should discuss a set of Goals and their interlinkages, with a view to facilitating an in-depth review of progress made on all Goals over the course of a four-year cycle, with means of implementation, including with respect to Goal 17, reviewed annually.

For the high-level political forum on sustainable development to be convened under the auspices of the Council during its 2018 session, the General Assembly decided, in its resolution 70/299, that Sustainable Development Goals 6, 7, 11, 12 and 15 should be reviewed in depth, in addition to the annual review of Goal 17.

In accordance with General Assembly resolutions 70/1 and 70/299, the follow-up and review at the high-level political forum will be informed by an annual progress report on the Sustainable Development Goals to be prepared by the Secretary-General in cooperation with the United Nations system. Every four years, a more scientific and analytical *Global Sustainable Development Report* will be prepared to complement the Secretary-General's annual progress report. In response to the invitation by the General Assembly in its resolution 70/1, the President of the Council conducted a process of consultations on the scope, methodology and frequency of the *Global Sustainable Development Report*, the outcome of which was reflected in the annex to the ministerial declaration of the session of the high-level political forum in 2016.³ The *Global Sustainable Development Report* will be published in 2019.

Pursuant to General Assembly resolutions 67/290, 70/1 and 70/299, the high-level political forum, under the auspices of the Council, should hold voluntary national reviews by all countries, including countries in special situations, with the aim of facilitating the sharing of experiences, including successes, challenges and lessons learned. The Assembly, in its resolution 70/299, requested that the Secretary-General update and make available voluntary national reviews, taking into account feedback from countries participating in the voluntary national reviews at the high-level political forum under the auspices of the Council.

The General Assembly, in its resolution 67/290, invited the regional commissions to contribute to the work of the high-level political forum on sustainable development

convened under the auspices of the Economic and Social Council, including through annual regional meetings.

7. Operational activities of the United Nations for international development cooperation

Pursuant to Council resolution 2018/1, the operational activities for development segment will be held from 27 February to 1 March 2018.

(a) Follow-up to policy recommendations of the General Assembly and the Council

In its resolution 71/243, the General Assembly requested the Secretary-General to present to the Council in 2018 and 2019 a report on system-wide implementation of the provisions of the quadrennial comprehensive policy review of operational activities for development of the United Nations system and the results achieved, and to make other recommendations to further strengthen system-wide reporting.

Also pursuant to its resolution 71/243, the General Assembly requested a system-wide outline of the present functions, as defined in their strategic plans and similar planning documents, and existing capacities of all United Nations entities carrying out operational activities for development in support of the implementation of the 2030 Agenda for Sustainable Development. The Assembly further requested that the heads of the entities of the United Nations development system, under the leadership of the Secretary-General, develop and present, for consideration by the operational

activities for development segment of the 2018 session of the Council, a system-wide strategic document translating the recommendations of the system-wide outline into concrete actions that would be adapted efficiently and coherently in order to improve their collective support to the implementation of the 2030 Agenda for Sustainable Development. The strategic document would also include options for aligning funding modalities with the functions of the United Nations development system, to be reflected in the new strategic plans and similar planning documents of its entities. The Assembly also requested the Secretary-General to prepare a comprehensive proposal on further improvements to the resident coordinator system administered by the United Nations Development Programme, with a view to ensuring, at all levels, sufficient leadership and prerogative over the United Nations country team, as well as impartiality, independence, funding and a proper dispute resolution mechanism.

The General Assembly also requested in its resolution 71/243 that the Secretary-General, under the auspices of the Council and in cooperation with United Nations resident coordinators, conduct a biennial survey, directed to governments on a voluntary basis, on the quality, relevance, effectiveness and efficiency of the support of the United Nations development system for national development priorities and plans, and requested that the results of such surveys be published and made available to Member States.

The Council will have before it the annual reports of the Executive Boards of the United Nations Development Programme/United Nations Population Fund/United Nations Office for Project Services, the United Nations Children's Fund, the United Nations Entity for Gender Equality and the Empowerment of Women and the World Food Programme (General Assembly resolutions 48/162, 62/208, 64/289, 65/176, 67/226 and 68/229 and Council resolutions 1995/51, 2011/5, 2013/5 and 2015/15).

Pursuant to General Assembly resolution 70/1, the relevant governing bodies of the United Nations development system should take action to review the support to the implementation of the 2030 Agenda for Sustainable Development by the United Nations development system and to report on progress and obstacles.

(c) South-South cooperation for development

Pursuant to General Assembly resolutions 33/134 and 58/220, the High-level Committee on South-South Cooperation meets once every two years in odd-numbered years and reports to the Assembly through the Executive Board of the United Nations Development Programme/United Nations Population Fund/United Nations Office for Project Services and the Council.

At its nineteenth session, the High-level Committee on South-South Cooperation, in its decision 19/2, approved the provisional agenda for its twentieth session, to be held in 2018. Subsequently, the General Assembly, in its resolution 71/318, decided to postpone the twentieth session of the High-level Committee on South-South Cooperation to one day in June 2019. Consideration of this sub-item will therefore be postponed until the 2019 session of the Council.

8. Integration segment

Pursuant to General Assembly resolution 68/1, an integration segment is held annually, the timing and modalities of which are decided by the Council. The main functions of the segment are to consolidate all the inputs of Member States, the subsidiary bodies of the Council, the United Nations system and other relevant stakeholders and to promote the balanced integration of the three dimensions of sustainable development. The integration segment brings together the key messages from the Council system on the main theme and develops action-oriented recommendations for follow-up.

Pursuant to Council resolution 2018/1, the integration segment will be held from 1 to 3 May 2018. The Council, in its decision 2018/206,⁵ and recalling General Assembly resolution 70/299, decided that the theme of the integration segment of its 2018 session would be "Innovative communities: leveraging technology and innovation to build sustainable and resilient societies".

9. Special economic, humanitarian and disaster relief assistance

In accordance with General Assembly resolution 52/12 B, by which the Assembly established a humanitarian affairs segment of the Economic and Social Council, and pursuant to paragraph 11 (b) of the annex to General Assembly resolution 68/1, a humanitarian affairs segment will be held in June, through which the Council should continue to contribute to strengthening the coordination and effectiveness of United Nations humanitarian assistance and support and complement international efforts aimed at addressing humanitarian emergencies, including natural disasters, in order to promote an improved, coordinated response by the United Nations. The Council should also continue to hold a special event to discuss the transition from relief to development, to be convened immediately preceding the humanitarian affairs segment and following the annual session of the executive boards of the funds and programmes of the United Nations system.

Pursuant to Council resolution 2018/1, the humanitarian affairs segment will be held from 19 to 21 June 2018.

10. The role of the United Nations system in implementing the ministerial declaration of the high-level segment of the substantive session of the Economic and Social Council

In its resolution 45/264, the General Assembly requested the Secretary-General to implement the recommendations addressed to him in the annex to the resolution, which included the recommendation that the substantive session of the Council be organized under segments, including a coordination segment, and that the coordination segment focus on the coordination of the activities of the specialized agencies, organs, organizations and bodies of the United Nations system in the economic, social and related fields, in accordance with Articles 63 and 64 of the Charter of the United Nations. In its resolution 68/1, the Assembly decided that dedicated coordination and management meetings would be held regularly to perform the functions of the coordination and general segments.

11. Implementation of and follow-up to major United Nations conferences and summits

At the United Nations Conference on Sustainable Development, the United Nations system was requested to mainstream the economic, social and environmental dimensions of sustainable development throughout its work. The General Assembly, in its resolution 72/216, invited the Secretary-General to continue to report to the

General Assembly, through the Council, on progress made in further mainstreaming the three dimensions of sustainable development throughout the United Nations system.

In its decision 2011/217, the Council invited the Chair of the Committee on World Food Security to transmit to the Council annually, starting in 2012, a report on the main decisions and policy recommendations made as well as the results achieved by the Committee in the area of food security and nutrition, in accordance with its new roles and vision.

The Council, recalling its resolution 2107 (LXIII) of 3 August 1977, by which it established the United Nations System Standing Committee on Nutrition, and pursuant to Council decision 2018/207, decided to request the Standing Committee on Nutrition to transmit to the Council a report on its activities on an annual basis, starting in 2018, with a view to promoting the coherence and impact of the United Nations system response to nutrition problems, and to reflect on policy implications for achieving the 2030 Agenda for Sustainable Development.

(a) Follow-up to the International Conference on Financing for Development

Pursuant to General Assembly resolution 69/313, the Economic and Social Council holds an annual forum on financing for development follow-up, one day of which is dedicated to the special high-level meeting with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development and up to four days of which are dedicated to discussing the follow-up and review of the financing for development outcomes and the means of implementation of the 2030 Agenda for Sustainable Development. The forum's intergovernmentally agreed conclusions and recommendations are fed into the overall follow-up and review of the implementation of the 2030 Agenda for Sustainable Development.

The General Assembly, in its resolution 70/192, decided that the annual sessions of the forum would be held at United Nations Headquarters in New York in the spring. It also decided that the forum would be chaired by the President of the Council, who would take the steps necessary to prepare the work of the forum according to paragraph 132 of the Addis Ababa Action Agenda.

In its resolution 72/206, the General Assembly looked forward to the consideration of financial inclusion for sustainable development at the 2018 Economic and Social Council forum on financing for development follow-up. In addition, in its resolution 72/207, the Assembly looked forward to the inclusion, in the 2018 report of the Inter-Agency Task Force on Financing for Development, of an analysis of international cooperation to combat illicit financial flows and strengthen good practices on assets return to foster sustainable development, and to the deliberations of the forum on financing for development follow-up.

Furthermore, in its resolution 72/203, the General Assembly encouraged the Council to consider, at its annual forum on financing for development follow-up, a discussion and analysis of systemic issues and challenges, taking into account the roles of the international financial institutions. The Assembly also encouraged the Council to continue discussions on ways to improve external debt sustainability in its resolution 72/204.

The next Economic and Social Council forum on financing for development followup, including the special high-level meeting with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development, will be held from 23 to 26 April 2018, and the forum's modalities will follow those applied to the 2017 forum (decision 2017/255).

The Council, in the same resolution, requested the Advisory Group to submit a report on its work, with recommendations, as appropriate, to the Council for consideration at its 2018 session.

In the same resolution, the Council requested the Secretary-General, in close collaboration with the Director General of WHO and in full consultation with Member States through WHO, to develop the terms of reference for the United Nations Inter-Agency Task Force on the Prevention and Control of Non-communicable Diseases, incorporating, but not limited to, the work of the Ad Hoc Inter-Agency Task Force on Tobacco Control and the current work of the secretariat of WHO to develop a division of tasks and responsibilities, as exemplified in appendix 4 to the WHO Global Action Plan for the Prevention and Control of Non-communicable Diseases 2013–2020 (see also Council resolutions 2014/10 and 2015/8).

In its resolution 2017/8, the Council requested the Secretary-General to report at the 2018 session on the implementation of resolution 2013/12 in preparation for a comprehensive review by the General Assembly, in 2018, of the progress achieved in the prevention and control of non-communicable diseases.

(g) Calendar of conferences and meetings in the economic, social and related fields

In its resolution 66/233 on the pattern of conferences, the General Assembly requested the Secretary-General to propose, at its sixty-seventh session, a comprehensive review of conference servicing highlighting any duplications and redundancies. The Secretary-General, in paragraph 13 of his report on the pattern of conferences (A/67/127 and A/67/127/Corr.1), indicated that the Secretariat had reviewed the process of preparing the biennial calendar of conferences and meetings, which incorporated the provisional biennial calendar of meetings in the economic, social and related fields. He further indicated that the biennial calendar contained almost two thirds of the meetings listed in the provisional biennial calendar and that the time and effort to prepare, translate and issue two almost identical calendars so close to each other might be considered a duplication and redundant.

In paragraph 15 of his report, the Secretary-General therefore recommended that the General Assembly might wish to invite the Council to reconsider the necessity of

reviewing its provisional biennial calendar of conferences and meetings in the economic, social and related fields.

Subsequently, upon the recommendation of the Committee on Conferences, the General Assembly, in its resolution 67/237, concurred with the observations in paragraph 13 of the report of the Secretary-General on the pattern of conferences regarding the biennial calendar of meetings of the Council.

In addition, as indicated in paragraph 23 of the report of the Committee on Conferences (A/67/32), most delegations expressed the view that the issue should initially be brought to the attention of the Bureau of the Council, through its secretariat, and then to the Council as a whole. Therefore, it was suggested that the Council might then wish to review paragraph (b) of its decision 281 (LXIII), on the need for a biennial calendar of conferences and meetings in the economic, social and related fields, in the context of the mandate set out by the General Assembly in section II, paragraph 16, of its resolution 66/233.

The General Assembly, in its resolution 71/262, reaffirmed the need to address the issue of duplications and redundancies in conference servicing, and noted in that regard that the Council had decided, in its resolution 2013/13, to consider at a later date the necessity of reviewing its provisional biennial calendar of conferences and meetings in the economic, social and related fields in the light of the ongoing intergovernmental consultations on the further strengthening of the Council.

The Council, in its resolution 2017/27, decided, on an exceptional basis, to include the item in the agenda of its 2018 session and requested the Secretariat to propose to the Bureau of the Council a streamlined list of bodies whose conferences and meetings should be included in future provisional calendars of conferences to be considered by the Council on a biennial basis, starting at its 2019 session.
