**Elections, nominations, confirmations and appointments**

## **Election of 20 members of the Governing Council of the United Nations Human Settlements Programme**

### **Note by the Secretary-General**

1. Pursuant to General Assembly resolution [56/206](#), the Economic and Social Council is to elect 20 members of the Governing Council of the United Nations Human Settlements Programme for a four-year term beginning on 1 January 2019 to fill the vacancies that will occur on 31 December 2018 upon the expiration of the terms of the following members: Argentina, Democratic Republic of the Congo, Ecuador, Egypt, Finland, Gabon, Ghana, Guatemala, Indonesia, Iran (Islamic Republic of), Iraq, Japan, Russian Federation, Senegal, Slovakia, United States of America, Uruguay and Zimbabwe. In addition, the two seats with terms expiring on 31 December 2018 from Western European and other States that remain vacant are to be filled.
2. The election will be held at the coordination and management meetings of the Economic and Social Council, from 16 to 18 April 2018.
3. In accordance with paragraph 4 of section I.A of General Assembly resolution [56/206](#), the 20 members are to be elected according to the following pattern:
  - (a) Six members from African States;
  - (b) Four members from Asia-Pacific States;
  - (c) Two members from Eastern European States;
  - (d) Four members from Latin American and Caribbean States;
  - (e) Four members from Western European and other States.
4. The membership of the Governing Council in 2018 is listed in the annex to the present note.
