Basic programme of work of the Council

Annotated agenda for the 2021 session of the Economic and Social Council

The Economic and Social Council, in its decision 2021/202, adopted the provisional agenda for its 2021 session (E/2021/1).

Section I of the present document reflects the list of items on the agenda for the 2021 session of the Council. Section II contains the annotations for the items. The annotations are intended to provide a brief history of each item and to indicate, where applicable, the documentation that is to be made available during the course of the session.

The annex to the present document contains the basic programme of work for the 2021 session of the Council, prepared in accordance with the working arrangements adopted in its resolution 2021/1.

II. Annotations

1. Election of the Bureau

Pursuant to General Assembly resolutions 68/1 and 72/305, the programme of work of the Economic and Social Council is on a July-to-July cycle. The term of office of the officers of the Council (the Bureau) for the 2021 session will be from the date of their election until the date of the election of their successors, in accordance with rule 19 of the rules of procedure of the Ocuncil. In accordance with the principle of equitable geographical rotation of the office of the President among the regional groups, the President of the Council at its 2021 session should be from the Asia-Pacific States. The four Vice-Presidents of the Council are elected from the other regional groups.

In its decision 2021/200 A, the Council elected by acclamation Munir Akram (Pakistan) as President of the Council and Collen Vixen Kelapile (Botswana), Sergiy Kyslytsya (Ukraine) and Pascale Baeriswyl (Switzerland) as Vice-Presidents of the Council for its 2021 session. In its decision 2021/200 B, the Council elected by acclamation Juan Sandoval Mendiolea (Mexico) as Vice-President of the Council for its 2021 session.

On the recommendation of the President, the Council, in its decision 2021/205, decided on the following special responsibilities of the Bureau for the 2021 session: the President, Munir Akram (Pakistan), would be responsible for the high-level segment, the high-level political forum on sustainable development convened under the auspices of the Council, the forum on financing for development follow-up, the Development Cooperation Forum, the special meeting on international cooperation in tax matters, as well as any joint meetings and other special meetings that might be convened should the need arise; the Vice-President, Sergiy Kyslytsya (Ukraine), would be responsible for the operational activities for development segment; the Vice-President, Pascale Baeriswyl (Switzerland), would be responsible for the humanitarian affairs segment; the Vice-President, Juan Sandoval Mendiolea (Mexico), would be responsible for the integration segment; and the Vice-President, Collen Vixen Kelapile (Botswana), would be responsible for the management meetings, including the elections to fill the vacancies in the Council's subsidiary and related bodies.

2. Adoption of the agenda and other organizational matters

The Council, pursuant to decisions 2020/205, 2020/206 and 2020/219 on the procedure for taking decisions during the coronavirus disease (COVID-19) pandemic, adopted the provisional agenda for its 2021 session (E/2021/1; Council decision 2021/202).

Pursuant to General Assembly resolutions 68/1, 72/305 and 74/298, the thematic focus for the 2021 high-level political forum on sustainable development, convened under the auspices of the Council, and for the 2021 session of the Council is "Sustainable and resilient recovery from the COVID-19 pandemic that promotes the economic, social and environmental dimensions of sustainable development: building an inclusive and effective path for the achievement of the 2030 Agenda in the context of the decade of action and delivery for sustainable development".

3. Basic programme of work of the Council

Pursuant to Council resolution 1988/77 on the revitalization of the Council, the President, with the cooperation of the other members of the Bureau, arranges consultations with members of the Council on the draft programme of work and makes proposals thereon for consideration by the Council.

Pursuant to Council decision 2006/206 on adapting the work of the Council, the President of the Council convenes consultations of the Council, on an "as available" basis, to adapt its organization of work and current methods of work in pursuance of the provisions set out in General Assembly resolutions 60/1, 61/16, 68/1 and 72/305.

4. Elections, nominations, confirmations and appointments

Pursuant to General Assembly resolution 72/305, the Council will schedule the elections to fill vacancies in its subsidiary bodies during dedicated management meetings in the first half (20 April 2021) and last quarter of the year. In accordance with Assembly resolution 72/305, in preparing for elections by the Council, Member States should present candidates at least three working days in advance of elections. Also in accordance with the resolution, and as applicable to the Council, the provisions of paragraphs 47 and 48 of Assembly resolution 71/323 should be followed.

5. High-level segment

The General Assembly, in its resolution 68/1, decided that a high-level segment would be held in July. It would discharge the functions of the high-level segment of the Council as provided for in Assembly resolutions 45/264, 48/162, 50/227, 61/16, 70/299 and 72/305.

Pursuant to Council resolution 2021/1, the high-level segment, including the threeday ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the Council, will be held from 13 to 16 July 2021.

(a) Ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the Economic and Social Council

Pursuant to paragraph 11 (c) of the annex to General Assembly resolution 68/1 and paragraph 18 of Assembly resolution 70/299, the three-day ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the Council, will be held during the high-level segment of the Council in order to avoid duplication, enhance efficiency and strengthen complementarity and synergy.

(b) High-level policy dialogue on future trends and scenarios and the long-term impact of current trends on the realization of the 2030 Agenda for Sustainable Development

In accordance with General Assembly resolution 72/305, the final day of the highlevel segment of the Council, following the ministerial segment of the high-level political forum, will focus on future trends and scenarios related to the Council theme and the long-term impact of current trends, such as the contribution of new technologies, in the economic, social and environmental areas on the realization of the Sustainable Development Goals, based on the work of the United Nations and other regional and international organizations and bodies as well as other stakeholders.

(c) Development Cooperation Forum

Pursuant to General Assembly resolutions 60/1, 61/16, 68/1 and 72/305 and Council resolution 2020/3, the Council will hold its biennial high-level Development Cooperation Forum to review trends in international development cooperation, including strategies, policies and financing, promote greater coherence among the development activities of different development partners and strengthen the links between the normative and operational work of the United Nations.

Pursuant to Council resolution 2021/1, the Development Cooperation Forum will be held on 6 and 7 May 2021.

6. High-level political forum on sustainable development, convened under the auspices of the Economic and Social Council

The General Assembly, in its resolution 67/290, decided that the high-level political forum on sustainable development under the auspices of the Council would be convened annually by the President of the Council and would have a thematic focus reflecting the integration of the three dimensions of sustainable development, in line with the thematic focus of the activities of the Council and consistent with the 2030 development agenda. The thematic focus of the high-level political forum on sustainable development to be convened under the auspices of the Council during its 2021 session is "Sustainable and resilient recovery from the COVID-19 pandemic that promotes the economic, social and environmental dimensions of sustainable development: building an inclusive and effective path for the achievement of the 2030 Agenda in the context of the decade of action and delivery for sustainable development" (see Assembly resolution 74/298).

Pursuant to General Assembly resolutions 67/290 and 70/1, the high-level political forum, under the auspices of the Council, would carry out regular thematic reviews on the follow-up and implementation of sustainable development commitments and objectives, including those related to the means of implementation, within the context of the 2030 Agenda.

In its resolution 70/299, the General Assembly decided that the high-level political forum under the auspices of the Council, without prejudice to the integrated, indivisible and interlinked nature of the Sustainable Development Goals, should discuss a set of Goals and their interlinkages, with a view to facilitating an in-depth review of progress made on all Goals over the course of a four-year cycle, with means of implementation, including with respect to Goal 17, reviewed annually.

The General Assembly also decided, in its resolution 74/298, that the high-level political forum for 2021, without prejudice to the integrated, indivisible and interlinked nature of the Sustainable Development Goals, should discuss Goals 1, 2, 3, 8, 10, 12, 13, 16 and 17 in depth.

In accordance with General Assembly resolutions 70/1 and 70/299, the follow-up and review at the high-level political forum will be informed by an annual progress report on the Sustainable Development Goals to be prepared by the Secretary-General in cooperation with the United Nations system.

Pursuant to General Assembly resolutions 67/290, 70/1 and 70/299, the high-level political forum, under the auspices of the Council, should carry out voluntary national

reviews of all countries, including countries in special situations, with the aim of facilitating the sharing of experiences, including successes, challenges and lessons learned. The Assembly, in its resolution 72/305, invited the Bureau of the Council to consider ways of optimizing the time currently available for countries to present their voluntary national reviews during the ministerial days of the high-level political forum, with a view to improving the exchange of national experiences on implementing the Sustainable Development Goals.

The General Assembly, in its resolution 67/290, invited the regional commissions to contribute to the work of the high-level political forum on sustainable development convened under the auspices of the Council, including through annual regional meetings.

Pursuant to General Assembly resolution 74/298, the Assembly will conduct, in conjunction, the reviews of Assembly resolution 72/305 on the review of the implementation of Assembly resolution 68/1 on the strengthening of the Council, resolution 67/290 on the format and organizational aspects of the high-level political forum on sustainable development and resolution 70/299 on the follow-up and review of the 2030 Agenda at the global level, during its seventy-fifth session. Pursuant to Council resolution 2021/1, the high-level political forum on sustainable development, convened under the auspices of the Council, will be held from 6 to 12 July 2021.

7. Operational activities of the United Nations for international development cooperation

In accordance with General Assembly resolution 72/305, the strengthened operational activities for development segment should serve as a platform to ensure accountability for, and acceleration of, system-wide performance and results in relation to the 2030 Agenda and provide guidance to and overall coordination of the United Nations development system.

Pursuant to Council resolution 2021/1, the operational activities for development segment will be held from 18 to 20 May 2021.

(a) Follow-up to policy recommendations of the General Assembly and the Council

In its resolution 75/233, the General Assembly requested the Secretary-General to continue regular follow-up, monitoring and reporting, including to the Council at its operational activities for development segment, on the work of regional assets of the United Nations development system in support of the 2030 Agenda with a view to enhancing transparency, accountability, efficiency, coordination and results-based management at the regional level in order to ensure that the longer-term reprofiling and restructuring of the regional assets of the United Nations are addressed on a region by-region basis and in accordance with the region's specific needs and priorities, as agreed in resolution 74/297 of 11 August 2020.

In the same resolution, the General Assembly reaffirmed that the Council, through its operational activities for development segment, serves as a platform to ensure and enhance accountability and oversight for and the acceleration of system-wide performance and results in relation to the 2030 Agenda, as well as to provide guidance and overall coordination of the United Nations development system.

Also in the same resolution, the General Assembly emphasized the need to ensure the independence, credibility and effectiveness of the evaluation office, and in this regard requested the Secretary-General to provide relevant information to the Council at its 2021 operational activities for development segment about the Development Coordination Office's proposed structure, funding modalities as indicated in the report of the Secretary-General on the implementation of Assembly resolution 71/243 on the quadrennial comprehensive policy review of operational activities for development of the United Nations system (A/75/79-E/2020/55), as well as collaboration with other entities in the system with an evaluation mandate.

In its resolution 75/233, the General Assembly requested the Chair of the United Nations Sustainable Development Group to continue to present a timely, comprehensive, evidence-based, analytical and more detailed performance report on an annual basis, including on progress made and remaining challenges and obstacles encountered, as well as on the operational, administrative and financial aspects of the activities of the Development Coordination Office, to the Council at its operational activities for development segment, while noting that the Office assumes managerial and oversight functions of the resident coordinator system under the leadership of an Assistant Secretary-General and with collective ownership of the United Nations Sustainable Development Group.

In the same resolution, the General Assembly requested the Secretary-General to present to the Council a report in 2021, 2022 and 2023 on system-wide implementation of the provisions of the resolution, including an update and

amendments where necessary of the existing monitoring and reporting framework for the quadrennial comprehensive policy review of operational activities for development with specific and measurable performance indicators on progress made, and on that basis invited the Council to exchange views on lessons learned and challenges and to propose to the Assembly overall recommendations to contribute to strengthening the oversight of States over the United Nations development system and to guide the overall progress in the full implementation of the provisions of the resolution through the annual Assembly follow-up resolution on the operational activities for development of the United Nations system.

Pursuant to General Assembly resolution 72/305, the Council should provide improved overall coordination and guidance on operational activities for development, on a system-wide basis, to the governing bodies of the United Nations development system, in keeping with the mandates of the quadrennial comprehensive policy review.

The Council will have before it the annual reports of the Executive Boards of the United Nations Development Programme/United Nations Population Fund/United Nations Office for Project Services, the United Nations Children's Fund, the United Nations Entity for Gender Equality and the Empowerment of Women, and the World Food Programme (General Assembly resolutions 48/162, 62/208, 64/289, 65/176, 67/226 and 68/229 and Council resolutions 1995/51, 2011/5, 2013/5 and 2015/15).

Pursuant to General Assembly resolution 70/1, the relevant governing bodies of the United Nations development system should take action to review the support to the implementation of the 2030 Agenda by the United Nations development system and to report on progress and obstacles. In accordance with Assembly resolution 72/305, and with a view to avoiding repetition of discussions, the executive boards that report to the Council should further highlight in their existing reports to the Council the issues requiring examination and identify actions to be taken, guided by the chosen theme.

(c) South-South cooperation for development

Pursuant to General Assembly resolutions 33/134 and 58/220, the High-level Committee on South-South Cooperation meets once every two years in odd-numbered years and reports to the Assembly through the Executive Board of the United Nations Development Programme/United Nations Population Fund/United Nations Office for Project Services and the Council.

At its nineteenth session, the High-level Committee on South-South Cooperation, in its decision 19/2, approved the provisional agenda for its twentieth session, to be held in 2018. Subsequently, the General Assembly, in its resolution 71/318, decided to postpone the twentieth session of the High-level Committee on South-South Cooperation to one day in June 2019. Subsequently, the Council, in its decision 2018/210, decided to consider the sub-item at its 2019 session.

In its decision 73/553, the General Assembly decided to further postpone the twentieth session of the High-level Committee on South-South Cooperation to May 2020 and decided that it should consist of a one-day organizational meeting and a four-day substantive session. At its 2019 session, the Council decided to consider the sub-item at its 2020 session.

In its decision 74/553, the General Assembly, noting with concern the situation concerning the coronavirus disease (COVID-19) pandemic, decided to further postpone the twentieth session of the High-level Committee on South-South Cooperation to a later date. At its 2020 session, the Council decided to consider the sub-item at its 2021 session.

8. Integration segment

In its resolution 68/1, the General Assembly decided that an integration segment of the Council should be held annually. Pursuant to Assembly resolution 72/305, the integration segment would be held for one day immediately before the high-level political forum. It would discuss and consolidate all the inputs of Member States, including case studies and lessons learned, the subsidiary bodies of the Council, the United Nations system and other relevant stakeholders to promote the balanced integration of the three dimensions of sustainable development. The segment would thus bring together the key messages from the subsidiary bodies of the Council and the United Nations system on the main theme, develop action-oriented recommendations for follow-up and feed into the high-level political forum. It would also coordinate the work of the subsidiary bodies of the Council, promoting a clearer division of labour among them, and the policies and activities of the specialized agencies relating to the Sustainable Development Goals and other internationally agreed development goals. The Secretary-General would present to the Council the annual overview report of the United Nations System Chief Executives Board for Coordination.

Pursuant to Council resolution 2021/1, the integration segment will be held on 2 July 2021.

9. Special economic, humanitarian and disaster relief assistance

In accordance with General Assembly resolution 52/12 B, in which the Assembly established a humanitarian affairs segment of the Council, and with Assembly resolutions 68/1 and 72/305, the Council should, in line with paragraph 11 (b) of the annex to Assembly resolution 68/1, through the humanitarian affairs segment, continue to contribute to strengthening the coordination and effectiveness of United Nations humanitarian assistance and support and complement international efforts aimed at addressing humanitarian emergencies, including natural disasters, in order to promote an improved, coordinated response by the United Nations. The humanitarian affairs segment should continue to alternate between Geneva and New York and should be convened preceding the annual session of the executive boards of the funds and programmes of the United Nations system.

The Council should also continue to hold a special event to discuss the transition from relief to development, to be convened immediately preceding the humanitarian affairs segment and following the annual session of the executive boards of the funds and programmes of the United Nations system. The special event, which addresses the linkages between humanitarian assistance and development, will help the Council to discuss and review more fully the implications of the transition from relief to development and improve the efforts of the international community to respond better to transition situations.

Pursuant to Council resolution 2021/1, the humanitarian affairs segment will be held from 23 to 25 June 2021, in Geneva.

10. The role of the United Nations system in the integration of the three dimensions of sustainable development into the implementation of and follow-up to the 2030 Agenda for Sustainable Development

In its resolution 45/264, the General Assembly requested the Secretary-General to implement the recommendations addressed to him in the annex to the resolution, which included the recommendation that the substantive session of the Council be organized under segments, including a coordination segment, and that the coordination segment focus on the coordination of the activities of the specialized

agencies, organs, organizations and bodies of the United Nations system in the economic, social and related fields, in accordance with Articles 63 and 64 of the Charter of the United Nations.

In its resolution 68/1, the General Assembly decided that dedicated coordination and management meetings would be held regularly to perform the functions of the coordination and general segments. In its resolution 72/305, the Assembly decided that the dedicated coordination and management meetings would be renamed the management segments. The meetings of the management segment would, in principle, last no more than two days, twice per cycle. The meetings would focus on the adoption of procedural decisions, consideration of recommendations of subsidiary bodies, as well as the introduction of reports and consideration of draft proposals submitted under relevant agenda items.

The Council, in its decision 2019/202, renamed the item to align with the consideration of the report of the Secretary-General requested in General Assembly resolutions 69/214, 70/201, 71/223, 72/216 and 73/227.

11. Implementation of and follow-up to major United Nations conferences and summits

The Council, recalling its resolution 2107 (LXIII) of 3 August 1977, by which it established the United Nations System Standing Committee on Nutrition, and pursuant to Council decision 2018/207, decided to request the Standing Committee on Nutrition to transmit to the Council a report on its activities on an annual basis, starting in 2018, with a view to promoting the coherence and impact of the United Nations system response to nutrition problems, and to reflect on policy implications for achieving the 2030 Agenda.

(a) Follow-up to the International Conference on Financing for Development

Pursuant to General Assembly resolution 69/313, the Council holds an annual forum on financing for development follow-up, one day of which is dedicated to the special high-level meeting with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development and up to four days of which are dedicated to discussing the follow-up and review of the financing for development outcomes and the means of implementation of the 2030 Agenda. The forum's intergovernmentally agreed conclusions and recommendations are fed into the overall follow-up and review of the implementation of the 2030 Agenda in the high-level political forum on sustainable development.

The General Assembly, in its resolution 70/192, decided that the forum would be chaired by the President of the Council, who would take the steps necessary to prepare the work of the forum according to paragraph 132 of the Addis Ababa Action Agenda.

In its resolution 72/203, the General Assembly encouraged the Council to consider, at its annual forum on financing for development follow-up, a discussion and analysis of systemic issues and challenges, taking into account the roles of the international financial institutions.

Furthermore, in its resolution 73/221, the General Assembly requested the annual forum on financing for development follow-up to organize a substantive expert debate among the major institutional stakeholders on how to improve debt sustainability and debt restructuring.

In its resolution 75/208, the General Assembly invited the President of the Council in consultation with the President of the Assembly to consider convening a special segment during the 2021 forum on financing for development follow-up, as a one-time event, to discuss concrete steps towards a sustainable, inclusive and resilient recovery from the economic downturn caused by the COVID-19 pandemic, in relation to the efforts towards the achievement of the Sustainable Development Goals and the implementation of the Addis Ababa Action Agenda, and requested the Secretary-General to submit to it at its seventy-sixth session an action-oriented report, presenting emerging challenges and key accelerators, for a resilient and sustainable recovery from the economic shocks caused by the COVID-19 pandemic, that may be relevant for future discussion in the framework of the Council forum on financing for development follow-up.

The sixth Economic and Social Council forum on financing for development follow-up will be held from 12 to 15 April 2021, including the special high-level meeting of the Council with the Bretton Woods institutions, the World Trade Organization and the United Conference on Trade and Development, and the forum's modalities will follow those applied to the 2019 forum (E/FFDF/2020/3, sect. I)

substantive input to the Fifth United Nations Conference on the Least Developed Countries.

In its resolution 2020/9, the Council requested the Secretary-General to submit to it at its 2021 session a report on the implementation of the resolution and of resolution 2019/2, including on accountability of the United Nations system at the global, regional and country levels and on progress made in the implementation of the United Nations System-wide Action Plan on Gender Equality and the Empowerment of Women.

In the same resolution, the Council requested the Secretary-General, in close collaboration with the Director General of WHO and in full consultation with Member States through WHO, to develop the terms of reference for the United Nations Inter-Agency Task Force on the Prevention and Control of Non-communicable Diseases, incorporating, but not limited to, the work of the Ad Hoc Inter-Agency Task Force on Tobacco Control and the current work of the secretariat of WHO to develop a division of tasks and responsibilities, as exemplified in appendix 4 to the WHO Global Action Plan for the Prevention and Control of Non-communicable Diseases 2013–2020 (see also Council resolutions 2014/10 and 2015/8).

In its resolution 2020/22, the Council requested the Secretary-General to report to it at its 2021 session on progress achieved in implementing resolution 2013/12, under the sub-item entitled "Prevention and control of non-communicable diseases" of the item entitled "Coordination, programme and other questions".

In the annex to its resolution 68/1, the General Assembly stated that the Secretary-General should make proposals to promote collaboration across the United Nations system, taking account of the functions of a strengthened Council, with the Department of Economic and Social Affairs of the Secretariat serving as a central hub of support for the Council, in order to better utilize existing resources of the United Nations system to broaden support to the Council and its Bureau. The proposals were to include measures to enable the Secretariat to better support the implementation of a unified development agenda. Similarly, the Secretary-General was to explore proposals to strengthen support to the Council, including to the office of the President of the Council.

In the annex to its resolution 72/305, the General Assembly stated that the Council should continue to strengthen its leadership and policy guidance role, and its role as the central mechanism for coordination of the activities of the United Nations development system and its specialized agencies and supervision of its subsidiary bodies while integrating their analysis throughout its segments. It should also address new and emerging issues in the economic, social, environmental and related fields and provide overall support for the integration of the three dimensions of sustainable development. It should promote a coordinated follow-up to the 2030 Agenda and the outcomes of other major United Nations conferences and summits in the economic, social, environmental and related fields.

The working modalities of the Council should be guided by the principles of inclusiveness, transparency and flexibility based on the deliberative function of its meetings. It should be a platform for discussion and the exchange of national experiences. The Council should aim to create synergy and coherence as well as avoid duplication and overlap in its work to ensure efficiency and effectiveness. It should also ensure an adequate division of labour among its subsidiary bodies and harmonization and coordination of their agendas and work programmes, while ensuring that the principles, critical aspects and implementation gaps of the 2030 Agenda are addressed.

Pursuant to General Assembly resolution 74/298, the reviews of Assembly resolution 72/305 on the review of the implementation of Assembly resolution 68/1 on the strengthening of the Council, resolution 67/290 on the format and organizational aspects of the high-level political forum on sustainable development and resolution

70/299 on the follow-up and review of the 2030 Agenda at the global level, will be conducted, in conjunction, at its seventy-fifth session.

The new body would be named the United Nations Group of Experts on Geographical Names, which would be composed of representatives of States Members of the United Nations, including experts appointed by Governments, and would focus on technical issues associated with the standardization of geographical names that may, where appropriate, support relevant aspects of the 2030 Agenda. In the same resolution, the Council also decided that the United Nations Group of Experts on Geographical Names would convene biennial sessions, in principle, over a period of five days, beginning in 2019.
